


The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
On **05/01/2025**, at **02:59** (Specifically include facts constituting cause for arrest.)

On **05/01/2025**, at **0259 hours**, while on routine patrol in the **1900 block of 14th Ave**, I observed a suspicious person who appeared to be covered half way by a blanket in the plaza of **1920 14th Ave (Armani's Cucina)**.

I then stepped out and made contact with the defendant who I later identified as **Loretta M. Sidoti (DOB: 05/31/1961)**. It should be noted that on **04/30/25**, at **2033 hours**, I responded to suspicious person reference (**CFS#043025-100**) at the aforementioned location where I made contact with the owner of **Amani's Cucina (Complainant)**. The owner advised Sidoti was bothering his customers asking for money and wished for her to leave the area. I then made contact with Sidoti and advised her to pick up her belongings and move along. Sidoti stated she would willingly leave the business.

I then explained to Sidoti that the owner requested her to leave the plaza earlier that day. Sidoti acknowledged that she was asked to leave but stated "where else do I go." I then advised Sidoti if she would not leave willingly, she would be trespassed from the property. Sidoti stated "trespass me then." Vero Beach Communications advised there was a Blanket Trespass Affidavit on file for that location.

I explained to Sidoti I would give her fifteen minutes to pack her belongings and leave. Sidoti said "arrest me then I'm not leaving." Sidoti was then trespassed from **1920 14th Ave plaza** reference (**CFS#050125-10**).

I requested Sidoti to leave multiple times after she was given the trespass warning. Sidoti continued to refuse to leave.

I then placed Sidoti under arrest for the violation of **F.S.S. 810.09(2A) Trespassing Property Not Structure or Convey**.

Sidoti was then transported to the **Indian River County Jail** for processing and booking where she is held on a **\$500 bond**.

On May 1, 2025, at approximately 0503 hours, I responded to 1200 Old Dixie Highway, Vero Beach, Florida, in reference to a disturbance.

Upon my arrival, I made contact with the couple later identified as Christopher L. Plummer and Caitline R. Lister. When I stepped out of my vehicle both Plummer and Lister were acting strange, pacing back and forth with their hands in and out of their pockets. I asked to see their hands and while Plummer kept pacing about. Lister stated that she suffers from epilepsy and that the patrol lights bother her. I instructed Lister to turn around and not stare at the lights.

I then got into a foot pursuit with Plummer. While I dealt with Plummer Lister was detained by deputy Ballester. Deputy Ballester asked Lister for consent to search her belongings to which she agreed to and willingly admitted that there were a couple used needles that she used to inject fentanyl approximately three hours prior.

Deputy Ballester and I searched Lister's bag that yielded 2 used needles as she had previously stated and a burnt straw. Based on my training and experience I know these items to be used to ingest drugs.

I then read Lister her Miranda rights which she understood and agreed to speak with me. Lister stated that she was being honest with us and she admitted to having the needles and using them. When asked if there were any drugs on her or her personal her belongings, she stated that she wishes because then there would have been no argument between Plummer and her. At this time, Lister asked if she's going to jail, I replied yes and she stated that she was done. I then immediately stopped asking question.

Lister was transported to the Indian River County Jail without further incident.

Based on my investigation I have probable cause to charge Lister with:

1. F.S.S. 893.147.1 Possession of drug paraphernalia and or use - Bond \$500




On May 1, 2025, at approximately 0503 hours, I responded to 1200 Old Dixie Highway, Vero Beach, Florida, in reference to a disturbance.

Upon my arrival, I made contact with the couple later identified as Christopher L. Plummer and Caitline R. Lister. When I stepped out of my vehicle both Plummer and Lister were acting strange, pacing back and forth with their hands in and out of their pockets. I asked to see their hands and while Plummer kept pacing about. Lister stated that she suffers from epilepsy and that the patrol lights bother her. I instructed Lister to turn around and not stare at the lights. As I instructed Lister, Plummer started to walk away and when asked to stop he began to run south on a grass field. I instructed him to stop multiple times or he would be tased. I then pulled out my agency issued Taser 10 and activated the on position making an audible sound. At this time Plummer threw himself on the ground and began to comply to my commands. Plummer was placed in handcuffs that were checked for proper fitment and double locked. I then escorted Plummer back to my patrol vehicle where I asked if he had anything on him that might poke me stick me or stab me before I conducted a search of his person. Plummer admitted to having 2 needles in his left pocket. The search of Plummer's person yielded 2 needles as stated.

I then searched the surrounding area and gathered multiple folded pieces of aluminum foil with burnt residue and straw with a burnt end based on my training and experience these drug paraphernalia are used to ingest several different drugs in various ways.

I then read Plummer his Miranda rights from my agency issued card which he understood and agreed to speak with me. Plummer then stated that the needles were his and that he's on "uppers". Plummer also admitted to using Fentanyl but would not state how long ago. When asked if there were any drugs on him or somewhere else, he stated that there were no drugs.

Plummer was transported to the Indian River County Jail without further incident.

Based on my investigation I have probable cause to charge Plummer with:

1. F.S.S. 843.02 Resist without Violence – Bond \$500
2. F.S.S. 893.147.1 Possession of drug paraphernalia and or use - Bond \$500

On Thursday, May 01, 2025, at approximately 2231 hours, I observed a white in color Lexus sedan revving their engine at the intersection of Roseland Road and County Road 512 WB. The white Lexus then proceeded to accelerate at a high rate of speed, at which time I activated my agency issued Stalker DSR 2X Radar unit in an attempt to validate my visual estimation of 60 miles per hour. My radar unit provided a clear and consist audio and visual read back showing the vehicle was traveling 56 miles per hour in a posted 45 mile per hour zone which confirmed my visual estimation. The vehicle was also driving along the solid white shoulder indicator line.

I initiated a traffic stop on the vehicle, which came to a stop in the 7-11 gas station located at, 9050 County Road 512, Sebastian, Florida. It was at that time that I made contact with the driver and sole occupant of the vehicle, Andrew Gallegos, who was identified by his Florida driver's license.

As I interacted with Andrew, I observed several physical signs of impairment: A strong odor of an alcoholic beverage emitting from his breath and vehicle, glossy, watery eyes, and Andrew admitted he had consumed a beer. This answer was due to the fact that I had asked Andrew how much alcohol had had consumed. Andrew stated he had consumed one beer, and later changed his answer to two beers.

I became concerned Andrew was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Andrew if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked Andrew a series of medical questions to ensure he could participate in field sobriety exercises. Andrew stated that he had no physical defects, was not sick or injured, did not have epilepsy or diabetes, did not wear contacts or glasses.

All field sobriety exercises were explained and demonstrated proficiently prior to Andrew beginning each exercise, and I confirmed he understood the instructions prior to the start of each exercise.

The following exercises were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees. Vertical Gaze Nystagmus was not present.
- 2.) WALK AND TURN - A straight painted white parking line used for the exercise. Andrew was advised of all instructions prior to the commencement of this exercise, to which he stated he understood and had no questions. Prior to the start of this exercise, Andrew failed to maintain the instructed position and was reminded to return to the instructed stance. Once the exercise began, Andrew exhibited the following: missed heel-to-toe, used his arms to balance, improper turn, stepped off the line.

3.) ONE LEG STAND - Andrew was advised of all instructions prior to the commencement of this exercise, to which he stated he understood and had no questions. For this exercise, Andrew chose his right foot, and the stop watch feature of my apple watch was utilized to keep time. During the exercise, Andrew showed the following: unable to maintain balance, used arms to balance, did not count in the proper manner provided, used his arms to balance, did not look at his raised foot, and miss counted. Andrew counted twelve thousand, thirteen thousand, fifteen thousand, etc.

Overall, Andrew performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on Thursday, May 01, 2025, at 2237 hours, Andrew was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond his normal faculties, incapable of operating a vehicle safely.

Andrew was arrested for DUI at 2251 hours and was advised of the charge. I took Andrew into custody without incident and transported him to the Indian River County Jail for booking.




NARRATIVE

On 5/2/2025 at approximately 0009 hours, I conducted a traffic stop at N Indian River Dr and US1 on a Silver Jeep Cherokee bearing Washington license plate #BZT8518 for Tag not visible within 50 feet.

I made contact with the driver later identified as Carrie Takacs (arrestee). Carrie advised she could not provide her vehicle's documents as the vehicle does not belong to her but rather a friend from out of state. I asked Carrie for her name and date of birth, she provided the name Crystal M. Margure, date of birth 11/07/1968; and Social Security Number 172-62-0227. Dispatch notified me a short time later that the name and social provided came back to no record found. I asked Carrie if she was lying to me about her name and she advised she was not.

I requested a backup unit with RAPID ID to positively identify Carrie, a short time later I asked Carrie if she had any warrants, and she advised that she had a warrant out of Indian River County for Violation of Probation and a warrant out of Brevard County for failing to appear to a traffic arraignment. Carrie apologized for providing a false identity and gave me her real name and social security number. During a post-Miranda interview, Carrie admitted that she altered the license plate attached on her vehicle which she received from a friend, due to not being able to register the vehicle. She altered the license plate by writing "2025" into the top right corner of the license plate with what appears to be white-out paint. Carrie admitted to knowingly altering and placing this license plate which belonged to a Chevrolet Tahoe and expired in 2022 on her unregistered 1999 Jeep Cherokee. Carrie advised she still does not have a valid license, during an inventory of the vehicle two Florida Identification cards were located belonging to Carrie. An electronic query of Carrie's driving history revealed she has been convicted of driving with a suspended/revoked license 7 times on the following dates 09/05/2024 - Indian River County, 03/09/2014 - Brevard County, 06/05/2007 - Pennsylvania, 06/03/2007 - Pennsylvania, 01/12/2003 - Pennsylvania, 05/08/1996 - Pennsylvania, 03/30/1992 - Pennsylvania.

Dispatch confirmed the warrant out of our county #VP202412355, and a hold was placed on Carrie reference her Brevard County warrant #2024CT039492.

Corporal Lang, conducted an Inventory, Towsheet and turned the vehicle over to Nettle's Towing.

Carrie was subsequently cited and charged with False ID given to Leo, Operating a motor vehicle with no valid license Citation #AJ5RNSE, Operating an unregistered motor vehicle Citation #AJ5RNRE, Defaced license plate Citation #AJ5RNTE, and Tag not visible within 50 feet Citation #AJ5RNQE.

Carrie was transported to the Indian River County Jail without further incident.

On 05/02/2025, at approximately 0215 hours, I was dispatched to [REDACTED] in reference to a disturbance.

Upon arrival on scene, I made contact with Joseph Romano, he advised that a female (Carla Taylor) whom doesn't live there was knocking on the door then attempted to push past him to get inside the residence. Romano advised that he heard knocking at the front door and when he opened it, Ms. Taylor was standing outside waiting to be let in. He advised that he told her to go away and at this point she proceeded to get by him through the front door, he advised that he pushed her out of the doorway to prevent her from getting in. Romano advised that they exchanged words outside until she ultimately walked away from the property. Romano advised that Ms. Taylor does not live at the residence and is not supposed to be there, he also advised he is a tenant of the property and not the owner. Romano advised he only knows Ms. Taylor due to her being a friend of the home owner.

Deputy Doval had made contact with Ms. Taylor at this time, she advised to him that she was allowed to stay there by the home owner (Buell Hudson) for the time being as she just got out of jail. Ms. Taylor advised she knocked on the front door to attempt to go inside the house, this is when Romano stood in the door way and told her to go away while physically preventing her from going inside, she advised that Romano pushed her by the neck out the doorway and then slapped her in the face once she was on the front porch. Ms. Taylor advised that she called Law Enforcement shortly after this incident. Ms. Taylor advised that she wishes to pursue charges against Romano.

Deputy Doval advised that Ms. Taylor had marks on her face and chest consistent with being slapped and pushed. Deputy Doval captured photos of these injuries and uploaded them to Evidence.com

I made contact with the home owner Mr. Hudson, he advised that he had been allowing Ms. Taylor to stay there temporarily after she got out of jail to help her. Mr. Hudson advised that he did not want her to stay there permanently but had granted her permission to stay inside the residence for the time being. Mr. Hudson advised he did not provide Ms. Taylor keys to the residence and instructed her to knock on the front door whenever she needs to get inside. Mr. Hudson advised he did not witness the altercation but heard screaming while he was in the kitchen.

While on scene I noticed a camera on the front porch that faced the front door. I made contact with Helen Dewees who is Joseph Romano's wife, she showed me the footage of the incident that was on her phone. In the video you can see Ms. Taylor approach the front door and knock, you can hear Romano open the front door and tell her to leave, this is when Ms. Taylor attempts to enter the residence. While Ms. Taylor was attempting to enter the residence, you can see her get pushed out of the doorway, then see Romano step out on the porch immediately after. As the video continued you can see Romano and Ms. Taylor argue about her being allowed to be there, this is when you can see Romano reach across with his left hand and slap Ms. Taylor in the face, after this occurred, they continued to argue until Ms. Taylor leaves the front porch area. I told Ms. Dewees to email me the camera footage and provided her with my email address. This footage was also captured on my Axon body worn camera.

Due to Ms. Taylor's statement, the physical marks on Ms. Taylor's person and the video footage of the incident, I found



