NARRATIVE

On 09/08/25 at approximately 1923 hours, I was dispatched to [REDACTED] in reference to a Disturbance at that location. The caller later identified as Mary Ann Vega-Juliano reported that [REDACTED] kicked her in the knee last Friday. She said [REDACTED] had returned to [REDACTED] and they were arguing.

Upon my arrival I spoke with Mary Ann [REDACTED]. She said he was supposed to be going to rehab while working and saving money. Mary Ann said Fabian has not been living up to his end of the bargain. She said he is constantly drinking and not saving up [REDACTED]. Mary Ann said on Friday 09/05/25 she was speaking with Fabian about his plans to save up [REDACTED]. Mary Ann said she and Fabian began to argue over this topic. She said they were outside at first, but then went into the house. She said Fabian was in [REDACTED] and she tried to continue the conversation with him. She said Fabian became upset and kicked her in the left knee. Mary Ann said she told Fabian she was going to contact law enforcement. Fabian gathered his things and left the house. Mary Ann said Fabian did not return throughout the weekend. She said he returned tonight just prior to her calling law enforcement. She said she waited to call law enforcement because she wanted Fabian to be present so he could be spoken with by Law Enforcement. As I spoke with Mary Ann, she was wearing a brace on her left knee. I asked her to remove the brace so I could see her knee. Once the brace was removed, I could see an area of swelling along the left side of her knee cap. This swelling was not present in the right knee. The swelling was exactly in the area that Mary Ann said Fabian made contact with her.

## NARRATIVE

On Monday, September 8, 2025, at approximately 1850 hours, I, Deputy M. Neill #6317 observed a subject operating a dirt bike near the intersection of 17<sup>th</sup> Street SW and 19<sup>th</sup> Avenue SW, Vero Beach, Indian River County, Florida.

On my previous call for service, I could hear a dirt bike driving fast by hearing the loud engine noises nearby. As I approached 19<sup>th</sup> Avenue SW, I observed a subject on a dirt bike traveling southbound. Upon catching up to the subject, we approached the intersection of 17<sup>th</sup> Street SW and 19<sup>th</sup> Avenue SW. The dirt bike did not have a tag displayed and the subject was not wearing a helmet or eye protection.

I activated my blue and red emergency lights, as well as my siren to indicate for the subject to pull over. The subject looked back at me, then immediately accelerated eastbound on 17<sup>th</sup> Street SW at a high rate of speed. I estimate that the subject was traveling approximately 55MPH. Due to it not meeting our pursuit policy, I deactivated my emergency lights and siren and continued at a normal rate of speed to ensure the subject did not later crash.

The subject is described as a 20–25-year-old white or Hispanic male, with long black hair, about shoulder length (possibly a mullet style). He was wearing a gray shirt and black shorts.

Due to the subject's rate of speed and him traveling on dirt, I was able to follow the tire tracks around. The subject continued eastbound until approaching 7<sup>th</sup> Road SW, then went northbound until going westbound on 13<sup>th</sup> Street SW until they proceeded southbound on 19<sup>th</sup> Avenue SW. This is where I lost the tracks due to pavement and harder roadways.

While searching the area, I located similar dirt tracks on 18<sup>th</sup> Avenue SW, which drove to 1560 18<sup>th</sup> Avenue SW. the tracks went in to the yard and then another set of tracks were seen leaving. There also appeared to be tire tracks which went to the back of the residence. The residents there stated the subject arrived earlier but left after showing off his dirt bike. They advised they did not know who it was.

Parked in front of the residence on the street was a 2006 Gold Toyota truck bearing Florida tag 97BCMM. It is registered to Ms. Hilda Gonzalez who resides at 2503 3<sup>rd</sup> Street SW, Vero Beach, Florida. Upon looking up subjects attached to that residence in our CAD system, I located Mr. Fabian Zavala. Mr. Zavala appears to look similar to the subject that was on the dirt bike. Utilizing Facebook, Mr. Zavala has a Facebook profile which shows a dirt bike.

I responded to 2503 3<sup>rd</sup> Street SW, Vero Beach, Florida to make contact with Mr. Zavala or the registered owner. Upon arriving at the residence, there was no answer at the door.

I requested the IRCISO Real Time Crime Center (RTCC) to complete an attempt to identify bulletin from my dash camera to see if anyone recognizes the driver.

I responded back to 2503 3<sup>rd</sup> Street SW to see if there was anyone home. After knocking on the door, I made contact with Ms. Gonzalez. During a interview, she advised that her grandson, Mr. Zavala does like to ride dirt bikes and

was at a friend's house earlier today. I showed her still images from my dash camera of the subject who fled. She advised originally that it was Mr. Zavala, then after showing her more photos that it appeared to be him. I then asked Ms. Gonzalez if she would call Mr. Zavala to see if he would meet for a interview. Mr. Gonzalez then went inside the residence. After a while, she did not return out. I looked inside and saw a subject who appeared to be Mr. Zavala peaking around the corner. I then made announcements to have Ms. Gonzalez come back outside. After waiting another minute or two, Mr. Zavala came back outside to speak to me. During this time, Mr. Zavala admitted that it was him that fled from the traffic stop earlier today. He stated he fled due to the dirt bike not being his. He was afraid that if he were to stop that I would have towed the dirt bike which would have costed his friend money. Mr. Zavala was also shown photos from my dash camera. He admitted that the subject in the photos was him. After fleeing, he returned the bike to his friend who lives in the area and got a ride home. Mr. Zavala admitted to seeing my blue and red emergency lights activated but did not hear my siren.

After seeing Mr. Zavala in person, I can confirm that he was in fact the person who was operating the dirt bike earlier. His hair style has changed since his last drivers license photo.

Mr. Zavala was then placed under arrest. Once we got back to my patrol vehicle, he was advised of his Miranda Rights. He confirmed what was mentioned above, that he had fled due to not wanting his friend's dirt bike to get towed. He also confirmed that he did not leave his friends residence that law enforcement was watching due to knowing we would stop his truck, therefor he left with another friend to go back to his residence.

The dirt bike which he was operating did not have a tag displayed and appears to be a unregistered motor vehicle. Additionally, per FCIC/NCIC, Mr. Zavala does not have a motorcycle endorsement which is required to operate a vehicle such as a dirt bike.

Based on the statements and evidence, I believe there is probable cause to arrest Mr. Fabian Zavala for the offense of Fleeing and Eluding with Lights and Sirens Active at High Speeds, Pursuant to FSS 316.1935(3)(a), driving an unregistered motor vehicle, pursuant to FSS 320.02.1, and not having a motorcycle endorsement, pursuant to FSS 322.57.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
On **09/08/2025**, at **22:51** (Specifically include facts constituting cause for arrest.)

On September, 8th, 2025, at approximately 2130 hours I observed a white Chevrolet pick up truck bearing Florida registration 69EMZQ driving southbound on Powerline Road from the intersection of Barber Street. While behind the vehicle I observed it begin driving in the middle of both north and southbound lanes and continued heading southbound. I conducted a traffic stop on the vehicle utilizing my overhead emergency lights. The vehicle came to a final stop south of the intersection of Yearling Trail and Powerline Road.

I made contact with the driver and sole occupant, Roger Difillipo, identified by his Florida driver license. I immediately detected the odor of an alcoholic beverage emitting from the vehicle. I noticed Difillipo's speech to be slow and slurred, and the odor of an alcoholic beverage became stronger as he spoke. Difillipo's eyes appeared to also be glossed over and red. Difillipo struggled to retrieve his license out of his wallet, and proof of valid insurance. I asked Difillipo if he consumed an alcohol, which he stated he had hours ago.

I became concerned Difillipo was impaired beyond normal faculties by alcoholic beverages due to my initial observations.

I requested Difillipo to exit the vehicle, which he complied but immediately began stumbling and utilized myself and his truck for balance while walking.

To dispel my concerns, I asked Difillipo if he would participate in a series of standardized field sobriety exercises, to which Difillipo agreed. I asked Difillipo a series of medical questions to ensure Difillipo could participate in field sobriety exercises. Difillipo stated he does not wear contacts or glasses, or suffer from any illness that effects his vision or ability to complete the exercises.

All field sobriety exercises were explained and demonstrated proficiently prior to Difillipo's beginning each exercise and I confirmed he understood the instructions prior to the start of each exercise. The following exercises were performed:

- 1.) **HORIZONTAL GAZE NYSTAGMUS** - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed. During the testing, Difillipo would turn his head to follow the stimulus and stare at me instead of the stimulus.
- 2.) **WALK AND TURN** - A straight line of duct tape was used for the exercise. When asked, Difillipo agreed with me that the line was straight and flat. During the instructions of the exercise, Difillipo failed to maintain the starting position and had to be instructed multiple times to maintain the starting position until told to begin. Difillipo would then begin walking on the line prior to being told to begin. When Difillipo began the exercise, he failed to maintain the heel to toe position and would wave his arms, in attempts to utilize his arms for balance.
- 3.) **ONE LEG STAND** Difillipo stated he understood the exercise and began. Difillipo failed to count out loud or hold his foot up parallel to the ground and kept losing his balance.

Overall, Difillipo performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that Difillipo was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond their normal faculties, incapable of operating a vehicle safely.

Difillipo was arrested for DUI at 2209 hours and was advised of the charge. I took Difillipo into custody without incident and transported Difillipo to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Solomon advised me that Difillipo agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Difillipo had a breath alcohol concentration (BrAC) of 0.15 grams per 210 liters of breath and 0.16 grams per 210 liters of breath.

## NARRATIVE

On Tuesday, September 9, 2025, at approximately 0151 hours, I responded to 5155 20<sup>th</sup> Street (Staybridge Suites) in reference to a BOLO issued for a stolen vehicle.

Prior to my arrival, Sergeant Thimmer located the stolen vehicle, a silver in color Lexus RX350 bearing FL tag # RTCX17. The vehicle was reported stolen out of Gainesville Police Department reference case # GPD25-0013185. The following is the probable cause that was transferred to me from Officer D. Johnson #1164 of the Gainesville Police Department:

"On the above date, time, and location, the Def asked the Wit for the Vic's keys to retrieve something out of her vehicle. The Wit is the Vic's daughter. The Wit handed the keys over to the Def so that she may do so. Approximately 1 hour later, the Wit and Vic noticed that the vehicle was gone.

The Wit and Vic attempted to contact the Def by phone but she would not answer the phone. She also blocked all forms of contact through social media. Due to the Def blocking contact and the Wit last seeing the Def when she handed over the keys, it is reasonable to believe that the Def stole the vehicle.

The Vic provided a photo of the Def and has known her from the past. The Vic was able to provide the Def's full name and date of birth. I positively identified the Def by her FL ID photo."

It should be noted that this incident occurred on September 6<sup>th</sup> at approximately 1600 hours at 4121 NE 15th ST 5-48 in Gainesville, FL. The victim is Charisma Gibson, the Witness is Marneshia Green, and the defendant is Jhayla Anglin.

When I arrived on scene, I made contact with the employees at Staybridge Suites and requested to review camera footage of the individual driving the stolen vehicle. At this time, I was informed the suspect was Jhayla Anglin and a photo of Anglin was provided to me by other deputies. While reviewing the surveillance footage it is observed that the aforementioned vehicle arrived out front of the Staybridge Suites. A female, matching the physical description of Anglin, wearing a blue dress exited the vehicle. I was then informed by the staff that Anglin checked into room 228.

Myself, Corporal Quaglia, and Deputy Williams made contact with Anglin in room 228. Anglin was immediately detained in mechanical hand restraints and placed in the rear of my marked patrol vehicle. I read Anglin her Miranda Rights from my agency-issued Miranda card and Anglin stated she understood and wished to speak with me. When I asked Anglin about the vehicle, she stated that she pays Gibson \$200 a month through her "Chime" app and the two had a verbal agreement. When Anglin was asked about the stolen iPhone SE, she originally stated





On September 9, 2025, at approximately 0830 hours, I responded to 2655 5<sup>th</sup> Street SW (Salvation Army) Vero Beach in reference to an indecent act.

Public Safety Dispatch advised that a black male wearing a multi colored shirt was urinating on the fence on the property in the parking lot of the business.

Upon arrival, I made contact with the male later identified as Lavern Leon Felton. I spoke with Lavern and asked why he was urinating on the fence and he said that he wasn't. When I asked for his name, he was very dismissive and avoidant, then finally stated his name was Johnson Howard born 4/9/1981. I wrote the name down and attempted to run his name in our local's database. I did not believe the name he gave me as he appeared far older than someone born in 1981. When I found no record of the name in our local database, I ran the name given over Channel 2 through FCIC/NCIC. Dispatch advised that there was no record for that name. I continued to ask about his name and have him spell it for me so i could ensure I was given the correct information. He then began to act as if he didn't know his name stating he forgot it, and that he didn't know when he was born.

I then went to speak with the caller, Flavia Pereira, who said that she was inside when she saw the male walk onto the property and stand by the gate to their onsite pond, he then started urinating on the fence and talking to himself. She stated that the male looked like someone they had trespassed last month. She then showed me a booking photo of the male and the name on the booking sheet was Lavern Leon Felton born 05/31/1964. While speaking with Flavia, she stated she did not see anything other than what she believed to be him peeing on the fence, she advised he was facing away from her at the time of the incident.

I wrote the name down and ran it through Dispatch who advised that Lavern has an active trespass warning for this address. I found Lavern's FL ID card number and ran him in Driver and vehicle information database (DAVID), which showed an ID card photo that looked like the same male i was out with. When I looked in our local database I found another photo of Lavern, and I showed him the photo, he stated that he hated that photo because it made himself look ugly. When I informed him that he lied about his name and that he was being arrested for trespassing he stated he though he just couldn't be on the other side of the property which faces 27<sup>th</sup> Avenue.

I then placed Lavern into physical hand restraints and searched his person. While searching his person I located a wallet which had a Florida ID card in it that identified him as Lavern Leon Felton.

Lavern is being charged with one count of trespass on property other than structure or conveyance for willfully and intentionally entering or remaining on property that he was lawfully issued a trespass warning for on August 18<sup>th</sup>, 2025 original case # 2025-00088040.

Lavern is also being charged with one count of giving false name to LEO for willfully and intentionally giving a name he knew to be untrue in order to prevent law enforcement from discovering an active trespass warning that he was a subject of from being discovered to avoid arrest.

On Wednesday, September 10, 2025, at approximately 0212 hours, I, Deputy M. Neill #6317 was conducting traffic enforcement near the 500 block of 27<sup>th</sup> Avenue SW, Vero Beach, Indian River County, Florida.

While conducting traffic enforcement, I noticed a vehicle traveling southbound, just north of the intersection. As I was conducting stationary radar, I observed the vehicles speed. At the time, I estimated the vehicles speed to be 60MPH in a posted 40MPH zone. My in-car radar captured the speed to be 58MPH. As the vehicle was continuing to get closer to me, the speed would increase. The speed went up to 65MPH in a posted 40 MPH zone. This was also the only vehicle on the roadway.

As I pulled out to catch up to the vehicle, it continued to speed away. It made an abrupt right turn. The vehicle continued to speed down a dirt road over pot holes until it reached 2975 7<sup>th</sup> Street SW, Vero Beach, Florida. By this time, I was able to catch up to the vehicle as it was pulling down the driveway. I activated my blue and red emergency lights to conduct the traffic stop on the vehicle.

I made contact with the driver, who was later identified as Mr. Kyle Hazley by his Florida Drivers License. Mr. Hazley immediately started to ask for a break before even being told the reason for the stop. Upon asking Mr. Hazley for his license, I could smell the odor of an alcoholic beverage emitting from his breath. He had watery eyes and had difficulty removing the license from his wallet. Upon asking why Mr. Hazley sped away like he did, he would only keep asking if I would give him a break since he made it home.

Mr. Hazley admitted to having a couple of alcoholic drinks earlier today when asked if he had consumed any alcohol.

I asked Mr. Hazley if he would submit to Standardized Field Sobriety Exercises (SFSE's). He stated he would not. He was then informed that his refusal to perform SFSE's could be used against him in court if an arrest was made. He advised he understood and again refused to perform SFSE's. Mr. Hazley was then placed under arrest for DUI. He was secured in handcuff restraints which were checked for proper fit and double locked.

Mr. Hazley was transported to the Indian River County Jail. There he refused to provide a breath sample. Deputy Solomon advised Mr. Hazley of implied consent. After being advised of implied consent, he again refused to provide a breath sample.

Per DAVID, Mr. Hazley had a prior refusal to submit to a lawful test of his breath. This was documented with citation AA05YWE on 06/21/2023.

Based on the above statements, observation, and my training and experience, I believe there is probable cause to arrest Mr. Kyle Hazley for the offense of DUI, pursuant to FSS 316.193(1)(A), and for Refusing to Submit to a Lawful Test of his Breath with a Prior Refusal, pursuant to FSS 316.1939.
