On July 30, 2026 at approximately 0434 hours, I, Deputy Gadacz responded to [REDACTED] in reference to a suspicious person.

While on my way to the incident location, dispatch provided the description of a black male, wearing no shirt and blue shorts.

Upon arrival, I made contact with an unknown black male, who was later identified as Cedric Dion Anderson, and who matched the description provided by dispatch. Anderson advised he lives at that location and was emptying out trash from the back of his 2007 white Dodge truck. Anderson advised he does not have his license on him but provided his information. Anderson also advised he has charged the address on his license yet. I checked Anderson for any active warrants, and it yielded negative results. I advised Anderson to have a goodnight and keep the volume down. I left the incident location but filled out a Field Investigation Report.

Sometime later, dispatch received another call about the same individual still acting suspicious. I contact with caller over the phone and was advised, the individual was climbing on top of trash bins in an attempt to enter an apartment on the second floor. I returned back to the incident location and observed Anderson next the building with multiple trash bins next to him.

I made contact with Anderson, who advised he lives in [REDACTED] but does not have keys to enter the residence. Assisting deputy went and spoke to the home owner while I waited with Anderson down stairs. Anderson advised he lives at that location but believes there is a DCF case regarding him and he was just trying to get into the apartment to see his kids. The assisting deputy, came back from speaking with the home owner, and advised Anderson does not live there and the home owner wants him trespassed. Anderson was issued a trespass warning and advised not to come back to that location or he will be arrested. Anderson entered his vehicle and left the area.

While driving away from the incident location, dispatch advised they had received another call from the female who just trespassed Anderson from that location. Dispatch advised he was knocking on her door. I returned back to the incident location and observed Anderson sitting at the top of the stairs next to [REDACTED]. I advised Anderson place his hands behind his back and he complied. While cuffing Anderson, he was screaming to the home owner to let him in and that he wanted his clothes.

Anderson was arrested and placed in the back seat of my patrol vehicle. Anderson was transported the Indian River County Jail and charged with F.S.S 810.08(2)(a), Trespassing.

Cedric Dion Anderson did unlawfully and willfully, without being authorized, licensed or invited, enter

NARRATIVE

On July 30th, 2026 at approximately 2048hrs, I Deputy Finkle and Cpl. Ballester conducted a traffic stop in the area of the 8700blk of 20th street, Vero Beach FL.

While traveling westbound on 20th St, I came upon a blue in color Ford pickup (B3WCW) that was emitting a loud audible tone from the exhaust, much louder than that of a factory system. The vehicle also had extremely tinted windows that could not be seen through (once stopped).

I queried the registration on the vehicle through David which returned to a Willie King (FL-K380-496-76-000-0) who had an active license suspension since 2025 as well as a seize tag order for no insurance. I also queried Mr. King and confirmed this information. I initiated a traffic stop on the vehicle which pulled into the parking lot of Sunoco gas station (8418 20th St).

Once stopped, I had to instruct the driver to lower the windows due to the safety hazard presented because the dark tint. Once the windows were down and I approached the front driver window, I observed a cloud of smoke begin exiting the interior of the vehicle. I then immediately observed the strong odor of burnt marijuana.

I made contact with the driver, Kenetha Holmes (FL-H452517777550) and inquired about the smoke to which she advised it was marijuana. I informed her the multiple reasons for the traffic stop and observed a front seat passenger, later identified as the registered owner, Mr. King. Both occupants stated that neither have a medical marijuana card which I confirmed through Public Safety Dispatch.

Ms. Holmes advised she smoked at home and that Mr. King was the one smoking in the vehicle. I instructed both occupants out of the vehicle and to the front of my patrol vehicle. I searched Mr. King finding no contraband and did not observe any obvious items on Ms. Holmes person who was wearing a dress with no pockets.

I began a probable cause search on the driver side of the vehicle. I was informed by Cpl. Ballester that Ms. Holmes stated she had marijuana in her purse as well as a firearm. Cpl. Ballester then began searching the front passenger area and located a black in color purse/bag. Inside the bag he located Ms. Holmes driver's license.

As he continued searching, he located a cigar package with fresh marijuana inside. He then located a clear plastic container that had a blue in color vape inside. Once he opened it, the vape had a dark liquid substance visible through the sight glass.

Based on my training and experience, I believed the vape to be filled with THC oil. I responded to Ms. Holmes and asked her if it was THC to which she stated it was. Cpl. Ballester then located a firearm

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **07/30/2026**, at **23:05** (Specifically include facts constituting cause for arrest.)

On **07/30/2026**, at approximately **23:05** hours, I was traveling behind a grey Ford sedan in the **2600** block of Indian River Boulevard. The vehicle had very dim tag lights, which made it difficult to legibly read the license plate from 50 feet to the rear. I drove closer to perform an inquiry on the tag while I was operating in the lane adjacent to the sedan. I then discovered that the Ford (displaying FL tag #XSB707) was registered out of Greenacres, Florida under "TDF LLC". The driver, an unknown male, observed my patrol vehicle adjacent to them and performed a reactionary lane change into the left turn lane at the intersection of 21st Street and Indian River Boulevard. I then maintained visual of the vehicle as I continued towards the next intersection and turned around. I observed that the Ford briefly entered the residential neighborhood of "Vero Isles" before the driver performed a U-turn within the four-way intersection at Vero Isles drive and Park Avenue. The driver was now facing westbound at the intersection of Park Avenue and Indian River Boulevard.

I positioned myself directly behind the Ford as it continued westbound through the intersection, and I performed a traffic stop on the vehicle for the violations. I made contact with the sole occupant, later identified as Ramon Diaz (H/M DOB: 06/14/2001). I immediately detected a very strong odor of burnt Marijuana emanating from the inside of the vehicle. I advised Ramon on the reason for the stop, and I requested his license along with the paperwork for the vehicle. Ramon explained to me that this was a rental vehicle, which he possessed for several weeks as the authorized user. Ramon then provided me with his license and some photographs on his phone depicting the paperwork for the vehicle. When I mentioned the strong odor of Marijuana, Ramon told me that he often transports Cannabis for his family's "business". While I was speaking to Ramon, I could see ash on the center console area, as well as lighters and Marijuana rolling papers in the vehicle. I recognized from my training and experience these indicators to be consistent with the smoking/usage of Marijuana. I asked Ramon if he had any Marijuana or Cannabis inside of his vehicle, and he initially told me there was nothing in his car. I asked Ramon to exit the vehicle, and he then mentioned to me that his firearm was accessible on the door panel. I observed there was a Glock handgun with an extended magazine. The handgun was not stored in a holster, and it was immediately accessible to Ramon. I then performed a frisk for additional firearms of the immediate area within reach of where Ramon was positioned in the driver's seat. In the center console area, there was a container for Marijuana with shake residue. The Marijuana container was not from a dispensary and had a faded label. I then observed that there was a black bag on the passenger side of the vehicle. Inside of this bag I recovered:

- a large Ziploc bag containing approximately 32.1 grams (TPW) of loose Marijuana.
- a second Ziploc bag containing approximately 9.2 grams (TPW) of loose Marijuana.
- a third Ziploc bag containing "RAW" rolling papers, a disposable lighter, and an emptied Marijuana container.
- a white container labeled "Snow Capz", which had residue Marijuana shake. "Snow Caps" Marijuana is a high-potency Cannabis product made by coating Cannabis flower buds in crushed THC isolate. It is designed to provide the user with an intense high.
- a black, zippered, soft-shell case. This case contained a metal grinder with loose Marijuana shake, a lighter, multiple "RAW" rolling paper bundles, spice/additive smoking products, and additional Marijuana shake scattered inside the case.
- Dove Men's Deodorant.
- a single 9mm bullet (matching the ammunition that was loaded in the handgun recovered from the driver's door).

None of the Marijuana was properly labeled or packaged. The large quantity of Marijuana was loosely stored in clear Ziploc Bags. Ramon advised me that he did not possess a valid Medical Marijuana Card, and I verified this through an inquiry. Post-Miranda, Ramon claimed that the bag belonged to his girlfriend, who was currently in West Palm. It was verified through a subsequent inquiry that Ramon's girlfriend also did not possess a valid Medical Marijuana Card. Ramon did claim ownership of the handgun. While discussing the inappropriately packaged Marijuana, Ramon admitted that he smokes Marijuana with his girlfriend. He advised me that he provides his girlfriend with Marijuana products, and he expressed knowledge of the presence of the Marijuana inside of the bag. Ramon stated that this bag is often used to store his handgun and Marijuana products, but he denies ownership of the black bag.

Based on the facts above, Mr. Ramon Diaz was placed under arrest for possession of a controlled substance (more than 20 grams of Marijuana). He was issued FL UTC (#AMZ9AXE) for the offense and transported to the Indian River County Jail.

NARRATIVE

On July 30th, 2026, at approximately 2356 hours, I was dispatched to 615 18th St. Apt. 3., Vero Beach, for a report of a civil call. The reporting party was identified as Christine Dalzell, stated a female identified as Cindy Wilcox, had been given permission to drive her car but has not returned it within a reasonable amount of time. The vehicle was identified as a red Mitsubishi bearing Florida registration SJTC13.

Christine provided me a view of Cindy's Facebook profile, where I observed her date of birth to be December 6th, 1971. I conducted a DAVID search, which resulted in a Cindy Wilcox having an address in Vero Beach. A FCIC/NCIC check resulted in a 100 percent match for a felony arrest warrant out of Brevard County (Warrant No. 2026CF037512). As a result, I began to attempt to locate the vehicle to take Cindy into custody.

I located the vehicle at approximately 0142 hours on July 31st, 2026, in the 600 block of 20th Ave. SW driving south. The vehicle then turned east on 9th St. SW., where I pulled alongside of it, and illuminated the driver's side front window with my side alley light. I could see clearly into the driver's compartment, where I observed Cindy driving the car. Due to the belief, she had an active arrest warrant, I conducted a traffic stop in the 1000 block of 9th St. SW.

I approached the driver's side, where I stated to the driver "Cindy", where she responded to this. I asked her to step out of the vehicle, where she was handcuffed (double locked/checked for fit). A search of her person resulted in no findings. She was explained she had a warrant for her arrest. She was escorted into my cruiser. I radioed IRCSO Dispatch, who sent out a hit confirmation to Brevard County for the warrant. Brevard County Sheriff's Office confirmed the hit.

While waiting for the hit confirmation, I contacted Christine via telephone and advised I found her vehicle. I asked her for consent to search the vehicle, where she gave me consent to do so. I advised her to respond to the scene.

A male passenger identified as James Hardee, was asked to step out of the vehicle, which he did so. He was escorted to the front of my agency vehicle. I asked for consent to search his person, which he agreed to. In his front left jean pocket, I discovered a box of cigarettes. Within the box of cigarettes, I observed a folded piece of tin foil, which appeared to have black residue on it. From my training and experience, I knew this to be consistent with narcotic packaging along with a method for consumption. James was detained in handcuffs around this point (double locked/checked for fit).

I opened the tin foil up, where I observed a small amount of white powder (very finite), along with brown/yellow residue. Also within the cigarette box was two cut straws, one clear in color and one black

James was read his Miranda rights, where he agreed to speak with me. He stated the folded piece of tin-foil was believed to be "painkillers" or something to that effect. I asked if this was fentanyl, which he stated possibly. James explained he smokes the narcotics using the cut straws. It should be noted, the folded piece of tin foil, straws, and use of the pain-killer term is all consistent with my training and experience for narcotic related paraphernalia specifically fentanyl. James remained with other deputies while I conducted a field test of the residue within the tin foil.

I conducted a field test of the white powder within the tin foil using a sterile Q-Tip to lift the residue from the tinfoil. This resulted in a presumptive positive field test for fentanyl. This was photographed along with the cut straws and uploaded to evidence.com

James was placed under arrested and transported to IRCSO Jail by Deputy Goodrich. I transported Cindy to IRCSO Jail.
