#### NARRATIVE

On July, 9<sup>th</sup>, 2024, at approximately 0818 hours, I, Deputy A. Brady, responded to 13330 83<sup>rd</sup> Avenue in reference to a disturbance that occurred on 7/8/2024.

Upon arrival, I made contact with the victim, Amanda I. Hogan. Hogan stated she was involved in an physical altercation with her boyfriend, Zachary H. Orne, on 7/8/2024 between the hours of 2200 and 2300. Hogan stated she and Orne had been dating approximately four years and live together at 8260 133<sup>rd</sup> Place, where the altercation took place. Hogan went onto explain that Orne had been drinking heavily before their argument and he began to slap her with an open hand on the back of her head several times. Hogan stated she got tired of being slapped in the back of the head and she began to fight back, striking Orne trying to defend herself. Hogan stated Orne then began to punch her in the body and the head several times with closed fists. Hogan stated she was able to push Orne off of her and she ran out of the residence to a friends house at 13330 83<sup>rd</sup> Avenue, where she spent the night.

I visually observed Hogan's left eyebrow and cheek bone to be very swollen. Hogan had a black and blue eye developing. On Hogan's left eyebrow was also a laceration. Hogan also had some bruises on the back of her left arm. I photographed Hogan's injuries with the Axon capture app and submitted them into evidence.

My partner, Deputy Sheriff C. Moon, was arriving on the scene when she spotted Orne, matching the description given in the call notes for this case. D/S Moon stopped Orne, at which time he stated he was looking for his girlfriend. D/S Moon detained Orne, placed him in handcuffs, and secured him in the rear of her patrol vehicle. I then read Orne his Miranda warnings, to which he stated he understood. Post Miranda warning, Orne stated the altercation was his fault, that he had been drinking too much, and, "took it too far." I explained Orne the allegations against him described to me by Hogan, to which he agreed and confessed to hitting Hogan. Orne was remorseful and embarrassed for his actions and understood his guilt.

I then secured Orne in the rear of my patrol vehicle. I transported Orne to the Indian River County Jail, where he was turned over to correction Deputies without incident.

With Hogan's statement, Orne's admission of guilt post Miranda warning, and the physical evidence of Hogan's injuries, I placed Zachary H. Orne under arrest for F.S.S. 784.03 Battery (Domestic Violence).

My involvement with this case was recorded on my body-worn camera.

#### **NARRATIVE**

On July 08, 2024, your affiant was informed by Detective Bridgette Sanders #5935 that Irving Harris (DOB 06/10/1977) registered sexual offender was in violation of his sexual offender obligations. Det. Sanders Provided me the following information for Harris as she has an active investigation;

Harris Irving meets the criteria for the designation as a sexual offender under F.S. 943.0435 as he was adjudicated guilty on 03/29/1996 for violation of F.S. 800.04 - Lewd and Lascivious Indecent Act Victim under 16 in Indian River County (refer to IRC court case number 31-1995-CF-1080A).

Harris completed his initial registration in Brevard County in September of 2000 (previous last name was Van Dyke which was on the document and listed in FDLE SOPS as alias for Harris). This document was uploaded to the FDLE SOPS and was located under the registration page, this was his initial written notification of his requirement to register.

Based on my review of FDLE SOPS Harris has been registering as a sexual offender in Florida in three counties; Brevard, Saint Lucie, and Indian River County. Harris has been registering as a transient sexual offender in Indian River County since September of 2023 and has been completing regular transient check-ins with this office.

I reviewed Harris' profile on the FDLE Sexual Offender and Predator System (SOPS). I confirmed that Harris' has a transient address in Vero Beach which was reported as "27.632378992453184, -80.46270797604674" (27° 37'56.6"N 80°27'45.8"W). I put the latitude and longitude coordinates in google maps and the result was a wooded area east of 66th Ave. and north of College Ln.

The last registration entry in FDLE SOPS for Harris was on 05/31/2024 in which Harris completed a transient check-in for May 2024, and confirmed the aforementioned address. in Indian River County. Harris has a requirement to check-in every 30 days with the Sheriff's Office in the county in which he resides due to his transient status. Harris failed to complete this within the month of June as required by F.S. 943.0435(4)(b)(2). Harris is in violation of F.S. 943.0435(9) - Sexual Offender – Transient – Fail to Report Every 30 days.

Harris' also has a requirement to re-register four times per year, during his birth month of June (DOB 06/10/1977) and every three months thereafter in September, December, and March. As of July 5, 2024, Harris has failed to register as required for the month of June which is his birth month and is in violation of F.S. 943.0435(14)(B) – Sexual Offender fail to register every 3 months.

Your affiant was notified that Irving Harris came the morning of 07/08/2024 at approximately 0500 hours and tried to complete his registration, however due to it being before the business hours Harris did not register (reference case number 2024-73373). Even with Harris' attempt to register on today's date he is still in violation due to his failure to register within his required month.

#### NARRATIVE

On Tuesday, July 9, 2024, at approximately 1806 hours, during traffic enforcement in the 10400 block of CR512, Vero Beach, Florida, my in-car Axon license plate reader alerted me to a vehicle owner having a suspended license. The vehicle was a silver 2013 Ford F150, bearing Florida tag #MAK6. I ran the tag through F/NCIC and DAVID confirmed that the vehicle owner did in fact have a suspended license. I also pulled up the vehicle owners photograph to identify them.

I advised dispatch that I was going to conduct a traffic stop on the vehicle at the 9000 block of 102<sup>nd</sup> Avenue. I initiated the stop by turning on my overhead emergency lights and siren. The vehicle then made an abrupt stop at 9045 102<sup>nd</sup> Avenue and put the vehicle in reverse. The vehicle rapidly reversed and caused several rut marks in the unpaved roadway. The vehicle reversed into the driveway all the way up to the garage, then went forward towards the road once again. The vehicle then came to a stop and the driver only opened the window slightly. I then approached the vehicle and made contact with the driver, previously identified as Maria Isela Prieto. I advised Ms. Prieto that I was stopping her due to her license being suspended. Ms. Prieto informed me that she has a "permit". Then exclaimed that she's not driving anymore why do I have to show you my. I then informed her that I just witnessed her driving. I then requested her to step out of the vehicle and she did not comply. I then ordered Ms. Prieto to step out of the vehicle and she began reaching into the center console, causing me to raise my voice and asked her for a third time to step out of the vehicle. On the third demand she stepped out and I told her to turn around so I can place her into handcuffs. Ms. Prieto then turned around and began tensing her arms to prevent me from gaining control of her arms. After a brief struggle over her arms, I was able to place Ms. Prieto into custody. I went to place Ms. Prieto in the back of my patrol vehicle and she refused to put her feet inside the vehicle. After asking several times, I had to lift her legs and place them inside so I could close the door.

While in the back of my patrol vehicle Ms. Prieto informed me where the "permit" was and gave consent for me to go retrieve it. I found the permit she was talking about and I noticed that it had expired on July 6, 2024. I inquired with Ms. Prieto if she knew today's date and she did not. I then informed her that the permit had expired three days ago and she spontaneously uttered that the other one was in the mail. This utterance confirmed that Ms. Prieto knew the permit was expired and that her driving privileges are currently suspended.

Upon initial contact with Ms. Prieto, I noticed she had red blood shot glassy droopy eyes. Also, when I went into her vehicle to retrieve the permit, I detected the slight order of burnt marijuana inside of it.

Due to all these indicators, I read Ms. Prieto her Miranda Warnings of Constitutional Rights from a prepared card. Ms. Prieto refused to acknowledge she understood her rights and only said that she "wanted her lawyer".

Since Ms. Prieto invoked her rights, no questions were asked on scene and she was informed that she was placed under arrest.

Ms. Prieto was transported to the Indian River County Jail and while at the jail I requested she submit to Standardized Field Sobriety Exercises to which she refused. Due to this refusal, Ms. Prieto was asked if she would
