NARRATIVE

On Tuesday, July 16<sup>th</sup>, 2024 at approximately 0226 hours, I Deputy Ramiro Doval was patrolling the area 2600 block of 43<sup>rd</sup> Street, Vero Beach Fl, when I observed a black male on a bicycle with no back light/reflector on a non-lit street, which is in violation of F.S.S 316.2065(7).

I conducted a traffic stop on the bicyclist at the 4300 block of 26<sup>th</sup> Avenue. I advised the bicyclist the reason for the stop and asked for identification, he stated he did not have an identification card with him. I ran him via dispatch by his name and date of birth as Timothy A Thomas with a date of birth of 07/29/1971.

Dispatch advised me he had an active warrant out of Leon County, Florida and would extradite. (See IRCSO case # 2024-76363). Timothy was detained at this time.

I asked Timothy if he had any illegal narcotics on his person or on his bicycle, Timothy stated he only had a pipe, which he uses to smoke crack cocaine from, Timothy was then searched and no other drugs were located.

The pipe was located in his right pocket, wrapped around a white napkin. The pipe was metal and has a white residue substance inside of it. The substance was swabbed and field tested, which yielded a positive result for the presence of Cocaine.

Based on the information above, Timothy was placed under arrest for the following offenses;

Count 2.) Violation of F.S.S 893.147(1)(B) Possession of drug paraphernalia, when Timothy was found with a pipe to smoke crack cocaine from.

Timothy was transported to the Indian River County Jail without incident.





NARRATIVE

On July 16<sup>th</sup>, 2024 at approximately 1759 hours, I responded to the parking lot of 1255 U.S. Highway 1 (Publix) in reference to a suspicious person.

Prior to my arrival, public safety dispatch advised me of the following: a witness observed a white female driver entering and exiting her vehicle, having great difficulty parking it in a handicapped parking stall, almost striking a pedestrian. The witness believed the driver was intoxicated.

Deputy Sheriff T. Rollando arrived several minutes before me and observed the driver sitting in the driver's seat with the keys in the ignition. I observed that the vehicle, a red in color Toyota Camry (Florida tag AH37KF) was parked crooked in a handicapped parking stall. Upon arrival, D/S Rollando advised me I was possibly dealing with an impaired driver. The driver was identified as Deborah Lefebvre by her Florida Driver's License. Furthermore, D/S Rollando advised me that Lefebvre stated she had two glasses of wine and her breath smelled of an alcoholic beverage.

I briefly spoke with a concerned Publix employee, Charles Coleman, who observed Lefebvre having great difficulty exiting her vehicle and erratic driving as he stated she accelerated in an unsafe manner ("flooring it") while attempting to park her vehicle.

As I interacted with Lefebvre, I observed several physical signs of impairment: she was unsteady on her feet; she had bloodshot watery eyes; she spoke in a slurred speech pattern; she had very slow movements and was attempting to smoke an unlit cigarette.

I became concerned Lefebvre was impaired beyond her normal faculties by alcoholic beverages or a chemical or controlled substance. Lefebvre had to be helped from the parking lot pavement up several times by myself and D/S Rollando as she was extremely unsteady on her feet and was unable to keep her balance.

To dispel my concerns, I asked Lefebvre if she would participate in a series of standardized field sobriety tasks, to which she agreed. I asked Lefebvre a series of medical questions to ensure she could participate in field sobriety exercises. Lefebvre stated that she was not sick or injured, did not have epilepsy or diabetes and did not suffer from seizures. Lefebvre stated she did not have any orthopedic issues with her ankles, knees, hips or lower back but then stated she was [REDACTED]

I attempted to perform the horizontal gaze nystagmus task but Lefebvre was unable to follow the stimulus and was extremely unsteady on her feet despite leaning up against the trunk of her vehicle. While conducting the exercise, I began to detect an overwhelming odor of an alcoholic beverage emanating from her breath and person. Lefebvre spoke in an even more distinct slurred speech pattern.

Due to Lefebvre's unsteadiness on her feet, I did not conduct the walk and turn or one leg stand due to safety concerns and Lefebvre already falling several times.

Based upon my investigation, probable cause exists that on July 16<sup>th</sup>, 2024, Deborah Lefebvre was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was

impaired beyond her normal faculties, incapable of operating a vehicle safely.

Lefebvre was arrested for DUI at 1819 hours and was advised of the charge.

I conducted a vehicle inventory search and discovered a mostly empty wine bottle in an animal cushion that was on the front passenger seat. A small amount of liquid that smelled like a wine type alcoholic beverage was in the bottom of the bottle. A "tumbler" type cup was also located in the passenger floorboard which had a small amount of liquid that smelled like a wine type alcoholic beverage.

I transported Lefebvre to the Indian River County Jail for booking. Upon arrival at the sally port area of jail booking, Lefebvre attempted to walk around aimlessly and had to be constantly directed where to go by D/S N. Rentas. D/S Rentas advised me that Lefebvre did not meet the volume of breath needed for all three breath samples taken by the breath test instrument. D/S Rentas advised me she explained this to Lefebvre as implied consent was read to her and that this was considered a refusal.

Based upon the above, I charged Lefebvre with the following:

F.S.S. 316.193(1) – DUI (impairment)

NARRATIVE

On Wednesday, July 17<sup>th</sup>, 2024 at approximately 0023 hours, I, Deputy Sheriff Ramiro Doval while patrolling the area of Old Dixie Highway and 45<sup>th</sup> Street, observed a white Ford Explorer fail to stop at a stop sign at the intersection of Old Dixie Highway, and 45<sup>th</sup> Street, which is in violation of F.S.S 316.123.

While maintaining eye sight on the vehicle, I was able to conduct a traffic stop at the 4600 block of US Highway 1, on the white Ford Explorer bearing Florida tag #CH61VL. I made contact with the driver, later identified as Jasmine Sarah Burrell by her North Carolina license. I advised her for the reasoning of the stop, she stated she understood and apologized.

I asked Jasmine if she had any weapons or narcotics in the vehicle, she hesitated and stated no. I asked her if she would consent to a search of the vehicle, Jasmine replied yes. I had Jasmine exit the vehicle and walk back towards my patrol car.

While speaking to Jasmine, I observed a large bulge in her crotch area, almost as if she was concealing something. I asked her what was in her pants. She stated a tampon, Jasmine then immediately stated it was a "meth pipe", which she was holding for her boyfriend. Jasmine was able to retrieve the pipe which was in a small cloth bag from her crotch area.

At this time, she was detained and placed in hand cuffs and asked if she had any other illegal narcotics on her, she stated no. Upon opening the cloth bag, I located two clear baggies, one with a crystal-like substance in it. And the other a white powdery substance inside of it and a clear glass pipe with a crystal-like residue inside of it. The crystal-like substance was field tested, which yielded a positive result for Methamphetamine. The white powdery substance was also field tested, which yielded a positive result for the presence of Cocaine. The clear glass pipe was also swabbed and field tested, which yielded a positive result for the presence of Methamphetamine.

A female deputy arrived on scene and Jasmine was searched, during the search of Jasmynes person, a straw was located in her bra area. The straw had a white residue inside of it, used to ingest cocaine.

Jasmine was read her Miranda Warning from a departmental business card, and asked if she wished to speak to me. Jasmine stated the drugs and paraphernalia was not hers and belonged to her boyfriend and did not wish to speak to me any further and insisted on smoking a cigarette, until she became irate.

At this time, I placed Jasmine Sarah Burrell under arrest for the following offenses;

Count 1.) Violation of F.S.S. 893.13 (6)(A), possession of methamphetamine, when Jasmine was found in possession of methamphetamine, which she was concealing on her person. No Bond.

Count 2.) Violation of F.S.S. 893.13(6)(A), possession of Cocaine, when Jasmine was found in possession of a clear baggy with cocaine inside of it. No Bond.

Count 3.) Violation of F.S.S 893.147(1) Possession of Drug Paraphernalia; when Jasmine was found in possession of a clear glass pipe with a crystal-like substance inside of it, used to smoke methamphetamine. Bond \$500.00.

Jasmine was transported to the Indian River County Jail without incident.

The male had come out with an axe and was walking around the easement on the south side of the property.

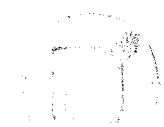
As I am familiar with the property, I responded to the next block south and approached the area on Landsdowne Drive. Upon arriving at the area, I located the Defendant walking on the church property, near the shed, holding a large ax. Upon contact, a high-risk stop was conducted. The Defendant complied with all instructions and was placed into a kneeling final challenge position. The Defendant was taken into custody and placed into handcuffs without incident. Post Miranda, the Defendant advised he did not want to speak with police.

Contact was made with church staff member (Guylan Mc Kenzie). Upon checking the shed, Guylan discovered the shed had the locking clasp broken and the lock that was on the door was missing. Guylan confirmed the ax the Defendant had been holding belonged to the church and had been inside the shed. Guylan advised the damage to the shed was approximately \$15. The ax was valued at \$30. Guylan advised they wanted to pursue charges regarding this incident.

The Defendant was subsequently transported to the Indian River Jail. While enroute, the Defendant made spontaneous utterances that he had taken the ax because he wanted to cut down pineapple trees. The Defendant later spontaneously uttered that the shed had been unlocked. Also, while talking with other officers, while on the phone, and inquiring about the value of the missing lock, the Defendant advised he had placed the lock on the counter inside the shed. A check of the area, officers were able to locate the lock.

The Defendant was transferred to the custody of the Indian River Jail for processing.

Ramirez refuse any medical services and stated that he was jumped by two Hispanic males, who left the scene in a grey Chrysler 300. Ramirez advised that he resides at \_\_\_\_\_ and was planning on walking to the store. Ramirez advised while walking northbound in the 1800 block of 41st Ave. he observed two Hispanic males (unknown description) emerge from the property of 1836 41st Ave. Ramirez advised the Hispanic males began punching/kicking him and commented that it was too late for him to be walking around. Ramirez stated he did not fight back and that he repeatedly told the two males that he did not want any problems. Ramirez stated he ran across the street to the front yard of 1837 41st Ave. and stated he was followed by the two Hispanic males who continued to beat on him. Ramirez stated he then observed the two Hispanic males retreat to the 1836 property and a short time later he observed a grey Chrysler 300 squeal out of the parking lot. Ramirez stated the attack was unprovoked and that he has previously worked with the two Hispanic males. Ramirez told me one of the attackers was named Alex. 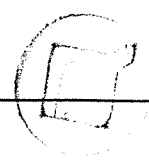



I, Officer Bannister, responded to [redacted] Avenue in reference to a disturbance. The [redacted] came into dispatch as a male threatening the store clerk with a knife. Upon arrival, I made contact with the victim, Mancil Mascarenhas.

As I was exiting my vehicle, Mascarenhas ran outside of his business at this location, he then quickly stated that an unknown white male came into the store and began making threats towards him. Mascarenhas stated that the male appeared to have a knife in his hand while making these threats. I was able to get a suspect description of a white male with a white beard, wearing a grey shirt and shorts.

A male matching this description was located on the sidewalk just north of this location. The male was positively identified as Todd Gais, via an identification card found in his front pocket. Gais was detained at this time without incident, while the investigation continued. Gais was found with a purple/silver metal tobacco pipe in his hand when officers made contact with him.

A written and video recorded victim statement was received from Mascarenhas. Mascarenhas victim statement is, "a white male comes into the store, starts to verbally abuse and threaten me, and racially abuse me. He starts to aggressively point an object from his hand towards me and threaten me. [redacted] On the way out, he slams the door, kicks and damages 2 signs."

Marcarenhas stated that he did feel in danger for his life, due to the aggressive nature of Gais, threats and racial slurs from Gais, and by the way Gais was gesturing towards him with the unknown object in his hand. Marcarenhas, fully believed that the object in Gais hand was a knife, and [redacted]

While investigating the incident, I was flagged down by a City of Vero Beach maintenance worker, Aaron Neuberger. Neuberger stated that while he was at 2140 14th Avenue, Pocahontas Park, he encountered a white male matching Gais description. Neuberger stated that Gais was verbally agitated and was making several statements about going to "stick" the non American clerk at the market, 2265 14th Avenue. Neuberger stated that after making these statements, Gais then turns towards him, while holding some sort of pipe in his hand. Gais then threatens Neuberger, stating "I can stick this in your neck" referring to the pipe he was holding in his hand. Gais then left Pocahontas Park and started to walk in the direction of 2265 14th Avenue. Neuberger's statement was video recorded on my department issued body camera. Neuberger stated that he did not wish to press charges against Gais for the threats.

I reviewed video surveillance footage from the store, and Gais is seen inside of the store aggressively yelling at Mascarenhas. Gais is actively making aggressive motions towards Mascarenhas while holding some sort of metal object in his right hand. Gais makes numerous stabbing motions in the direction of Mascarenhas. Gais is then seen leaving the store. Outside surveillance footage captures Gais leaving the store and kicking 2 caution wet floor signs from in front of the business into the parking lot. Gais then flees the scene of the incident, northbound out of the parking lot.

Mascarenhas stated that both wet floor signs, valued at \$75 each, had damage to them.

Mascarenhas stated that he did wish to press charges against Gais for the assault and the damages to businesses signs.

Gais was then officially taken into custody and transported to the Indian River County Jail.

Gais was charged with 1 count of FSS 784.011, Assault and 1 count of FSS 806.13(1B1), Criminal Mischief- property damage under \$200.

Gais was issued a trespass warning for 2265 14th Avenue.

All video surveillance footage and evidence photos were uploaded to Vero Beach Police Department evidence library.
