#### NARRATIVE

On August 5th, 2025, at approximately 1212 hours, I was conducting a patrol in the vicinity of Indian River Boulevard and Grand Harbor Boulevard while traveling northbound. I observed a 2004 beige Chevrolet Impala, bearing Florida tag Z930NQ, that was stationary at a steady red light. The vehicle subsequently proceeded through the intersection and began exceeding the posted speed limit of 45 miles per hour. Utilizing unit 1616, I paced the vehicle at a speed of 60 miles per hour and initiated a traffic stop at the 2400 block of 53rd Street.

Prior to my contact with the driver, he spontaneously remarked, "Hello, officer, I know my status, but I had to take my 92-year-old mother to the orthopedic." Upon making contact with the driver, later identified as Alan Pannizzo, I explained the reason for the stop and requested his driver's license. Mr. Pannizzo voluntarily disclosed that his license was suspended. When I inquired about the vehicle registration, he indicated that he was unable to register the vehicle due to his suspended license, which also prevented him from obtaining insurance.

I proceeded to verify Mr. Pannizzo's driver's license status through dispatch, which confirmed that his license had been suspended since May 4th, 2021, due to unpaid traffic citations issued by Indian River County (citation #ADISE1E). I subsequently requested Mr. Pannizzo to exit his vehicle for further discussion. I read him his Miranda rights, to which he acknowledged his understanding and consented to continue the conversation. After being read his rights, he admitted to knowingly operating a motor vehicle with a suspended license, driving an unregistered vehicle, and failing to maintain insurance coverage.

During the course of my investigation, I observed that the license plate that bore an up-to-date Florida decal, which appeared legitimate. Upon questioning Mr. Pannizzo about the sticker and why it was on there, he confessed, "Because I faked it," admitting to having affixed a fictitious decal to the plate and creating a laminated photocopy to simulate a genuine decal sticker. Further investigation revealed that the license plate attached to the vehicle had never been assigned to the 2004 beige Chevrolet Impala. Mr. Pannizzo admitted that he had utilized an old plate that was originally assigned to a different vehicle he owned, the plate came back to a 2011 Honda Civic. He stated, "I screwed it on there."

Based on the facts and statements made, Mr. Pannizzo was charged with the following:

F.S.S. 322.34 (2) (A) - Knowingly Driving While License Suspended (1st Conviction)

F.S.S. 320.02 (1) - Operating Motor Vehicle Without Registration

F.S.S. 324.022 (1) - Failing to Maintain Insurance

F.S.S. 320.261 – Attaching Unassigned Tag/Registration Decal

#### NARRATIVE

On Tuesday, August 5th, 2025 at 1926 hours, I responded to the Wawa Gas Station, which is located at 1180 US Highway 1, in reference to a shoplifting incident. 

## NARRATIVE

On August 5th, 2025, at 2142 hours, I responded to 2071 5th Court Southeast, Vero Beach, Florida, in reference to a disturbance.
While en route, I was advised that the suspect, identified as Stephen Phillabaum Jr., had left the area traveling northbound on 27th Avenue in a 2010 Ford F-350 bearing Florida Firefighter tag YI7YH. The Real Time Crime Center (RTCC) assisted by locating the vehicle through FLOCK cameras on Oslo Road and 43rd Avenue, westbound, at 2146 hours.
Upon arrival, I made contact with Charles Schwinger, who stated he had driven with his friend, Erica Bielen, to his ex-wife's (Megan Rion) residence at While parked outside the residence, Stephen drove his truck at a high rate of speed toward their vehicle, stopped, exited, and approached Charles's vehicle. Stephen then reached into the passenger compartment, grabbed Erica by force, and pulled her from the vehicle without her consent.
Charles stated Stephen dragged Erica toward his truck and attempted to place her in the passenger seat. Charles intervened to stop Stephen from taking Erica. Stephen then pushed Charles in the chest and stated, "I know who you are, I know where you live. You better leave her alone, or else." Erica broke free from Stephen's grasp, got back into Charles's vehicle, and they drove away.
I spoke with Erica, who was seated in the passenger seat of Charles's vehicle. She stated she had been dating Stephen for approximately 10 months  She said they broke up about two months ago but had been intimate since.  and last had intimate contact with him about a week prior to today's incident. Erica confirmed Charles's statements of Stephen forcefully removing her from the vehicle against her will.
During my interview with Erica. She appeared in shock and wasn't proving law enforcement with detail information regarding the incident.
Deputy Muraca responded to Megan Rion's residence and spoke with her and her daughter, Chloe Schwinger. Chloe stated her father arrived to drop off a cat while his girlfriend (the victim) remained in the vehicle. While her father was inside, Chloe heard a commotion and saw Stephen pulling the victim from the vehicle with his arm around her neck. The victim was able to break free and get back into Charles's vehicle before they drove away. Megan stated she only observed the end of the incident, where the victim was escaping Stephen and returning to Charles's vehicle. Please refer to deputy Muraca's case supplement for further information.
Deputy Lowell later spoke with Erica regarding her iPhone, which was located near the edge of a canal on
with her and violently took her phone from her possession. Charles said he saw Stephen take Erica's phone and throw her belongings onto the ground in front of the residence. Please refer to deputy Lowell for further information.

#### NARRATIVE

On Tuesday, August 5, 2025 at approximately 2238 hours I responded to 9400 89th Street, Vero Beach in reference to a suspicious incident. Upon my arrival I saw some good Samaritans around an intoxicated male later identified as suspect, Angel Luis Rivera sitting up on the ground.

Rivera had been passed out in the middle of a dirt road that was a wooded area next to a small lake. Rivera had his mountain bike laying on its side next to him with a plastic bottle of a half full Captain Morgan Spiced Rum (750 ml) next to him as well.

Complainants/mom, Jillian Marie Arce and her juvenile/son, Jace James Arce had noticed Rivera passed out on the roadway thinking at first that he might be deceased.

Rivera was heavily intoxicated, slurring his speech and was unsteady on his feet. Rivera was hard to understand due to him appearing to know only a little English.

As I was gathering information from the complainants I could hear Rivera getting loud with the Indian River County Station #15 Fire Personnel. I stopped at one point walking over to Rivera using voice control to quell his disorderly conduct as Rivera was yelling at the fire crew.

Upon later speaking with Rivera he advised me when I asked him that he did not crash his bike. It appeared Rivera had been drinking in the middle of the road and at one point passing out on the dirt road. No visible injuries were seen on Rivera except for an old scar on his right shin allegedly from being shot when he lived in Puerto Rico.

We attempted to get family members to come to the scene and pick up Rivera, Rivera once again began started yelling loudly at Temporary Lieutenant, Zach Scott Stevens. Rivera started pointing at Stevens and raising his voice calling him a "mother fucker".

At this point due to Rivera's behavior, intoxication and a possible danger to himself or others I arrested Rivera for Disorderly Intoxication.

Rivera was handcuffed, searched and transported to the Indian River County Jail charged with F.S.S.-856.011 Disorderly Intoxication.
