NARRATIVE

On October 27th, 2025, at approximately 0538 hours, I responded to 415 6th Road Southwest in reference to a disturbance in progress.

Prior to my arrival, public safety dispatch advised via radio that a female called in stating that "you punched me in my mouth". Corporal C. Moon, N. Quaglia and J. Lang were on scene prior to my arrival. Deputy T. Byrd was also on scene. Corporal Quaglia arrived on scene at the intersection of 6th Avenue Southwest / 6th Road Southwest / Caribbean Circle Southwest and made contact with Ashley Jenkins who was behind the wheel of her parked vehicle, a 2022 Audi bearing Florida tag 96AQLX. Corporal Quaglia observed that Ashley had a contusion to her right lower lip. Ashley explained to Corporal Quaglia that she was in a physical disturbance with her boyfriend Charlay Gelin inside the vehicle. Corporal Quaglia then made contact with Charlay at his residence at 415 6th Road SW and detained him in handcuffs in Deputy Byrd's patrol vehicle.

Ashley explained the following to me:

Charlay and Ashley were arguing over him using a pair of her child's shoes for his child. This occurred at Ashley's residence in [REDACTED]. Charlay was driving Ashley's vehicle to his house while she was in the passenger seat. The argument turned physical when Charlay struck her in the face with an open right backhand. Charlay then pushed her around the passenger side compartment of the vehicle, knocking her around. Ashley attempted to stop him by grabbing his arm and physically resisting him. Charlay left the vehicle, walking to his house and Ashley called law enforcement.

I observed a fresh contusion to Ashley's lower right lip.

Ashley explained the following to me in regards to her relationship with Charlay: Charlay and Ashley have dated for two years and lived together as a family for approximately one year until October 24. Charlay and Ashley have continued their relationship since moving out together a year ago and routinely spend the night together over each one's respective residence. Charlay later confirmed his and Ashley's relationship. I determined this was investigation was domestic violence related.

Next, I spoke with Charlay who was detained with D/S Byrd. I read Charlay his Miranda rights, to which he waived.

Charlay explained the following to me in essence:

Charlay and Ashley were arguing over him using a pair of her child's shoes for his child. This occurred at Ashley's residence in [REDACTED]. Charlay drove Ashley's vehicle to his house while she was in the passenger seat. Ashley continued to argue with him. At some point while he was turning east from U.S. Highway 1 to Oslo Road, Ashley was so angry, she attempted to grab the wheel and crash the vehicle. Charlay stated he "pushed" Ashley in order to stop her from gaining actual physical control of the vehicle and a struggle ensued over the vehicle. He then stopped the vehicle and left on foot, returning to his residence.

I observed several marks to Charlay's right outer forearm. I observed two small crescent shaped marks consistent with finger nail scratches just below Charlay's right elbow. Just below the crescent shaped marks, I observed several small marks

consistent with an abrasion. The marks were not scabbed over and appeared fresh as I observed the skin was freshly torn. Charlay later stated the marks were possibly from Ashley biting him however the marks were inconsistent with being bitten and appeared to be from fingernails as well as being scraped.

I was unable to establish that Ashley attempted to gain control of or gain actually gain physical control of her vehicle as there was no dash cam footage and no independent witnesses. I was unable to corroborate Charlay's statement. Ashley denied attempting to gain control of the vehicle. I did not observe any physical evidence inside the vehicle.

The injuries to both parties were consistent with Ashley's statement. Ashley's injury to her lip was consistent with being slapped and not pushed.

Based upon the statements of both Ashley and Charlay as well as the observed injuries, I find probable cause to charge Charlay Gelin with the following:

F.S.S. 784.03 Battery (domestic violence)

Charlay Gelin was placed under arrest and transported to the Indian River County Jail. Charlay was booked in for the listed charge.

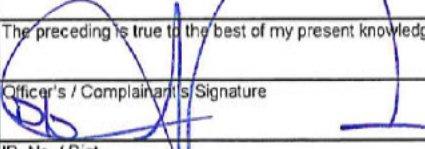
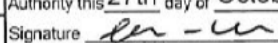

NARRATIVE

On October 27th, 2025, at approximately 1537 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with the juvenile victim Carnell Harris. Harris stated he exited his residence to meet with his little sister who had just gotten off of Go-Line bus. Harris stated when he met with his sister, he observed an adult male following and harassing his sister and friends. The male was later identified as the defendant Terrance Hicks. Harris stated Hicks was screaming and cursing at the group of juveniles. Harris stated Hicks approached him in an aggressive manner and got inches away from his face. Harris said he told Hicks to go away and get back. Harris stated he pushed Hicks away from his person. Harris stated this was when Hicks grabbed the front of his shirt and proceeded to try and hit him. Harris stated Hicks at one point put his arms around his neck almost in a head lock. While speaking with Harris, I observed multiple deep scratches on his neck.

I spoke with witness Dezmond Simmons who was able to records parts of the altercation. In one of the recordings, I observed Hicks approaching Harris in an aggressive manner getting inches away from Harris' face while cursing and yelling. Harris during this was telling Hicks to back up. I observed Harris push Hicks away from his person as he stepped backwards and retreated. Hicks proceeded to follow Harris as he was retreating backwards. Dezmond stated that he observed Hicks strike Harris first. Dezmond's videos did not show the primary altercation.

I spoke with another witness Jamell Jackson. Jackson advised he observed only a part of the altercation. Jackson observed Hicks wrapping his arm around Harris body and swinging him around. Jackson said he did not see anything else.

Deputy Brady spoke with Hicks. Hicks denied striking Harris. Hicks admitted to grabbing Harris and wrapping his arms around Harris body in order to calm him down. Hicks was questioned about Harris' injuries but still denied striking Harris.
