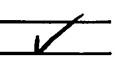

NARRATIVE

On 04/21/2024, at approximately 2331 hours, while sitting stationary along the 1400 block of 10th Avenue, I observed a white Chevrolet work truck bearing Georgia tag (SDS2076), failed to stop for a stop sign at the intersection of 14th Lane and 10th Avenue. After failing to stop at the stop sign, the vehicle accelerated and started straddling the center solid line of the road way.

I conducted a traffic stop on the vehicle in the parking lot of 1615 U.S. Highway 1 (Shell).

Upon making contact with the male driver, I immediately smelled the strong odor of an alcoholic beverage emitting from the vehicle. When the male driver made direct eye contact with me, I observed that both of his eyes were bloodshot and glassy. At the time, the driver was asked for his driver's license and registration. I was then informed by the driver, that the vehicle belonged to the company that he works for. When he spoke, I could smell strong odor of an alcoholic beverage and noticed that his words were very slurred. I was able to identify the driver as Cory Mitcham, from his Georgia license.

Contact was also made with front seat passenger, Nicholas Partain.

Next, I informed Cory that I would be conducting a D.U.I investigation, which he stated that he understood. While speaking to Cory, he informed me that he recently consumed four Michelob Ultra beers while hanging out at Stix Billiard Club, approximately a few hours prior. Throughout my brief conversation with Cory, I continued to notice that his words were slurred and slow. I also noticed that his body was sway from front to back, due to him standing in the front of my patrol vehicle.

During the Horizontal Gaze Nystagmus Exercise, Cory showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. Cory's body was observed swaying from front to back.

During the demonstration and instructional phase of the Walk and Turn Exercise, Cory loss his balance numerous times, while he was attempting to place his feet in the starting position. During the first phase, Cory missed all nine steps, that were not on the line or heel to toe, as instructed. For the second phase, Cory missed all nine steps, that were again not heel toe or straight in a line. Cory had to place both of his arms out to the side of his body, to help maintain his balance while conducting the exercise.

During One-Leg Stand Exercise, Cory immediately placed his left foot of the ground at the two second mark of the time exercise. When Cory attempted to re lift his left leg, he again immediately placed it back onto the ground. Throughout the exercise, Cory was observed to having a difficult time maintaining his balance.

The following exercise I explained and demonstrated was the finger to nose. After explaining and demonstrating the exercise, Cory stated that he understood the instructions.

NARRATIVE

On Sunday, April 21, 2024, I was dispatched to assist the Sebastian Police Department (case number 24-0608) at 10600 Roseland Road.

Upon arrival, I was briefed by the Sebastian officer who had observed a vehicle heading southbound drive off the roadway, causing a cloud of dust to billow into the air. The vehicle came to a complete stop for several minutes. With precision and vigilance, Officer Buffington pursued the silver Mustang traveling northbound, noting its erratic lane changes into oncoming traffic. Deputy R. Henson, demonstrating his thorough understanding of the law, read Mr. Reiss his Miranda rights, which Mr. Reiss acknowledged.

I then contacted Mr. Harry Reiss John III, the driver of the silver Mustang (FL HRHM07). I confirmed Mr. Reiss by his Florida driver's license.

While on scene I was not able to do the first exercise the horizontal gaze nystagmus exercise. Mr. Reiss would not move his eyes, so he kept staring forward. They were glassy red and bloodshot. Due Mr. Reiss medical history I attempted to preform two field exercises from the Seated Battery. I then asked him to do the palm pat exercise, at which point I explained and demonstrated multiple times, but Mr. Reiss was unable to do the exercise. I then asked Mr. Reiss to do the hand coordination once again Mr. Reiss was unable to preform this task even slightly. I explained the task multiple times.

At this point, I then placed Mr. Reiss under arrest for driving under the influence.

I then asked Mr. Reiss if he would consent to giving a breath sample. Mr. Reiss stated that he would not be willing to provide a breath sample. I then read the consent form to Mr. Reiss about the possible consequences for refusing the provided breath, blood, or urine. Mr. Reiss then stated he would give blood, so I said that at the hospital, I would have them draw his blood there. While arriving at the hospital, Mr. Reiss stated he did not wish to provide a blood sample while walking in.

I issued Citation number AJ8SRSE for DUI, refusal to submit, and AJ50KE DUI Misdemeanor 316.193(1).

NARRATIVE

On April 19th, 2024, at approximately 2223 hours, I responded to the area of 9th Street SW and 9th Court, Vero Beach, in reference to a vehicle all over the roadway.

Deputy Lorenz got behind the vehicle at 9th Street SW and 27th Avenue, Vero Beach. Deputy Lorenz observed a white in color Ford pick up truck bearing Florida tag # DXQR97, swerving in the lane crossing the clearly marked fog lines on the roadway. Deputy Lorenz activated his overhead emergency lights to initiate a traffic stop for the driving pattern, at this time the vehicle continued to travel eastbound on 9th Street SW until coming to a final stop on 9th Court SW, just south of 9th Street SW.

The Driver, later identified by his Florida drivers license as Raul Sabanilla Trejo, was ordered to exit the vehicle. Raul exited the vehicle and was having difficulty listening to commands. Raul finally complied and made it back to Deputies patrol vehicles. While speaking with Raul, I detected the odor of alcohol emitting from his person. Raul kept asking why he was being pulled over even after being informed several times of the violation. While Raul spoke the odor of alcohol emitting from his person continued to grow stronger. Raul asked if he could just go home to his family, when asked if he had anything to drink, he advised he did not and was on his way home from work. When asked where he works, he said he installs pavers and fencing. I asked Raul to perform SFST's, to which he agreed.

Raul first performed the horizontal gaze nystagmus, I instructed Raul to keep his head still and follow the tip on my pen with his eyes only. Raul moved his head several times during this exercise, Raul also had onset before 45 degrees and onset at maximum deviation. Raul did not perform this exercise to standard.

Next Raul was instructed and shown a demonstration on how to perform the walk and turn. Raul could not keep the start position like instructed while the instruction portion was being conducted. Raul started several times before being instructed too due so. Once the exercise began Raul stepped off line several times, then went back and started the exercise again. He stepped off line at steps 7, 8, and 9 on the second attempt. Raul used his hands for balance as well as failed to keep heel to toe contact while walking. Raul did not perform this exercise to standard.

The next exercise that Raul performed was the one leg stand. Raul did not maintain the start position as instructed during the instruction portion. Raul then began the exercise, he placed his foot down at the count of eleven thousand and one, then again at the count of thirteen thousand and one. When Raul placed his foot down the second time, he had to be

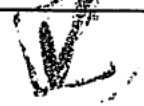

On Friday, April 19th, 2024 at 1923 hours, I responded to [REDACTED] in reference to a domestic disturbance. Prior to arrival, Public Safety Dispatch advised the [REDACTED] had been drinking heavily throughout the evening and began to threaten her.

NARRATIVE

Ms. Weems then began scratching Ms. Green on her arms and face. During the attack, Ms. Green sustained a small laceration to her left forearm and a broken nail on her right hand. Ms. Green also had superficial scratches on her neck and jaw line. After being separated, Ms. Green left the bar and returned home. While she was at her residence, Ms. Weems began banging on her door, attempting to continue the fight. [REDACTED]

He confirmed Ms. Weems was the one who initiated the fight and the attack was unprovoked.

I then spoke with Ms. Weems, who advised the following in substance: She confirmed she was at Dom's Bar and saw both Ms. Green and Mr. Hillsman. She stated "something happened" but would not give further details.

Ms. Weems was then arrested for simple battery and transported to the Indian River County Jail.



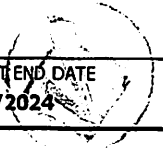

On 04/21/2024, at 01:59 (Specifically include facts constituting cause for arrest.)

On 04/21/2024, at approximately 0159 hours, I, Officer Hernandez (#443), conducted a traffic stop on a red Ford (FL tag #: PZHW72) at the 500 block of 20th Street (westbound).

Prior to the traffic stop, I was traveling south bound on Indian River Boulevard, approaching the intersection of SR60/Merrill Barber Bridge. I was stopped due to having a red light and noticed the above mentioned vehicle traveling westbound on Merrill Barber Bridge and making a very slow left turn onto Indian River Boulevard. The red Ford traveled southbound on Indian River Boulevard on the left lane. During that time, I observed the red Ford fail to maintain its lane of travel and cross the solid white line once (left side).

Upon noticing that, the red traffic light where I had temporarily been stationary at, turned green. I then, proceeded through the intersection and began traveling behind the red Ford (left lane), observing the red Fords driving pattern.

The driver of the red Ford moved into the right lane and swerved back into the left lane. The driver of the red Ford then swerved left, crossing the solid white line of the left lane and again swerved back into its lane of travel. The driver of the red Ford then switched into the right lane, without using the right blinker to indicated the change to a vehicle that was already in the right lane at the time. Upon noticing that, I turned my right turn signal on, creating enough space between the unknown vehicle and the red Ford. I merged onto the right lane and continued traveling behind the red Ford on Indian River Boulevard.

At the 2100 block of Indian River Boulevard, the traffic light turned red and the red Ford and myself came to a halt. Based on my observation and upon the traffic light turning green, I conducted my traffic stop on the red Ford (FL Tag #: PZHW72) at the 2100 block of Indian River Boulevard (southbound).

It should be noted that upon activating my patrol lights, the driver of the red Ford reduced its speed, but continued traveling southbound and drove on the bicycle lane. I then activated my sirens in an attempt to capture the drivers attention. Upon doing so, the driver continued driving at a reduced speed, approaching the 2000 block of Indian River Boulevard. The driver then traveled in the right turning lane and made a right turn, heading westbound on 20th Street.

I then activated my sirens again, where the driver geared right and drove over a curb and eventually came to a complete stop at the 500 block of 20th Street.

Once stopped, I made contact with the driver and sole occupant of the vehicle. I later identified the driver as Oriana Belen Duarte (H/F DOB:) by her Argentina drivers license.

I advised Duarte that the reason for the traffic stop was because I was concerned with her driving pattern and inability to maintain her lane of travel. When attempting to form a conversation with Duarte, I noticed she was having trouble comprehending. I then asked Duarte if she spoke Spanish, to which she stated yes. Duarte stated she understood and spoke some English but was more comfortable speaking in Spanish. I then, continued my traffic stop in Spanish.

It should be noted that I reiterated to Duarte in Spanish, that the reason for the traffic stop was because I was concerned with her driving pattern and inability to maintain her lane of travel. I then asked Duarte where she was coming from and she stated she had just left Grind & Grape (925 Bougainvillea Lane) and was heading home. Duarte stated she only had "two shots."

While speaking to Duarte, I noticed she had red, glossy eyes, and strong odor of alcoholic beverage emanating from within the vehicle and her mouth as she spoke. I noticed slurred speech from Duarte when I asked her for her drivers license and other documents. It should also be noted that Duarte had trouble comprehending when asking her to provide me with proof of either documents, and never produced those documents. Duarte also stated she did not have a drivers license and had never been issued one.

Based on all my observations at that time, I had reasonable suspicion to believe that Duarte was impaired. I then, asked Duarte to turn the vehicle off, step out, and stand near the rear of the red Ford. But Duarte remained in the front driver seat with her seat belt on and began using her cell phone. Duarte had to be told to remove her seat belt and exit the vehicle more than twice. Eventually, Duarte exited the front driver seat.

As Duarte walked towards the rear of the red Ford she had a slight imbalance and slight swaying from side to side. While I was standing in front of her, the strong odor of alcoholic beverage continued emanating from her person and mouth. Duarte again, stated she had just left Grind & Grape and only had consumed two shots.

After observing Duarte's behavior, I asked her if she was willing to perform field sobriety exercises to which she agreed.

Each exercises were demonstrated and explained (in Spanish) to Duarte prior to having her perform them and Duarte stated that she understood them. The results of the field sobriety exercises are as follows:

Duarte was informed accordingly (In Spanish).

At 0236 hours, Duarte was transported to the Indian River County Jail for booking and processing.

At 0255 hours, Duarte was placed in the Indian River County Jail Intox Room under video surveillance. After an approximate 20 minute observation period, Duarte was asked by D/S Rodriguez of the Indian River County Sheriff's Office, who is a certified Breath Test Operator, if she would provide a sample of her breath for the purpose of determining its alcohol content to which Duarte agreed. Duarte provided two breath samples. At approximately 0335 hours, Duarte provided the first sample which read 0.153 g/210L and the second sample was provided at 0338 hours, which read 0.143 g/210L.

Duarte was then turned over to jail staff for booking and processing and to be held on a \$1,500.00 bond.

On 04/21/24 I, Ofcr. S. Gonzalez (471) was stationary on the shoulder of southbound Indian River Boulevard at the foot of the Merrill P. Barber Bridge running stationary laser speed enforcement on traffic traveling west on the Merrill P. Barber bridge.

At approximately 0112 hrs., I observed a single vehicle traveling west on the Merrill P. Barber Bridge in the median lane. I visually estimated the vehicle's speed to be approximately 61 mph in a posted 45 mph zone. I activated my hand-held laser speed measurement device, acquired the Defendant's vehicle through the reticle, obtained a steady audible tone and digital reading of 60 mph.

As the Defendant turned right onto southbound Indian River Boulevard, I fell in behind him and initiated a traffic stop as we approached the intersection of Indian River Boulevard and Royal Palm Pointe. The Defendant continued south before turning onto eastbound Royal Palm Point before coming to a full and complete stop on the roadway approximately 100 yds. east of Indian River Boulevard.

I exited my police vehicle and approached on the passenger side of the vehicle. When I arrived at the door, I tapped on the window and made contact with the occupants and observed that the Defendant was seated in the drivers seat and was in control of the vehicle; the female whom I subsequently identified as TANISHA ISIS GRIFFITH (w/f 11-25-97).

On 04/20/24 while traveling north on U.S.-1 approaching 11th Avenue in the curb lane in the City of Vero Beach, I observed the Defendant's vehicle traveling ahead of me in the median (left) lane. What drew my attention to the Defendant's vehicle was that I observed that it drifted to the right such that both right-side tires rode on the lane separator/divider lines.

As I continued to travel north on U.S.-1, I conducted a registration / drivers license check through DHSMV's Electronic License and Vehicle Information System (E.I.V.I.S.) by entering Defendant's license plate into the system.

A delayed query response indicated that the Defendant did not have a valid drivers license in that he only possessed a valid Florida identification card. In addition, a further review of the query response showed that the Defendant's license was revoked as a special condition of probation.

A subsequent review of the Defendant's probationary status showed that the Defendant was on felony probation stemming from an Aggravated Fleeing/Eluding LEO charge out of Brevard County. See case no.: 21-49795.

Before I could initiate a traffic stop, the Defendant turned off of U.S.-1 at approximately the 3800 block and onto northbound Dixie Highway. I proceeded to 41st Street where I turned onto westbound 41st Street and caught up to the Defendant at the four-way stop sign at 41st Street and Dixie Highway.

The Defendant was stopped and did not proceed through the stop sign until I flashed my high beams and motioned for him to proceed. As the Defendant proceeded past me, I fell in behind him and initiated a traffic stop by activating the emergency lights on my fully marked police vehicle.

Upon coming a full and complete stop, I exited my police vehicle and approached the Defendant's vehicle on the passenger-side door.

Once at the passenger-side door, I made contact with the Defendant and noted that he was the sole occupant and driver of the vehicle and asked him for his driver's license and vehicle registration.

As the Defendant was retrieving his license, I observed a clear "zip-loc" type sandwich baggie on the passenger seat containing a green leafy substance which, based on my training and experience, I recognized to be cannabis.

After obtaining and reviewing the license and vehicle registration the Defendant provided me with, I informed him of the reason for the stop. As the Defendant and I spoke, I requested another unit to

respond; K-9 Ofcr. J. Doty (434) and his trainee Ofcr. W. Brumley (482) responded to the scene.

I then retreated to my vehicle to call in and verify the Defendant's information through dispatch and wait for the additional unit I called for.

Dispatch advised and confirmed my initial observation that the Defendant only possessed a valid identification card and that he was on probation and that as part of his probation, the special conditions revoked his driver's license and prohibited him from possessing illegal drugs or alcohol.

Upon his arrival, I apprised K-9 Ofcr. Doty of the situation. The Defendant was then asked to exit his vehicle at which time he was confronted about his license status and the cannabis I observed in his vehicle.

The Defendant maintained that his license was valid and acknowledged possession of the cannabis claiming he had a medical marijuana card, however, no medical marijuana card was found to be in his possession nor any dispensary containers.

Based on a totality of the foregoing, the Defendant was placed under arrest and informed accordingly.

During a subsequent search of the Defendant's vehicle I found and addition small plastic baggie containing marijuana. The baggie of marijuana I initially observed on the passenger seat was found under the passenger seat as the Defendant attempted to conceal the baggie when I went back to my vehicle after making initial contact with the Defendant.

In addition, I located a bottle of tequila and a small plastic up containing ice and upon smelling its contents, I smelled what based on my training and experience appeared to be ab alcoholic beverage.

The foregoing violations occurred within the City of Vero Beach, Indian River County, Florida.

The Defendant was then transported to the Indian River County Jail where he was turned over to the custody and control of corrections personnel for processing and booking.

The foregoing was recoded with the use of my body-worn video camera which was later uploaded to a secure server.

On 04/20/24 00:07 hours, I was dispatched to 3341 Bridge Plaza Dr (Riverside Cafe). in reference to a disturbance.

Upon arrival I made contact with Bar Security who were confronting a male later identified as Abdulhalim L. Brothers. Donald R. Dardeen (Bar Security) informed me that Abdulhalim had been involved in a physical altercation with another unidentified male which resulted in Abdulhalim being removed from the property. Donald advised that Abdulhalim proceeded to walk back onto the property an additional two more times. Donald stated that upon Abdulhalims third attempt he began to fight bar security when confronted.

Upon speaking with Abdulhalim he appeared visually intoxicated with glassy eyes and slurred speech. Abdulhalim only stated that he had been assaulted by another male in the bar and that he was only attempting to regroup with the people he arrived at the bar with.

Abdulhalim's statement regarding being assaulted was unfounded based on the statements made by Bar Security.

Abdulhalim was transported to the Indian River County Jail without incident.

On 04/19/2024 at approx. 2218 hours, I conducted a traffic stop on a red Ford Fiesta (FL Tag #RCRC45) at the 1400 block of 21st St.

Prior to conducting a traffic stop on the above mentioned vehicle I observed the vehicle to have dark window tint covering on the driver side rear window. I then conducted a traffic stop on the above mentioned vehicle. Ofc Aguilar #437 was on scene with me, and utilized his agency issued Tint Meter. Ofc Aguilar obtained a 2% reading on the driver side back window (In violation of FSS 316.2953).

I then made contact with vehicle driver Clearance Young and vehicle passenger Africa Thomas. I notified Young of my reason for the stop and asked for consent to search his vehicle. Young denied consent to a vehicle search. I then requested IRC SO K9 D/S Le to respond and assist with my traffic stop.

K9 Le conducted an exterior sniff of the vehicle for the odor of narcotics to which he stated there was a positive alert on the vehicle (IRC SO Case #2024-43552).

I then conducted a search of the vehicle which led me to find drug paraphernalia (a spoon with burnt residue and an unused glass pipe) that was located in Thomas tan handbag, which was in the back seat of the vehicle where Thomas was seated. Prior to searching the vehicle Thomas claimed that the tan handbag in the back seat was her property.

I then requested a probable cause search of Thomas to be conducted by Ofc Hernandez #443.

Ofc Hernandez then conducted a search of Thomas person and found a brown crumbled up napkin under her right breast. Inside the brown napkin I found broken glass covered with a brownish in color substance. Ofc Aguilar utilized an agency issued field test kit to test the substance from the glass. The field test kit tested positive for the presence of methamphetamine.

I then placed Thomas under arrest for violation of FSS 893.13(6a), possession of a controlled substance. Thomas was also issued a citation for violation of FSS 893.13(6a), possession of a controlled substance (citation #AJH038E)

Thomas was also charged with violation of FSS 893.147, possession of drug paraphernalia/equipment.

On 04/19/2024, at approximately 2359 hours, I, Officer Hernandez (#443), conducted a traffic stop at the 2200 block of Indian River Boulevard on a blue Ford Explorer (FL tag # Y357GB).

Prior to the traffic stop, I was traveling westbound on Merrill Barber Bridge, behind the above mentioned vehicle. During that time, I noticed the blue Ford fail to maintain its lane of travel and crossed the solid white line three times. Once off the Merrill Barber Bridge, I followed behind the blue Ford. The blue Ford turned left onto Indian River Boulevard and began traveling southbound (right lane).

Upon making the left turn, I noticed the driver of the blue Ford fail to maintain its lane of travel once again, crossing the solid white line twice (right side). The driver of the blue Ford then switched to the left lane, still traveling south bound on Indian River Boulevard. The driver of the blue Ford again, failed to maintain its lane of travel and crossed the solid white line twice again (left side).

Based on my observation, I conducted my traffic stop on the blue Ford (FL Tag #: Y357GB) at the 2200 block of Indian River Boulevard (southbound).

It should be noted that upon activating my patrol lights, the driver of the blue Ford reduced its speed, but continued traveling southbound. I then activated my sirens in an attempt to capture the drivers attention. Upon doing so, the driver slowed down and eventually came to a complete stop.

Once stopped, I made contact with the driver and the front passenger. I later identified the driver as Erica Goggans (W/F DOB: 10/11/1997) by her Florida drivers license.

I told Goggans that the reason for the traffic stop was because she failed to maintain her lane of travel. Goggans then stated her friend and she, had just left Grind & Grape (925 Bougainvillea Lane) and were heading to her friends house. Goggans stated she had a few drinks, then specified she had three beers.

While speaking to Goggans, I noticed a moderate odor of alcoholic beverage emanating from within the vehicle and her mouth as she spoke. I noticed slurred speech from Goggans when I asked her for her drivers license and other documents. It should also be noted that Goggans had red, glossy eyes.

Based on all my observations at that time, I had reasonable suspicion to believe that Goggans was impaired. I then, asked Goggans to step out and stand near the rear of the blue Ford. Goggans exited the front driver seat. While I was standing in front of her, the odor of alcoholic beverage continued emanating from her person and mouth. Goggans walked towards the rear of her vehicle with a slight imbalance and slight swaying from side to side.

After observing Goggans' behavior, I asked her if she was willing to perform field sobriety exercises to which she agreed.

Each exercises were demonstrated and explained to Goggans prior to having her perform them and Goggans stated that she understood them. The results of the field sobriety exercises are as follows:

Horizontal Gaze Nystagmus (HGN)

- Lack of Smooth Pursuit in both eyes
- Distinct and Sustained Nystagmus at Maximum Deviation in both eyes
- Onset of Nystagmus Prior to 45 degrees in both eyes
- Slight swaying from side to side
- Did not follow tip of pen as directed
- Moved head when directed not too

Walk and Turn

- Did not touch heel to toe on steps 3, 4, 5
- Did not touch heel to toe on some returning steps
- Used arms for balance
- Stepped out of line

One Leg Stand (Used right foot for exercise)

- Used arms for balance
- Did not raise foot high enough as instructed
- Placed foot on the ground prior to being instructed to stop
- Did not count as instructed

PROBABLE CAUSE STATEMENT

On 4/19/2024 I was stationary observing traffic facing the intersection of Main Street and Indian River Drive when I observed a beige Honda sedan approach the three way intersection traveling south with a clearly visible stop sign. The vehicle approached the stop sign and failed to make any attempt to stop at the stop sign, rolling through to make the right turn to travel west on Main Street. I followed the vehicle and observed it to drift within its lane multiple times from touching the right fog line to the center yellow line. The vehicle would brake randomly and unnecessarily while traveling down the roadway at an average speed of 30mph in a posted 30 mph zone. It was evident the operator was struggling to perform the multitasking that is required for normal driving. Based on the above facts, I conducted a traffic stop on the vehicle with it yielding at the intersection of Main Street and Easy Street.

I made contact with the operator, identified via Florida Driver License as Craig Camerota. I observed Camerota to have red bloodshot eyes, heavily slurred speech which was difficult to understand, and a strong odor of alcoholic beverage emitting from the vehicle. Camerota promptly gave me his driver license and registration when asked however after holding all of his insurance information, took about a minute to finally provide me with his insurance card. I asked Camerota where he was coming from which he replied with Earl's Hideaway (Drinking Establishment). Camerota was asked what he thought the reason for the stop was which he replied with "Swerving". Camerota made a comment to the passenger that I was going to make her drive the vehicle.

I asked Camerota to exit the vehicle which he complied with. I instructed Camerota to go to the front bumper of my patrol vehicle. Camerota had to be reminded several times where to stand. While speaking with Camerota outside of the vehicle, I could not smell a strong odor of alcoholic beverage emitting from his breath. I asked Camerota if he would perform SFSTs which he replied "no". Camerota stated something to the effect if he did field sobriety exercises he would be going to jail. I explained to Camerota if he refused to perform SFSTs I would have to make an arrest decision based off my observations up to this point which he still refused. I explained to Camerota I wanted to gauge his level of impairment which he stated "I'm definitely over".

Based on the totality of the circumstances, I determined Camerota was operating a motor vehicle while under the influence of alcoholic beverage and was affected to the extent that his normal faculties were impaired. Camerota was placed under arrest for driving under the influence and transported to the IRC Jail. At the Jail, Camerota provided two lawful breath samples to Corrections Deputy Rodriguez, one measured at .093 and one measured at .088.
