NARRATIVE

On September 30, 2025 at approximately 17:37 hours, I responded to 5555 20th Street (Walmart), in reference to a shoplifting call for service.

Upon my arrival, I went into the loss prevention office where the individual was detained and spoke with the loss prevention officer, Jacob Parker. The suspect was later identified as Clarence Tyrone Schenck. Jacob stated that Clarence entered the store with a black backpack and left the store with it full, as well as with a shopping cart full of items passing all points of sale without any attempt to pay.

Jacob provided me the following probable cause incident statement, "I, API Jacob, while conducting routine CCTV surveillance of the salesfloor observed an individual now known to me as Clarence Schenck selecting merchandise (apparel and food items) and concealing it inside of personal backpack. After concealing the merchandise Clarence Schenck passed all points of sale by exiting the grocery exit without ever attempting to make a purchase. Upon passing all points of sale I stopped Clarence Schenck while identifying myself as Wal-Mart Asset Protection. Clarence Schenck was escorted into the AP office where all merchandise was sorted and recovered. The total amount of merchandise equals (19) items \$251.45. Wal-Mart wishes to prosecute and trespass Clarence Schenck. End of Statement."

I read Clarence his Miranda Warnings prior to questioning and he advised he understood them. Clarence agreed to talk and stated he entered Walmart with a black backpack and put items inside of it as well as into his shopping cart. Clarence stated that his intentions were to steal from Walmart and hoped to get away but he got caught. Clarence stated that he enjoys the adrenaline rush from shoplifting. Clarence was placed into custody and set in my marked agency issued patrol vehicle.

The following items are what Clarence passed all points of sale with the intent to shoplift:

(2) packs of chicken Ramen noodles, (2) cans of chili, (1) pack of fried chicken, (1) pack of cut meat, (3) men's-wear apparel outfits, (3) wrist watches, (1) pack of Cheetos chips, (2) espresso coffee boxes, (2) DVD movies, (1) color changing HD Antenna, (1) woven shirt. (All items came out be worth \$251.45)

Clarence was issued a trespass warning for Walmart and advised not to return in the future or it will lead to an arrest, Clarence stated he understood.

Jacob showed me CCTV camera footage from inside of the store. The camera footage clearly showed Clarence with his black backpack and shopping cart full of items exit the store passing all points of sale.

All pictures were uploaded to Axon Evidence. Jacob provided me with the CCTV footage on a disk and it was submitted into Crime Scene for Evidence.

It should be noted that While Clarence was inside of my marked agency issued patrol vehicle with all cameras on, Clarence stated that he has shoplifted from this Walmart in the past and has stolen thousands of dollars' worth of merchandise and never been caught.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **09/30/2025**, at **20:28** (Specifically include facts constituting cause for arrest.)

On September 30th, 2025, at approximately 2028 hours I observed a red dodge pick up truck bearing Florida registration GYUA42. The registration GYUA42 was showing assigned to a 2002 green Ford explorer that did not match the vehicle it was attached. The registration was also showing expired as of September 6th, 2026. I conducted a traffic stop on the vehicle utilizing my overhead emergency lights and came to a final stop in the area of Louisiana Avenue and Temple Avenue.

I made contact with the driver and sole occupant of the vehicle, Johnathan Chandler. Chandler stated he did not have his driver license with him and provided his name and date of birth to identify himself. At this time I noticed the steering column of the vehicle to be in poor condition with multiple visible loose wires and a screwdriver being utilized as a key for the vehicle. At this time, I became suspicious of the vehicle was stolen with its identity being concealed by utilizing another tag to deceive law enforcement. Chandler was then ordered out of the vehicle for further investigation.

Corporal Revis stated he observed a pipe, butane lighter, and other visible paraphernalia inside of the vehicle.

At this time, I detained Chandler by placing him into mechanical hand restraints behind his back and placed him in the rear of my patrol vehicle.

Myself and Corporal Revis conducted a search on the vehicle. During the search, multiple small plastic baggies were located on the driver floor board. Based on my training and experience, small plastic baggies are utilized by drug dealers to distribute smaller denominations of drugs to users. In between the front driver and passenger seat was a mesh bag. I opened the mesh bag and observed a glass methamphetamine pipe utilized to smoke methamphetamine. I know the glass methamphetamine pipe to be utilized by drug users to smoke methamphetamine. The user inserts methamphetamine inside of the bowl section of the pipe, then utilize a heat source to heat up the bowl and inhale the methamphetamine in order to achieve a high. Also inside the mesh bag was a brown wood egg shaped container. I opened the egg shaped container and observed one small plastic baggie with crystal like substance inside and a small clear crystal shard that I identified as suspect methamphetamine. Also inside the egg shaped container was another small plastic baggie with a green powder substance that I identified as suspect fentanyl. I conducted a preliminary field test kit on the suspect methamphetamine which yielded positive results for methamphetamine. I then conducted a preliminary field test kit on the suspect fentanyl which yielded positive results for fentanyl.


While searching the vehicle, Florida registration 94EWSB was located by the passenger seat. I conducted a Florida registration query on the registration which yielded to being assigned to a 2001 red Dodge ram, and matching the VIN of Chandler's vehicle. The registration was also showing as expired on April 7th, 2025.

Sebastian Police department dispatch stated Chandler's license was invalid and suspended since 2024 and a seize tag order on the vehicle. I conducted a query on Chandler's driver history which yielded to Chandler having 3 previous driving while license suspended convictions.

Based on the totality of circumstances I found Chandler to be in violation of F.S.S 320.261 Attach tag not assigned, F.S.S 893.13(6)(a) Possession of controlled substance for the baggie of methamphetamine, F.S.S 893.16(6)(a) Possession of controlled substance for the baggie of fentanyl, F.S.S 847.14 Possession of drug paraphernalia for the methamphetamine pipe, F.S.S 320.34(2) Driving while license suspended 3rd or subsequent conviction.

Chandler was placed under arrest for transported to the Indian River County Jail for processing.

NARRATIVE

On September 30th, 2025 at approximately 2215 hours, Corporal Kramer, ID# 6247, and I responded to 7-11, located at 4150 9th Street SW, Vero Beach, Florida, in reference to a disturbance.

Upon arrival, I made contact with Rachael Dowd who stated she was involved in a disturbance with a male named Thurston Rivers at her residence located at [REDACTED]. Rachael stated they were in a verbal argument over Thurston refusing to leave her residence. During the argument, Rachael stated Thurston told her she was "a crazy ass lunatic and needed to die," then used his hand to grab her throat and began applying pressure. During this time, Rachael's breathing was impeded and she was unable to breathe or yell for help. Rachael stated Thurston continued to restrict her breathing and screamed, "I'm going to kill you!" Rachael stated she then collapsed to the ground, urinated on herself, and lost consciousness. When she regained consciousness, Thurston was standing over her and then fled the scene on foot.

I observed red marks on Rachael's throat consistent with her statement, as well as bruising on her right leg and scratches on her upper back. Rachael also stated she had a sore throat and was continuously coughing while speaking with deputies. Photographs were taken of Rachael's injuries and uploaded through Evidence.com

Deputies subsequently located and detained Thurston at the Walgreens, located 5755 20th Street. I advised Thurston of his Miranda Rights, and asked if he was willing to speak to me. Thurston agreed and confirmed he was involved in an argument with Rachael, during which Rachael struck him "over and over again." At the time of the interview, I did not observe any physical injury to Thurston's person. Thurston admitted to grabbing Rachael, but stated it was only to stop her from striking him further.

Due to the physical marks left on Rachael, Thurston was placed under arrest for the offense of battery by strangulation. Thurston was placed into handcuffs that were checked for proper fit and double-locked prior to my arrival. Thurston was transported to the Indian River County Jail, without incident.
