NARRATIVE

On Thursday, August 6th, 2026, I, Deputy C. Greeley #6038, responded to 2006 58th Avenue, in reference to a shoplifting. Upon arrival, I spoke with the complainant, Richard Green, who is the general manager for 'Harbor Freight'. He explained on July 31st, 2026, another employee, Adam Johnson, retrieved a 'Predator' power station valued for \$999.00. Adam entered the store, grabbed a shopping cart, and walked to the manager's office. Adam then placed the power station into the shopping cart and walked through the exit. At no point did Adam stop at any of the points of sale to completed a purchase for the item.

Richard provided a video of the incident, in which the video is labeled for July 31st, 2026, at 06:38 PM.

The video footage mentioned shows Adam enter the store with his dog on leash. Adam grabs a shopping cart that is adjacent to the store's entrance and walks inside. Adam then walks directly to the manager's office; however, at the specific corner the cameras do not capture. The next frame shows Adam with the power station in his shopping cart walk directly towards the exit and pass all points of sale. The power station is the only item within the cart at that time.

Richard identified the male seen in the video as, Adam Johnson, the store's assistant manager. As Richard has managed several stores for multiple years, he knew of Adam and has directly worked and spoke with him.

I then spoke with a witness, Michael Blasi, who is the store's manager. He recalled that specific day, Adam walked out of 'Harbor Freight' with the 'Predator' power station. This transaction struck him as rather unusual; therefore, he further researched the item Adam was seen with. Michael discovered only one was physically in the store, but the inventory reflected two should have been. Due to this discovery, Michael contacted the general manager to conduct an investigation.

I then spoke with Adam, who was seated within the manager's office. Post Miranda, Adam admitted to walking out of 'Harbor Freight' without purchasing the 'Predator' power station. He described having the same or similar item; however, the item was older and had a recall. Adam would then bring in his older item and returned that item earlier in the day, in which the funds for that transaction were placed back onto a bank card. During that returned transaction, the power station was not present or nearby the register.

Later, Adam admitted to entering 'Harbor Freight' and removing the power station from the manager's office. He placed it into the shopping cart, and exited the store. Adam explained, he initially planned to exchange the older item for the newer power station. But and explanation was not provided as to why the item was not exchanged during his initial transaction.

Adam then admitted to passing all points of sale and leaving.

Adam also provided a written statement to 'Harbor Freight' expressing remorse and guilt, and due to his alcoholism, he has chosen bad decisions.

Based on my investigation, I find probable cause Adam Johnson, violated F.S.S. 812.014, by knowingly obtained 'Harbor Freight's' item which was valued \$999.00 and intentionally deprived them of its benefits.

Adam was transported to the Indian river county sheriff's officer jail without further incident.

On August 06, 2026, at 17:49 hours, I Deputy D. Coon #6379 responded to JC Penny (Indian River Mall) at 6200 20th St - Suite 700 in Indian River County in reference to a Trespassing Call. The complainant, Karen Lynne Kayko, is the store manager at JC Penny. Karen informed dispatch that a black male subject was currently inside their store and had shoplifted earlier today and in the past.

Upon arrival, I met with Karen inside the store. She stated that the male was being disruptive with store staff, and she suspected that he had been shoplifting today. Although Karen did not have direct evidence of a retail theft, she requested that deputies issue a formal trespass warning to the subject.

Seconds later, I made contact with the subject who was walking through the store. I identified him as Oringen Savory Colebrook Flowers through FLHSMV records and my previous encounters with him. Oringen is a local homeless vagrant. He has an extensive history with the Indian River County Sheriff's Office. I greeted Oringen and asked him if he had taken anything. He replied no and immediately gave me consent to search his pockets. Before I could even don gloves, Oringen began emptying his pockets. He removed rolling papers and a small, plastic transparent pouch from his left pant pocket. Inside the pouch appeared to be a hand-rolled cigarette. I asked Oringen what it was, and he replied "weed".

I escorted Oringen out of the store and detained him at my patrol vehicle. While conducting a presumptive test on the hand-rolled "weed" cigarette, dispatch informed me that Oringen had previously been trespassed from the Indian River Mall on 09/11/2019 (case# 2019-00165539) due to being involved in a disturbance. The hand-rolled "weed" cigarette contained a green leafy substance, which I suspected was cannabis based on my training-knowledge and experience. The substance field-tested positive for Marijuana (0.03 grams NET). I placed Oringen under arrest for the following charges:

- Trespass After Warning, F.S.S. 810.09 (1)(a)(1)
- Possession of Cannabis (under 20 grams), F.S.S. 893.13 (6)(b)
- Possession of Drug Paraphernalia, F.S.S. 893.147 (1)(a)
