#### NARRATIVE

On November 19, 2025, at approximately 1430 hours, I had the victim, Kerrisa Vellequette come in for an interview reference a violation of pre-trial release. This case is linked to a Domestic Violence battery by strangulation case under case #25-120461/court # 2025 CF 001289 A.

Craig Taylor was arrested for this charge on November 10, 2025 and attended first appearance on November 11, 2025 where he was provided the following stipulations:

- "The Defendant will refrain from any contact of any type, direct or indirect with the victim. Not be within 500 Feet of the victim's or other named person's residence, even if the defendant and the victim share the residence. Not be within 500 feet of the victim's or other named person's vehicle, place of employment, or a specified place frequented regularly by such person. This section includes any other conditions per F.S. 903.047 Kerrisa Vellequette".
- "The Defendant may contact the arresting agency and make arrangements to return to the property one time, only with law enforcement, to retrieve personal belongings."

These were fully explained to the defendant and signed by the judge.

Kerrisa came in and provided a statement with the following information:

Kerrisa stated Craig has actively been

Kerrisa stated the night of the battery by strangulaton

due to being scared,

one of her friends told her Craig was at the residence.

Kerrisa said she thought he was not allowed to be there and was confused as to why he returned. Kerrisa has been trying to contact me since November 14, 2025, in reference to this, due to other cases I was unable to meet with her until November 19, 2025. Kerrisa stated she believes Craig knew he was not supposed to be there because he only shows up to the residence after 2000 hours. The office staff at the apartments are aware he is not supposed to be there as well. Kerrisa also works at the same place as Craig and knows his work schedule stating he works from 0400 hours until 1600 hours.

Due to them working at the same place of employment, Piper Aircraft and within the pre-trial release it stating, Craig is not to be within 500 feet of the named persons (Kerrisa) place of employment this is also a violation. Kerrisa has also stated due to being in fear for her safety she has not gone back to work ever since he was released

I called over to Piper (772-567-4361) and spoke to Kevin Casper who works in management. Mr. Casper stated Craig has been attending work every scheduled day, 11/12, 11/13, 11/14, 11/17, 11/18, and 11/19. Craig was provided the first appearance pretrial release stipulations on 11/11/2025, and went back to work at the same place Kerrisa works the following day, without letting management know or working this out with the anyone when provided the stipulations for pre-trial.

It should be noted, Kerrisa reported feeling fearful to attend work due to Craig's presence there. She also stated she was

#### NARRATIVE

On Thursday, November 20, 2025, I was working at 5555 20th Street (Walmart). While observing the self-checkout we noticed a male skipping item's that were in his cart, and hiding them.

Luis Cofles-Duque later identified While sitting in LP office, the store manager OBY helped translate due to a langue barrier. OBY read him his Miranda rights, and stated that he understood his rights and wished to speak with me. He stated that "he wanted to be honest and he fucked up".

API Nathan stated the following:

"11/20/25I, API Nathan Toliver, observed the subject now known to me as luis cofles-duque at the self-checkout register with a large cart of merchandise. During his transaction he began ringing up and bagging cheaper merchandise and placing it on top of more expensive items that he never removed from the cart or made any attempt to scan.

Additionally, he skip-scanned several candy items by scanning one and moving several into the bagging area.

Once the transaction was finished, he exited the store through the grocery doors where I approached him and identified myself as Walmart loss prevention. I requested he return inside to the loss prevention office to recover the stolen merchandise and he did without incident. The value of the stolen merchandise \$162.88.

Walmart wishes to trespass and prosecute the subject for this offense. End Statement."

There were 20 miscellaneous items not scanned, and totaling \$162.88.

While running Mr. Cofles-Duque with dispatch I was informed that he has an outstanding warrant with St. Lucie County.

Mr. Cofles-Duque was then placed into custody and transported to the Indian River County Jail without further incident.

#### NARRATIVE

On November 20, 2025, at 1659 hours, Detective Daugherty was traveling westbound on State Road 60 (20th Street) in an agency issued unmarked vehicle. The vehicle traveling directly in front of Detective Daugherty was a black Honda Civic bearing Florida license plate 63DVMQ.

A query of the license plate was run through FCIC/NCIC, which showed a registered owner of Enrique Jardon Dorantes, born July 15, 1987. There was no Florida drivers's license for Dorantes. Detective Daugherty also ran the license plate through the Florida DHSMV website, which showed the same registered owner. There was no picture, driver's license or social security number listed for Dorantes.

A traffic stop was conducted on the vehicle. Upon making contact, Dorantes was identified as the driver of the vehicle via two Mexican identifications. A passenger was in the vehicle, who provided a Guatemalan identification. He was identified as Mariano Pop Sis, born February 9, 2001. Neither occupant could provide any form of legal documentation from the United States.

Due to a language barrier, Sergeant Avila and Corporal Ballester arrived on scene to assist with translation. During their conversation, neither Dorantes nor Pop Sis could provide any legal documentation to Corporal Ballester.

Based on Dorantes never having been issued an identification or driver's license, he was placed under arrest.

Pop Sis was also detained by Corporal Ballester, who transported both parties to the jail.

Dorantes was issued a citation for driving without a valid driver's license under citation number AIHAYZE.

#### NARRATIVE

On November 20th, 2025, at approximately 1716 hours, IRCSO dispatch received two calls regarding a

Critton. I am familiar with both of these parties. They are in a substantial dating relationship which is sexually intimate, and Cecilia is currently pregnant with Travis's child. I know this due to a prior call for service on November 7 <sup>th</sup> , 2025, where Cecilia and Travis informed me of the pregnancy together. I also know them to reside together at
Other units arrived on scene prior to me. I arrived at around 1746 hours. I spoke with Travis. He explained he called the Sheriff's Office due to a verbal disturbance. He explained an argument started over his clothes which were inside the residence, and his wish to leave the house with the clothes. He stated he called law enforcement first to protect himself against false claims. He explained he observed Cecilia outside the residence scratching her neck area with something, which he believed to be a fork. He could not provide a quality description of this, nor a location of this item to investigating deputies.
I spoke with Cecilia. She explained an argument started volume being on low. She explained the argument continued because Travis wanted to leave with his clothes. She explained he bought Travis these items, thus she stated to him this was a civil issue and he was not allowed to take the clothes. It should be noted, Travis clothes has been an on-going issue which Cecilia consistently asks deputies about during interactions.
She explained Travis pushed her down to the bed within the master bedroom. She explained she fell in the middle of the bed, horizontally across the mattress. She stated he got on top of her, where he took both hands and proceeded to press on her neck. She stated she was choked by him. She stated this lasted for approximately 5-10 seconds, where Travis would readjust his hands. I observed scratches and redness around her neck consistent with her description of the incident. The redness appeared to be small fresh scratches in the area of the base of her neck and clavicle. These were photographed by D/S Greeley and uploaded to Axon. She explained while she was being "choked" she needed to gasp

Cecilia explained she is approximately 5-6 months pregnant. She stated Travis is aware of this, which I

Travis was ultimately placed into handcuffed (double locked/checked for fit) and transported to IRCSO Jail. During the transport, Travis explained he called law enforcement first for his protection. He also stated Cecilia was going to drop the charges. Travis provided deputies with a written statement, which stated he the aforementioned information, regarding wanting to leave the residence after a verbal

for air. Therefore, Cecilia advised her normal airway was impeded during the incident.

#### NARRATIVE

On November 20, 2025, at approximately 2201 hours, while in the area of 2600 45th Street, I observed a white 2007 Chrysler van bearing a Florida license plate of Y945RL driving west bound on 45th Street. While behind the vehicle, I observed two out of the three brake lights were not functioning.

Based on the traffic violation above, I conducted a traffic stop on the vehicle. Contact was made with the driver, later identified as John Roberts. John was informed of the stop and he understood. Det. L. Bennett was also on scene and stood by the passenger door.

During the stop, Det. L. Bennett informed me it appeared John had something in his right hand. I looked at John's right hand, which was balled in a tight fist, and I observed what looked like a plastic bag in his hand. I asked John what was in his hand and he never answered the question. John kept moving his hand that he would not open so I told him to get out of the vehicle. John stayed in the vehicle so I grabbed his arm and he complied and exited the vehicle.

As John exited the vehicle, I tried to grab his right arm and he was actively resisting me from grabbing his arm. John was told to put his hands behind his back, but he refused. At this time, I had a grip of one of John's arms and Det. L. Bennett had a grip of his other arm. Both Det. L. Bennett and I tried to put John's arms behind his back, but he kept tensing and trying to pull away. John was told to stop resisting and he kept saying he was not. It should be noted that John also used his arms to push off of the vehicle that he was operating, actively resisting, while Det. L. Bennett and I were actively attempting to detain him. I eventually conducted a single leg take down on John and he was escorted to the ground. John continued resisting on the ground and Det L. Bennett and I were able to finally get control of John's arms and he was arrested. During this time, I was driving an agency-issued marked patrol vehicle with my red and blue emergency lights activated. I was also wearing an agency-issued vest with a 5-pointed gold star that says "Indian River County Sheriff's Office." Underneath the star it says "Deputy" and "SHERIFF" written on the back of my vest.

Once John was arrested, I was able to take the items out of his hand that he would not let go. Inside his hand were three separate baggies. In two bags, there were white rock-like substances consistent with crack-cocaine and inside the third bag there was a green-leaf like substance that was consistent with marijuana. Field tests of the rock-like substances were conducted, which yielded positive results for the presence of cocaine. One bag contained 2.3 grams gross weight of crack-cocaine, the other contained 1.8 grams gross weight of crack-cocaine, and the third contained 3.3 grams gross weight of marijuana.

Contact was made with John and he was verbally advised his Miranda Rights, which he understood and waived them. Post Miranda, John advised the following verbally:

John said the items inside the bags in his hand were crack-cocaine and marijuana. John advised he smokes marijuana and laces it with the crack-cocaine. John said he was resisting because he was nervous and thought he

#### NARRATIVE

On Thursday, November 20<sup>th</sup>, 2025, at approximately 2230 hours, Sergeant Avila and I were patrolling the 1200 block of US Highway 1, Vero Beach, Florida, when I observed a white Mazda bearing Florida tag 33EIVP traveling southbound with no headlights or break lights activated.

I attempted to conduct a traffic stop by activating my red and blue emergency lights as we turned east on 12th Street and US Highway 1. The vehicle failed to stop immediately and continued eastbound, passing multiple safe and well-lit areas to stop, including the Wawa entrance at 12th Street and 7th Court and a roadway entrance on 7th Avenue and 12th Street.

The vehicle eventually came to a stop at the red light at 6th Avenue and 12th Street. The driver initially appeared as if he was going to turn northbound on 6th Avenue but changed direction and turned southbound, ultimately coming to a complete stop just south of the intersection.

I conducted a driver-side approach and made contact with the driver and registered owner, Jadan Carlos Lugo. As I stood at the driver-side window, I immediately detected a strong, fresh odor of unburnt marijuana emitting from the interior of the vehicle. The odor was concentrated at the driver's window, consistent with recently handled or freshly cannabis. The odor was distinct and readily identifiable to me based on my training and experience in narcotics investigations, including prior encounters with both fresh and burnt cannabis odor during traffic stops.

While speaking with Lugo, I observed on the driver's floorboard a large crystal smoking device commonly used to smoke marijuana. I also observed loose green leafy residue consistent with marijuana scattered on the center console and passenger-side compartment. I asked Lugo if he possessed a medical marijuana card. He stated he did not.

I instructed Lugo to exit the vehicle. Lugo refused and instead began shifting his hands toward the center console, manipulating his cell phone, and repeatedly looking down toward the console area. I gave multiple clear and loud verbal commands to leave his phone in the center console and exit the vehicle. Lugo continued to ignore the commands and directed his attention down toward the console.

Based on my training and experience, Lugo's actions were indicative of someone searching for or attempting to access a weapon, especially given his refusal to comply and repeated movements toward an area not in plain view. Due to these officer-safety concerns and Lugo's continued resisting behavior, I took hold of his arm, removed him from the vehicle, and secured him against the driver-side door where he was placed in handcuffs.

Once detained, Lugo was escorted to the front of my patrol vehicle where I conducted a probable-cause search of the vehicle based on the odor of fresh marijuana, visible marijuana residue, and observed drug paraphernalia. Inside the center console, I located a small clear plastic bag containing fresh marijuana, which I estimated to weigh less than 20 grams based on my training and experience. On the passenger-side floorboard, I located a metal rolling tray containing marijuana residue and a crystal pipe containing water and both green and black burnt residue, consistent with very recent marijuana use.

#### NARRATIVE

On 11/20/25 at approximately 2345 hours, Deps. Castano, Orehostky, Ferrer, and I responded to the Ocean Breeze Inn (3384 Ocean Dr) in reference to a warrant search. Christopher Stokes had an active warrant for his arrest for violation of pre-trial release related to an active flee and elude case. He was on GPS monitoring through pre-trial services and was pinging at the location.

I confirmed that Stokes was staying in room 235 and we made multiple annoucements at the front door of the hotel room without response. Dep. Orehostky used a keycard to open the door at which point Stokes and a female, later identified as Brittney Forbes Cartwright, were standing behind the door. Stokes removed the security latch from the hotel room door and opened the door. Stokes exited and Dep. Castano and Orehostky were in the process of securing him in handcuffs and affect a lawful arrest. The female was still standing in the doorway within arms reach of Dep. Orehostky at which time I told her three times to either go back into the room or close the door. She responded "no, I'm going to watch." Dep. Orehostky had to turn his back to the female to affect the arrest and control Stokes, whos left hand was concealed behind the hotel room door. I stepped into the threshold and told her to get back and attempted to close the door and she braced the door to keep it open. I pushed her back away from the door and closed it.

Deputies secured Stokes, conducted a search of his person, and he was walked downstairs to the parking lot to wait for a transport unit.

Forbes Cartwright then walked down to the parking lot from the hotel room and I placed her under arrest for resisting arrest without violence.

Both subjects were transported to the county jail by Dep. Brasheers.
