NARRATIVE

On Tuesday, March 24th, 2026, at approximately 0647 hours, I was dispatched to a traffic crash where one vehicle left the scene. The caller advised the suspect vehicle was a blue Honda Civic bearing VA tag SZP2315 driven by a Hispanic male.

Upon arrival, I contacted the victim identified via Florida Drivers license as Crystal Giblo. Giblo advised she was stopped at the intersection of 4th Street and 20th Avenue for the solid red traffic light. While stopped, the suspect vehicle crashed into the center rear of her white Chevrolet Tahoe bearing FL tag FDZB43. Crystal advised both vehicles pulled over on the east side of 20th Avenue near 4th Place. Crystal and the Hispanic male suspect both exited their vehicles, and crystal attempted to obtain insurance information. When she asked, the Hispanic male got back into the Honda and left the scene east bound on 4th Place. Crystal was able to take a clear photo of the suspect vehicle tag, which is the same information she provided public safety dispatch before the vehicle fled the scene.

I observed the center rear of Giblo's Tahoe to have scratches and blue paint transfer.

At approximately 0703 hours, Deputy A. Brady located the suspect vehicle in the 2100 block of 15th Place. Deputy A. Brady was able to make contact with the driver, a Hispanic male who identified himself as Josue Diaz Alfaro. When asked for proper documentation, Josue advised he did not have a drivers license. He also advised Deputy Brady he was involved in a crash but did not provide an explanation on why he left.

Due to the suspect vehicle being located, I relocated to the 2100 block of 15th Place. I made contact with Deputy Brady and the defendant who again advised me he did not have a drivers license. It was also learned on scene from the defendant that the suspect vehicle was not insured.

Due to the defendant not providing valid identification, I requested Deputy Mckay for an immigration investigation.

Based on the above Josue was taken into custody and transported to the Indian River County Jail and charged in violation of the following statutes;

- 1 CT- F.S.S. 322.02(1) NO DRIVERS LICENSE (CITATION #AKFRF8E)
- 1 CT – F.S.S. 316.061(1) FAILURE TO GIVE INFORMATION AT CRASH (CITATION #AKFRF9E)
- 1 CT – F.S.S. 324.221(2) FAILURE OF OWNER/OPERATOR TO MAINTAIN REQUIRED INSURANCE (CITATION #AKFRFAE)

NARRATIVE

On Tuesday, 03/24/2026, at approximately 1730 hours, Corporal Kramer (ID #6247) and I responded to Home Depot, 13361 U.S Highway One, Sebastian, Florida 32958, in reference to a theft investigation.

Upon arrival I made contact with the complainant Robert Vincent Kirkham (Loss Prevention Manager), who stated the suspect, Megan Ann Cagot (Identified by Florida driver's license), was being investigated by their loss prevention team for taking \$1,210 while working the cash register. Kirkham provided me with paperwork showing multiple transaction dates, amounts totaling up to \$1,210, pictures of the security cameras, and a signed statement from Cagot, building probable cause for F.S.S 812.014.2(c)(1) Grand Theft valued at \$750 or more, but less than \$5,000.

The following incidents were documented by camera footage and cash register shortage reports:

- 03/11/2026 \$100.00 taken from Register 13
- 03/14/2026 \$280.00 taken from Register 13

Based on the probable cause from the investigation, I detained Cagot and informed her of her Miranda rights, Cagot voluntarily waived her Miranda rights and agreed to speak with me. Cagot stated she was hired by Home Depot one month ago to work the cash registers at the store. Cagot stated she started taking cash from Home Depot 2 weeks ago because she needed money for her son to have dental work done. Cagot advised me that she did not know the exact amount she took from the registers, however stated she spent \$750 on her son's braces and scheduled additional dental appointments for her son. I showed Cagot the pictures of Camera Footage showing a female take money from the registers and placing it into their apron, Cagot confirmed that it was her in every picture that I showed her. I asked Cagot if she wrote the statement Home Depot provided me and signed it, Cagot stated that she wrote the statement and signed it voluntarily for Home Depot.

Based on the totality of the circumstances and statements made by Cagot, Cagot used a trusted position to knowingly and unlawfully obtain \$1,210 in cash with the intent to temporarily or permanently deprive Home Depot their right to the cash and benefit from it by appropriating the cash for her own personal use.

On Tuesday, March 24, 2026 at approximately 1907 hours, I was in the area of 122 Avenue and State Road 60, Vero Beach, Florida when I received a call from Deputy S. Haffield.

NARRATIVE

On Tuesday March 24, 2026 at approximately 2001 hours, D/S Mims and I were dispatched to [REDACTED] in response to a burglary in progress.

Upon arriving on scene, I made contact with the victim Trista A. D'Auria who gave the following summarized statement:

Ms. D'Auria heard a noise outside her residence, which caused her to look out of the living room window. She observed a male wearing what she described was a dark hooded jacket, with big puffy hair, opening the doors on her vehicle a Black Jeep Wagoneer, which was parked in her driveway. Ms. D'Auria said she knew the door on the vehicle was open as it projects light onto the ground when the door is opened. Ms. D'Auria ran from her living room, to her bedroom, to put on clothes [REDACTED] Ms. D'Auria heard the inner garage door, which leads into the home from the garage, being opened. It should be noted that the garage is attached to the home. She yelled for the person to get out of her house and she heard the door close. Ms. D'Auria proceeded [REDACTED]

Deputies responded to the area and located a suspect, matching the description the victim provided and detained the male suspect, who was identified by his Florida ID as Wilmer Villalobos. Ms. D'Auria was standing in her driveway while the suspect was at the end of the driveway. She made a positive identification of Mr. Villalobos as the person she observed out her window entering her vehicle.

While conducting my investigation, Ms, D'Auria was able to provide doorbell camera footage of Mr. Villalobos, who was on camera, on the front porch, at the time of the incident.

Mr. Villalobos was read his Miranda Rights and stated he understood them and would answer questions.

When asked why he was in the neighborhood, he stated that he was looking for access to Old Dixie Hwy. He advised he had walked from Seminole enroute to West Palm and could not provide a legitimate reason for being in the neighborhood. Mr. Villalobos denied entering the victim's car, denied opening the door to the house and being on the front porch, even after being confronted about him being on camera.

Based on all the evidence gathered during this investigation, I believe, Wilmer Villalobos, did knowingly and intentionally enter an occupied dwelling, which is the property owned by Trista A.

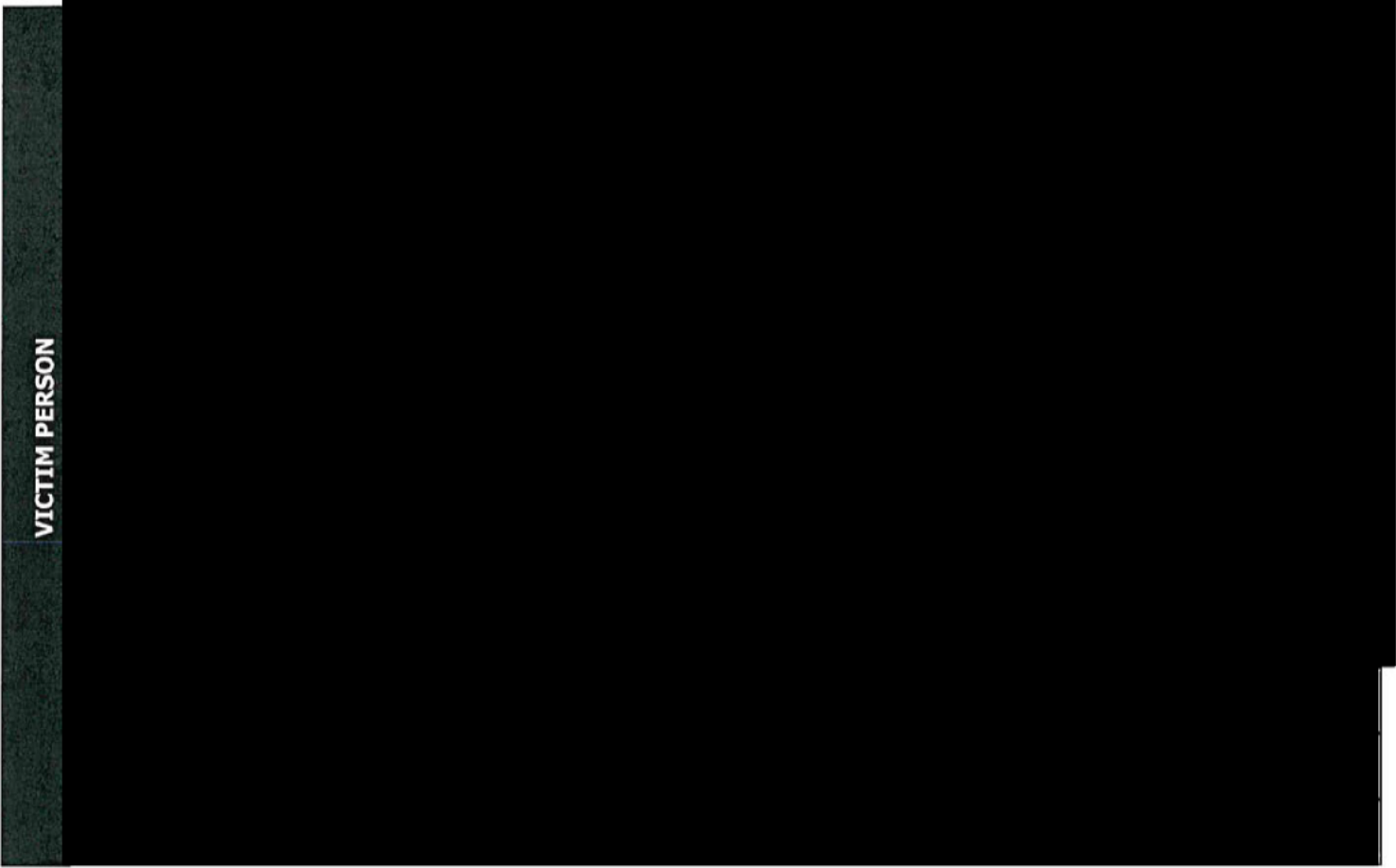

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 03/24/2026, at 23:47 (Specifically include facts constituting cause for arrest.)

On March 24, 2026, at approximately 2038 hours, I responded to [redacted] in reference to a Fight/Disturbance incident.

Upon my arrival, I made contact with the [redacted] victim, Draven M. Casher, who stated that when he came back to the residence from a walk, the arrestee, Mia J. Munoz, destroyed his door before entering his room without his consent. Draven stated that Mia grabbed his phone, grabbed his hair, grabbed him by the collar of his shirt, and threw punches to his body with a closed fist. Draven stated that the physical attacks ceased for a brief moment when her boyfriend, Landon J. Weikel, pulled Mia away from him. Draven stated that he and Mia got into a verbal argument after the attacks occurred. Draven stated that Mia broke his brand-new door, brand-new casing, and broke his nightstand. Draven stated that the estimated total of Damages was \$465 dollars. Draven stated that Mia caused bruises on his chest, scratches on his back, and pain to the back of his head. Draven stated he did not need to be evaluated by EMS.

I made contact with the [redacted] Complainant [redacted] who stated that [redacted] arrestee, Mia J. Munoz, came into Draven's room and yelled, "lets Fucking go." [redacted] stated that Mia was upset because [redacted] had put her dogs in the home, and when Mia broke into the room, they told her to leave. [redacted] stated that Mia started physically attacking Draven by punching [redacted] with a closed fist and grabbing [redacted] hair. [redacted] stated that Mia's boyfriend, Landon, came into the room and attempted to separate Mia and Draven. [redacted] stated that Mia proceeded to attack him by pulling his hair, hitting his head, and scratching [redacted] right underarm. [redacted] stated that Mia attempted to take [redacted] phone when [redacted] was calling the police, and [redacted] stated that Mia threw another punch at [redacted] stated that [redacted] pushed her away, and Mia charged at [redacted] once again before taking [redacted] hat and glasses. [redacted] stated that Mia broke [redacted] room door and broke [redacted] sunglasses. [redacted] stated that sometime after Mia broke [redacted] mini bike tank off, Mia broke the plastic off [redacted] ATV bike.

I made contact with Mia's Boyfriend, Landon, who stated that he restated every word that Mia stated verbatim. Landon stated that Draven and [redacted] attacked and injured her leg. Landon stated that he separated the parties when the altercation turned physical.

I made contact with the arrestee, Mia J. Munoz, who stated that she did not want to talk with me because she felt as if I did not like her without any substantial grounds. Officer Hatton had read Mia her Miranda rights. When I asked Mia if she had entered Draven's room without consent, Mia stated that it was her house and that she could enter the room. Mia was informed that Draven had that incident on the footage and that the video clearly showed her barging into Draven's room while saying slurs. Mia denied the allegations made against her, and she invoked her right to remain silent.

Mia was placed under arrest, placed in double locked mechanical restraints, which were checked for proper fit, searched for any weapons or contraband, and transported to Indian River County Jail without further incident.
