I observed a tan sedan traveling southbound at an estimated speed of 26-mph in a 20-mph school zone. I activated my in-car Stalker and received a heads-up display of 26-mph. I conducted a traffic stop and spoke with the driver, later identified by his Mexico Passport, Isidoror Alejo-Jaimes.

I asked Mr. Alejo for his license and the documentation for the vehicle. Mr. Alejo gave me the registration, insurance and a Michigan Driver's License. I placed Mr. Alejo under arrest for No Valid DL and transported him to the Indian River County Jail without incident.





NARRATIVE

On Saturday, April 12th 2025, at 1618 hours, I responded to the intersection of 66th Avenue and 20th Street, in reference to a reckless driver. While this call was being dispatched, it became apparent that multiple citizen witnesses observed this driver. In total before he was stopped, four citizens called to report the apparent impaired driver. The vehicle was described as a silver Toyota bearing Connecticut license plate BP44225.

Upon arrival, I approached behind Lieutenant (LT) Linda Nolan. I observed the vehicle was a silver Toyota 4 door bearing CT/BP4425. I observed damage to the passenger side bumper. While standing next to the back driver side door, I could hear the driver, Edward Gaias, slurring his speech as he spoke. When LT Nolan stepped back, I moved next to Gaias and began speaking with him. I asked Gaias about any medical conditions he may have. He mentioned but nothing that would impair his ability to drive. While speaking to Gaias I observed his eyes to be red and glassy. I could smell the odor of an alcoholic beverage emitting from his breath as he spoke. I asked Gaias how much alcohol he has consumed, he advised none. Based on the interaction, I asked Gaias to step out of the vehicle.

While Gaias was standing up, I observed that the groin area on his pants appeared to be wet. I asked him if he urinated on himself. He could not give me a clear answer. I asked Gaias to walk to the front of my patrol vehicle. He appeared to be lost. I pointed to the location I wanted him to walk. He appeared uneasy on his feet. He swayed as he walked. Using simple instructions, I asked Gaias to sit against the bumper of my patrol vehicle. I asked Gaias to stand up straight and remove his hat and glasses.

I asked Gaias if he would do the Standard Field Sobriety Exercises. He advised he would do them.

During this exercise, I instructed Gaias to lean against my patrol vehicle to assist his balance. I checked Gaias' eyes for equal tracking and equal pupil size, both were present. I observed a lack of smooth pursuit in both eyes. I observed distinct and sustained Nystagmus at maximum deviation. I observed Nystagmus prior to 45 degrees. Multiple times throughout the exercise, I had to ask Gaias to hold his head still.

I asked Gaias if he felt able to complete the other standard field sobriety exercises, my main concern being his ability to stand without assistance. Gaias advised he could. I instructed Gaias to walk from the front of my patrol vehicle to the sidewalk. While walking, Gaias appeared unsteady on his feet. I began explaining the starting position to Gaias. He appeared to be so uneasy on his feet that he was about to fall. I advised I did not feel safe continuing this exercise. Gaias insisted that he could do the exercise. I began explaining the starting position a second time. Gaias attempted to mirror how I was standing. He was unable to. I told Gaias that based on his level of impairment, we would be skipping this exercise.

I instructed Gaias to lean against my patrol vehicle again. When he was leaned against the vehicle, I provided the instructions for the finger to nose exercise. I emphasized that he should not wait for me to tell him to put his hand back down at his side. Gaias advised he understood the instructions. I instructed Gaias to close his eyes and tilt his head back. He closed his eyes but he did not tilt his head back. I asked him again to tilt his head back. He advised it was tilted back. I did not observe any tilting motion. On the first instruction, I instructed left, Gaias touched the pad of his finger to the side

of his nose. On the second instruction, I instructed right, Gaias again touched the pad of his finger to the side of his nose. His movement was slow. For the remainder of the exercise, Gaias touched the pad of his index finger to the tip of his nose. On all instructions, I had to remind Gaias to remove his finger and place his hand back at his side. On one instruction, I allowed Gaias to keep his finger on his nose for approximately 30 seconds to see if he would remember the instructions. He did not.

I again asked Gaias how much alcohol he consumed. He advised not much. I asked him what he drank. He advised this morning; he consumed a drink with alcohol in it. He specifically advised the drink was about 8%. I asked Gaias when he took his first drink. He advised around 10 am. I asked him when this afternoon he took his last drink. He advised he did not drink this afternoon. I asked him when he took his last drink. He advised 8 am. I asked Gaias, if he started drinking at 10 am, if it made sense that he stopped at 8 am. He advised it did make sense.

Based on the totality of the circumstances, I found Gaias to be in violation of F.S.S. 316.193(1) DUI. I transported Gaias to the Indian River County Jail without incident.

After the completion of the observation period, Gaias was asked to provide a breath sample. He provided two samples resulting in a .227 and a .229.

NARRATIVE

On April 13, 2025, at approximately 0136 hours, I conducted a traffic stop on a red Ford Mustang (bearing FL tag 72TEE) in the area of Jackson Street and US Highway 1, Sebastian, Florida, for reckless driving.

At that time, I was stationary in median in the area of 13000 US Highway 1, Sebastian, in my marked patrol vehicle. I then witnessed a red Ford Mustang (bearing FL tag 72TEE) accelerate rapidly past me while traveling southbound on US Highway 1, and I visually estimated the vehicle to be traveling at approximately 75 miles-an-hour, in a 45 mile-an-hour zone. The Mustang then began quickly changing lanes and almost struck numerous other vehicles on the roadway. I subsequently conducted a traffic stop on the Mustang near Jackson Street and US Highway 1 and it came to a stop near Davis Street and US Highway 1, Sebastian. I made contact with the driver, who I identified as Mr. Michael Knipple by his Florida-issued driver's license, and front seat passenger, Mr. Gabriel Lorenzo.

As I was speaking with Mr. Knipple, I witnessed he had watery eyes and had slurred speech. I could also detect the odor of an alcoholic beverage emanating from the interior of the vehicle. While attempting the explain the reason for the traffic stop, Mr. Knipple became very argumentative. Based on Mr. Knipple's erratic behavior, I requested another deputy respond and K9 Deputy Le, ID# 5795, arrived on scene.

While Deputy Le spoke with Mr. Knipple, Mr. Lorenzo requested to exit the vehicle to speak with me. Mr. Lorenzo then advised me that Mr. Knipple was heavily intoxicated and had consumed several alcoholic beverages while they were at a local bar called Rack 'M, located at 13537 US Highway 1, #1, Sebastian. Mr. Lorenzo also stated that Mr. Knipple was speeding and driving erratically and both of them saw me parked on US Highway 1.

Based on my observations and Mr. Lorenzo's statements, Deputy Le and I requested Mr. Knipple exit the vehicle numerous times so I could conduct a DUI investigation; however, Mr. Knipple refused and stated he was not going to exit his vehicle. After providing Mr. Knipple with multiple lawful orders to exit the Mustang, Deputy Le and I then attempted to remove Mr. Knipple from the driver's seat. Mr. Knipple then began swatting Deputy Le's hands off of him and began yelling for us not to touch him. I then grabbed Mr. Knipple's right arm while Deputy Le grabbed his left and began removing Mr. Knipple from the vehicle. As we did so, Mr. Knipple continued to lean back within the vehicle and was twisting back and forth as if to get away from us. He was subsequently taken out of the vehicle and redirected to the ground where he was placed into handcuffs. His handcuffs were checked for proper fit and double-locked.

After placing Mr. Knipple in my patrol vehicle, I spoke with Mr. Lorenzo again. Mr. Lorenzo reiterated the same statements he made to me previously. He also advised he looked at the speedometer when Mr. Knipple passed me and stated the speedometer showed 76 miles-an-hour. Mr. Lorenzo also stated he had video of the incident and would provide a copy of it via Axon Capture.

Mr. Knipple was subsequently placed under arrest for the offenses of DUI, reckless driving and resisting an officer (without violence). He was transported to the Indian River County Jail, without incident. After arriving at the jail, I requested Mr. Knipple complete Standardized Field Sobriety Exercises (SFSE's) and Mr. Knipple stated he would complete them; however, Mr. Knipple stated he multiple medical issued that prevented him from being able to stand unassisted. During the exercise, I observed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees, in both eyes.

The next exercise was the fingertip-to-nose exercise. I then explained the instructions for the exercise and demonstrated it. Mr. Knipple advised he understood and did not have any questions. During the exercise, Mr. Knipple missed touching the tip of his nose multiple times and when I advised his to use his left finger, he lifted his right arm, corrected himself, then used his left finger to touch the tip of his nose.

The third exercise was the Modified Romberg exercise. I then explained the instructions for the exercise and demonstrated it. Mr. Knipple advised he understood and did not have any questions. Mr. Knipple estimated 30 seconds elapsed after approximately 24 seconds.

After completing the exercises, booking staff requested Mr. Knipple provide breath samples and he stated he would provide them. He subsequently provided breath samples with the following results: 0.165 and 0.159

Mr. Knipple was issued two citations for DUI (AIE07AE) and reckless driving (AKFRWQE).

On April 13th, 2025, at approximately 0856 hours, I was dispatched to reference to a disturbance (domestic violence). Upon arrival, I met with the caller who was not involved or identified who stated the following:
Before my arrival, he heard a female screaming "stop". Upon further listening the screaming stops. This prompted the caller to
I made contact with the above residence, making contact with a white male later identified as Dalton McDaniel. I immediately observed what appeared to be fresh cuts to his legs that were actively bleeding. Mcdaniel began to explain that he was involved in an altercation. I separated McDaniel from the residence and had him stand at the end of the resident drive way.
A female then came out the resident who was later identified as Amber Valduga who also confirmed that an altercation occurred between McDaniel and Andrew Valduga. Amber later confirmed that she did not witness how the physical altercation began, but she was able to separate the two after both were fighting one another.
I made contact with Andrew and immediately observed a fresh cut near his eyelid that was actively bleeding. Andrew explained that the physical altercation took place on the rear porch of the residence. McDaniel and Andrew were having a verbal dispute which led McDaniel to strike him in the face with a closed fist causing the injury on his eyelid. Andrew admitted to defending himself after being battered by McDaniel.
l made contact with McDaniel who admitted to striking McDaniel in the face. I read Miranda warnings to Mcdaniel who confirmed understanding. McDaniel again admitted to battering Mcdaniel. I determined that Andrew is

NARRATIVE

On 4/13/2025, at approximately 1027 hours, I, Deputy A. Brady, responded to the 5400 block of US-1 in to assist the Indian River County Fire Department with a non-compliant subject who was irate. The IRCFD was dispatched to the abovementioned area in reference to a possible fire. A motorist driving by saw smoke and was concerned there may be a brush fire. Firefighters advised me there is a red flag warning in effect for Indian River County pertaining to the current weather conditions that are ideal for amplifying brush fires. Reference IRCFD case # 2025-10280.

Upon arrival, I made contact with the IRCFD firefighters who had extinguished a small fire. Firefighters told me a male was standing near a small fire and upon their arrival he began kicking sand onto the fire. Firefighters stated the male then cursed them out and became very aggressive before gathering his belongings and heading north along US-1.

I could see the male, later identified as Nathan Carl Runions, walking quickly northbound away from my position. I attempted to stop Runions by using my emergency lights and siren, to investigate his reason for starting a fire on property that does not belong to him. Runions disregarded me and continued walking. I then pulled in front of Runions and exited my vehicle. Runions was immediately hostile and I could see fixed blade knife attached to his belt horizontally. I gave Runions commands not to touch the knife while I waited for backup to arrive. I advised Runions he was not free to leave. Sheriff's Deputy J. McNeal arrived on the scene to assist, at which time Runions grabbed his knife and removed it from the sheath. I drew my agency issued firearm and gave commands to Runions to drop the knife. Still aggressive, Runions complied and put the knife on the shopping cart he was pushing. Runions still carried on with his aggressive disrespectful behavior. D/S McNeal pulled the shopping cart away from Runions to keep the knife and any other potential weapons away from him. D/S Mcneal and I both asked Runions to identify himself several times and he refused. Runions stated he would not identify himself or answer any questions.

Without Runions identifying himself, and continuing to refuse to answer questions, he obstructed my investigation into a possible arson or criminal mischief. D/S McNeal and I then attempted to place Runions in handcuffs for the charge of Resisting an Officer without violence. At this time Runions physically resisted and took up an aggressive stance pulling away from D/S McNeal. D/S McNeal and I then brought Runions to the ground, where he continued to physically resist. D/S T. Rollando also arrived on the scene to assist and with his help, D/S McNeal and I were able to secure Runions in handcuffs.

I then transported Runions to the Indian River County Jail, where he was turned over to Corrections Deputies without incident. I placed Nathan Carl Runions under arrest for F.S.S. 843.02 Resisting and Officer without violence.

My involvement with this case was recorded on my body-worn camera.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 04/12/2025 05:13 On (Specifically include facts constituting cause for arrest.) On March 12, 2025, at approximately 0200 hours, I was dispatched to reference to a physical disturbance, Prior to my arrival, dispatch advised the complaint said Damion Rohrback had his hands on her throat. Dispatch advised Damion had fled on foot from the scene. Upon my arrival, other Sebastian Police officers were already at the residence. I observed several officers in the backyard of the residence and Corporal McElvy on the front porch speaking with a female. I approached Corporal McElvy and the female. I observed the female to be visibly upset due to her physically shaking, being unable to slow her speech, her voice fluctuating, and crying. Corporal McElvy was able to identify the female as Krysta Svelling White from previous incidents. Krysta stated she and Damion Krysta stated she and Damion were on their back porch talking. Krysta stated she attempted to tell Damion about her mom and sister, asking if her brother was invited to her niece's, baby's baptism. Krysta stated she told Damion it was not her place to know or tell them. Krysta stated Damion then became aggravated with her, asking why it was her problem and why they would ask her. Krysta stated when she attempted to answer Damion's questions, he told her to shut up and listen. Krysta stated that Damion asked her why they would ask her, and she told him she did not know; she was just attempting to have a conversation with him. Krysta stated at this time, Damion told her she did not listen and she is a raggedy bitch and walked off. Krysta stated she sat on the porch by herself for a few minutes. Krysta stated she then walked out to the front of their residence to her Jeep. Krysta stated she went to her Jeep to get her keys and wallet, because Damion likes to take them and hide them from her. Krysta stated when doing so, she felt a hand on the back of her pants. Krysta stated Damion said what are you doing. Krysta stated she explained to Damion she was grabbing her keys. Krysta stated Damion told her I did not take your keys or your wallet you raggedy bitch. Krysta stated Damion then threw her wallet at her. Krysta stated Damion then grabbed her by her neck. Krysta Krysta stated stated she used her arms to break his grip and told Damion back to their residence. Krysta stated that Damion grabbed her again by her neck and knocked her phone out of her hand. Krysta stated she then got out of his grip and ran to their back porch. Krysta stated she barricaded herself on the back porch and spoke with dispatchers. Krysta stated she went inside the residence and attempted to look out to the front of the residence, but she believed she saw Damion so she locked herself inside. Corporal McElvy asked Krysta if her breathing was impaired at any point. Krysta stated yes, when Damion first grabbed her neck, she attempted to tell him but she was unable to breathe due to how hard he was holding her. At this time, Officer Irwin advised that the incident met his requirement to deploy his K9. Officer Irwin quickly went to his patrol vehicle and deployed K9 Officer Suma. Sergeant Melius and Officer Irwin began tracking. Corporal McElvy began to set a perimeter, Sergeant Melius advised dispatch to make contact with the Indian River County Sheriff's Office and see if deputies were available to assist. Several deputies responded to the incident and were advised by Corporal McElvy where to set the perimeter. Krysta stated she had Damion's location due to an app called Life 360. Corporal McElvy used this app to advise Officer Irwin where Damion was. Using the map on Life 360, Corporal McElvy was able to observe Damion in a ditch between Peterson Street and Fleming Street. Officer Irwin and Sergeant Melius responded to the area. Officer Irwin and Sergeant Melius both gave Damion verbal instructions to exit the ditch and surrender. At this time, Deputy Kramer advised via radio that she observed a male matching Damion's description running away from the area of Peterson and Fleming. Deputy Kramer stated she observed the male running eastbound across Fleming (Indian River County Sheriff case number #2025-37641). At the same time, Life 360 updated and showed Damion running to the intersection of Lake Drive and Banyan Street. Officer Irwin and Sergeant Melius quickly responded to the intersection and discovered Damion at 474 Banyan Street. It was determined that 474 Banyan Street was a house being built and was a construction site. I then responded to 474 Banyan Street. Upon my arrival, I made contact with Damion. I observed Damion to have a cut on his face. I read Damion his Miranda Warning. Damion stated she understood and stated he woul<u>d speak to me</u>. I asked Damion what happened. Damion stated had a verbal argument. Damion stated face. Damion stated he then ran away from the residence to get away from I asked Damion to go into detail about what happened. Damion became upset and yelled, "I told you what happened". I asked Damion where the argument occurred. Damion stated their back porch. I asked Damion where Krysta struck him at the residence. But before I could finish my question, Damion became even more upset and yelled, "In my face, can't you see I'm bleeding?". I explained to Damion I was not finished with my question and repeated the full question. Damion stated Krysta struck him on their back porch. I asked Damion where he went after he left the residence. Damion stated she was attempting to go to asked Damion where Law Enforcement discovered him. Damion then became extremely irate and began to yell, "You're not charging me with trespassing, I mowed that house." I attempted to explain to Damion I was asking due to my not being at the scene, but Damion velled, "This conversation is over." It should be noted, by using the Life 360 app, Law Enforcement was able to see Damion hiding in heavily wooded areas, and it was extremely possible that Damion injured his face in the wooded area.

On April 12th, 2025, at approximately 1618 hours, I responded to back Sergeant Richard up on a traffic at 526 Fleming Street, Sebastian, Florida 32958.

Upon arrival, Sergeant Richard stated the following: "On 04/12/25 while conducting routine patrol I observed a white SUV traveling at a high rate of speed northbound on the 500 block of Fleming Street. I was traveling south on Fleming Street and visually estimated the vehicles speed at 55mph in a 30mph zone. My radar unit was set on moving radar, had a correct patrol speed, had a strong doppler tone on the vehicle, which was the only vehicle traveling north at that time, and confirmed the vehicles speed at 58mph in the 30mph zone. The white SUV proceeded to pass me it as it traveled north and I was able to identify it as Hyundai. As I slowed to turn around, I watched the vehicle stop on Fleming Street and proceed to back into a driveway. Never loosing sight of the vehicle, I activated my emergency lights, drove to the vehicle's location, and parked at the bottom edge of the driveway located at 526 Fleming Street.

As I placed my marked patrol car in park the aforementioned SUV was also placed in the park, the driver opened the door, and before he was able to exit the vehicle, I made contact with him. I ordered the driver to turn off his vehicle, close the driver's door, and roll down the window; to which he complied. At this time, I observed two young children in the car; one located in the front passenger seat and the other located in the rear passenger seat.

I asked the driver for his license to which he stated he did not have it on him and it was in the house. A female that was in the garage went into the residence and provided me with a FLDL which confirmed his identity as Andre L Pound Jr.

As I continued to speak with Pound, I smelled a strong odor of alcohol emanating from the vehicle. I observed Pound had glassy watery eyes which through my training and experience I know to be an indicator of alcohol consumption. I asked Pound if he has had any alcohol to drink today to which he stated he did not.

I felt pound was possibly driving under the influence of alcohol and asked Pound to exit his vehicle. Pound complied and ${f I}$ escorted him to the front of my patrol car. While I continue to speak with Pound, I smelled a strong odor of alcohol emanating form his person and asked him again if he had consumed any alcohol today. Pound stated this time that he had one drink (alcoholic beverage)."

Due to Sergeant Richard's observations and what he advised me of on scene, I asked Andre if he would perform a series of field sobriety exercises which he agreed to do.

The first exercise I preformed was the Horizontal Gaze Nystagmus. Andre stated he was not wearing glasses or contacts. I observed Andre to not have equal tracking both eyes. Andre was also unable to keep his head still and initially had to be reminded more than once to keep his head still. Throughout the course of the exercise, I observed Andre to have a lack of smooth pursuit. I also observed distinct and sustained nystagmus at maximum deviation in both of Andre's eyes.

The next exercise I attempted to perform was the Walk and Turn. I asked Andre if he had any mobility issues to which he stated he did not. I then explained to Andre the starting poisiton. Once in the starting position, I observed Andre to be unsteady on his feet. Andre continuously lost his balance throughout the duration of me explaining to him the instructions. Once I finished explaining and demonstrating the exercise, Andre stated he would be unable to perform the exercise due to

I asked Andre if he would be able to stand on one leg in order to perform the next exercise, One Leg Stand, which he stated he would be unable to do so.

It should be noted, throughout my entire interaction with Andre I was able to detect a heavy odor of an alcoholic beverage emanating from his breath as he spoke. Andre's speech was also slurred and his eyes were watery and glossy. I was also advised by Corporal Dean of a cup inside of the vehicle's center console which contained a liquid that smelled like an alcoholic beverage.

Based on the totality of circumstances to include Sergeant Richard observing the way Andre was driving his vehicle through a residential roadway, his observations during his initial stop, as well as my observations during the course of my investigation to include the Horizontal Gaze Nystagmus exercise and the attempt of the Walk and Turn, as well as the alcoholic beverage in the center console of the vehicle, I found probable cause to place Andre under arrest for violation of FSS 316.193(1A) DUI.

Once placed under arrest, I advised Andre of his Miranda Rights which he understood and waived. Post Miranda, Andre stated he was at the North County Pool with his children for a party. While at the pool, Andre stated he and some friends were drinking alcoholic beverages, specifically beer. Andre stated this was between 12 and 1pm. I asked Andre about the beverage inside the cup of the center console, to which he stated it was a Heineken beer however it was not from today's date. Andre stated the beer in the center console was from yesterday.


Andre was then transported to the Indian River County Jail without incident. While at the jail, Deputy Kane requested that
