#### NARRATIVE

On September 29, 2025, at approximately 0214 hours, while patrolling Old Dixie Highway, I noticed a suspicious person in front of 470 4th Lane SW, Vero Beach, Florida.

As I approached the male, I could see his belongings laid out all around the front of the closed business called Perfect Way Pavers, with a fire pit display in front of it. As I interacted with the male later identified as Jason Nesbitt, I could see several lighters, knives, a bicycle and a metal detector that was inside the fire pit display. Nesbitt stated that he was on his way to a friend's house for the night at the end of an adjacent neighborhood called Whispering Palm. As I continued to interact with Nesbitt, I noticed a clear plastic zip lock style bag directly to the left and within arm's reach of where Nesbitt was sitting. I then read Nesbit His Miranda rights from my agency issued card, which he waived and agreed to speak with me. Jason was asked about the clear plastic zip lock style bag that was to his immediate left side in plain view within arm's reach. Nesbitt stated that its not his, "everything else is mine but that" pertaining to the clear zip lock bag. The zip lock bag contained a crystal-like rock inside of it. From training and experience I know that to be methamphetamine. Due to Nesbitt's body language, I noticed he became uneasy and would not look up when asked questions. Nesbitt has a history of theft and drug use that was concerning based on the circumstances.

Due to the recent strings of business and residential burglaries in the neighboring areas there was concern of loitering and or prowling.

At this time, I granted Nesbitt the opportunity to dispel my fears as to why he was in front of a closed business in a time and manner of a law-abiding individual. I asked Jason if he had permission to be there or if he was invited to be there, Nesbitt stated no. Jason's only reason for being there was for a change of clothes. It should be noted that it was still raining at this time.

Nesbitt did not provide a Justifiable reason as to why he was there, therefore loitered or prowled in a place, time and manner not usual for law abiding citizens. It raised alarm and immediate concern for the safety of persons or property in the vicinity due to the recent residential and business burglaries.

I then placed Nesbitt under arrest for loitering and or prowling. While searching his person Jason stated that there's a glass bowl in his bag, when asked what it was used for, he stated methamphetamine. Nesbitt was then placed in the back of my patrol vehicle while Deputy Martinez and I field tested the crystal substance and the glass bowl that Jason stated was used

The field test yielded positive results for Methamphetamine on both the crystal rock and the glass bowl.

I once again spoke to Nesbitt, he stated that he was trying to be a good person and get off Methamphetamine and that's why he left the homeless camp. I then asked if he lied to me, he stated yes, and admitted that the methamphetamine was his. He stated that he left the homeless camp to go smoke with a friend.

Based on the facts listed above I find probable cause to charge Nesbitt with:

- 1. F.S.S. 856.021 L&P.
- 2. F.S.S. 893.147.1 possession of drug paraphernalia.
- 3. F.S.S. 893.13 possession of a controlled substance. Citation #: A667XKE

#### NARRATIVE

On September 29, 2025 at approximately 0706 hours, I responded to

regarding a past disturbance.

Arrest Affidavit Report

While enroute to the call I was advised that the caller Kendra Hunt had stated that the father of her child Tyler Alemgahides had pulled her hair the previous night and she had left the residence and walked two residences down with their daughter and stayed the night. Hunt said that when she returned this morning the drivers front window of her vehicle was broken out and there was blood on the ground leading into the house.

Upon making contact with Hunt, she reiterated what she had informed dispatch. Hunt stated that when she returned to the residence, she observed the broken window and blood and when she went inside the residence, she observed blood throughout the residence leading to a back bedroom that was locked. Hunt said she believed that Alemgahides was in the room but was not sure of what his condition was. Hunt went on to show me the window of her vehicle and I observed blood on the outside door as well as the interior of the car. I also observed glass from the window on the inside and outside of the vehicle. When asked what had transpired the previous evening that made her leave the residence Hunt stated Alemgahides had been going through her phone and wanted to talk to her about something he had found. When Hunt did not respond to him Alemgahides grabbed her by the hair and pulled it. At this point Hunt grabbed their two year old daughter and left the residence. When asked if when Alemgahides had pulled her hair to get her attention Hunt stated no it was harder than that but not to the point that her scalp was sore today.

Hunt gave permission for a search of the residence for Alemgahides to be completed. When entering into the residence I observed blood on the floor which led back to the back bedroom. When contact was made with Alemgahides in the back bedroom he was covered by a blanket and had to be ordered multiple time to show his hands before finally complying. A search of the bed where Alemgahides was laying revealed a long machete like blade with a long handle where Alemgahides hands were concealed under the covers. It was also observed that Alemgahides had a paper towel around his right hand when checked there was a fresh laceration.

Once Alemgahides was secured into handcuffs he was advised of his rights he agreed to talk but when questioned invoked his rights.

Based on the facts of the case it is believed that Alemgahides actually and intentionally touched or struck Hunt who he has a child in common with against her will. And he damaged personal property belonging to Hunt and this damage was done willfully and maliciously.

Alemgahides was transported to the Indian River County Jail where he was turned over to Correction Staff for the charges of FSS 784.03.1a Battery Touch or Strike and FSS 806.13.1B Criminal Mischief.

The defendant was placed under arrest for FSS 322.03(1) No DI- Never had one issued, 322.051 Posses fake ID card and was taken to the Indian River County Jail without incident.

The defendants vehicle and child, who was sitting in the back seat, was turned over to her neighbor, later identified as Maria Hernandez, who arrived on scene. The defendant stated she was ok with her neighbor taking her child home.

## NARRATIVE

On Monday, September 29th, 2025, I, Deputy C. Greeley #6038, responded to 3606 11th Street, in reference to a stolen vehicle.

Prior to my arrival, I spoke with the victim, Paula Ritchie, via phone call. She explained her vehicle was missing and she believed her ex-husband, Joseph 'Joe' Ritchie might have her vehicle. She described her ex-husband as a slender white male; however, he did not have access to her vehicle. Her vehicle was described as a silver Mazda, four-door vehicle, with the Florida license plate #CC75CQ.

Paula stated Joseph resides in the same residence as her however, they live in separation sections. She expressed knowledge of Joseph's suspended license, and therefore he cannot operate a motor vehicle. She is only aware of one vehicle key fob, and does not recall ever giving him a secondary key. She does not know how he was able to turn on her vehicle. Paula stated months ago, she told him he was not to operate her vehicle for any circumstances.

Paula recalled at approximately 1200 hours she left her residence and utilized another vehicle. At that time her Mazda vehicle was still parked in front of her residence. When she returned at 1330 hours, she noticed her silver Mazda #CC75CQ was missing from in front of her residence.

A D.A.V.I.D. inquire of the vehicle revealed the only sole owner of the vehicle to be Paula.

Moments later, the vehicle was located by Deputy B. Gage. The silver Mazda was traveling at the 1200 block of 50th avenue. A traffic stop was then affected on the vehicle in which they complied and pulled over on the side of the road. A white male was discovered inside the vehicle, Joseph 'Joe' Ritchie.

Joseph provided his named and date of birth, in which it was discovered his Florida Driver's License had been suspended since November 16th, 2017. In Joseph's driver's history it revealed three suspensions, one revocation, and one cancellation.

Due to Joseph being located in actual and physical control of the vehicle, he was issued a citation #AM2NF6E.

Post Miranda, Joseph admitted to taking Paula's vehicle. He described a single key fob for the Mazda in which he was in possession of. He stated this key fob remains within his living space. He recalled after Paula left in her truck to attended to horses, he went outside and entered her vehicle. Joseph stated he is normally given access to operate Paula's vehicle; however, this is typically when they are in each other's company.

Joseph while I interviewed him was wearing gray short, green shirt, and a gray hat.

Joseph also described how he accessed the vehicle. He placed the key fob on the key's ignition in order to start the vehicle.

I noticed in front of Paula's residence was a security camera. She was able to provide me with a video in which I observed the following: the video is time stamped for Monday, Sep 29th, 2025 at 1144 hours. A white male wearing the same clothing Joseph is currently wearing approached Paula's vehicle. He then holds the driver's side door handle momentarily before entering the vehicle.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 09/29/2025 On

(Specifically include facts constituting cause for arrest.)

I conducted a traffic stop on a blue Chevrolet Malibu bearing FL tag # 36DESY at the 4100 block of 16th Street, Prior to the stop, I was traveling behind the aforementioned vehicle. At that time, I conducted a query of the Florida license plate which advised that the registered owner did not have a Florida license. I also observed a blue handicap placard hanging on the rearview mirror.

The stop was conducted and I then approached the passenger side front window, where I made contact with a Hispanic male driver and a white female front passenger. The male was identified as Francisco Perez (H/M DOB: 04/29/1986) and the female was identified as Rachel Crane (W/F DOB: 06/28/1984).

Perez stated he borrowed the blue Chevrolet Malibu from the registered owner, identifying him as "Chuck" and stated that they had been using the vehicle for the past two days. Perez was unable to provide vehicle insurance information and displayed slight nervousness as his body appeared tense while conversing with him. Crane remained in the front passenger seat and would not make eye contact with me, looking down throughout the interaction and shuffling through documents that were in the glove box compartment. Crane appeared fidgety, having trouble staying still. I then requested both subjects to exit the vehicle, where Crane became verbally defensive. Eventually both subjects exited and walked towards the rear of their vehicle.

K9 Ofc. Hatfield (#416) responded to the scene, where he remained with both subjects as I returned to my vehicle to continue my investigation. Ofc. Hatfield advised he observed a used/burnt pipe with residue fall from the immediate area where Crane had been standing. Ofc. Hatfield stated he was unsure where exactly the pipe fell from, but stated that Crane had been holding several documents in her hand at that time.

Based on the foregoing, Crane was detained and placed in the rear of my patrol vehicle. A search was then conducted of the vehicle (FL Tag # 36DESY), where a burnt aluminum foil was located inside of the center console and a cut length blue straw with white powder residue was located underneath the front passenger seat. Based on my training and experience the burnt aluminum foil, the cut length blue straw, and the used/burnt pipe with residue is known to be a common method for the consumption of illegal narcotics. Also, a small blue baggy containing white powder residue was located on the front passenger seat and a small clear baggy containing a white powder substance was located inside of a black eyeglass case which was located inside of a white and brown purse that was on the front passenger floorboard. The small clear baggy containing a white powder substance was field tested and had a positive reaction to the presence of cocaine (0.4g).

Based on the foregoing, Crane was advised of her Miranda Rights to which she advised she understood and denied ownership of all the items located on the front passenger seat. Crane stated she last used narcotics last night (09/28/2025) and her drug choice is either Cocaine or Fentanyl.

Due to all items located being in her immediate reach and my observations prior to locating the items, Crane was placed under arrest for possession of drug paraphernalia F.S.S. 893.147(1) and possession of controlled substance F.S.S. 893.13(6a).

Crane was issued a citation (# ALZPAYE) for F.S.S. 893.13.

She was transported to the Indian River County Jail for booking and processing and to be held on no bond.

BWC footage and photographs have been uploaded to evidence library.

All evidence was placed into VBPD evidence.
