**NARRATIVE**

On Tuesday, March 31, 2026, at approximately 1300 hours, [REDACTED] along with [REDACTED] was conducting surveillance at 1027 Lincoln Street, Fellsmere, Florida. The purpose of the surveillance was to gather information regarding Damian Detroy Collins, who had an active warrant issued by the Indian River County Sheriff's Office for the following offenses:

- 1 Count of FSS 893.13.1E: Sell, manufacture, deliver, or possess with intent to sell a controlled substance within 1,000 feet of a place of worship (cocaine).
- 1 Count of FSS 893.13: Possession of cocaine.
- 1 Count of FSS 934.215: Unlawful use of a two-way communications device.

While conducting surveillance, myself and [REDACTED] observed Damian Collins standing outside the residence. He was wearing a black shirt and tan cargo shorts and had long dreadlocks. Collins was standing alone near a black Chevrolet pickup truck parked in the front yard.

As myself and [REDACTED] attempted to coordinate with road patrol units to take Collins into custody, the black Chevrolet pickup truck departed the residence. The vehicle displayed Florida tag #63FRDA. At approximately 1305 hours, myself and [REDACTED] observed the vehicle traveling with a black male driver matching Collins' description, including distinctive dreadlocks.

Myself and [REDACTED] followed the vehicle as it traveled southbound on Interstate 95 and exited at Exit 147 (State Road 60), heading eastbound. During the surveillance, I observed Collins in the driver's seat through the driver-side mirror and maintained continuous visual contact.

The vehicle entered the parking lot of Wawa, located at 9050 20th Street, Vero Beach, Florida 32966, and parked near a gas pump on the west side of the property.

[REDACTED] and myself briefly lost visual of the vehicle while attempting to make a U-turn. Road patrol units arrived shortly thereafter and advised the vehicle was unoccupied. Myself and [REDACTED] entered the Wawa store and observed Damian Collins inside, wearing the same clothing previously described. Collins was taken into custody without incident. A search of his person was conducted and I collected a large wad of cash which was in his right bottom cargo pocket. The currency was counted on scene by [REDACTED] and myself.

Collins was asked if any other individuals were inside the vehicle; he stated there were not. K-9 Deputy Adam Brady conducted a free-air sniff of the vehicle, which resulted in a positive alert for the presence of narcotics.

A subsequent search of the vehicle was conducted. [REDACTED] observed a clear plastic baggie containing a white powdery substance and a separate clear plastic baggie containing a green leafy substance. Based on training and experience, the white powdery substance appeared to be fentanyl, and the green leafy substance appeared to be marijuana. A handgun was also located in the center console, the firearm was checked via IRCSO dispatch and confirmed it was not stolen.

I brought the suspected fentanyl to the Indian River County Crime Scene building. I tested the white powdery substance using a field test kit which yielded a positive result for the presence of Fentanyl. The substance weighed 2.36 grams; photographs were

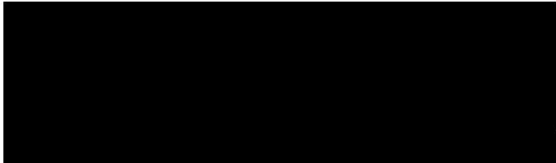



NARRATIVE

On Tuesday, March 31<sup>st</sup>, 2026 at approximately 1708 hours I responded to the 3500 block of 43<sup>rd</sup> Avenue in the wooded area in reference to a warrant search.

K9 Deputy Ferrer and K9 Deputy Brady located the defendant John Edmund Schneider in reference to one active felony warrant (IRCSO 2026-33969), one active misdemeanor warrant (IRCSO 2026-18508), and a pickup commitment order. K9 Deputy Ferrer escorted him from the wooded lot towards my patrol vehicle. K9 Deputy Ferrer transferred custody of Schneider to Deputy Binner and I.

I informed Schneider that he was going to be searched incident arrest. I asked Schneider if he had anything illegal on his person or any weapons. He stated that he did not have any weapons on him or anything that would stick or poke me. I asked if he had any drugs on his person, he stated, "Not that I know of". During a search incident to arrest in his right cargo pant pocket I located a syringe that appeared to have some liquid inside of it and a black piece of tape that contained a clear plastic baggie. Inside of the baggie I observed a crystal-like substance that I believed to be crystal meth based upon my training and experience. K9 Deputy Ferrer stated that Schneider told him that the substance was meth.

I waited until I arrived at the Indian River County Jail in order to administer a field test due to windy conditions. Inside of the sally port I weighed the substance in the baggie. The combined weight was approximately 0.24 grams. A presumptive field test was positive for Amphetamines/Meth. Schneider declined to provide a statement.

Based upon the totality of the evidence Schneider was charged with the following:

- Violation of FSS 893.13 – Possession of a Controlled Substance (Crystal Meth)
- Violation of FSS 893.147(1)(b) – Possession of Drug Paraphernalia

Schneider was transported to the Indian River County Jail for booking.






I deployed Tobi on the driver side of the vehicle. Tobi brought me to the driver's front window that was open, and gave me a change in behavior that is consistent of him being in an odor he is trained to detect.

A search of the vehicle was conducted and I locate an oven mitt under the front passenger seat. Inside of the oven mitt, I located a digital scale that had a white residue on it, a small bag of marijuana, and a clear glass cylinder that was charred on both ends. Through my training and experience, I knew the glass cylinder to be a smoking device for cocaine. Due to locating the drug paraphernalia under the passenger seat, I conducted a search of Bourbon. Inside of Bourbons front two pockets, I located two more smoking devices for cocaine. Nothing else was located on his person.

I read Bourbon his Miranda Warning to which he acknowledged he understood. Bourbon advised me that the drug paraphernalia located on his person and under his seat was his.

NARRATIVE

On March 31, 2026 at approximately 21:46 hours, I responded to 1856 Hedden Place in reference to a past physical disturbance call for service.

Upon my arrival, I spoke to the victim who was identified as Steven Rudolph Kliemisch. Steven stated he was involved in a physical disturbance and a male attacked him during a road rage incident. Steven stated his significant other, Dana Lynn Williams was with him when the incident occurred and she witnessed everything. Steven stated he knew the male who attacked him. Steven identified the male to be Jesse Violante.

Steven stated he was on his motorcycle and Dana was sitting passenger on the rear. Steven stated he was headed Eastbound on County Road 512 coming back from Fellsmere area. Steven stated as he was driving Eastbound on CR-512, he observed two vehicles in front of him. Steven stated he observed the lead vehicle slow down in traffic and the male driver stuck his arm out the window to signal a left turn. Steven stated he observed the vehicle behind the lead vehicle which was a black SUV in front of him come to a stop behind the lead vehicle. Steven stated he safely and slowly went around both vehicles and continued driving Eastbound on CR-512 towards the I95 highway on ramp. Steven stated while he was driving his motorcycle, he observed the black SUV speed up again and began to follow him very closely. Steven stated he did not know what was happening and continued to speed up to create separation from the black SUV behind him. Steven stated as he continued to speed up, the black SUV did so as well and continued to drive behind him at an unsafe distance.

Steven stated he stopped at the intersection at CR-512 and I95 exit due to catching the red light at the intersection. Steven stated while he was at the light, he observed Jesse to be the driver of the black SUV. Steven stated he observed Jesse to be irate and upset and started yelling at him. Steven stated he observed Jesse pull his black SUV into the grass near where he was stopped at the intersection. Steven stated he observed Jesse open his vehicle door and step out of the driver's seat while still acting irate. Steven stated as he saw Jesse approach him, he turned off his motorcycle and stepped off of it as he did not want to get attacked while sitting on his motorcycle. Steven stated he personally knew Jesse and identified himself to him before the altercation took place and asked what was going on. Steven stated he was confused as to why Jesse was upset, but believed the reason to be because he passed him on the roadway. Steven stated that even after Jesse saw who he was, Jesse still aggressively approached him and kicked him in the chest, as well as hit him in the wrist. Steven stated after the physical altercation happened, then a verbal dispute continued and Jesse got back into his vehicle and left the scene.

Steven stated he continued back to his residence where he later called law enforcement to report the incident. Steven stated he wanted to pursue criminal charges for Jesse's aggressive and physical behavior towards him.

While on scene, Steven had a visible red mark on his wrist that he stated was from the physical altercation. Steven stated he believed his wrist to be possibly sprained, but would take himself to the doctor's office at a later date to get it checked out, therefore he did not need EMS. Steven stated his injury was from Jesse. (Pictures of Steven's injury were uploaded to Axon Evidence).

Dana stated she was with Steven the entire time and witnessed the physical attack take place. Dana stated she saw Jesse approach Steven and kick him in the chest and hurt his wrist. Dana stated before the altercation took place, she pulled out her cellphone to record. Dana showed me a clear video of Jesse kicking Steven and making physical contact with his person. The video Dana provided was captured on my agency issued Axon body worn camera.

Furthermore, into my investigation, Jesse's full identity was later confirmed using law enforcement software (David). Steven stated the altercation approximately took place around 6:00PM. Steven positively identified Jesse by seeing the photo only. His full identity was confirmed to be Jesse Owen Violante. The address for Jesse that was on file was 13385 107<sup>th</sup> Street Fellsmere, FL 32948. North County units, Deputy M. Davis and M. Mangel with the help of Fellsmere Police, arrived to that address in an attempt to locate Jesse, as probable cause existed. Jesse was located at that address and placed into custody. Deputy M. Davis transported Jesse to my location. I took custody of Jesse and placed him into my marked agency issued patrol vehicle.

Jesse was read his Miranda Warnings and he stated he understood them. Post Miranda, Jesse stated he wanted to remain silent. Jesse did not cooperate with law enforcement.

Jesse was transported to the Indian River County Jail without further incident.

This interaction was captured on my agency issued Axon body worn camera.
