NARRATIVE

On Monday, December 17th, 2024 at approximately 2304 hours, I, Deputy Sheriff Ramiro Doval responded to in regards to a disturbance in progress.

Upon arrival, I made contact with Karen Sapp who was outside her porch sitting down. I asked her what was going on, she stated later identified as Alfred Sapp has been on methamphetamine and has been up for nine days straight. Today they had an argument over Alfred finding a new place to live and Karen not being happy anymore and

Karen stated during the argument, Alfred grabbed both of her wrist and pushed her back, Karen then fell on the floor in the bedroom. I was able to observe bruising on both arms of Karen, no other bruising on her was visible.

It should be noted, Karen also has been drinking wine throughout her night and had a strong odor of an alcoholic beverage emitting from her breath as she spoke to me.

I then made contact with Alfred. He stated him and Karen did have a verbal argument but it never became physical. He stated he was just arrested for battery on Karen a few months ago. Alfred stated the argument began due to Karen thinking he has been talking to other females and Karen wanting him

due to her not working.

I did not see any bruises, scratches, or marks on Alfred. Photos were taken of Karen and submitted into evidence.com.

At this time, due to Karen's statements, I found Alfred as the primary aggressor in this incident and placed Alfred Sapp under arrest for the following offenses;

Count 1.) Violation of F.S.S 784.03 Battery (Domestic), when Alfred Sapp, grabbed Karen by her arms and pushed her back making her fall and causing small bruising to Karen's wrists.

Alfred was transported to the Indian River County Jail without incident.

NARRATIVE

On Monday, December 16, 2024, at 2230 hours, I responded to **a second second second second** in reference to a disturbance. Dispatch advised me while enroute, that two males were actively fighting in the street.

Upon my arrival at the aforementioned address, I observed a crowd of about 7 people standing near the street screaming at each other. I recognized one of the males from a previous encounter at the residence, Dahmir White, and told him to stand at the front of my patrol vehicle to prevent any further altercations. While attempting to calm down all personnel at the residence, Dahmir stated him and **second second** Luis Nunez, got into a physical altercation because of

Dahmir stated him and the second began arguing when he got home from work because the reportedly put some of his dirty underwear on his bed which embarrassed him. Dahmir stated he became angry and grabbed **second** by the shirt, and they began to yell at each other. Dahmir stated after they were yelling at each other, **second** went outside and he followed continue to argue.

It should be noted that Dahmir had what appeared to be scratch marks on his left shoulder, and red marks on his back.

Due to the people located outside of the residence yelling at each other and Dahmir, I detained Dahmir and placed him into the back of my agency issued patrol vehicle to further conduct my investigation. I met with who stated Dahmir arrived home from work, at which point he became angry with **see**because **see**placed some of his dirty stated Dahmir began yelling at **see** and grabbed **see** by the shirt yanking underwear on his bed. stated Dahmir was very aggressive, and when he yanked **state** by the shirt it hurt informed me that **see** is recovering from a broken clavicle which got last week. continued stating that went outside, and Dahmir followed grabbing a half empty liquor bottle. stated Dahmir swung the bottle at at which point, Luis intervened to protect

stated Dahmir and Luis began fighting outside, and at one-point Dahmir struck Luis in the head causing him to hit his head against the ground losing consciousness. As K9 Deputy Mangel and I were speaking with began to hyper-ventilate and started to pass out.

Indian River County Fire Rescue was dispatched to evaluate, Dahmir, and Luis.

As K9 Deputy Mangel remained with **second i** met with Luis in an attempt to obtain his recollection of events; however, Luis was very disoriented and was unable to maintain conversation for very long.

It should be noted that Luis had a laceration to his head and left arm from the altercation, which were photographed utilizing the Axon Capture App.

IRCFR Rescue 4 arrived on location and began to evaluate all personnel involved, which ultimately resulted in

Luis being transported to Vero Beach ER for further evaluation.

I met with Dahmir's designed Jesi Torres, who was attempting to show me the camera footage from the incident. Jesi started to show me the footage, but was unable to show the full thing as the cameras were not loading. Based on the totality of circumstances, the injuries obtained, the statements provided, and the limited camera footage available. I was able to determine that Dahmir was the primary aggressor in the incident as he followed to out of the residence, retrieved a liquor bottle, and attempted to strike to strike with the bottle. This corroborated the statements provided to me, that Luis acted in defense of the statement of and in doing so resulted in the physical altercation between Luis and Dahmir.

I was informed by the Vero Beach ER staff that Luis sustained a concussion along with the contusion to his head. While at the Vero Beach ER, I also spoke with **state and a severely** again who confirmed that was fearful that Dahmir was going to severely hurt her with the Liquor bottle outside of the residence. This was captured on video on the security camera outside of the residence.

Due to the Facts and Circumstance listed above, and the video evidence obtained I find probable cause to charge Dahmir with the following:

Count 1: F.S.S 784.03: Battery- Touch or strike, against his Step-Father, Luis Nunez.

Count 2: F.S.S 784.03: Battery- Touch or strike, against

Count 3: F.S.S 784.021.1A: Aggravated Assault with Deadly Weapon without intent to kill.

NARRATIVE

On Monday. December 16, 2024 at 1444 hours, I responded to the area of 58th Avenue and 20th Street in reference to a crash.

On arrival, I observed the crash to involve (3) vehicles. Driver of the at fault vehicle was identified as Alyson Brynn Katana who was seated in her 1999 White Jeep bearing FL Tag RFJR09. While speaking with the defendant, I asked basic questions as to how the crash occurred. The defendant was showing signs of slow and slurred speech. The defendant also had trouble recalling how the crash occurred in which she rear ended the vehicle in front of her. The defendant also appeared to be extremely drowsy as she spoke and paused for periods to gather her thoughts. The defendant explained that she panicked when she was trying to change lanes but told the other drivers there was no damage. The damage was visible on all three vehicles with the lead vehicle requiring EMS transport for the driver to Cleveland Clinic. I verified her medical conditions which she stated was a seizure disorder and took various medication for the condition. When asked if she had taken anything prior to driving she stated "no". The defendant advised she was uninjured in the crash and refused treatment by EMS.

After I completed the crash investigation, I informed the defendant that I was "Changing Hats" and moving into a criminal investigation based on my observations. I explained my concern for her signs of impairment and asked her again if she took any medication. At this time, we were standing on the sidewalk due to the vehicles needing to be moved out of the lane of travel. The defendant again was having difficulty keeping her eyes open. I spoke to the defendant regarding my findings of her suspended drivers license and she denied any knowledge of getting a traffic citation in her over (40) years driving. The defendant showed a revoked drivers license effective 11/22/2023 and additionally her David driver history showed a DUI suspension for a period of (180) days with notification provided by the courts effective 05/31/2024 which still indicated action required. I informed the defendant of my findings for her driving record and she denied ever being arrested for driving under the influence. It was not until her passenger identified as Jeannie Hefner reminded her that she was the one who picked her up from jail. Based on my observations I suspected the driver to be under the influence of a medication and requested she consent to roadside standard field sobriety exercises. The defendant consented and below are my findings:

Horizontal Gaze Nystagmus (HGN):

-Subject denied any eye sight problems prior to testing. -Subject was unsteady and swayed side to side while in the starting position. -Subject was unable to follow the stimulus and lacked smooth pursuit. Additionally, the subject

-Subject was unable to follow the stimulus and lacked smooth pursuit. Additionally, the subject had to be verbally reminded to keep her eyes open.

-Subject showed signs of nystagmus at max deviation but not prior to the onset of 45 degrees.

-Subjects pupils showed to be pin point throughout the exercise.

One leg stand:

-Subject denied any knee of foot injuries preventing her from balancing.

-Subject elected to use her right leg for the exercise.

-Subject advised she understood the instructions as I demonstrated the exercise.

-On the first attempt, subject did not follow instructions as given and bent her right knee, she failed to raise her foot to the correct height and did not count. When asked again if she understood the instructions, she stated she thought so. I then again explained the instructions and offered her a second attempt at the exercise.

-On the second attempt, the subject again did not follow instructions for arm and leg height.



Walk and Turn:

-Subject again was given instructions to complete a (9) step heel to toe walk down and back. The subject stated she understood but had to be reminded to keep her eyes open multiple times to view my demonstration. -Subject failed to follow instructions and did not touch heel to toe but rather walked a total of (15) steps before being

told to stop.

-Subject was asked again if she understood my instructions and she stated "yes, 12 steps", I reminded her that the instructions were (9) steps.

-On the return pass, the subject again did not touch heel to toe and walked in a normal manner back with a total of (12) steps.

Finger to nose (LRLLR):

-I provided instructions as to the conduct of the exercise and had the subject identify the tips of her fingers. -In the starting position, I gave the command of Left and she did not react. I regained her attention and explained what she needed to do upon my verbal commands.

-I started again with the command of left, Subject raised her right hand and failed to make contact with the tip of her finger to the tip of her nose by using the meaty portion of her finger.

I gave the second command of right and the subject raised her left hand and failed to make the correct contact with her nose.

-I gave the third command of left and she raised her right hand with the same previous nose contact.

-The fourth of left received no reaction.

-The fifth and final command of right also was used with the left hand and missed the tip of the nose by touching her nostril.

-On all attempts the subject failed to return her arm to her side and was repeatedly told to do so after clear instruction to do so automatically.

-Multiple commands were also given for the subject to keep her eyes closed as she opened them after each attempt.

Subject was taken into custody and medically cleared at Cleveland Clinic Indian River prior to transport to the Indian River County Jail for further processing.

While at the Indian River County Jail the defendant was asked to provide two lawful samples of her breath to determine its alcohol content by certified breath test operator D/S Shuren of the Indian River County Sheriffs Office on the intoxylizer 8000 instrument. The defendant consented and provided (2) separate samples of .000/210L and .000/210L. The defendant was then asked to consent to a lawful test of her urine to determine the presence of drugs to which she consented. Urine has been submitted to the FDLE drug lab for testing. A Drug Recognition Expert was available and the defendant agreed to speak with him. LT. Jaworski (Certified DRE #31515) responded to the Indian River County Jail and stated that in his opinion, Alyson Katana is under the influence of a narcotic analgesic. He further stated that Katana is unable to drive a vehicle safely.

Based on the totality of the circumstance, I found the defendant to be in violation of FSS 316.193 DUI Drugs (AJ5RM4E) and FSS 322.34 (2) DWLS With Knowledge (AJ5RM5E).

NARRATIVE

On December 13, 2024, at approximately 2122 hours I was dispatched to 4385 23rd Court in reference to an agency assist.

Upon arrival the suspect, Archelaus Boldes, was sitting in his in the driver seat of a white Toyota. Deputy Crawford was at the driver's side of the vehicle talking with Boldes. As I approached the vehicle, Deputy Crawford was giving Boldes a lawful order to exit the vehicle. Boldes was given multiple chances to exit the vehicle but refused. I also overheard K9 Deputy Le give several commands to Boldes to exit the vehicle. Deputy Crawford then removed Boldes from the vehicle with the assistance of Corporal Ruiz and myself. Corporal Ruiz secured Boldes in handcuffs. I then escorted Boldes to the side of K9 Deputy Le's patrol vehicle for a search. The search revealed two one-dollar bills in Boldes left front pocket. I then escorted and secured Boldes in the back of my patrol vehicle.

Deputy Crawford submitted a supplemental report (see the following statement);

"On December 13th, 2024, at 2105 hours, I was advised by Deputy McKenzie that VBPD had probable cause for Archelaus Boldes for aggravated battery. I was advised that Boldes was driving his own vehicle to which I personally know him to drive which is a white Toyota two-door Camry bearing FL tag 55ECBI.

While driving east on 43rd Street to Boldes's residence located at 4385 23rd Court, I observed the aforementioned vehicle to be stationary parked at 2411 43rd Street. I approached the vehicle and observed Boldes to be in the driver's seat on his phone with two additional passengers.

I asked Boldes what he was doing parked in front of the residence to buy time for other deputies to arrive on scene. Boldes refused to roll down the window as initially I could not hear him. Boldes became argumentative as I asked him to step out of the vehicle when additional units arrived on scene. I ordered Boldes to get out of the vehicle two additional times and Boldes refused. I then advised Boldes that I am giving him a lawful order and that he is detained and not free to go. Boldes continued being argumentative, refusing to exit the vehicle. Boldes was extracted from the vehicle by myself and Deputy Ruiz. While extracting Boldes, he tensed up his arm to further resist being taken into custody, all while yelling and arguing with law enforcement.

Boldes was taken into custody and transported to the Indian River County Jail by Deputy Ruiz.

Boldes's vehicle was locked and secured as his key and phone were dropped off at the jail.

Due to Boldes refusing to exit the vehicle to be taken into custody, he was charged with FSS 843.02 Resisting without Violence."

Corporal Ruiz submitted a supplemental report (see the following statement);

"Upon arrival I observed Deputy Crawford at the driver's side of a white 2007 Toyota bearing FL Tag #55ECBI and he was speaking with the defendant Archelaus Uriah Boldes. Prior to our arrival we were informed that the Vero Beach Police Department had probable cause for aggravated battery for Boldes. I overheard Deputy Crawford and K9 Deputy Le give several commands for Boldes to exit the vehicle. I also gave Boldes a verbal command to exit the vehicle and he refused.

Deputy Crawford and I pulled Boldes out of the vehicle and secured him in handcuffs. I informed Boldes that he was given a lawful order and that he needed to exit the vehicle, Boldes advised that it was not. Deputy Muszynski took custody of Boldes and secured him inside of his patrol vehicle."

Boldes was then taken to the Indian River County Jail. He was then transferred to Sebastian Police Department to be transported to the hospital to be medically cleared.

Due to the information and statements above, I found Archelaus Boldes in violation of Florida Statute;

• 843.02 Resisting officer without violence


