**NARRATIVE**

On Wednesday, April 8, 2026, at approximately 2004 hours, I was conducting patrol duties in the vicinity of the 2600 block of 17th Lane Southwest. I observed a white SUV bearing Florida license plate JY963U traveling westbound on 17th Lane Southwest without functioning headlights. I initially continued eastbound, then reversed direction to westbound, increasing my speed to catch up with the vehicle. A traffic stop was initiated around the 1300 block of 27th Avenue Southwest.

As the vehicle pulled over, the driver was observed moving within the front seat and did not come to a complete stop for approximately twenty feet after being on a side street with no traffic or hazards that would prevent a safe stop. I identified the driver as Mason Lamar Smith, based on his Florida driver's license. Deputy Good Rich arrived on scene and was requested to gather the remaining documents for the traffic stop, specifically Mr. Smith's registration and proof of insurance. I requested public dispatch to query for any wants or warrants associated with Mr. Smith.

Shortly thereafter, Deputy Good Rich approached my vehicle and provided a valid registration and an expired insurance card. I requested an up-to-date insurance card for the vehicle. Mr. Smith stated that the vehicle was not owned by him and belonged to his ex-wife, Amber Renee Mayor. I instructed him to contact Ms. Mayor to obtain proof of insurance. Upon calling Ms. Mayor, she stated she did not have active vehicle insurance. I informed her that without insurance, the vehicle could not be operated on public roadways, and it was subject to towing.

Due to company policy an inventory of the vehicle has to be completed prior to the vehicle being towed. I approached the passenger side and began the inventory and during the inventory of the vehicle and its contents, I discovered a large black bag on the front passenger floorboard containing two smaller tote bags. One of these tote bags contained prescription pill bottles bearing Mr. Smith's name. Underneath his prescribed medications, a silver metal pill divider with three different types of prescriptions was located. I approached Mr. Smith and read him his Miranda warnings, which he acknowledged and understood and agreed to speak to me. He confirmed that he was the sole owner of the black bag. When asked about the pills in the silver pill divider, he stated that they belonged to Ms. Mayor and that he was aware they were in his bag. I contacted Ms. Mayor, who confirmed that she had left the pills inside Mr. Smith's bag.

The pills were identified using Drugs.com's pill identifier as follows: [REDACTED]

[REDACTED] Both substances are controlled substances and are not prescribed to Mr. Smith. Inside the silver pill divider, a hard white substance was found; field testing confirmed it was fentanyl.

Mr. Smith was placed into handcuffs, and a search of the vehicle was conducted by myself and other deputies present. During the search of the center console, I discovered a clear plastic baggie containing two folded pieces of paper, each appearing to be stuffed with an unidentified substance. Upon opening the papers, the first was found to contain a hard white substance consistent with fentanyl, confirmed by field testing. The second paper contained a fine white powder, which also tested positive for fentanyl.

NARRATIVE

On Wednesday, 04/08/2026, at approximately 1935, I was dispatched to [REDACTED] in reference to a disturbance.

F.S 29.072(3)(a) & Florida Constitution, Article 1, Section 16 (b)(5)

Upon arrival I made contact with the complainant, Darryl Christopher Hyatt (identified by Florida driver's license) in the backyard of his residence. Hyatt stated that he has been in an [REDACTED] with Tracy Tori Jones and that [REDACTED] Hyatt stated he was in a loud verbal argument with Jones over issues in [REDACTED] and food. During the altercation, Jones struck Hyatt with a closed right fist hitting the left side of his face. Hyatt stated that when he [REDACTED] Jones left the residence on foot, travelling east from the residence.

I observed Hyatt to have redness on his left cheek as-well as swelling. I utilized Axon Capture to photograph the area.

On Wednesday, 04/08/2026, at approximately 2143 I responded to [REDACTED] in reference to a plotted 911 hang-up.

Upon arrival I saw Hyatt standing outside of his residence at [REDACTED] Hyatt advised me that Jones kicked down the garage door to the residence and was inside the bedroom. I made contact with Jones and informed her of her Miranda rights, which she voluntarily waived and agreed to speak with me. Jones stated she got into a verbal altercation with Hyatt over food but declined putting her hands on him. Jones was not cooperative with further questioning, when attempting to ask questions she would state that Hyatt is lying and constantly gets her arrested.

I placed Tracy Tori Jones under arrest for violating F.S.S. 784.03 – Battery – Domestic Violence.

While transporting Jones to the Indian River County Jail, Jones made statements that when she is released the sheriff's office would have to respond out for further incidents at [REDACTED] I did not engage or question Jones while she continued to yell in the back of the vehicle. Jones later made a statement, during a conversation with herself, that she pushed Hyatt and put her hands on him because she was upset about Hyatt throwing out the food she cooked.

Hyatt advised me there is extensive history of Domestic Violence between Jones and him. I was told by Hyatt that Jones had previously been arrested for striking him in the past. Upon further investigation I discovered Jones is on probation for aggravated battery against Hyatt (Indian River Clerk of Courts case# 2019-110585), which was confirmed when querying Jones through the Indian River County Sheriff's Office Public Safety Dispatch.

At the time of this investigation Jones had previously been adjudicated guilty for aggravated battery on



NARRATIVE

On Wednesday, April 9, 2026, at approximately 2202 hours, Corporal Thomas and I responded to [REDACTED] F.S 29.072(3)(a) & Florida Constitution, Article 1, in reference to a Disturbance.

[REDACTED] Section 16 (b)(5) Upon arrival, I made contact with Maurine Occeus, who stated the following in substance: [REDACTED] Richter Occeus. She was in the kitchen cooking food for herself. Her brother was also in the kitchen. She was standing in front of the utensils drawer making her food when Richter came and shoved her with his shoulder. She reacted by yelling and proceeded to hit Richter 3 times with a closed fist in the back of the head. He then attacked her, and put her in a choke hold. She was able to breathe, then attempted to get free from the choke hold by scratching at him. During the altercation, she fell to the ground and Richter was on top of her. She began receiving punches to the face, back of the head, and getting her hair pulled. She began to scratch multiple areas of Richter's body, causing him to remove himself from on top of her. She then ran to her room to grab her phone to contact her parents and law enforcement. She returned to the kitchen and saw Richter in possession of her tablet smashing it on the kitchen counter which caused the screen to shatter and body to bend. She went to grab her 13-year-old baby sister, who was sleeping in her room, to take her somewhere safe. She [REDACTED] to report the incident to law enforcement.

I made contact with Richter, who stated the following in substance: He was in the kitchen making himself something to eat. He needed a utensil from the drawer that his sister was standing in front of. He told his sister to move and reached over towards the drawer grabbing the handle and aggressively opening it. He then turned his head and felt his sister hitting him 4 times in the back of the head. He turned around to separate himself and shoved her away. He then pushed her a second time placing his hands on her shoulders, which caused her to fall on the floor. He then proceeded to make his food when he saw his sister run to her room and call their mother. He stated the tablet was broken during a separate incident, then changed his account and advised the tablet must have fallen off the counter during the altercation.

It should be noted, I checked Maurine for injuries. I observed swelling on both sides of her face, a scratch on her forehead, and swelling on her nose. I observed blood around her nose, and on her hands, which was consistent with her account of bleeding from her nose area.

I checked Richter for injuries and observed the following: Scratches on his upper chest, both sides of his body, the back of his arms, and shoulder area.

Additionally, Maurine's tablet was recovered and had extensive damage. The tablet screen was severely fractured, as well as the body of the tablet was bent and permanently disfigured. The damages observed were consistent with Maurine's account, and not consistent with simply falling from the counter top.

**NARRATIVE**

On April 9<sup>th</sup>, 2026, at 0014 hours, I was patrolling the area of 1163 Commerce Avenue, Vero Beach, Florida, when I observed a subject sleeping on the ground behind a closed business, partially concealed by a white van. As I walked around the van, I observed a black and green shopping cart bearing a Publix logo, a gray backpack, a green Publix bag, a white bag containing food items, and scattered trash around the subject.

I made contact with the subject, later identified as Michael Brian Dolberry. I asked Dolberry if the items belonged to him, and he stated that they did. I then advised Dolberry of his Miranda rights, which he stated he understood.

I asked Dolberry where he obtained the shopping cart, and he stated that he took it from Publix located at 1255 US Highway 1 earlier in the day and intended to return it later. Dolberry also stated that he was homeless and claimed that the Sheriff's Office should be investigating individuals who allegedly defrauded him of \$500,000, stating he had given the money to Nigerians.

Due to Dolberry knowingly possessing a shopping cart belonging to Publix (1255 US Highway 1) without authorization and admitted to removing it from the business. He was located off the premises with the cart. Based on the totality of the circumstances, Dolberry was taken into custody and charged with the following:

1. Possession of a shopping cart, in accordance with F.S.S. 506.509.
