On November 11, 2025, at approximately 2135 hours, I arrived at the intersection of 82<sup>nd</sup> Avenue and 12<sup>th</sup> Street, in reference to a crash. Upon my arrival, contact was made with the driver of one of the vehicles, later identified as Otoniel Perez-Vicente. Otoniel advised the following verbally:

Otoniel was driving a black 2012 Ford Focus that bore a Florida license plate of 80EWRZ. Otoniel said he was driving southbound on 82<sup>nd</sup> Avenue when the vehicle he was driving was struck by another vehicle. When Otoniel was asked to provide his driver's license, he said he did not have one and he was never issued one.

Otoniel went on to explain he is from Guatemala and he has lived in the U.S for approximately two years. Otoniel informed me in those two years, he never received a driver's license from any state and he did not possess a Guatemalan driver's license either, he only had an identification card.

An FCIC/NCIC search of Otoniel was completed via Teletype, which confirmed he did not have a Florida driver's license, nor did he possess a driver's license in any other state.

Based on the information above, I found Otoniel was in violation of F.S.S 322.03(1); no driver's license, never had one. Otoniel was arrested and was later transported to the Indian River County Jail without incident.

#### NARRATIVE

On November 10, 2025 at approximately 1318 hours, I responded to the 1285 US Highway 1, Carrabba's Italian Grill, in reference to an auto accident.

Prior to my arrival, public safety dispatch advised a red vehicle crashed into the rear of Carrabba's Italian Grill.

Upon arrival, I observed a red Toyota, Camry bearing Florida tag FIZS10, with heavy front-end damage, directly west of where the garbage cans are located, in the rear of Carrabba's Italian Grill. I observed a single occupant later identified as Melynnie Kutrufis, in the driver's seat with actual physical control of the vehicle.

I made contact with Melynnie and asked what had occurred, Melynnie stated "I was drunk driving" after this statement, I read Melynnie her Miranda Warnings prior to further questioning. Melynnie stated she understood her rights and was willing to answer further questions. When asked how the auto accident occurred, Melynnie was unable to explain what happened, she stated she did not know. Melynnie told me she was an alcoholic and she had consumed a pint of vodka. When asked if she had anything to eat with the liquor, she advised no. Melynnie stated she did not take any prescription or illegal narcotics, solely drank the vodka.

I requested to check Melynnie's eyes, she agreed. Due to now standing directly in front of Melynnie, I could smell a strong odor of an alcoholic beverage emitting from her breath as she spoke. Melynnie showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. Throughout the exercise Melynnie was unable to keep her head from moving, unable to keep her eyes completely open and was unsteady on her feet.

I asked if Melynnie would be willing to consent to further Standardized Field Sobriety Exercises, to which she refused. Melynnie was informed if she refused to submit to the exercises, her verbal refusal could be used against her. She advised she understand and still wished to refuse.

Based on my observations and Melynnie's admission to consuming vodka and operating her vehicle while intoxicated, Melynnie was placed under arrest under F.S.S. 316.193.3c1[374] DUI Damage to Property or Person. An inventory search of Melynnie's vehicle revealed and empty 375 ML of Skol Vodka. I asked Melynnie if that was the vodka she drank today, she advised yes. Due to being involved in an auto accident, I transported Melynnie to Indian River Cleveland Clinic for medical clearance. Upon receiving medical clearance, Melynnie was transported to the Indian River County Jail.

At the jail, D/S J. Kane requested Melynnie to submit to a lawful test of her breath for the purpose of determining its alcohol content. Melynnie refused to provide a breath sample.

#### NARRATIVE

On November 10th, 2025, at approximately 2021 hours, I was exiting Wawa onto US-1 located at 1180 US-1, Vero Beach, Florida 32960 when I observed a white SUV Volkswagen and two other vehicles driving at excessive high rates of speed in addition to weaving in and out of traffic. I activated my front facing radar and attempted to catch up with the three vehicles.

I was able to maintain visual on the vehicles while traveling southbound on US-1 at 100+ mph in attempts to catch up with the suspect vehicles.

I received a positive alert tone from my agency issued and tested radar and was presented a reading of 112 mph for the white SUV Volkswagen that was two cars in front of me that continued to weave through traffic. The speed limit for US-1 is 45 mph.

While at the stop light of 4<sup>th</sup> Street and US-1, I was able to read the white SUV Volkswagen's Florida license plate as RWVU01 that was approximately four cars ahead of me.

In addition to being stationary at the stop light, I was flagged down by a female driver in the adjacent lane to me who asked if I had seen the three vehicles that were driving recklessly. The female advised that she was almost ran off the road and was forced to jerk her wheel as she was afraid of being hit by one of the vehicles. Due to being briefly stopped at the stop light and still attempting to catch up to the vehicles I was unable to get the female's information.

As the light turned green to travel southbound, I continued to observe a reckless driving pattern from the white SUV Volkswagen including the vehicle to be quickly weaving lanes to get around cars and also following to close to vehicles.

I conducted a traffic stop on the white SUV Volkswagen at the 1800 block of US-1 South.

I made contact with the sole occupant and driver who identified himself as Milkis Lopez Duban. Dispatch advised that Lopez obtained a suspended drivers license that was suspended on 6/22/2025.

Lopez did not speak fluent English as I requested for Corporal Ballester to respond in reference to a Spanish speaker translation.

I was advised by Corporal Ballester that Lopez admitted to driving 120-130 mph and did not know the other vehicles that were recklessly driving with him.

Lopez was placed under arrest and transported to the Indian River County Jail without further incident.

Lopez was charged in violation of FSS 316.1922 Dangerous Excessive Speeding as Lopez:

Operated a motor vehicle in excess of the speed limit by 50 miles per hour or more which was 45 mph, travelling at 120+ mph in a manner that threatened the safety of other persons or property and interfered with the operations of

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 11/11/2025 09:25 On (Specifically include facts constituting cause for arrest.)

1, Officer Bannister, responded to 1005 21st Street, Citgo, in reference to a shoplifting/disturbance. Upon arrival, I witnessed both the complainant, Syed Raza, and the defendant, Pierre Fabrice, in an active physical altercation.

I separated both Raza and Fabrice from each other. Raza entered back into the business at this time. Fabrice was detained for further investigation. A female walked by and said something to myself and Fabrice, to which I did not here what she stated. Fabrice asked if I had heard her, and when I informed him that I had not, he began yelling and actively attempting to pull away from my control, while also attempting to turn his body towards mine. I was able to regain control of Fabrice against the hood of my cruiser. Once I attempted to move Fabrice towards the back of my vehicle, so I could investigate the incident that had occurred, Fabrice began actively yelling and attempting to pull away from my control. Once at the side of my cruiser, Fabrice began attempting to turn towards myself and other officers. Fabrice was then forced to the ground by his arms, in order to regain control of the incident. Once on the ground, Fabrice settled and officers were able to get him off the ground and into the back of my cruiser in order to investigate the shoplifting/disturbance that had occurred.

I made contact with Raza, who stated that Fabrice had taken a Flash Point Whiskey bottle, valued at \$2.25, out of the cooler and placed it in his pocket. When Raza confronted Fabrice about the bottle, Fabrice took the bottle out of his pocket and placed it on the counter. A verbal argument ensued, which then turned physical once Fabrice attempted to take the bottle back from Raza, by reaching across the payment counter and grabbing at Raza. A physical argument ensued until Law Enforcement arrived on scene.

Raza did have full video surveillance footage of the incident and the following is what I witnessed via the video footage. At 0915 hours, Fabrice enters the business and begins walking around the store. At 0917 hours, Fabrice grabs the whiskey bottle out of the cooler with his left hand. Fabrice is then seen walking around the store with the bottle in his left hand, visible via the red bottle cap sticking out of his closed fist. At 0917:49 hours, via his left hand, Fabrice is seen placing the whiskey bottle inside of the pocket located on the front of his hooded sweatshirt. At 0920 hours, Fabrice attempts to pay for various other items, excluding the whiskey bottle, which was still in his pocket at this time. Raza then confronts Fabrice about the bottle, and Fabrice is seen removing it from his pocket and placing it on the counter. Raza grabs the bottle and holds it in his left hand. A verbal argument ensues when Raza picks up a phone and calls for Law Enforcement assistance. During the argument Fabrice reaches over the counter multiple times in an attempt to take the whiskey bottle back from Raza. Fabrice grabs Raza's arm numerous times, before grabbing Raza and pulling him towards the counter. A physical altercation between the two ensued, but ended very shortly after. Raza then reaches behind the counter and retrieves a stick. A verbal argument continued and Fabrice walks out of the store and into the parking lot. Raza, still holding the stick, walks around from behind the counter, and follows Fabrice out into the parking, and a verbal argument ensued once more. At 0922 hours, Raza and Fabrice become face to face with each other. Fabrice then hits Raza, with an open left hand, on the right side of Raza's face, causing him to fall down and drop the stick. Fabrice then grabs the stick and is seen standing over Raza. A bystander intervened and the two parties were separated. Raza then reenters the store. A 0923:30 hours, Fabrice reenters the store and a verbal argument ensued again. Raza then approaches Fabrice and a physical altercation ensued in the doorway until I arrived on scene and intervened.

Fabrice was taken into custody and transported to the Indian River County Jail without further incident.

Fabrice was charged with FSS 812.014(3A) for the attempted theft of the whiskey bottle, FSS 784.03(1A1) for the Battery to Raza, and FSS 843.02 for resisting officer's, without violence.

Fabrice was also trespassed from this location.

#### NARRATIVE

On November 11, 2025, at approximately 1932 hours, I observed a white Acura MDX bearing Florida tag PC338E, operating without tag lights. Prior to initiating the traffic stop I conducted an NCIC/FCIC query of the aforementioned tag, and discovered it was not valid.

After observing the violations of Florida Statutes, I initiated a traffic stop in my marked agency issued patrol car on Interstate 95 southbound at MM 145. I approached the passenger side of the vehicle and made contact with the driver, later identified by his Bahamian Identification card, as Kevin Alexander Lightbourne. I requested Kevin's driver's license, proof of insurance, and registration. Kevin handed me the title of the vehicle, and his Bahamian Identification card.

As I was speaking with Kevin, I smelled the odor of burnt marijuana and observed several burnt marijuana cigarettes in an ashtray on the center consul. I asked Kevin if he had a medical marijuana card. Kevin advised he did not.

I waited for Deputy Lowell to arrive, and we removed Kevin from the vehicle. I asked Kevin to stand with Deputy Lowell at the front of the vehicle while I conducted my traffic stop.

During my query of Kevin, I discovered he had been cited on September 15, 2025, for fail to display vehicle registration-ALYN5TE, no proof of insurance- ALYN55E, driving while license suspended, revoked no knowledge- ALYN5RE, while driving the aforementioned vehicle.

A query of the Driver and Vehicle Information Database (DAVID), I discovered Kevin has never had a Florida Driver's License.

I exited my vehicle and approached Kevin and asked if he had ever insured the vehicle, he advised he has not.

I approached the vehicle to conduct a probable cause search, and discovered the following items of evidence;

#### Center Consul:

- 6 bags of individual packaged green leafy substance, that later field tested positive for marijuana. The marijuana field weighed 11 grams.
- 3 bags of individual packaged mushroom like substance, that later field tested positive for Psilocybin. The Psilocybin field weighed 2.96 grams.

#### Glove Box:

A loaded Taurus TCP 380 ACP SN: 66475E, I contacted TELETYPE and ran the firearm. TELETYPE informed me
the firearm was stolen out of Palm Beach County. A HIT confirmation was sent and received to Palm Beach County
Sheriff's Office.

I placed Kevin in handcuff restraints checked for proper fit, and put him in Deputy Lowell's patrol car. I read Kevin his Miranda warnings from my agency issued Miranda card, which he advised he understood and wished to speak with me. I asked Kevin if that was mushrooms in the bag, which he advised it was. I asked Kevin where he purchased the firearm, he advised from a guy on the street, he later informed me for \$200.00, but could not provided the individual's name.

On 11/12/25 at approximately 0248 hours, I, Officer W. Brumley, conducted a traffic stop in the 1900 block of 42nd Ave in reference to a male riding a bicycle without lights.

Upon approach, I explained to the male on the bicycle, later identified as Alexis Ramirez (defendant), the reason for the stop. The defendant consented to a search of his back pack, prior to searching the defendants bag, I conducted a pat down of the defendant to make sure he did not have any weapons on him. During my pat down, with my left hand I felt what I believed to be a glass pipe with a bowl on the end, which is usually used to smoke illegal narcotics from, in his left jacket pocket. When opening his left jacket pocket I observed a clear glass pipe with a bowl on the end containing white residue within. I then conducted a search of the defendants person and located a small clear baggie containing two white rock like substances.

Pre and post miranda, the defendant stated the white rock like substance was "meth" and he was going to take it to a friends house and smoke it from the glass pipe.

A field test of the two white rock like substances was conducted and had a positive reaction to the presence of Methamphetamine.

The defendant was placed under arrest for violation of FSS. 893.13(6A) Possession Of A Controlled Substance and 893.147 Possession Of Drug Paraphernalia. The defendant was transported to the Indian River County Jail without incident.

This event was captured on my BWC and uploaded to Evidence Library. The two white rock like substances and the glass pipe was submitted into evidence.
