NARRATIVE

On September 3, 2025, at approximately 0326 hours, I was dispatched to Behavioral Health Center, located at 1190 37th Street, Vero Beach, Florida, in reference to a battery.

Upon arrival, I made contact with Nurse Leila Ferguson who stated the following in summary; At approximately 2315 hours, Leila responded to Barbara Snipes Anderson's room in reference to disturbance. When she arrived at the room Barbara was trying to move furniture and arguing with her roommate. Leila said she tried to deescalate the situation, but was unsuccessful. During the incident Leila was struck twice in the head, scratched on her right wrist, and kicked in her left thigh, by Barbara.

After talking with Leila, I asked if there were any witnesses to the incident. Leila brought me to Dylan Seissiger who stated the following in summary; Dylan said when he arrived to Barbara's room, she was trying to move furniture out, and Leila was trying to deescalate the situation, which was unsuccessful. While Leila was moving the chair back into the room, Barbara struck her twice in the head, and when Barbara was trying to strike her a third time, Leila moved, causing the third strike to fall short.

After Barbara struck Leila, Barbara was placed in an isolation room, [REDACTED] After Barbara woke up, a loud noise was heard by staff. Barbara told staff she fell and hit her head.

Barbara was transported to Cleveland Clinic, where she was medically evaluated and released into my custody. I secured Barbara in handcuff restraints checked for proper fit and transported her to the county jail.

I took photographs of the two scratches on Leila's wrist, felt the lump on her head, but due to her wearing pants, I was unable to see any injuries on her leg.

It should be noted, Barbara's right knuckles appeared to be swollen, which would be consistent with striking someone with a closed fist. I photographed Barbara's right hand, and also her left hand for comparison.

This investigation is cleared by arrest.

This investigation was captured on my body worn camera.

NARRATIVE

On September 3, 2025, at 0328 hours, I responded to a 14410 US Highway 1, in reference to a suspicious vehicle. Prior to arrival, Deputy Davis and Sgt. Fricke were already on scene with a suspicious vehicle. Moments later a radio keyed up. Dispatch asked Deputy Davis and Sgt. Fricke if they were okay. A radio was heard keying up, but it was inaudible. Due to this units began to respond until someone on scene could advise they were okay.

Upon arrival, I observed two white males on scene along with Deputy Davis and Sgt. Fricke. The tall thin built white male in handcuff, was identified as Robert McPartlan Jr.

I was able to observe several oval orange pills scattered near the passenger door of gray sedan. Myself and Deputy Mangel began picking up the orange pills and placed them in a brown paper bag. Deputy Davis then conducted a search of McPartlan's person and placed him in the back seat of his patrol vehicle. A field test of the oval orange pills done by K9 Le showing positive for the presence of fentanyl. Due to the positive presence of fentanyl, emergency services to check on McPartlan's wellbeing.

Emergency services arrived on scene and asked McPartlan to exit the patrol vehicle to check his vitals. At this time, I was standing next to the rear right passenger door, where McPartlan sat and was exiting from. When McPartlan began to exit the vehicle, I was able to observe an orange object in McPartlan's hands. Having seen the orange pills earlier, I grabbed a hold of McPartlan and attempted to remove the object from his hand. McPartlan clenched his hand into a fist and pressure on his hand and thumb had to be applied. Oval orange pills began to fall from McPartlan's hands. Several clear plastic bags were removed from McPartlan's hands. Sgt. Fricke who came to assist me in removing the object from McPartlan's hand advised he was manipulating his hands in a way to crush the pills.

Deputy Mangel collected these pills and later advised additional pills; blue rectangular pills were also located amongst the oval orange pills that fell from McPartlan's hands. The orange pill is an oval orange pill with a dash down the middle (from top to bottom) with a 3 on the left-hand side of the pill and a 0 on the right-hand side of the pill. On the back of the orange pill is the letter B on the upper part of the pill and the numbers 974 below the B. This pill was identified as follows through Drugs.com: The pill with imprint b 974 3 0 (Orange, Oval, 12mm) has been identified as Amphetamine and Dextroamphetamine 30 mg and is used for ADHD, and Narcolepsy. It belongs to the drug class CNS stimulants and is classified as CSA Schedule 2 (High potential for abuse). A total of 184 orange oval pills were collected.

The second pill the blue rectangular pills had dash marks going from top to bottom with the marking B707 throughout the dash marks. The pill was identified as follows through Drugs.com: The pill with imprint B 7 0 7 (Blue, Rectangle, 15mm) has been identified as Alprazolam 2 mg and is used for Anxiety, and Panic Disorder. It belongs to the drug class benzodiazepines and is classified as CSA Schedule 4 (Some potential for abuse). There were two clear plastic bags containing these blue pills totaling in the amount of 30 broken up pieces of the pill and

Deputy Davis advised he and Sgt. Fricke were on scene behind the closed business, Penny Pediatrics, when a vehicle (the one observed on scene) pulled into the back parking lot of the closed business in a hurry. Deputy Davis's and Sgt. Fricke's marked patrol vehicles were clearly visible as the vehicle drove past them. The vehicle entered quickly into the back parking lot, pulled into a parking spot and backed out. The vehicle then quickly attempted to drive in the same direction it had entered from. Due to the time of day, the vehicle's odd behavior, a light was shine into the vehicle as it drove back towards deputies. The vehicle came to a stop and the passenger of the vehicle began leaning forward.

Deputy Davis advised he could see the passenger leaning forwards and his hand and shoulder going down pass the door. Deputies made contact with the vehicle and the passenger continued to reach forward and into the passenger door. The passenger was asked to stop reaching for any items. Deputy Davis advised after the driver was asked to step out of the vehicle, the passenger continued to lean forward and grabbed something. Deputy Davis advised he told the passenger to stop. Deputy Davis opened the passenger door to stop the male prevent the male from grabbing something. Deputy Davis moved the passenger back as he was leaned forward and was able to observe something in the passenger's hands. Deputy Davis did not know what the item in the passenger hand was. Deputy Davis stated "he had something cupped in his right hand". Deputy clarified he could not make out with the item was. The passenger then attempted to throw/move the item. Deputy Davis took the subject to the ground.

Once on the ground the passenger, identified later as Robert McPartlan Jr, refused to follow verbal commands from Deputy Davis and attempted to get up from the ground three times. McPartlan was eventually restrained. Deputy Davis informed me once McPartlan was taken to the ground he observed several orange pills scattering around.

I spoke to Sgt. Fricke. She informed me she was on scene with Deputy Davis. A vehicle barreled into the back parking lot of the closed business. The vehicle made a U-turn and in a hurried manner began leaving. Due to the vehicle's maneuvers, the time of day, the business being closed, a light was shined into the vehicle. Sgt. Fricke advised she was able to observed both subjects in the vehicle were not wearing any clothing (Medical clothing) that would suggest they belonged or were going to the closed business for a legitimate business purpose. Sgt. Fricke stated the passenger began nefarious behavior of him reaching around the vehicle lead her to believe the passenger had ulterior motive. Contact was made with the occupants. Driver was removed from vehicle. Sgt. Fricke was standing by with driver of the vehicle, when she overheard Deputy Davis. She turned to look and observed Deputy Davis and the passenger on the ground. The passenger, Robert McPartlan did not comply with verbal commands. McPartlan was eventually placed in handcuffs.

Sgt. Fricke informed me of what she observed when McPartlan was being seen by emergency services. Once outside of the vehicle and when I attempted to get the item out of McPartlan's hand, she described seeing

She commented this was the same action McPartlan was doing with the pills in his hand was he was on the ground refusing to comply with verbal commands. I was informed the driver of the vehicle was unable to provide legitimate reasoning for being behind the closed business.

McPartlan was placed under arrest and transported to the Indian River County Jail. Once at the jail, I was able to count the total all the pills located which resulted in 184 (orange oval pills) Amphetamine and Dextroamphetamine and 30 broken up pieces of Alprazolam 2 mg and 4 whole Alprazolam 2 mg pills (blue rectangular pills).

Once at the county jail, Deputy Magill assisted me with weighing all the Amphetamine and Dextroamphetamine pills. Deputy Magill advised the pills had a total weight of 75.23 grams weighed without the plastic bags.

Robert McPartlan Jr was charged 1 count for violation of F.S.S. 893.135 Trafficking in Fentanyl 4 grams or more, 1 count for violation of F.S.S 893.13 Possession of a controlled substance (Alprazolam), 1 count for violation of F.S.S. 856.021 Loiter or Prowl, and 1 count for violation of F.S.S. 843.02 Resisting without violence and 1 count for violation of F.S.S 918.13 Tamper with destroy evidence.

On September 3, 2025, at approximately 2119 hours, I responded to 660 S. US Highway 1, Vero Beach Florida, in reference to an intoxic.

Upon arrival, I observed a male later identified at Christopher D. Tenczar, on his back in the middle of the road, in actual physical control of his bicycle that was on top of his right leg. As I approached Tenczar, he moved the bicycle and attempted to get up but couldn't. I asked Tenczar what's going on and he stated that he's trying to go home but can't make it.

As I continued to interacted with Tenczar, I observed several physical signs of impairment: Tenczar had slurred speech that was very difficult to understand, he had red droopy watery eyes and was emitting a strong odor of an alcoholic beverage, from his person and his breath as he spoke. Tenczar stated that he was riding his bicycle home from miracle mile by 17th Street and US Highway 1, that is north of our location but he pointed south. Tenczar stated that he can't get up because he's intoxicated. I helped Tenczar get on his feet and moved him off the roadway. While helping Tenczar on his feet he was very unstable. I asked if he needed medical attention and he denied. I then read Tenczar his Miranda rights which he waived. Post Miranda Tenczar stated that he was riding his bicycle and he was drinking and alcoholic beverage.

I became concerned Tenczar was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Tenczar if he would participate in a series of standardized field sobriety exercises, to which he refused. Tenczar was advised because of his refusal I would have to make a decition based on the facts I have witnessed thus far. I also explained that his refusal could be used against his in a court of law. Tenczar understood and was arrested for DUI bicycle.

Based upon my investigation, probable cause exists that on September 3, 2025, Tenczar was in actual physical control of a bicycle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond their normal faculties, incapable of operating a bicycle safely.

Tenczar was arrested for DUI at 2144 hours and was advised of the charge. I took Tenczar into custody without incident and transported him to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Solomon advised me that Tenczar agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Tenczar had a breath alcohol concentration (BrAC) of .289 grams per 210 liters of breath, .300 grams per 210 liters of breath, and .289 grams per 210 liters of breath.

Due to Tenczar's BrAC concentration being .300, jail policy required he gets medically cleared. Tenczar was transported to Cleveland Clinic Medical Center, where he was cleared and released back to the Indian River County Jail.

Based upon my investigation, I find probable cause to charged Tenczar with the following:

1. F.S.S. 316.193.4 – DUI Bicycle .15 or higher. Citation #AM5W8GE, bond \$1000.
