NARRATIVE

On Monday, May 12, 2025 at approximately 0520 hours Sgt. Fricke responded to 4326 27th Avenue, Vero Beach, Florida 32960 in reference to a medical assist.

Upon arrival, deputies discovered that occupants within the residence had been involved in physical fight, resulting in injuries.

While the injured party was being escorted to the ambulance, Ms. Shan'taysia White followed in close proximity to deputies and law enforcement despite orders to the contrary.

Sgt. Fricke grabbed Ms. White to stop her from walking away from deputies as she was detained for the purposes of the investigation; as it was not yet determined what her role was in the physical fight. She began to pull away and resist Sgt. Fricke while attempting to place her in handcuffs.

Ultimately, due to Ms. White's interference with Sgt. Fricke's investigation and physical resistance, she was placed under arrest for Resisting without Violence F.S.S 843.02.

Due to shift change, Sgt. Fricke briefed me on her investigation and transfered probable cause to me.
