NARRATIVE

On May 13, 2026, at approximately 2256 hours, I responded to 4055 41<sup>st</sup> Avenue, Vero Beach Florida, in reference to a disturbance.

Upon my arrival, I made contact with Corrections Deputies Hiss and Loiseau, who informed me two female inmates were involved in a disturbance. Corrections Deputy Loiseau showed me video footage of the incident. I observed a female later identified as Sarah Ranson (suspect), stand up after using the restroom, pick up a black slipper, and thrown it at Lawaynedra Walker (victim), who was laying down. The video shows the slipper striking Walker on her right arm while she was holding a tablet. Correction deputies informed me, Walker got up, approached the cell door, and stated she wanted to press charges.

I made contact with Walker, who stated the following: Walker advised she was laying down watching her tablet while Ranson rambled on about an unknown subject that Walker was not interested in. Walker stated she raised the volume on her tablet as Ranson continued rambling. Walker stated she was then struck by a slipper. Walker further stated Ranson has tried to pick a fight for three out of the four days they have been in the same cell and believes it's because she's not interested in conversating.

I then made contact with Ranson, read her Miranda rights from my agency issued card, stated she understood and invoked her right.

Based on the video footage and Walker's statement, I find probable cause to charge Sarah Ranson with:

1. F.S.S. 784.082.3 – Battery by person detained in prison or jail facility. No bond. (F3)

NARRATIVE

On May 13<sup>th</sup>, 2026, at 0712 hours, I was dispatched to a disturbance at [REDACTED].  
 Upon arrival, I made contact with Shanita Paris, who stated there had been a disturbance during the night of 05/12/2026. She advised that she decided to take her children and go to her mother-in-law's house to create space between herself and her husband, Wesley Paris.

Shanita stated that at approximately 0630 hours this morning, her son dropped her off at the residence while taking the other children to their grandfather's house. While she was standing in the bathroom, Wesley exited the bedroom and began yelling, asking where the children were and where the car was. Wesley reportedly told her she needed to call their son to bring the car back because he was going to scrap the vehicle for \$300. Shanita advised she did not have cell phone service and was unable to make a phone call.

Shanita stated Wesley then made several threatening statements, including that he should punch her in the face and slap her. She further stated Wesley said he had no problem shooting her and the children and spending the rest of his life in jail.

Shanita stated she then walked into the living room area just outside the master bedroom in an attempt to make a phone call or send a text message telling her son not to return. At that time, Wesley allegedly grabbed her around the neck with both hands and pushed her against the wall. Shanita stated she had difficulty breathing but did not lose consciousness. She advised her neck was sore afterward.

Shanita further stated Wesley then threw her to the ground and hovered over her while stating he should hit her and demanding she put their son on the phone. She stated Wesley ripped the phone from her hands and attempted to unlock it but did not know the passcode. Shanita stated Wesley then turned his back, at which point she stood up, retrieved her phone, and attempted to unlock it to make a phone call.

Shanita stated she asked Wesley to let her leave to look for her son. Wesley allegedly told her she was not leaving the house until the children returned. Due to her lack of cell phone service, Wesley eventually agreed to let her leave to look for the children. Shanita then left the residence and [REDACTED] I later made contact with her at the county fairgrounds, where I conducted my interview.

I then responded to the residence and made contact with Wesley Paris. Wesley stated that at approximately 0600 hours, their son pulled into the driveway, dropped Shanita off, and then left. Wesley admitted they argued because he wanted their son to return to the residence so he could scrap the vehicle. Wesley also stated he was upset because their son had [REDACTED] and "gotten into their business," stating there was no reason to involve law enforcement. Wesley denied making threats or placing his hands on Shanita.

During my investigation and interview with Shanita at the fairgrounds, I observed one scratch near the carotid area of her neck and two additional scratches below the neck near the center of her chest below the collarbone area. All injuries were documented and recorded on my body-worn camera. Shanita continued to complain that her neck was sore.

Deja was transport to the Indian River County Jail without incident.





Upon arrival I met Ms. Ludmila Da Costa Braga (victim) who stated the following: Her ex-boyfriend Mr. Eduardo Do Nascimento came over to her residence which she currently rents. Eduardo told her he was hungry so she allowed him to come inside to grab something to eat. Ludmila noticed Eduardo was intoxicated, she then told him to leave. Eduardo then became verbally aggressive towards Ludmila, Eduardo then struck the wall inside the living room of Ludmila's residence, which resulted in a hole in the dry-wall. Ludmila screamed at Eduardo to leave that she was calling the police.

Ludmila stated Eduardo doesn't live at the aforementioned address, and they broke up approximately 2 weeks ago. Ludmila valued to damage to be approximately \$400.00 dollars.

Deputies made contact with Eduardo at [redacted] Eduardo was sitting on the curb drinking cinnamon whiskey, he then attempted to dump out the bottle and throw the bottle in the rain gutter. Eduardo was detained by Deputies on scene and placed in the back of my patrol vehicle. I then read Eduardo his Miranda Warnings, during which Eduardo continuously cut me off and spoke over me. After reading his Miranda warnings, Eduardo stated he understood his rights, but refused to answer any questions.

While completed a Trespass Warning Affidavit, Eduardo spontaneously uttered he punched a hole in the dry-wall of Ms. Ludmila's living room, but he would never hit Ms. Ludmila.

Ms. Ludmila completed and signed a written statement, and Trespass Warning Affidavit.

Eduardo was placed under arrest and transported to Indian River County Jail Complex.

Eduardo was charged with Criminal Mischief F.S.S. 806.13. and held on \$500.00 bond.

NARRATIVE

On Wednesday, May 13, 2026, at approximately 1951 hours, I was performing traffic enforcement in the 10300 block of US Highway 1, Sebastian, FL, when my Axon in-car camera indicated a License Plate Reader (LPR) hit.

The hit was on a gold, 2009 Toyota Avalon bearing FL tag RBRK47. The hit indicated the registered owner had a suspended FL Driver License, effective 04/20/2026, for failure to pay traffic penalty citation# AMO02OE. I confirmed the image captured by the camera correctly read the aforementioned FL tag. I also identified the vehicle traveling north on US Highway 1 was the vehicle indicated by the LPR hit.

I affected a traffic stop on the vehicle after it turned into the parking lot of 10730 US Highway 1, The Promenade. The driver and sole occupant of the vehicle, Daveon Lashawn Barron Jr., DOB 01/11/2004, was identified via the Florida Driver and Vehicle Information Database (DAVID). Barron provided me his FL DL which had the right upper corner cut off. Based on my training and experience, I knew this to be something law enforcement did to driver licenses when they were no longer valid, returning them that way instead of seizing them. Barron explained he was pulled over this morning (in Indian River County) and told his license was suspended, for which he stated he was issued a citation.

I queried Barron's information through Indian River Public Safety Dispatch and discovered Barron had not been pulled over or issued a citation today. He was stopped on May 2, 2026, and issued a written warning. At that time, the deputy cut his license and returned it. Barron had no other local wants or warrants.

When confronted with this information, Barron confirmed he had lied. He stated he had been stopped on May 2, 2026, when the deputy issued him a written warning for having a suspended license and cut the top right corner.

Based on the above-mentioned information, I placed Barron under arrest and transported him to the Indian River County Jail.

Barron was charged with the following:

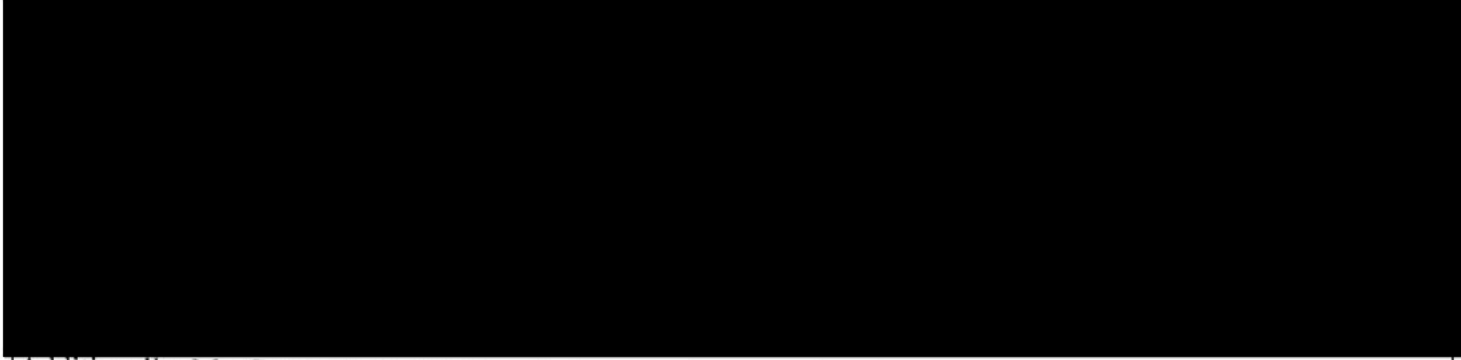
NARRATIVE

On Wednesday, May 13, 2026, at approximately 2101 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the 1100 block of 18<sup>th</sup> Avenue SW, Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I was patrolling the BP gas station located at 1999 9<sup>th</sup> Street SW. While there, I conducted an inquiry on license plate 61FZQD, which was attached to a white Dodge Ram pickup truck. The vehicle was registered to an older subject, who was not in or around the vehicle at the time I was driving around the area.

I conducted a local check with the registered owners address, to see who else the registered owner is associated with. During that time, I came across Mr. James Cooper, who has history at the same address. Upon looking at Mr. Coopers drivers license photo, I confirmed that Mr. Cooper was the driver of the vehicle.

Running Mr. Cooper in FCIC/NCIC, I found that he currently has a suspended Florida Drivers License. It is suspended for the following reasons:



Additionally, Mr. Cooper is on Felony probation, in reference to Leaving the scene of a crash with injuries, case number 2200903. Mr. Cooper has a probation term of 4 years, which expires on 07/11/2029.

Mr. Coopers drivers license states that he has received knowledge of the suspension, as it was either provided by UTC or court notice. Additionally, he has surrendered his drivers license and only possess a valid ID card for this state.

Mr. Cooper moved his vehicle from the gas pumps to a parking space in front of the store. He then walked inside the store. I was able to obtain another clear, unobstructed view of Mr. Cooper. After exiting the store, he went back and entered the vehicle from the driver's door. After waiting a minute, Mr. Cooper backed out of the parking space. While backing up, he had his window down. I could still see that it was Mr. Cooper driving the vehicle and that he did not have a seatbelt on as he started to pull away and go towards the exit of the parking lot.

After exiting the parking lot, I was able to catch up and conduct a traffic stop based on Mr. Cooper not having a valid license. Upon activating my blue emergency lights, the vehicle pulled over. Mr. Cooper was still not wearing his seatbelt and made no attempt to put one on.

NARRATIVE

On 5/13/2026 at approximately 2041 hours, I was dispatched to [redacted] in reference to a disturbance. The caller [redacted] Taylor Gardner was trying to beat [redacted] up.

When I arrived at the residence, I was met by [redacted] in the kitchen. [redacted] stated Taylor has [redacted]. This evening he noticed Taylor put clothing on top of a lamp in her bedroom that gets extremely hot. [redacted] asked her to remove the clothing from the lamp. Taylor refused, and [redacted] removed the lamp from the bedroom while she was in the shower.

I spoke with Patricia Warner [redacted]. Patricia said she saw the attack occur, and corroborated what [redacted] said was true.

[redacted] stated Taylor is [redacted]. [redacted] also confirmed that [redacted]. It should also be noted earlier in the day, dayshift responded to the address for a similar disturbance regarding Taylor being belligerent under agency Case# 2026-50488.

I made contact with Taylor inside her bedroom. It should be noted Taylor appeared to be in an altered [redacted]. I asked Taylor what was going on, and she said [redacted] and Patricia started "throwing hands." I asked Taylor what that meant, and she couldn't explain to me. I asked Taylor if she had any injuries or needed medical attention, and she said no.

At this time, I had probable cause to believe Taylor had committed a battery on [redacted] per F.S.S. 784.08.2(C).

I detained Taylor in mechanical wrist restraints, and escorted her to my patrol vehicle. Taylor was transport to the Indian River County Jail and booked under the following charges:
