#### NARRATIVE

On Wednesday, August 13, 2025 at approximately 0230 hours, I responded to a traffic stop of a reckless driver in the parking lot of the Wabasso Foods store located at 6375 85th Street in Vero Beach.

Mr. Kevin Picazzo had called into the dispatch center to report a reckless driver. Mr. Picazzo responded back to the scene and provided the following statement: Mr. Picazzo stated he was traveling East near the railroad tracks when he observed a vehicle quickly approaching him in the opposite lane of traffic. Mr. Piazzo stated the vehicle was traveling with no headlights and only a single flashing yellow light which he described as signal flashers. Mr. Picazzo stated the vehicle appeared to be driving in between the lanes and drifted towards him intentionally. Mr. Picazzo pulled over and

Upon my arrival, Deputy J. Martinez (6250) had located the vehicle and was speaking with the driver on the passenger side of the vehicle. Deputy Martinez stated he observed an open container of alcohol in the vehicle's center console and could smell alcohol in the vehicle. I opened the driver side door and instructed the driver to exit the vehicle. I identified the driver and sole occupant of the vehicle as Mr. Vernon Flowers (Arrestee) by the Florida driver's license he provided me.

While speaking with Vernon, I could see his pupils were extremely dilated (Mydriasis), he was sweating profusely. I explained to Vernon my suspicion he was impaired and requested he complete Standard Field Sobriety Exercises (SFSE's). Vernon was extremely paranoid and kept stating "Are you gonna fuck me up?" and "Please don't kill me man!"

I asked Vernon about his medical history

Vernon denied ingesting any other prescription medication or illegal narcotics. Mr. Vernon lost his balance and shuffled his steps to the left after he leaned off the bumper of Deputy Martinez's vehicle.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN). I explained the exercise to Vernon. Vernon could not track the stimulus and refused to cooperate with the exercise.

I then administered the Walk and Turn (WAT) exercise: I attempted to explain the exercise multiple times to Vernon but he refused to follow instructions and ultimately refused to attempt the exercise.

Vernon was given multiple explanations and provided a detailed Taylor warning. At one point during this investigation, Vernon stated "Just take me to jail man!"

Based on my training and experience, Vernon's behavior was very erratic and he displayed indicators and signs consistent with being under the influence of a CNS Stimulant.

Based on the above statements and observations of impairment, I placed Mr. Vernon Flowers under

arrest for Driving Under the Influence. Vernon was transported to the Indian River County Jail complex. During the transit, Vernon asked multiple times "Are you gonna kill me man?"
Upon arrival to the Jail complex, Vernon was profusely sweating and his veins were protruding from his forearms. During the booking process, Vernon's the normal range.
Vernon was taken in the DUI processing center by Deputy Shuren (5930). During this process, Vernon was very on edge. While standing in the orange box, Vernon was fidgety and was constantly manipulating his fingers. When Deputy Shuren requested Vernon to provide a sample of his breath, he stated he would comply, however Vernon refused to enter the Intoxilyzer room to provide a sample. The intoxilyzer timed out on Sample #1 and Vernon was advised of Implied consent by Deputy Shuren. Vernon again agreed to provide a sample, and walked into the Intoxilyzer room. Vernon ultimately refused to provide a sample and the process was terminated.
Vernon has a prior DUI conviction (UTC: 27775KE on 06/27/1984), and a prior Possession of Open container (UTC: 9549AWJ on 09/11/2003).
Vernon was charged with Driving Under the Influence (AJ8SWVE) and possession of open container (AF1V9QE).
Vernon was booked into the Indian River County Jail without further incident.

On	08/13/2025	, at	18:12	(Specifically include facts constituting cause for arrest.)

On 08/13/2025, at approximately 18:12 hours, VBPD officers responded to 2296 US-1 (7-Eleven) in reference to a shoplifting that had just occurred. Upon my arrival, I spoke with the clerk, Mr. Mount, and he advised me that a male suspect took a beer from the cooler and left the store without paying for the beverage. Mr. Mount advised that the incident just recently occurred, and he had interior surveillance footage pulled up to show me. The clerk allowed me to review the footage and pointed the suspect out to me in the paused footage.

I then reviewed the surveillance camera, which was time stamped from 18:07 hours on today's date. During my review, I observed that the suspect was a black male wearing dark shorts, black sandals, blue/grey hat, and a navy-blue shirt with yellow lettering. During my review of the footage, I observed the suspect approaching the beverage coolers on the north wall of the store. The male removes two large beer cans from the cooler and conceals these drinks in the front pocket of his shorts. The male then walks away and exits the store without paying for the merchandise.

At the conclusion of my review, the store clerk advised that the business would like to prosecute for the theft.

At approximately 18:20 hours, Officer H. Hogue (#468) located a male at 2202 US-1 (Flamingo Laundry) that possibly matched the suspect's description. I responded to her location and observed that she was out with the same subject that I observed on the store's surveillance footage. This subject was subsequently identified as the defendant, Jackie J. Parchment (B/M DOB 10/13/1955). Mr. Parchment was placed into handcuffs and advised of his Miranda warning. At the time of his arrest, Mr. Parchment had two personal bags that he claimed ownership of. Inside of one of the bags, two tall cans of "Budweiser" beer were recovered. These cans were ice cold with condensation formed on the entire can. Post-Miranda, Mr. Parchment admitted that he took these two Budweiser's from 2296 US-1. The total value of these two beverages was approximately \$4.00 in US currency.

Based on the facts above, Mr. Parchment was placed under arrest for petit theft from a convenience store. I then transported Mr. Parchment to the Indian River County Jail for booking and processing.

On August 13, 2025, I, Officer S. Gonzalez (471), responded to the Publix Super Market located at 415 21st Street in the City of Vero Beach, Indian River County, Florida.

Upon arrival, I made contact with the Victim, who stated he had ridden his bicycle to the store at approximately 19:15 hours. He secured the bicycle to a rack on the west side of the store's entrance before entering. When the victim exited the store approximately seventeen (17) minutes later, at 19:32 hours, he discovered his bicycle had been stolen.

The victim described the bicycle as a silver and black "Giant" brand bicycle, specifically a "Sedona" model, valued at approximately \$1,500.00. The victim also informed me that he wished to press charges.

The victim stated the store had surveillance video that captured the defendant stealing the bicycle.

After interviewing the victim, I made contact with store management, who allowed me to view the surveillance video.

In the video, I observed the Defendant walk up to the bicycle, defeat the security device used by the victim to secure it, and then ride off with the bicycle. I could clearly see the defendant's face in the video as he rode toward the security camera.

The Defendant was wearing a red hat with a pair of shield-style sunglasses with a white frame on the bill of the hat. Additionally, I noted the defendant was wearing a black shirt, gray pants, and had long hair extending from under the cap, as well as a robust goatee.

I immediately broadcast a local lookout over my police radio with a description of the Defendant and the bicycle as stated herein-above.

Shortly after putting out the local lookout, Corporal O. Dominguez (498) informed me over the police radio that he had observed the Defendant at the Walmart Neighborhood Market located at 1750 US-1 in the City of Vero Beach.

I responded to the Walmart by approaching on westbound 18th Street. As I approached the north entrance to Walmart off 18th Street, I spotted the Defendant walking toward the rear of the store and turning the corner.

I immediately pulled in and approached quietly to avoid alerting the Defendant to my presence, hoping he would lead me to the bicycle. However, by the time I turned the corner, I lost sight of the defendant but located the victim's bicycle leaning against a tree, which I then placed in the back seat of my patrol vehicle.

I informed Corporal Dominguez and Officer H. Hogue (468), who had responded to assist in locating the defendant, that I had lost sight of the Defendant.

Shortly thereafter, Officer Hogue encountered the Defendant in front of the CVS Pharmacy located at 1706 US-1.

I immediately responded to Officer Hogue's location and observed the Defendant standing behind Officer Hogue's vehicle.

I positively identified the Defendant as the individual I observed in the video stealing the victim's bicycle, as he was wearing the same clothes, including the red hat with the mirrored shield-style sunglasses on the bill of the hat.

I then took the Defendant into custody with the assistance of Officer Hogue and Corporal Dominguez. The Defendant had tensed up and was being uncooperative; however, I was able to take the defendant into custody, place him under arrest, and inform him accordingly without further incident.

I then transported the Defendant to the Indian River County Jail. Upon arrival, the Defendant complained of chest pain, necessitating medical clearance at the hospital.

On 14 August 2025, at approximately 0244 hrs, 1, a police officer for Sebastian, on routine patrol, observed a male sleeping on the park bench at 600 US HWY 1 ( Riverview Park).

As I approached the male, identified as John Gunnoe, I observed another male I know, Camron Cummins, get up from an adjacent bench and quickly walk away as I was speaking to John. I asked dispatch to check the status of Camron. Dispatched advised that Camron was trespassed from that location on 27 March 2025.

I asked Camron about the trespass, and he stated he didn't know he had been trespassed. At this time, placed Camron under arrest for the following charges:

FSS 810.09 Trespass on property other than structure or conveyance - Cameron willfully and knowingly trespassed at 600 US HWY 1 after being formally told by a law enforcement officer that he was trespassing on the location.

During a search of Camron's person and property incident to arrest, a small amount of marijuana was found inside his wallet. I confiscated the marijuana, photographed it, and submitted it to evidence for destruction.

Camron was transported to the Indian River County Jail without incident.
