NARRATIVE

On June 4th, 2026, at 1025 hours, I responded to 1135 10th Court SW, Vero Beach, Florida 32962 in reference to a reckless driver. Dispatch advised that a black male was driving recklessly up and down the street on a green dirt bike.

While driving southbound on 10th Court SW from Oslo Road, I observed a subject matching the description on the green dirt bike operating northbound on the public road way of 10th Court SW. It should be noted that the male was not wearing eye protection while operating the dirt bike.

I rolled down my window and requested that the male pull over to the side of the road and that I would like to talk to him. I did not maneuver my vehicle and stopped in the road way in the southbound travel lane.

I exited my vehicle and notified the male that we received a reckless driver call for him as he matched the description. The male advised that he was not driving recklessly and just got the dirt bike from his friend.

The male did not carry a valid driver's license on his person and further identified himself as Christian Green.

Dispatch advised that Green did not have an active driver's license and only had an ID card.

A query in a local data base provided findings that Green was arrested for driving with no valid driver's license on April 14th, 2026 (less than two months ago), reference case number 2026-39197. The original report included the dirt bike specs which showed the VIN to be JKBKXFCC5GA007680, further identifying the dirt bike as a 2016 KAWASAKI MOTORS LTD KX85 (84 cc) with no insurance on file.

The dirt bike was identified as a motor vehicle reference FSS 316.003(46) and (47) due to being gas powered, 84 cc, along with a Google search revealing the top speeds to be approximately 50 mph and over.

Green could not provide registration for the dirt bike to which I observed there no license plate on the rear of the dirt bike. A query in DAVID revealed that the dirt bike was unregistered.

Green was taken into custody and transported to the Indian River County Sheriff's Office Jail without further incident.



