NARRATIVE

On Thursday, March 20, 2025, at approximately 2030 hours, I was on uniform marked patrol, on 27<sup>th</sup> Avenue SW near 7<sup>th</sup> Street SW. I observed a 2006 White Chevy Silverado bearing FL Tag # 42DESX, with an attached trailer bearing FL Tag #CE1283. The vehicle made a left hand turn directly in front of me, cutting me off and cutting North bound traffic off. I conducted a stop on the vehicle at 7<sup>th</sup> Street SW and 27<sup>th</sup> Avenue SW.

I conducted a stop on the vehicle, subsequently making contact with the driver, Juventino Diaz. I explained the reason for the stop. I asked if he had his driver's license, registration and insurance. Juventino stated he does not have his license with him and admitting to it no longer being "good".

NARRATIVE

On March 20, 2025, at approximately 2052 hours, I responded to the area of 855 20<sup>th</sup> Place, Vero Beach, Florida, in reference to assisting Corporal Quaglia, ID# 6157, with a traffic stop.

Upon arrival, Corporal Quaglia advised he conducted a traffic stop on a silver Dodge Challenger (FL tag Z81DZT) in the area of 20<sup>th</sup> Street and US Highway 1, Vero Beach, in reference to the vehicle traveling northbound in the southbound lanes of traffic.

I then made contact with the driver and sole occupant, Mr. Michael Mangeot, who was identified through DAVID. I could smell the odor of an alcoholic beverage coming from the interior of the vehicle, Mr. Mangeot had watery, glassy eyes, and slurred speech, as well. While speaking with Mr. Mangeot, he stated he recently left "Rosie's" and had consumed multiple beers while there. Mr. Mangeot also stated several times he knew he should not be driving but was headed back to the bar to retrieve his wallet.

Based on my observations, I requested Mr. Mangeot exit the vehicle. As I continued to speak with Mr. Mangeot, the odor of an alcoholic beverage grew stronger. I then requested Mr. Mangeot perform Standardized Field Sobriety Exercises (SFSE's), to which Mr. Mangeot kept shrugging and would not advise if he would complete them or not. He then eventually stated he would perform SFSE's. During the medical questionnaire, Mr. Mangeot stated [REDACTED] but did not have any complications from it. He further stated he does not have any other medical conditions and does not take any medications.

The first exercise was the Horizontal Gaze Nystagmus exercise. As I began to explain the instructions for the exercise, Mr. Mangeot began rolling his eyes and stated that this would be a "failed test." He then stated he would do the exercise. During the exercise, I observed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees, in both eyes.

The next exercise was the Walk-and-Turn. As I explained the instructions for the exercise, and demonstrated it, Mr. Mangeot attempted to start the exercise before being instructed to do so, and was unable to keep his balance. He then stated he understood the instructions and did not have any questions. During the exercise, Mr. Mangeot took the wrong number of steps, stepped off the line, missed heel-to-toe, and made an incorrect turn.

The third exercise was the One Leg Stand. As I explained the instructions for the exercise, and demonstrated it, Mr. Mangeot attempted to start the exercise before being instructed to do so. He then stated he understood the instructions and did not have any questions. During the exercise, Mr. Mangeot put his foot down, used his arms for balance, and was swaying.

The fourth exercise was the Modified Romberg exercise. As I explained the instructions for the exercise, Mr. Mangeot attempted to start the exercise before being instructed to do so. He then stated he understood the instructions and did not have any questions. After completing the instructions, Mr. Mangeot estimated 30 seconds elapsed after approximately 20 seconds.

NARRATIVE (Continuation)

Additionally, during the exercises, Mr. Mangeot stated to Corporal Quaglia, "I'm fucked" and "I know where this is going."

Based on my observations, Mr. Mangeot was placed under arrest for the offense of driving under the influence (DUI). He was placed into handcuffs that were checked for proper fit and double-locked. While en route to the Indian River County Jail, Mr. Mangeot began moving around in the backseat of my patrol car and moved his handcuffs from behind him, to in front of him.

After arriving at the jail, booking staff requested Mr. Mangeot provide breath samples and stated he would not provide them. Mr. Mangeot was read Implied Consent but still refused.

Mr. Mangeot was issued two citations: driving under the influence (DUI) (citation #: AIE09EE) and refusal to submit (citation #: AIE09FE). Corporal Quaglia also issued Mr. Mangeot a written warning for driving on the wrong side of the road.

It should be noted, Mr. Mangeot has two prior DUI convictions from 2001 (citation #: 330184W) and 2007 (citation #: 1847XAJ). He also has a prior refusal to submit (citation #: 1847XAJ).

NARRATIVE

On Thursday, March 20, 2025, at 1858 hours, I responded to Carrabba's Italian restaurant, 1285 U.S. Highway 1, Vero Beach, Florida 32960, in reference to a disturbance. Communications advised a male was at the bar, highly intoxicated, causing a disturbance, and was refusing to leave the store.

CPL. Moon and I arrived at the aforementioned address, where we were met by the store manager, Kim Dell. Dell stated the male later identified as, Douglas Oehler, had entered the store and proceeded to the bar. Dell stated Douglas was causing a disturbance inside of the store as he was refusing to leave.

Dell stated Douglas was highly intoxicated falling asleep at the bar, and multiple customers approached staff stating it was making them uncomfortable. At that point, Dell approached Douglas asking him to leave the store to which he stated, "Fuck you, I'm not leaving." Dell stated she again asked Douglas to leave and he started to become belligerent refusing to leave the store.

Dell stated as [REDACTED] to have him trespassed, Douglas proceeded out of the store and took a seat on the bench in front of the store. CPL. Moon and I made contact with Douglas, who was immediately confrontational, and had a large black eye on his left eye, as well as, a bruised spot on the back of his head.

I requested Douglas provide me with his driver's license, and asked what had occurred between him and the staff. Douglas on multiple occasions attempted to hand me his debit/credit cards in lieu of his identification. I informed Douglas his cards were not his identification to which he stated, "Oh you're a fucking smart ass aren't you." Douglas was asked a series of questions in an attempt to gauge his cognitive awareness.

CPL. Moon asked Douglas what city he was in, to which he stated he was in Port St. Lucie, and was trying to get to Vero Beach. When asked again, Douglas stated he was in Port St. Lucie and became agitated due to his severe intoxication.

It should be noted that Douglas exhibited the following signs of impairment: Bloodshot-watery eyes, heavy odor of an alcoholic beverage, slurred speech, and emotionally unstable.

As CPL. Moon and I were placing Douglas into custody he was attempting to keep his hands separated in an attempt to prevent his arrest. SGT. Thimmer had to inform Douglas not to resist and to comply with our commands. CPL. Moon and I were finally able to place Douglas into custody, and began transporting him to my agency issued patrol vehicle.

Douglas began pulling away from CPL. Moon and I as we were escorting him to my patrol vehicle, shoving CPL. Moon into a sign that was in front of the restaurant knocking it over. When we arrived at my patrol vehicle, Douglas again began pulling away from the vehicle as I was attempting to conduct a search of his person prior to transport. Douglas also had to be pulled by CPL. Moon into my patrol vehicle from the opposite side as Douglas refused to enter on his own.

It should be noted that CPL. Moon, SGT Thimmer, and I were in our agency issued patrol uniforms, clearly identifying ourselves as law enforcement, and were conducting our lawful duties as such.

Due to Douglas creating a disturbance inside of the store, which effected their business, his refusal to leave when asked,

On 03/20/2025 at 18:47, at (Specifically include facts constituting cause for arrest.)

On 03/20/2025 at approximately 1847 hours I responded to 2001 US-1 (Walmart) in reference to a shoplifting in progress. While en route dispatch advised a white female is currently in the loss prevention office.

Upon arrival, I made contact with Loss Prevention Associate (LPA) Dawn Ethier who stated she was walking the sales floor when she observed a female, later identified as Katherine Leone Gordon, with several cut barcodes and a roll of tape in her hand. Ethier stated Katherine made multiple selections in the frozen aisle and proceeded to place the cut barcodes over the barcodes of the items, presumably to get a lower price point while at the register. Katherine proceeded towards the self-check-out where she was observed scanning the select merchandise. Ethier stated while observing Katherine's actions, she observed the items she was scanning were not the correct items appearing on the register screen due to the barcode placed on the item. Katherine then proceeds to the grocery exit, walking past all points of sale and making no attempt to purchase the items at full price. The merchandise recovered during this incident totaled to \$83.67.

I made contact with Katherine who was read her Miranda rights to which she stated she understood, although did not agree to speak with me on scene. Katherine made several comments regarding the ice cream she purchased, melting due to the investigation. Loss Prevention Associate Ethier stated to me, Katherine made a comment to her in regarding to children being inside of the vehicle. Once asked, Katherine disclosed to law enforcement she had [redacted] in the vehicle she arrived in. According to Katherine, she left the juveniles inside the vehicle intentionally without the car running, despite the juveniles requesting to leave the car on while Katherine went inside. Katherine stated she did not feel it was hot enough outside to leave the car on or leave the keys with the juveniles. It should be noted due to the Weather Channel it was approximately 82-85 degrees outside during the hours of 1700-1800 when Katherine arrived at Walmart.

PROBABLE CAUSE STATEMENT

Additional officers arrived on scene and located the two juveniles inside of a red Ford Truck bearing FL tag LBEE38 parked facing south in the first handicap parking spot, closest to the grocery entrance, in row 3. The above vehicle was registered to Katherine. Officer Irwin walked up to the passenger side door, and observed two [redacted] juveniles sitting in the vehicle. One in the back seat watching an electronic tablet and the other in the front seat looking at a cell phone. The vehicle did not appear to be running and all windows appeared to be rolled up, allowing no air flow into the interior of the vehicle. The juveniles appeared to not be moving, so Officer Irwin attempted to open the door, however, it was locked. The front seat passenger, immediately looked at Officer Irwin and opened the door at his request.

Immediately as the door opened, Officer Irwin stated he felt a rush of heat coming from the interior of the vehicle. He also immediately, noticed heavy moisture on the interior of all the windows, which I know to be caused from no air flow and buildup of carbon dioxide, and both juveniles [redacted] appeared to be sweating profusely. When Officer Irwin spoke to the front seat passenger, [redacted] appeared to be frightened and asked what was going on. Officer Irwin briefly informed of the above incident and asked if [redacted] could contact a guardian, which [redacted] did. Given the timeframe of approximately 1 hour, and that ambient temperature (85-82 Degrees) EMS was called to the scene to administer aid to the juveniles.

Further speaking to the juveniles, mainly [redacted] stated [redacted] had been in the vehicle for quite some time. When asked if [redacted] had the keys to the vehicle or the ability to turn it on and [redacted] stated [redacted] did not. Both Juveniles still appeared to be nervous about the situation.

EMS began treating the juveniles and determined all their vitals were within normal range. Sergeant Melius spoke to the juvenile's guardian and was given permission to release them to their temporary guardian.

After the juveniles were released, Katherine, called law enforcement over to the back of the patrol vehicle and waived her rights and began speaking to us about the incident surrounding the juveniles being inside of the vehicle. While speaking she explained she did not think it was problem leaving the juveniles in the vehicle as long as it was not running, further adding that the juvenile's parents do it all the time. I explained to Katherine how hot vehicles can get in Florida with daytime temperatures, using her patrol car as an example before Katherine got in the back of it. While sitting Katherine in my patrol vehicle, Katherine immediately requested the door to be open or the windows to be rolled down due to the extremely hot temperature. Katherine replied that the juveniles had the ability to open the door. I explained that with no air flow (Carbon Dioxide Buildup) and heat your body begins to shut down and one might not have the ability to open the door due to their normal faculties being impaired. Katherine still did not appear to understand how that could happen and stated they were fine.

While reviewing the cameras, it showed Katherine parking the above vehicle at approximately 1752 hours, and entering the store through the grocery entrance alone. Katherine is observed walking through several aisles and making several selections such as drinks, food, and miscellaneous household items. While traveling through the aisles, Katherine was observed taking several cut barcodes out of her purse and placing them on multiple items. The camera showed Katherine inside of the store for over 1 hour while shopping, where officers eventually discovered the juveniles at approximately 1858 hours.

At this time Walmart wishes to prosecute for the above amount (\$83.67).
