NARRATIVE

On Friday, July 11, 2025, at approximately 1318 hours, while on a Direct Patrol of Walmart, 5555 20th Street, I was advised by loss prevention of a shoplifting in progress.

Contact was made with Walmart Loss Prevention Employee, Jacob Parker, who advised of a female selecting items and concealing them in a bag she took off the shelf.

Myself and Parker were watching the female on live CCTV concealing the items into a bag. The female then exited Walmart on the general merchandise side, passing all points of sale with the stolen merchandise in hand.

Parker approached the female and identified himself. I identified myself and attempted to place the female, identified as, Amanda Perez, in hand restraints. Perez was pulling away from me, and tensing her arms and hands. I advised Perez to stop resisting and she kept tensing and pulling away from me. Utilizing a leg sweep technique, I brought Perez to the ground where I was safely able to place her in hand restraints.

Perez was brought to the loss prevention office where she was advised of her Miranda Rights and declined to speak to me.

A total of 20 general merchandise items, valued at \$155.46 were stolen/recovered.

Perez was placed in hand restraints and transported to the Indian River County Jail, where she was charged with petit theft and resisting without. Perez was turned over to jail staff without incidnet.

NARRATIVE

On Friday, July 11, 2025, at approximately 1843 hours, I conducted a traffic stop on a green Honda utility bearing Florida tag number RUKR39.

While sitting stationary at the 3600 block of 14th Street, I observed the suspect vehicle fail to come to a complete stop at the stop sign located at 37th Avenue and 14th Street. The vehicle traveled westbound on 14th Street. I then observed the suspect vehicle fail to stop at the stop bar at the stop sign located at 14th Street and 43rd Avenue. All four tires crossed the stop bar prior to the vehicle coming to a stop to then make a right hand turn northbound on 43rd Avenue.

After conducting the traffic stop I approached the driver of the vehicle and stated my name and authority and requested the driver's license, registration, and proof of insurance. The driver retrieved only a Mexican passport which identified the driver as Daniel Antonio Lopez Hernandez. I asked Hernandez if he had a Florida driver's license and he stated he did not. I asked him if he had ever been issued a driver's license and he stated he had not. I then asked Hernandez if he ever had a valid driver's license in any other state and he stated he did not.

The Public Safety Dispatch Unit conducted a query of Hernandez in electronic databases and confirmed there was no record for a driver's license in any state for Hernandez.

I subsequently requested Hernandez exit the vehicle and he complied. I placed Hernandez in mechanical hand restraints which were double locked and checked for proper fit. Hernandez was transported to the Indian River County Jail by Deputy Pollacek without incident for the following charges:

NARRATIVE

On Friday, July 11th, 2025, at approximately 1843 hours, I responded to reference to investigating electronic threats. (Statements are paraphrased)

Upon arrival, I spoke to the complainant, identified as Barbara Williams. Barbara said this past Monday night (7/7/2025), her 3-year-old daughter, named Kayla Helms, was at home with her. She said Kayla called her father, identified as Robert Helms III, and said that her stepfather hit her. Barbara said that this was not true and that she was never hit. This caused a dispute between Barbara and Robert over the phone, where Barbara hung up on him. This caused Robert to keep calling her, however, Barbara did not answer.

Due to her not answering, Robert began to send Barbara electronic records in the form of voicemails threatening to kill her and the stepfather. He sent several voicemails; however, two specifically outline Robert's threats.

In the first voice message he says "If that nigga want to motherfucking live you better tell that bitch as nigga to keeping his motherfucking hands off my daughter before I kill him". He then continued to make numerous statements insinuating he would kill the stepfather.

He then sent another voice message right after making more threats. In this voicemail, he is heard saying "I'll put both of yall bitches down". He then proceeds to clearly make a threat to kill Barbara by saying, "my child said that fuck nigga put his Hands on her I'm going to kill you and his pussy ass". It is important to recall she said her daughter was never struck and that she was at home with her siblings. Based on this, I determined Robert's response and death threats were not warranted or justified in any way.

Barbara identified the voice in the electronic messages as Robert and also the phone number of 772-404-4787 sending them as Robert's. She said these threats are putting her in fear that he would harm her.

Deputy Ballester arrived at Robert's residence of 1536 25th Street SW in the Vero Beach Highlands. He arrived and stood by Robert until I arrived. I arrived at Robert's house to speak with him, where post Miranda, he said did not recall making these statements but that he may have said some of these things out of anger. When I was with him I asked him for his phone number, which was the same phone number as the one sending the voicemails.

From my investigation, I determined Robert distributed an electronic record, which contained audio communicating he would inflict bodily harm or death to Barbara. As stated above, the two share a 3-year-old daughter together.

I charged Robert with violation F.S. 836.10.2a Written or Electronic Threat to Kill or do Bodily Injury. Robert was transported to the Indian River County Jail.

NARRATIVE

On Thursday, July 11, 2025, at approximately 2022 hours, Deputy D. Estrella (6212) and I were on patrol in the area of 1700 U.S. Highway 1, Vero Beach, Indian River County, Florida, 32960.

As we travelled southbound on U.S. Highway 1, I observed a black 2013 Dodge Journey, bearing Florida tag IH75CT, travelling northbound with only one headlight illuminated. We turned around and travelled northbound behind the vehicle. As the vehicle continued driving northbound, the driver pulled into the center lane and continued to drive over solid double yellow lines before entering the designated turn lane. As the vehicle turned westbound onto 17th Street, I initiated the emergency lights on my marked patrol car and conducted a traffic stop.

The passengers of the vehicle were identified, via the same method, as Mr. Dana Schlager and Ms. Kristina Grant, neither of whom had a valid driver's license.

I issued Mr. Grant three (3) uniform traffic citations in reference to the infractions (AKFRRBE, AKFRRCE, and AKFRRDE).

Based on the above, it was determined Mr. Grant did drive a motor vehicle upon a highway in the State of Florida without a valid operator's license issued by the State of Florida.

Mr. Grant was arrested and transported to the county jail without incident.

NARRATIVE

On Friday, July 11, 2025, at approximately 2248 hours, CPL. Moon and I were conducting radar traffic enforcement at mile marker 152 on Interstate 95, whereas I was monitoring southbound traffic. I observed a small black sedan approaching at a very high rate of speed and visually estimated the vehicle at 115 miles per hour. I activated my agency issued Stalker DSR 2X radar unit which confirmed the vehicle was traveling at 111 miles per hour in a posted 70 mile per hour zone.

CPL. Moon notified communications of the black Ford Mustang's reckless driving behavior as it continued past us at 111 mph and shifted between two vehicles in rapid succession. CPL. Moon and I were able to catch up to the Mustang at MM 148 Southbound, and initiated a traffic stop on the Mustang convertible.

It should be noted under Florida State Statute, 316.1922(1)(B), the driving behavior exhibited by the driver of the black Ford Mustang convertible, Omar Yesid Conde Morales, was qualified as "Super Speeder."

I made contact with Omar at which point he was ordered out of his vehicle, and was subsequently placed into handcuffs and double locked.

It should be also noted that while I was detaining Omar, two small children were observed in the rear passenger seat of the vehicle. It was brought to my attention that Omar is a Columbian National who was in the area for vacation under a travel Visa. Omar's wife, Yesmith Pinto, informed me the juveniles were as follows

Based on the above stated facts, due to Omar's high rate of speed, the road conditions due to recent rain, and the fact he was weaving through traffic, he knowingly placed both minors, himself, and his wife in imminent risk of bodily harm. In doing so, Omar was also operating his vehicle in excess of one-hundred miles per hour which is classified as a Super Speeder in the State of Florida.

Due to the above facts and circumstances, I find probable cause to charge Omar Morales with the following:

Count 1 & 2: Child Abuse, for conducting an intentional act that could reasonably be expected to result in physical or mental injury to a child, and the fact that two juveniles of tender age were present during the incident in the rear seat of the vehicle.

Count 3: Super Speeder pursuant to F.S.S. 316.1922(1)(B), For Dangerously operating his Motor Vehicle in excess of 100 miles per hour, which threatened the safety of himself and others.

NARRATIVE

On July 12th, 2025, at 1748 hours, I responded to the 400 block of 27th Avenue Southwest, Vero Beach, Florida, in reference to a traffic stop conducted by Sergeant Fricke.

Upon arrival, I observed a white male, later identified as Joseph R. Archer, the driver of a blue Mazda bearing Florida tag #CP22MU, and a white female, later identified as Desiree L. Brosious, the passenger. Both subjects were detained and separated.

Sergeant Fricke advised that prior to the traffic stop, she was parked at the 100 block of 27th Avenue Southwest when she was approached by a civilian who reported a physical disturbance between the occupants of the aforementioned vehicle.

Sergeant Fricke stated that while calling out the traffic stop on the radio, she observed Desiree in the backseat striking the driver multiple times while the vehicle made sudden jerking motions left and right. Upon stopping the vehicle, both subjects exited and were detained. Sergeant Fricke advised that she read Desiree her Miranda rights, which Desiree stated she understood and waived.

While interviewing Desiree, she repeatedly stated that she could not remember the incident due to being "blackout drunk." Desiree recalled drinking throughout the day and visiting Speakeasy Bar in Vero Beach, where she and Joseph had a verbal argument. She stated Joseph left her at the bar but later returned. Desiree indicated this incident may have escalated tensions inside the vehicle. She further admitted to moving to the backseat during the drive because she did not want to exit the vehicle when Joseph asked her to. Desiree also admitted to pouring a tea can over Joseph's head and onto the vehicle's seats "just to be an asshole."

Sergeant Fricke informed me that Joseph stated they were arguing inside the vehicle when Desiree struck him multiple times with her fists and a beer bottle. Joseph pulled over and told Desiree to exit the vehicle. Although Desiree initially complied, she immediately reentered through the backseat. Joseph said that as he continued driving, Desiree resumed striking him, which coincided with Sergeant Fricke initiating the traffic stop. Joseph denied ever striking Desiree, even in self-defense.

Desiree confirmed that she and Joseph are not married but have been in an intimate relationship for six to seven years and

She stated that she moved to the west coast of Florida in January but returned to be with Joseph.

Based on the above information, I placed Desiree L. Brosious under arrest for battery domestic battery, in violation of F.S.S. 784.03(1)(a)(1). She was transported to the Indian River County Jail without incident.

NARRATIVE

On July 12th, 2025, at approximately 2021 hours, I responded to T-Mobile, located at 6350 20th Street, Vero Beach, Florida, in reference to a possible intoxicated person.

While en route, Indian River County Sheriff's Office (IRCSO) dispatch advised that a possibly intoxicated male was seated in a white Toyota Corolla parked on the side of the business. As I was arriving at the location, I witnessed a black male exit the driver's side front seat of a white Toyota Corolla (bearing FL tag 48AQMH) and walk to the side door of T-Mobile. The male appeared unsteady on his feet, as well.

I then made contact with the male, identified as Mr. Trevin Mayronne by his Florida-issued driver's license. Mr. Mayronne had red, watery eyes and I could smell the odor of an alcoholic beverage coming from his person. As I began speaking with Mr. Mayronne, he had slurred speech and the odor of an alcoholic beverage grew stronger.

I attempted to speak with Mr. Mayronne and he became uncooperative. He then requested to smoke a cigarette and I advised that he could not. He then attempted to walk towards the driver's side of the vehicle. I instructed Mr. Mayronne not to walk away or enter the vehicle. Mr. Mayronne continued to walk towards the driver's door and attempted to open it. At that time, I detained Mr. Mayronne due to concerns he may attempt to drive away or retrieve a weapon or unknown object from the vehicle.

I attempted to ask Mr. Mayronne if he would complete Standardized Field Sobriety Exercises (SFSE's), however, he was argumentative and would not advise if he would complete them.

I then made contact with the T-Mobile store manager, Mr. Jose Vazquez. Mr. Vazquez stated he was concerned Mr. Mayronne had been consuming alcohol at work. He explained Mr. Mayronne had been acting strangely and he could smell alcohol on Mr. Mayronne's person. Mr. Vazquez subsequently instructed Mr. Mayronne to take a break. Mr. Vazquez advised that Mr. Mayronne did not return from his break after an hour and a half so he, and other employees, attempted to call him. After Mr. Mayronne did not answer the phone, Mr. Vazquez went outside and located Mr. Mayronne seated in the driver's seat of the vehicle. Mr. Vazquez stated that he attempted to bang on the window to get Mr. Mayronne's attention, but stated he was unsuccessful. Mr. Vazquez stated that Mr. Mayronne then exited the driver's side of the vehicle as I was arriving on scene.

It should also be noted, as I was placing Mr. Mayronne into handcuffs, I could feel that the hood of the vehicle was still very warm, indicating that the vehicle had recently been running. Additionally, the windows had condensation on the inside from the AC running inside the vehicle.

Mr. Mayronne was placed under arrest for the offense of DUI. He was transported to the Indian River County Jail, without incident.

After arriving at the Indian River County Jail, booking staff requested Mr. Mayronne provide a breath sample to determine its alcohol content, however, Mr. Mayronne refused. Mr. Mayronne was read Implied Consent and he still refused.

NARRATIVE

On July 12th, 2025, at approximately 2156 hours, Corporal M. Ruiz and I were dispatched to Target (5800 20th St., Vero Beach) for a report of a shoplifting. Dispatch advised the suspect to be a male wearing a blue shirt, jeans, and camo hat. Dispatch advised the reporting party, who was identified as Hayden Davies (Target Loss Prevention), stated the suspect was walking toward 20th St. Hayden reported the suspect was taking stolen merchandise out of his pants, while the suspect was walking towards 20th St.

Cpl. Ruiz and I would arrive quickly. We began to look for the described suspect Westbound side of 20th St. Ultimately, Deputy Barrientos would locate a party matching the description on the Eastbound side of 20th St. in the Chipotle Parking lot. The subject was detained in the parking lot of Chipotle. He was later identified as James Szaz. Cpl. Ruiz and I would back Dep. Barrientos up, where I observed the suspect. James was wearing a blue collared short sleeve shirt which had a Florida Gators logo on the front left side. He was wearing blue jeans, and white sneakers.

Cpl. Ruiz and I would respond to Target where we spoke with Hayden within the Loss Prevention Office. He would show us security camera video, which I identified to be James. James was observed through the camera system walking into the baby section, where he appeared to take a baby monitor off the shelve. He then walked down another aisle, where he would remove the spiderwrap on it, which is an anti-theft device. James would walk around the store, where it was observed on camera that the spiderwrap was removed prior to James shoving the baby monitor box down his pants. James concealed the stolen item within his pants and passed all points of sale. James was not observed paying for the item. Hayden was provided an Axon community link, where he would upload the video evidence for the case.

Hayden would agree to conduct a show up. Hayden was escorted to Cpl. Ruiz's agency vehicle. He sat in the rear driver's side, where I would read him the show up instructions from the agency issued show instructions card. Hayden was then driven to Chipotle where the show-up was conducted. A positive identification was made by Hayden.

I would park the vehicle, where I went to speak with James. I would read James his Miranda rights from my agency issued card, where he stated he understood. James was asked where the stolen items were, which he indicated his red backpack. Within the backpack was an Owlet Dream Sock. This item was later identified to have a value of \$299.99 USD by Hayden. I was informed by Dep. Barrientos that he located an anti-theft device within Jame's front left pocket. This item is a black piece of plastic, with magnets on it, which is designed and meant to disarm retail safety devices.

NARRATIVE

On Sunday, July 13, 2025, at approximately 0053 hours, I was patrolling the Gifford area when I observed a vehicle in a known narcotic area. The vehicle I observed was a black Chevrolet truck. The truck was facing east. I relayed the vehicle information to D/S Le who was just north of the vehicle location. D/S Le advised the vehicle left the narcotic area, came onto 31st Avenue without the vehicles lights on, and traveled northbound on 31st Avenue, passed by D/S Le and he also observed the occupants to not be wearing seatbelts. The vehicle made it to 45th Street and continued westbound. D/S Le conducted a traffic stop in the 4500 block of 32nd Avenue.

I arrived on scene and made a passenger approach to the vehicle. At the vehicle, I observed a clear plastic sand which baggie that was ripped on the driver's lap. Through my training, knowledge, and experience, I knew the type of baggie to be commonly used with narcotics. I also observed in the cup holder of the vehicle another clear plastic sand which bag that I believed to contain Marijuana seeds. D/S Le had Davis step out of the vehicle and he located a second clear plastic bag that contained Marijuana. I observed the bag and I also confirmed the contents to be Marijuana due to my training and experience. The driver, later identified was Tyrone Davis, which is 18 years of age. A second occupant was in the vehicle, which was later identified as Zaniyah Thomas, was also asked to step out of the vehicle.

Due to locating the Marijuana and observing the Marijuana seeds inside the vehicle, a search of the vehicle was conducted. In the back seat floorboard of the vehicle, which was behind the center seat. I located a gray backpack. As I opened the rear pouch of the backpack, which was not zipped shut, I observed an extended magazine that was inserted into the handgun. Due to locating this, Davis was placed into handcuffs. I went back to the vehicle and observed a second long gun that was under the backseat and not properly secured in any type of bag or storage device. Next to the rifle, I observed a third handgun that had an extended magazine inserted into it, which also was not properly secured in any type of bag or storage device. The firearms were made safe. The rifle and one of the handguns, a Taurus, had a round chambered. The firearms were ran through Public Safety Dispatch (PSD) and I was advised the rifle was stolen and reported out of this county, reference case number 2021-1569. Also located inside of the vehicle was various ammunition and an empty handgun magazine. Nothing else was located inside of the vehicle.

I read Thomas her Miranda Warning to which she acknowledged she understood. Thomas advised the she did not know the firearms were inside of the vehicle and that they were not hers.

I read Davis his Miranda Warning to which he acknowledged he understood. I explained the reason for the stop and me observing the clear plastic bag on his lap and the bag of Marijuana seeds in the cup holder. Davis agreed. I questioned Davis about the items located inside of his vehicle. Davis advised that he likes guns and that he's hurting anybody. Davis advised and acknowledged the rifle under the seat. When I advised Davis that the gun was stolen, he advised that he did not know it was stolen. When Davis was informed about the stolen firearm and the two handguns, Davis advised that he goes to the range with them. Davis was questioned on where he purchased the rifle and he advised "somebody".

Due to locating the Marijuana, observing the Marijuana seeds inside of the vehicle, a probable cause search was conducted which located three firearms. Due to Davis not having the firearms properly secured and readily accessible, Davis was

NARRATIVE

On July 13th, 2025, at approximately 0156 hours, I was traveling westbound on 20th Street near 58th Avenue, Vero Beach, Florida.

At that time, I witnessed a black Jeep Wrangler (bearing FL tag RAKC50) traveling westbound in front of me. The Jeep was traveling in the center lane and was unable to maintain a single lane - the driver's side wheels crossed the dotted white lines into the left lane numerous times, and the passenger side wheels crossed the dotted white lines into the right lane numerous times.

Based on my observations, I conducted a traffic stop on the Jeep in the area of 6600 20th Street. I activated my red and blue emergency lights; however, the vehicle continued traveling westbound. I subsequently activated my siren, and the vehicle eventually stopped in the 7000 block of 20th Street.

I made contact with the driver, and sole occupant, Mr. Preme Bresil. Mr. Bresil appeared disoriented and slow to respond. When I requested Mr. Bresil's license, he appeared confused and was slow to hand it to me. He then asked if I wanted his registration and I stated yes. Mr. Bresil then stared at me without attempting to locate his registration. When I asked Mr. Bresil where he was coming from, he stated Kissimmee. When I asked where he was going to, he again stated Kissimmee. I again asked Mr. Bresil where he was coming from and he eventually stated Vero Beach.

Based on my observations, I requested Mr. Bresil exit the vehicle. I then asked Mr. Bresil if he would complete Standardized Field Sobriety Exercises (SFSE's), and he stated he would. During the medical questionnaire, Mr. Bresil stated he does not have any medical issues and is not taking any medications. He advised he does not have diabetes. Mr. Bresil stated he does wear eyeglasses.

The first exercise was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions and Mr. Bresil stated he understood and did not have any questions. During the exercise, Mr. Bresil did not follow directions and kept looking away. I attempted to complete the exercise numerous times; however, he continued to look away.

The next exercise was the One Leg Stand exercise. I explained the instructions and demonstrated the exercise and Mr. Bresil stated he understood and did not have any questions. Mr. Bresil then lifted his left leg and was using his arms to keep balance. After several seconds, Mr. Bresil put his foot down and stated he could not complete the exercise.

The next exercise was the Modified Romberg exercise. I explained the instructions and demonstrated the exercise and Mr. Bresil stated he understood and did not have any questions. During the exercise, Mr. Bresil's eyelids were fluttering, he appeared to have body tremors, and he was swaying. Additionally, I stopped the exercise after 70 seconds.

Based on my observations, I placed Mr. Bresil under arrest for the offense of DUI. He was placed into handcuffs that were checked for proper fit and double-locked. He was transported to the Indian River County Jail without incident.

NARRATIVE

On Sunday, July 13th, 2025 at 0150 hours I was inside the Wawa Gas Station, which is located at 1180 US Highway 1, when I observed an employee of the Wawa attempt to stop a shoplifter while leaving the store. The suspect, who was later identified as George Grawe, failed to listen to the employee and continued to walk out of the store, passing all points of sale.

I then attempted to make contact with Grawe however he continued to walk away from me as I tried to get his attention. I then grabbed Grawe and attempted to place him in handcuffs however he tensed his body and restricted his movement. Grawe then continued to attempt to release himself from my grasp. Shortly after, I was able to place Grawe in handcuffs. While waiting for additional units to arrive on scene, I had placed Grawe against the window of the Wawa. Grawe proceeded to keep attempting to flee from my grasp. Grawe then kicked my left knee and used his head to hit me in the forehead, in which I then proceeded to take Grawe to the ground. It should be noted that during this incident I was wearing my Indian River County Sheriffs Office Class C uniform, which identifies me as Law Enforcement.

Prior to placing Grawe in the back seat of my marked patrol vehicle, Grawe attempted to bite Corporal Hattons finger while he was taking a picture of his injury. While doing so, Grawe struck Corporal Hatton in the finger with his mouth. Grawe was then placed in the back of my marked patrol vehicle.

Corporal Thomas then made contact with the aforementioned employee, identified as Amanda Phillips, who provided him with a receipt of the stolen merchandise. The following is a list of the stolen items and their value:

- FL Doritos Sweet and Tangy \$6.29
- FL Lavs Classic \$2.69
- Caesar Salad Chicken \$6.99
- Twisted Tea \$3.79

The total amount of the items was \$20.03.

This incident was captured on the stores camera system however they were not able to access through it at this time. The video camera footage will be obtained via follow up.

NARRATIVE

On July 13, 2025, at approximately 0445 hours, I observed a gray Toyota bearing Florida tag L1QXA, run a stop sign at 43rd Street and 28th Avenue. I measured the vehicle's speed at 52-mph in a 30-mph zone through the residential neighborhood, with my Stalker radar as it proceeded north on 28th Avenue. The vehicle ran the stop sign at 28th Avenue and 45th Street, as it made a right-hand turn and proceed east on 45th Street.

Due to the vehicles speed through the neighborhood and the continued running of stop signs, I was unable to initiate a traffic stop prior to the vehicle entering the parking lot of Cumberland Farms, located at 4490 US Highway 1, Vero Beach, Florida. As I approached Cumberland Farms, I observed the occupants exiting the vehicle and entering the store.

I took up a position of surveillance on the vehicle in the parking lot across the street, located at 2170 45th Street, Vero Beach, Florida.

The vehicle ran the stop sign as it left the parking lot of Cumberland Farms and proceeded west on 45th Street, at a high rate of speed.

Prior to initiating a traffic stop the vehicle made an abrupt left-hand turn, and proceeded south on 26th Avenue. Believing the vehicle was going to return the same direction I first observed it, I proceeded west on 45th Street, and made a left-hand turn on 28th Avenue, and proceeded south in an effort to better observe the vehicle from a stationary position. I stopped at 28th Avenue and 44th Street and faced south on 28th Avenue.

I observed the aforementioned vehicle run the stop sign as it made a left-hand turn from 43rd Street onto 28th Avenue as it proceeded south on 28th Avenue. As I accelerated towards the vehicle to initiate a traffic stop, I observed the vehicle miss the right-hand turn onto 43rd Street westbound, due to its speed. The vehicle hit the brakes as I approached, then proceeded south on 28th Avenue.

As the vehicle made a right-hand turn onto 42nd Street, I initiated my overhead emergency lights to conduct a traffic stop. The vehicle slow rolled down 42nd Street, made a right-hand turn onto 28th Court, where it came to a stop.

As I exited my patrol car, I observed the driver jump from the driver's seat, into the back seat with the other occupants. After observing the driver's actions, I requested more deputies. When more deputies arrived on scene, we conducted a felony traffic stop to get the occupants out of the vehicle.

As I took the driver, later identified as Wilmer Gordillo Lucena, into custody I immediately noticed his blood shot water eyes, and I could smell an alcoholic beverage emanating off of him.

After taking all the occupants into custody, I learned that Wilmer did not poses a driver's license. After conducting queries of the occupants, they were released from the scene. Wilmer was taken into custody for operating a motor vehicle without a driver's license and suspicion on driving under the influence.

Wilmer was placed in the back of a patrol car and transported to Indian River County Jail.

At the Indian River County Jail, I utilized Deputy Ballester to translate with Wilmer to conduct standard field sobriety exercises (SFSE).

NARRATIVE (Continuation)

I requested Wilmer submit to the field sobriety exercises, he verbally stated that he would. Prior to beginning the exercises Wilmer stated that he does not have any physical defects. I asked Wilmer if he wore glasses or contacts, he informed me he did not.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN). I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

During his first attempt I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and Nystagmus prior to 45 degrees almost instantly. I observed vertical gaze Nystagmus in both eyes.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Wilmer had difficulty maintaining his balance, and staying in the position he was instructed to. He swayed side to side.

During his first set of nine steps, he started his count on two and he stepped off of the line on step 2, During the second set of nine steps, he was able keep his feet on the line.

The third exercise I demonstrated and explained was the One Leg Stand exercise.

During his first attempt he did not place his foot down. He reached count 17 in the timed 30 second exercise. Throughout the exercise he utilized his arms for balance and continually swayed, until I informed him to stop.

Based upon the totality of the evidence Wilmer was informed he was being charged for violation of FSS 316.193(1) DUI. Upon completion of the exercises, Deputy Ballester advised Wilmer of his Miranda Warnings from his agency issued Miranda Card.

Wilmer provided a lawful breath sample to Deputy Rudolph ID# 5724. His first breath sample was 0.109 and his second breath sample was 0.110.

This investigation was captured on my agency issued body worn camera, and the front view camera of my marked patrol car.

The DUI packet for this case was submitted to records.

See Deputy Ballester's supplement report, for his involvement in this investigation.

This investigation is cleared with the arrest of Wilmer, for DUI, and driving without a license.

NARRATIVE
On July 13 th , 2025, at approximately 1213 hours, I responded to progress.
Prior to my arrival, public safety dispatch advised that someone was screaming for help and a female and a male were heard arguing. The male caller / complainant Shahin Ahmed stated to dispatch that he was "bleeding all over" and "bleeding from the mouth and nose". Ahmed also informed dispatch that the female involved in the disturbance was Ashley Bowman and she was previously trespassed from the residence.
Upon arrival, I observed an open door to the home and heard a loud verbal argument. I observed a female subject (Ashley Bowman) and the male subject (Shahin Ahmed) arguing in the kitchen area. Bowman's voice was overpowering Ahmed's voice as she was extremely loud. First, I immediately removed Bowman from the home and detained her in handcuffs as she was previously trespassed and appeared to be the primary verbal aggressor. Bowman was detained in Deputy Saint Eloi's patrol car. D/S R. Santana arrived and provided scene security.
Next, I attempted to interview Ahmed who initially was all over the place. A clear timeline and details of what happened were unable to be established. Ahmed calmed himself and then stated the following in essence:
Ahmed explained to me that he and Bowman have been in an on / off again relationship for year but currently do not live together and have not lived together in the past. Two days ago, Bowman showed up in an Uber and he invited her in as he felt bad for her. They had sex at some point this weekend. This morning, Bowman went through his phone and made a determination he was cheating. Bowman became upset and he asked her to leave multiple times. Bowman slapped Ahmed across the face and left the residence. Ahmed locked the door using the deadbolt. Bowman then became angry and was pounding on the door. Bowman then reached through a screen in the center of the door which is secured by duct tape, turning the deadbolt to open the door and cornered Ahmed on the couch. Bowman then began raining punches with both hands upon Ahmed and he was struck. Ahmed then called public safety dispatch.
I observed blood on the right side of Ahmed's face just about his upper lip. Initially, I believed it was cut to his face. However, I then observed his left nostril was bloody, suggesting he was possibly punched. Ahmed's right central incisor tooth appeared chipped. I observed what appeared to be some minor, fresh scratch and scuff marks to the front door of the residence just below where the screen was partially held in place by duct tape on the inside of the door.
It should be noted that Ashley Bowman was previously trespassed from the residence by Deputy Ian Mckay on June 20 th , 2025 in IRCSO case number 2025-64879. A disturbance occurred at the residence that was similar in nature to today's disturbance. Ahmed signed a declination of intent affidavit in regards to battery and Bowman was not arrested.
I then attempted to interview Bowman. As she was detained in handcuffs, Bowman was read her Miranda rights. Bowman invoked her Miranda rights. I did not ask her any further investigative questions.
Based upon my interview with Shahin, my observation of his injuries and what appeared to be fresh scratches to the front door of the residence, probable cause exists that Ashley Bowman unlawfully entered At this time, she was not invited to enter or remain. Bowman was previously trespassed from the residence reference IRCSO case number

NARRATIVE ...

On July 13th, 2025, at approximately 2054 hours, I was traveling in the area of 5800 20th Street, Vero Beach, Florida.

At that time, I conducted a NCIC/FCIC query of Florida license plate PAAF34, which was attached to a black Volkswagen sedan. The NCIC/FCIC query revealed the license plate was not assigned to a vehicle. Based on this information, I conducted a traffic stop on the vehicle in the area of 6200 20th Street.

I subsequently made contact with the driver, and sole occupant, Mr. Conner Ruf. I advised Mr. Ruf that I conducted a traffic stop due to the license plate not being assigned to a vehicle. Mr. Ruf then stated that he put the license plate on the vehicle because he did not have the money to register the Volkswagen sedan and he needed to drive the vehicle. I then requested Mr. Ruf's proof of insurance and he stated he did not have vehicle insurance.

While looking at the license plate, I also observed a yellow registration sticker displaying an expiration date of December 2025. The license plate listed on the registration sticker displayed RZAA60; however, the license plate PAAF34 expired October 17, 2024. When I told Mr. Ruf that the registration decal was also incorrect, he stated he knew and he had taken it from a friend's vehicle.

A query of the VIN on the black Volkswagen (VIN: 1VWBN7A30CC103821) also revealed that it was not registered.

Mr. Ruf was subsequently placed under arrest for the offenses of operating an unregistered motor vehicle, attaching unassigned tag, and failure to maintain vehicle insurance. He was placed into handcuffs that were checked for proper fit and double-locked. He was transported to the Indian River County Jail, without incident.

Mr. Ruf was issued five citations for unregistered motor vehicle (citation #: ADKN02E), attaching unassigned tag (citation #: ADKN01E), and failure to maintain vehicle insurance (citation #: ADKN3TE), unlawful alteration of tag (citation #: ADKN3UE), and expired registration greater than 6 months (citation #: ADKN3VE).



NARRATIVE



Upon arrival, I made contact with the manager, Briana Fuaua, who stated the following in substance; Briana stated she filed a report with Deputy Rollando in reference to an individual identified as Samuel Pickens, who on two occasions had stolen meat from Publix, on June 21, 2025, and June 30, 2025, which was captured on video.

Briana informed me that Samuel attempted to enter Publix today, July 13, 2025, when Samuel saw Briana watching him, he left before entering the store and went to the liquor store next door. Briana asked if I could trespass Samuel from Publix to stop him from stealing, while waiting for the theft investigation. I informed her I could.

I made contact with Samuel in the parking lot outside the liquor store, located next door to Publix. Shortly after Corporal Hatton arrived on scene. I asked Corporal Hatton if he would remain with Samuel, while I reviewed Deputy Rollando's investigation and spoke with Briana inside.

I met with Briana inside the camera room inside Publix, and asked her to pull the video footage of the incidents on the aforementioned dates. The following is what I observed on the camera footage.

On June 21, 2025, at approximately 1730 hours, Samuel is observed riding his bike to the front of Publix. Samuel leans his bike against a column and walks over to the recycling bin in front of Publix, where people discard their used plastic Publix bags. Samuel retrieves a few plastic Publix bags from the recycling container, places them in his pocket and enters Publix.

Samuel retrieves a cart and proceeds to push it to the meat department. Samuel loads three (3) Ribeye steaks, three (3) New York strip steaks, and three (3) Beef oxtails in the cart, valued at \$246.42. Samuel pushes the cart down an aisle, retrieves the plastic Publix bags from his pocket and places the aforementioned meat inside. Samuel leaves the cart in the isle and proceeds towards the exit door. Samuel passes all points of sale without paying for the items. Samuel walks out the front door, proceeds to his bike and rides away.

On June 30, 2025, at approximately 1952 hours, Samuel is observed riding his bike to the front of Publix. Samuel leans his bike against a column and walks over to the recycling bin in front of Publix, where people discard their used plastic Publix bags. Samuel retrieves a few plastic Publix bags from the recycling container, places them in his pocket and enters Publix.

Samuel walks to the meat department. Samuel grabs five (5) New York strip steaks, valued at \$120.57. Samuel walks down an aisle, retrieves the plastic Publix bags from his pocket and places the aforementioned meat inside. Samuel proceeds towards the exit door. Samuel passes all points of sale without paying for the items. Samuel walks out the front door, proceeds to his bike and rides away.

While watching the video, I took a still photograph of Samuel when he entered Publix on June 21, 2025, wearing a black & blue button up short sleeve shirt, khaki shorts, light brown slippers, and a gray hat. I also took a still photograph of Samuel when he entered Publix on June 30, 2025, wearing a white tank top, black shorts, light brown tennis shoes, with black sunglasses on his head.

I exited Publix and walked to where Corporal Hatton and Samuel were talking in the parking lot. I informed Samuel that Publix wanted him trespassed from the property. While Corporal Hatton was completing the trespass affidavit for Samuel, I

NARRATIVE

On July 14, 2025, at approximately 0038 hours, I responded to in reference to a disturbance.

Nicholas advised they got into a verbal altercation over the incident. The altercation continued to the RaceTrac and all the way back home.

Nicholas alleged that after getting back to the trailer, the altercation became physical when he grabbed Samantha's arm and neck. Nicholas advised he pushed Samantha against the trailer has he held her neck with his hands. Samantha tried to walk up the steps but he grabbed her hair and pulled it back. Nicholas advised that after grabbing Samantha's hair, he left the scene. Nicholas admitted to battering Samantha and wanted to tell the truth. NARRATIVE

On July 14th, 2025, at approximately 0140 hours, I was conducting traffic enforcement at Vista Palm and South US Highway 1, Vero Beach, Florida. While monitoring southbound traffic, I observed a dark-colored Kia Optima bearing Florida tag #HNZQ82 with a broken tag light, making the tag difficult to read from a lawful distance in violation of F.S.S. 316.221(2).

I attempted to catch up to the vehicle as it approached the intersection of Oslo Road and US Highway 1 Southwest. The vehicle turned right onto Oslo Road, heading westbound, and subsequently turned northbound onto Old Dixie Highway. While following, I observed the vehicle fail to stop for a steady red traffic signal before making a right turn at the intersection of Oslo Road and Old Dixie Highway Southwest, in violation of F.S.S. 316.075(1)(c)(1)(a).

The vehicle then turned into the parking lot of Live Oak Animal Hospital and came to a stop. As I turned into the parking lot behind the vehicle, I activated my emergency lights to initiate a traffic stop. At that time, I observed the driver, later identified as Alin Majuste, exit the vehicle from the driver's side. Due to the unusual behavior of exiting during a lawful traffic stop and the unknown threat to my safety, I immediately approached Majuste and placed him in handcuffs.

When asked why he exited the vehicle without instruction, Majuste stated he knew he was about to be pulled over and did not want law enforcement to draw firearms on him. Upon further questioning, he admitted he did not possess a valid driver's license and was aware he should not have been driving.

A query through D.A.V.I.D. confirmed Majuste had five prior adjudications for Driving While License Suspended (DWLS) and was classified as a Habitual Traffic Offender (HTO). His HTO status was effective for a five-year period beginning September 13th, 2021, in St. Lucie County (Citation/Case #: AD61RIE).

I read Majuste his Miranda rights, which he acknowledged and waived. When asked why he was driving knowing his status, he stated his family depends on him and he works two jobs requiring transportation.

Based on these findings, I transported Majuste to the Indian River County Jail without incident for the following charge:

1. Driving While License Suspended – Habitual Offender (F.S.S. 322.34(5)
