

NARRATIVE

On Saturday April 27th, 2024, at approximately 1118 hours, I conducted a traffic stop at the area of 6600 State Rd 60, Vero Beach, FL 32966.

While on routine patrol at the 8000 Block State Rd 60, a license plate reader notified me of a black Jeep with a suspended/expired registered owner, traveling east down State Rd 60 from the 9000 block. A few minutes later I observed the vehicle in question drive past me. The Jeep was a newer model with a pick-up bed bearing FL tag 14BHGT. I observed an adult Hispanic male driver, which matched the picture of the registered owner.

I accerelated my marked patrol vehicle east and conducted a traffic stop right before 66th Avenue. I made contact with the driver in question. The driver only spoke Spanish. He presented me with a Florida temporary driver's license and a registration card. The DL that was presented had the name of Viancarlo Jose Parmigiani Lopez, which matched the DAVID information I previously ran.

Deputy K9 Ferrer responded to the scene and assisted with translation. Lopez was asked in spanish about his suspended driver's license. He stated he knew it was expired but not suspended. He was asked in spanish about providing proof of insurance. He stated in spanish he did not have insurance on the Jeep due to not being able to afford it.

Lopez had no ties to Indian River County. He was taken into custody and transported to the IRC Jail for booking.

NARRATIVE

On Saturday, April 27, 2024 at approximately 2256 hours, I Deputy Ramiro Doval was patrolling the area 4200 block of 38th Avenue, Vero Beach Fl, when I observed a black female on a bicycle with no front lamp or back light/reflector on a non-lit street, which is in violation of F.S.S 316.2065(7).

I conducted a traffic stop on the bicyclist at the 4400 block of 38th Avenue. I advised the bicyclist the reason for the stop and asked for identification, she could not provide an Identification card or drivers license, she was later identified by her name and date of birth as Retha Mai Wells (DOB: 04/21/1970).

I asked her if she had any illegal narcotics on her person or on her bicycle. Retha initially stated no, she then advised she did have a "dime bag". Retha pulled out a small clear plastic baggy from her right side of her bra with a white powdery substance inside of it. I asked her what was in the clear baggie, Retha stated it is Cocaine.

I asked Retha if she had anymore narcotics on her person, she stated no. She stated she does not use often and only uses recreationally.

At this time, I detained Retha. The white powder was swabbed and field tested, which yielded a positive result for the presence of Cocaine.

Based on the information above, Retha was placed under arrest for Violation of F.S.S. 893.13 (6) (A), possession of cocaine.

Retha was transported to the Indian River County Jail without incident.

NARRATIVE

On April 27th, 2024 at approximately 0029 hours, I responded to [REDACTED] in reference to domestic battery.

Upon arrival I made contact with Tracy Dowse, who said that her husband Lloyd Mills had struck her several times in the face. Tracy said that she was at a shelter with her friends helping sell food to raise money for a charity when Lloyd demanded she give the money she made to him. Tracy said her friend Avril Flemming, brought her home, when she got inside that is when Lloyd began to argue with her more about the money. Lloyd struck her in the face several times, and choked her to the point she lost consciousness. Tracy said that while he was choking her, she tried anything she could to get away from him to include hitting him in the head. Tracy stated that when she woke up, she texted Avril to come get her, when she didn't hear back from her friend, she went to leave the house but Lloyd blocked the door and refused to move so she could leave. When Lloyd finally moved away from the door, she grabbed her purse, then ran out the door and down the street, once she was far enough away, [REDACTED]

Tracy had swelling and dark red marks on her left cheek, and forehead. Tracy also had redness on her neck which is consistent with being choked. Tracy also had redness on her chest, and bruising on her thighs.

Lloyd stated that Tracy was yelling at him for calling his kids, and for no reason she struck him with a pair of pliers in the left side of his head. Lloyd said that at no point did he hit Tracy. Lloyd had a small laceration on his left temple where he said that Tracy hit him with the pliers.

Avril Flemming, said that she was with Tracy at the fundraiser when Lloyd showed up and started yelling at Tracy. Avril said she dropped Tracy off after the fundraiser and went home, she said she texted Tracy to check on her but didn't hear back from her so she went to bed. Avril said she got a call from her daughter and when she picked up her phone she saw a message from Tracy, asking her to come get her. When she got there, Tracy was on the [REDACTED] and she could see that Tracy had several injuries. Avril said that this is not the first time that Lloyd had hit and injured Tracy.

Tracy was transported to Cleveland Clinic Hospital by ambulance to be treated for her injuries.

Tracy and Lloyd have been married over a year and live together as a family unit.

Lloyd is currently out on bond for Battery domestic violence from St. Lucie County, where Tracy is also the victim. Lloyd stated there is a court date set for May 28th, 2024 in reference to this case.

Based on physical evidence and statements from the victim, Lloyd Mills is being charged with one count of Battery domestic violence by strangulation, one count of false imprisonment of an adult, and Battery domestic violence.

NARRATIVE

On Sunday, April 28th, 2024, I Deputy Martin responded to [redacted] in reference to a disturbance in progress. Dispatch advised that a caller was reporting that she was out of town, and she left her [redacted] under the care of their [redacted]. Caller stated that her mother just struck one of her [redacted].

Upon my arrival, I made contact with a white female and white male in the entry of the residence. The two were separated from each other and I began to interview the female; later identified as Charlene Edalatkah. Edalatkah appeared to me to be under the influence of alcohol due to her slurred speech, lack of balance, and a odor of a alcohol emitting from Edalatkah when she spoke. Edalatkah would not provide a statement of what occurred inside of the house when I first spoke to her. I then interviewed Handsome Fanning who was present on scene. H. Fanning stated to me that he arrived home a short time ago and found his [redacted] crying in the living room with a large welt on the back of [redacted] head. When he asked his [redacted] what happened, [redacted] told him that [redacted] pushed me off the couch". While I was speaking to H. Fanning, Edalatkah entered the house with Deputy Matthews following behind her. Deputy Matthews informed me that she was not following his lawful commands, and I observed Edalatkah pulling from Deputy Matthews in attempt to resist him. She was placed into handcuffs, and moved to the back of a agency patrol vehicle for the time.

I then, separately interviewed [redacted] with [redacted] present. [redacted] stated to me that [redacted] was on the couch with [redacted] then pushed [redacted] off the couch causing [redacted] to fall to the ground and hit [redacted] head. [redacted] stated that [redacted] head hurt when [redacted] fell, and it could be seen and felt that there was a large amount of swelling on the back right side of [redacted] head. I then read Edalatkah her Miranda rights from my agency issued rights card. Edalatkah stated that she understood her rights and was willing to answer my questions. Edalatkah first stated that she tried to put the [redacted] to sleep and nothing else occurred. Edalatkah then stated that she now remembers what occurred. Edalatkah states that her and [redacted] were outside dancing and [redacted] hit [redacted] head on the ground. When asked to specify where exactly this incident occurred Edalatkah would not provide a direct answer.

Due to the fact, that Charlene Edalatkah knowingly and willfully abuse [redacted] by committing the intentional act of pushing [redacted] of the couch. Which could reasonably be expected to result in the injury that [redacted] sustained, and [redacted] Edalatkah was placed under arrest for FSS 827.03 Child Abuse felony with a no bond status and FSS 843.02 Resisting without violence misdemeanor \$500 bond. Edalatkah was transported to the Indian River County Jail for booking and processing.

While at the jail, Edalatkah was being fingerprinted with Correctional Deputies. Edalatkah leaned her head down and placed her mouth on the right forearm of Deputy T. Shuren # 5930 with her teeth making contact with his skin. She was then placed into restraints due to her action. This was witnessed by multiple other deputies and video footage was captured. Edalatkah will also be charged with FSS 784.07 Battery on Law Enforcement felony with a no bond status.

NARRATIVE

On Sunday, April 28th 2024, at approximately 2107 hours, I received a Bolo from St. Lucie County Sheriff's Office of a gray Honda four door, bearing FL license plate, IVKL68, had fled from a Traffic Stop and was last seen heading Northbound on Interstate 95.

At 2115 hours, I received a Flock alert that the gray Honda, bearing FL license plate, IVKL68, hit at CR 512 and I95 heading Eastbound. I observed the vehicle turn southbound on CR 510 from CR 512. The vehicle traveled from CR 510 and pulled into the Sebastian River High School parking lot. The high school was not open and did not have any lights on to indicate the high school was open. The vehicle then proceeded to fail to come to a complete stop at the stop sign exiting the high school parking lot. I then observed the vehicle pass multiple cars while crossing a double yellow line, indicating no passing. The vehicle then turned Westbound on CR 512 and cut off multiple vehicles weaving through traffic at a high rate of speed without using his turning indicators.

At 2124 hours, I attempted a Traffic Stop by activating my emergency lights and sirens on the vehicle due to the reckless driving for the above traffic violations I observed. As soon as my emergency lights and siren were activated the vehicle proceeded to accelerate over 100 miles per hour. Lt Moskowitz approved the use on stop sticks, at 2124 hours Deputy Lang advised he as a positive hit with stop sticks on the vehicle. I observed the vehicle enter the north bound on ramp of Interstate 95 where I lost sight of the vehicle.

At 2125 hours, Deputy Mangle advised she located the vehicle at Mile marker 158.0 on Interstate 95 Northbound. A felony stop was conducted on the vehicle and two subjects were taken into custody. The vehicle was searched and a black Michael Kors backpack was located on the passenger side rear seat of the gray Honda. Inside of the bag, Deputy Baumann located the following items in the big pocket of the backpack: Seventy-six yellow pills in a plastic bag inside of a plastic shopping bag, A plastic bag of a green leafy substance. Through my training and experience I know to be marijuana inside of a plastic shopping bag. Also located inside of the bag was the following: A plastic bag of marijuana, A plastic bag with red residue along with three yellow pills, A blue facemask, The yellow pills field tested positive for Fentanyl. Inside of the small front pocket Deputy Baumann located the following items: St. Lucie County Sheriffs Office Criminal Registration Form with the name of Terence Duval, along with a photograph of Duval's face and signature, lose money, inmate ID card with the name of Duval L. Terence along with a date of birth of 11/27/2000, A Gucci receipt with a customer name of Duval Terence, A family photograph. Deputy Baumann located a plastic bag of marijuana stuck between the passenger seat and center console. On the passenger floorboard Deputy Baumann located a small black holster.

Deputy Baumann photographed the evidence which was found on scene. Deputy Baumann secured the evidence in her patrol vehicle and transported the evidence to the Indian River County Crime Scene building. The yellow in color pills weighed to be 22.68 grams. The Marijuana weighed to be 67.80 grams. More photographs were taken of the evidence at the crime scene building. After the photographs were taken, they were entered into evidence.

Based on the information above I found Terence Duval to be in violation of F.S.S 316.1935, F.S.S 893.135, F.S.S 893.13, and F.S.S 316.191

NARRATIVE

On Friday, April 26, 2024, at approximately 1630 hours, I, Indian River County Sheriff's Office Deputy Ballester, responded to 350 US Highway 1 in Vero Beach, Florida, in Indian River County, in reference to a reckless alert call for service.

Upon my arrival, I made contact with Sergeant Avila, who informed me of the following:

On Friday, March 26, 2024, at approximately 1637 hours, Sgt. Avila responded to a reckless driver that was called in by Mark Wagner. Mr. Wagner was riding a black Harley Davidson motorcycle, following a black vehicle with Florida registration LKN-L75.

Mr. Wagner advised dispatch that the vehicle in question was unable to maintain a lane of travel. The vehicle was traveling northbound. I observed Mr. Wagner at the intersection of 17th Street and US Highway 1. Mr. Wagner signaled me that the aforementioned vehicle was two vehicles ahead of him.

Sgt. Avila observed the vehicle, activating its blinker while negotiating a curve. Sgt. Avila initiated a traffic stop and made contact with the driver, Cayetana Rubio Martinez, a Hispanic female born on August 7, 1986. Sgt. Avila requested Rubio Martinez's driver's license. Rubio Martinez asked if he spoke Spanish, which he did. Rubio Martinez stated she did not have a driver's license because she was never issued one. While speaking to Rubio Martinez, Sgt. Avila could smell a strong pungent odor of an alcoholic beverage emitting from her person. Sgt. Avila asked Rubio Martinez if she had anything to drink. Rubio Martinez informed him she had a Bud Light beer at Wal-Mart. Rubio Martinez was the only occupant in the vehicle.

Sgt. Avila requested that Rubio Martinez shut the vehicle off and called me, Deputy Ballester, since I speak Spanish, in order to assist with the investigation. While waiting, Sgt. Avila observed Rubio Martinez exiting the vehicle. Rubio Martinez was observed stumbling and told Sgt. Avila her back windows would not go down. It should be noted that her vehicle was in the off position.

I then arrived on scene and began my DUI investigation.

I made contact with Cayetana on the driver's side of her vehicle. I asked if she had a driver's license, and Cayetana told me the following:

She has not had a driver's license for the past 10 years due to her immigration status, and she was trying to get some milk for her kids, who were waiting for her at her house. As I interacted with Cayetana, I detected an odor of alcohol emitting from her breath. I also observed physical signs of impairment as she spoke in a slurred speech pattern. As she exited her vehicle, she was unsteady on her feet and was not understanding the instructions I was providing.

I informed Cayetana that I was going to conduct a series of standardized field sobriety exercises, which she understood. I asked her a series of medical questions to ensure she could participate in field sobriety exercises. Cayetana stated that she only had a broken left ankle and was receiving physical therapy for her right hip. Cayetana

stated that she had no head trauma or any other medical issues.

All field sobriety exercises were explained and demonstrated proficiently prior to Cayetana beginning each exercise, and I confirmed she understood the instructions prior to the start of each exercise. The following were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS – No resting nystagmus was observed. Equal pupil size was observed in both eyes. Cayetana had difficulties tracking with her eyes only as she kept moving her head to track. Distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior to 45-degrees was observed at an estimated 30-degree angle. Vertical Gaze Nystagmus was not observed.
- 2.) WALK AND TURN – An imaginary straight line was used for this exercise. When asked, Cayetana agree with me that the line was straight and she had no orthopedic issues other than her broken left ankle that would prevent her from putting weight on it or keep balance. Cayetana was unable to follow instructions during the starting position, she cannot keep balance while listening to instructions and starts too soon. On the first nine steps, she missed heel to toe multiple times, stopped while walking. She took ten steps and stepped off the line. While performing the turn, on the second nine steps, Cayetana missed heel to toe, took ten steps, and stepped off the line.
- 3.) ONE LEG STAND – Cayetana wore her sandals for this exercise and raised her left foot. She continued to lower her feet and was reminded multiple times how to do it correctly. Cayetana was given multiple opportunities to perform the exercise correctly. She kept swaying to her right and kept placing her left foot down. She was only able to count to 15 seconds before placing her left foot right.
- 4.) FINGER TO NOSE – Cayetana was instructed on how to perform this exercise multiple times, which she understood and had no questions about it. When instructed to touch her nose with the tip of her left finger, Cayetan touched her top lip and then her nose with the nail of her finger. Cayetana performed the same when instructed to touch her nose with her right finger. Throughout the exercise, Cayetana kept her finger touching her nose for several seconds. I then instructed Cayetana on how to perform the exercise once again and provided her with a chance to correct her mistakes. Cayetana continued to perform poorly and kept her left finger touching her nose for several seconds. Overall, Cayetana performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on April 26th, 2024, the defendant was in actual physical control of a motor vehicle while under the influence of alcohol, beverages, and/or controlled substances and was impaired beyond her normal faculties, incapable of operating a vehicle safely. I took Cayetana into custody without incident and transported her to the Indian River County jail for booking. After I arrived at the jail, I assisted Deputy Sheriff Hiss by translating. Cayetana agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Cayetana had a breath alcohol concentration (BrAC) of

I was able to turn around on the vehicle bearing Florida tag #KQDU26, a white Chrysler passenger car. I activated my emergency lights at the 3000 block US Highway 1. The vehicle continued onto Aviation Boulevard and came to a stop at the 2600 block of Aviation boulevard.

I made contact with the driver who was later identified as Angel Edgar Seville Martinez. While speaking with Angel through the passenger side window I could smell the strong odor of an alcoholic beverage emitting from the vehicle. Angel had bloodshot and watery eyes. Angel's speech was slurred as he spoke, and appeared nervous as I could see his hands trembling. I then had Angel exit the vehicle.

It should be noted, Angel had a strong Spanish accent, I asked Angel if he wished to speak in Spanish rather than English, he stated whatever I wished to do. I began to speak to him in Spanish for the rest of the investigation.

While speaking to Angel outside and away from the vehicle I could smell the odor of an alcoholic beverage emitting from his breath as he spoke to me. I asked Angel if he consumed any alcoholic beverages, he stated he had a few mixed Tequila drinks earlier in the day. I told Angel that I could smell the odor emitting from his breath as he spoke, he stated he knew.

I requested Angel to submit to the field sobriety exercises, he verbally stated that he would. Angel stated that he has had no physical defects or injuries. Angel stated that he has no issues that would impact his ability to complete the exercises. The first exercise I explained was the Horizontal Gaze Nystagmus (HGN) exercise.

I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

-During his first attempt I observed a lack of smooth pursuit in both eyes, I observed distinct and sustained Nystagmus at maximum deviation in both eyes, I observed Nystagmus prior to 45 degrees in both eyes.

I did not observe vertical gaze Nystagmus.

The second exercise I demonstrated and explained was the Walk and Turn exercise.

-During the first set of nine steps he took 9 steps, missed 3 heel-toe steps and used his arms for balance. During the second set of nine steps, he took 9 steps, stepped off the line, and used his leg and arms to balance himself.

The third exercise I demonstrated was the One Leg Stand exercise

During this exercise, Angel stopped before being told to stop as he was instructed to not stop until told to do so. He used him arms slightly to balance himself.





NARRATIVE

On April 26th, 2024, at approximately 0857 hours I responded to 4055 41st Ave (Indian River County Sheriff's Office) in reference to a domestic battery.

Upon arrival, I spoke with the victim, Christie Mauro, who advised the following in summary: Her and her husband were engaged in a verbal altercation this morning. When Christie tried to leave the residence, her husband, to whom she has been married for 50 years, followed her to their garage and reached into the car to prevent her from leaving. Christie further advised that when she started screaming, Anthony grabbed her mouth to cover it. After grabbing her mouth, Anthony punched her shoulder area, but Christie could not be more specific about where the punch landed, just that it occurred in the affray. I observed a red mark on Christie's lower left cheek, nearer to her mouth.

After speaking with Christie, I headed to [REDACTED] to gather Anthony's statement. Anthony would advise to me that he was engaged in a verbal altercation with his wife. When she tried to leave, he went to grab the keys with the intention to stop her from leaving so that they could continue talking. In addition, Anthony would advise that he never hit his wife in any manner. When I asked Anthony multiple times if he may have incidentally hit her while trying to prevent her from leaving, he advised that he did not. When I asked him why Christie has a mark on the left side of her face, his account of events changed, stating that if he did hit her, it was an incidental occurrence that happened due to his trying to prevent her from leaving.

Due to the injuries I observed on Christie, Anthony's admittance that he was trying to prevent her from leaving, and Anthony's changing statement about whether or not he physically struck his wife, I placed Anthony under arrest for battery on a person 65 or older (domestic violence) and false imprisonment (domestic violence) for when he confined Christie by force when he grabbed her keys to prevent her from driving away. This action was against Christie's will as she stated her intent was to leave the residence at that time.

Anthony was transported to the Indian River County Jail.

On Friday, April 26, 2024, at approximately 0930 hours, I responded to [REDACTED] in reference to a disturbance, upon arrival, I made contact with victim, Zoey Wolcott, who stated the following:

Wolcott advised that she overheard her young daughter and suspect, Stephen Parks arguing in the backyard of her residence. Wolcott stated that Parks lives above the detached garage in the back of her residence. Wolcott stated she responded to the backyard and made contact with Parks while recording on her phone. Wolcott stated that Parks became enraged that she was recording him, approached her quickly and grabbed for the phone that was in her hands. Wolcott stated that Parks missed the phone but knocked it out of her hands. Wolcott stated that Parks then grabbed her by her throat as she attempted to pick up the phone. I observed red marks on Wolcott's neck consistent with her statement.

I made contact with Parks. Parks was read his Miranda rights from my agency issued card to which he stated he understood. Post Miranda, Parks stated that he and Wolcott's daughter were arguing over the chickens in the backyard and Wolcott confronted him while recording on her phone. Parks stated he did attempt to grab the phone from Wolcott's hands. Parks stated he grabbed the phone however Wolcott pulled away and bent over. Parks stated that he did not grab Wolcott by the throat but he may have come into contact with her neck as she pulled away. Parks stated it was possible however unlikely.

Wolcott provided me with the recording off her phone of the incident. I observed Parks approach Wolcott then make contact with Wolcott as he reached for the phone. I observed the recording then shake rapidly and Wolcott appeared to retreat and state that she was calling the cops. I could not observe any further due to the camera angle.

Parks was taken into custody and transported to the Indian River County jail without further incident.

On April 26, 2024, at approximately 0813 hours, I was traveling northbound on 20th Avenue SW approaching 17th Lane SW when I observed an older model red Dodge minivan, traveling westbound on 17th Street SW approaching 20th Avenue SW. The vehicle made a left turn onto southbound 20th Avenue SW and quickly made a right turn onto 17th Lane SW failing to stop at the stop sign at the intersection of 20th Avenue SW and 17th Lane SW. As the vehicle made the right turn, there was another vehicle in the middle of the intersection attempting to complete the turn into the same lane. The red vehicle then began to travel westbound on 17th Lane SW at a high rate of speed. I estimated the vehicle to be traveling at 60mph in a posted 35mph zone. I activate my Stalker DSR radar and received a heads-up display of 58mph along with an audio doppler tone consistent with a vehicle traveling at that speed.

I activated my emergency lights and sirens and conducted a traffic stop on the vehicle at the 2500 block of 17th Lane SW. As I approached the driver, it was apparent that he was stress and crying. The driver, who was later identified as Matthew Scott Neavitt, advised that he was on his way home because his grandmother needed to go to the hospital. I asked Neavitt if he had a valid driver license and he replied no. Neavitt informed me that he was on probation and his driver license was suspended for un paid fines. Neavitt further advised that he had just dropped of a friend, and was in a rush to take the car home because he was not supposed to be driving.

A search on D.A.V.I.D. showed that Neavitt Florida driver license had been revoked since 03/29/2018. Neavitt driving history is as followed:

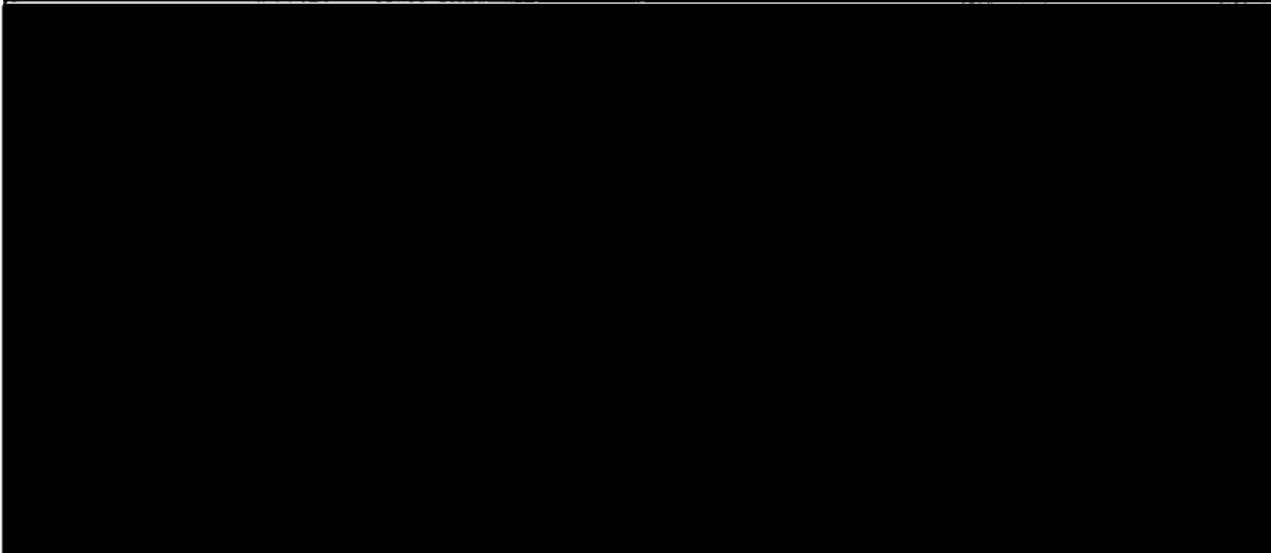

NARRATIVE

On April 26th, 2024, at 0301 hours, I observed a grey Chevy HHR driving northbound in the southbound lanes of travel, approaching the intersection of 53rd Street and US Highway 1. I advised PSD of the reckless driver and conducted a traffic stop on the vehicle. Upon making contact with the vehicle, I observed 3 children in back seat, an 18-year-old female passenger, and a female driver of the vehicle. The driver identified herself as Sara Peak, via her valid Florida Issued Identification Card. I asked Peak if she possessed a valid driver's licenses and she stated that she did not. I then requested Peak to exit the vehicle to which she complied. I questioned Peak as to why she was driving the wrong way on US HWY 1 and she stated she had just left her cousin's house and was looking for a gas station. I then informed Peak that due to the odor of alcohol emitting from her breath as she spoke, her bloodshot-glassy eyes, and her reckless driving behavior, I had reason to believe she was operating a motor vehicle under the influence of alcohol. Peak advised me that she had been drinking at her cousin's house and had consumed 2 wine coolers approximately 30 mins prior to our contact.

I then asked Peak if she would be willing to participate in preforming SFST's to dispel my suspicion to which she complied. Let it be noted that while standing outside her vehicle, Peak continuously swayed side to side and appeared to be off balance. Prior to initiating the exercises, I started by checking Peak's eyes for equal tracking and equal pupil size. I then checked for horizontal gaze nystagmus. I observed severe nystagmus in both eyes at maximum deviation. Peak's eyes displayed severe nystagmus in both eyes, prior to 45 degrees. Peak eyes also displayed minimal vertical nystagmus. I then requested Peak to partake in the walk and turn exercise. I demonstrated the exercise to Peak, verbally explaining each step ensuring Peak would have a clear understanding of the exercise. I requested Peak to stand straight with both hands down by her side until I finished giving the directions. Peak continuously swayed back and forth, lifting her arms momentarily to regain her balance. During the exercise, Peak missed the heel to toe contact on all 18 steps. For the third exercise, I explained the directions for the one leg stand. Peak expressed her understanding of the directions of the exercise and attempted the exercise. While preforming the exercise, Peak repeatedly dropped her foot and started her count over.

I detained Peak without incident and transported her to the Indian River Jail, where she agreed to participate in an alcohol testing program. Deputy Maegan Rodriguez administered a breathalyzer test to Sara Peak, resulting in 2 samples:

On 04/26/2024, at approximately 0338 hours, I responded to 955 35th Avenue in reference to a disturbance.

Prior to my arrival, 911 dispatched advised, that the complaint Kameron Conley, advised that his "baby momma" Taniya Clarke, arrived at his residence uninvited, starting a verbal argument yelling at him. Kameron also stated, that she is currently 7 months pregnant with his child.

Upon my arrival, I observed Taniya standing in the road way in front of the residence, yelling at Kameron who was standing in the driveway. When Taniya observed my patrol vehicle, she immediately started walking southbound on 35th Avenue. When I exited my vehicle, I gave Taniya several verbal commands to stop walking, but she refused. While following directly behind Taniya, I continued to give her verbal commands to stop walking and received no reply from her.

At the time, I grabbed Taniya's right arm and she started yelling for me to let her go, while she was attempting to snatch her arm out of my hand. I attempted to grab her left arm, to gain control of her body, when Taniya leaned forward and lowered her body weight tucking her left arm into her body, preventing me from gaining control of her left arm. Due to Taniya currently being pregnant, I was able to hold onto her right arm for body control, as a prevention to keep her from falling onto the ground, while she continued pulling away from me ignoring my commands. Deputy Ballester arrived on scene and was able to assist me with gaining control of both of her arms, placing her into a mechanical restraint device.

Throughout the whole incident, Taniya refused to comply with Deputy Ballester and my commands and had to be escorted to the rear of my patrol vehicle.

Taniya refused to speak about the incident and was transported to the Indian River County Jail for processing.

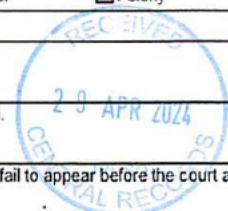

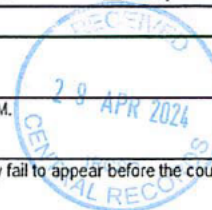

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **04/27/2024** at **11:38** (Specifically include facts constituting cause for arrest.)

On **04/27/2024**, at **09:10** hours, Corporal J. Brumley (#415) was dispatched to the womens Safe Space in reference to the removal of a female guest. The complainant advised dispatch that the female would not exit from her room, and that she also would not come to the front desk. Corporal Brumley arrived at **09:18** hours and tried to resolve the matter.

At **09:34** hours, Corporal Brumley requested for an additional officer and I arrived shortly thereafter. I made contact with Corporal Brumley and the defendant, Lisa Ann Mckinney (W/F DOB: **05/15/1973**) (Height: **5'9"** Weight: **180lbs**). I observed that Corporal Brumley was explaining to the defendant that she was being removed from the property and repeatedly asked Ms. Mckinney to gather her belongings. I was then briefed by Corporal Brumley and the staff that Ms. Mckinney was being removed for violating the terms and conditions of the shelter, as well as for causing a disturbance that affected other guests. The administrator for the Safe Space was also notified and authorized the removal of Ms. Mckinney.

Ms. Mckinney was defiant to law enforcement and refused to gather her belongings to leave. Corporal Brumley and I made several attempts to reason with Ms. Mckinney and gain her cooperation. It was thoroughly explained to Ms. Mckinney that the shelter revoked her permission to be on the property, and that she was no longer allowed to remain. Ms. Mckinney failed to make any attempt to gather her belongings and tried to question the authority of law enforcement. I explained to Ms. Mckinney that her willful refusal would result in her arrest for trespass after warning. Ms. Mckinney refused to cooperate and was provided a final warning by Corporal Brumley.

Ms. Mckinney then retreated to her room. While present with Ms. Mckinney, she was advised by Corporal Brumley that she was being placed under arrest. Ms. Mckinney then walked into me and tried to pass me. I tried to grab onto her arm and Ms. Mckinney successfully pulled away from me. She then tried to walk into the office space where the complainant/staff member was standing by. Ms. Mckinney was actively trying to avoid being placed under arrest, and I also had concern that she might try to confront the staff member in the office. I grabbed onto Ms. Mckinney's forearm and she again continued to try and pull away from me with greater force. I conducted a leg sweep and brought Ms. Mckinney to the ground. Ms. Mckinney fell on her back next to a metal storage shelf. Ms. Mckinney tried to unbalance the shelf to drop onto me and I fought her attempt. Ms. Mckinney began to kick and struck me on my thigh. Ms. Mckinney continued to kick and forcefully struck Corporal Brumley, knocking Corporal Brumley completely to the ground. I then tried to gain control of Ms. Mckinney's upper body and transitioned to a mounted position. Corporal Brumley recovered and tried to control Ms. Mckinney's legs. I tried to control Ms. Mckinney's arms and rotate her onto her back. Ms. Mckinney bit onto my hand and did not release. I retrieved my hand and Ms. Mckinney continued to try and bite me wherever she could reach with her mouth. While deflecting her attempts with my open hand, Ms. Mckinney then grabbed onto my pants. I noted that she grabbed onto my left pants pocket where my pocketknife was stored. I had to pry her grip off of my pants and Ms. Mckinney then immediately redirected her hand back onto my pants. This time, Ms. Mckinney forcefully grabbed onto my crotch and tried to cause injury to me by squeezing with great force. It took a great amount of effort to remove her grip and then partially turn Ms. Mckinney onto her stomach. Ms. Mckinney utilized the door frame to resist me and prevent me from completely rotating her onto her stomach. She then shrimped her body and tucked her arms underneath her. I ordered Ms. Mckinney to roll onto her stomach and place her hands behind her back. She did not comply and I warned her that she would be tased. Ms. Mckinney did not comply. I deployed my taser and applied a drive stun to the upper left side of her back. Ms. Mckinney again did not comply and started to physically resist me. A second drive stun was applied to the same area and was unsuccessful. I then fought Ms. Mckinney's attempts to roll back over until an additional unit arrived. Officer Willis (#467) arrived on scene and we were able to place Ms. Mckinney into handcuffs. Ms. Mckinney then went limp and forced officers to carry her dead weight to a patrol vehicle.

NOTE: Ms. Mckinney provided incorrect information to law enforcement regarding her identity during the course of this investigation. Upon contact, Ms. Mckinney provided Corporal Brumley with the name and date of birth of: Lisa Mannle **05/15/1973**. VBPD dispatch advised that there was no record found for this name and date of birth. Ms. Mckinney insisted that her name was "Lisa Mannle" and confirmed the spelling. There was still no record found out of the three different states that Ms. Mckinney provided (Florida, Texas, and Georgia). Later at the Indian River County Jail, Ms. Mckinney provided the same incorrect information (Lisa Mannle **05/15/1973**) to correction deputies processing her for booking. It was again explained to Ms. Mckinney that there was no record found and that she needed to verify her identity. Ms. Mckinney provided the same information, and added an incorrect social security number where the last four digits were re-arranged incorrectly from the correct sequence of her actual social. No record was found.

Officers later identified Ms. Mckinney through the micro-chip located in Ms. Mckinney's dog. while at the Humane Society, the micro-chip was scanned and provided the owner identification of Lisa A. Mckinney (DOB: **05/15/1973**). An inquiry through NCIC/FCIC revealed that Ms. Mckinney had an outstanding warrant out of Santa Rosa County, Florida. The warrant was in reference to a probation violation from a previous DUI arrest in that jurisdiction (Santa Rosa County SO warrant #233490CT). I was able to positively confirmed Ms. Mckinney's identity through an inmate booking photo on the Santa Rosa County Sheriff's Office website, and through the tattoos that she possessed.

- Based on the facts above, Ms. Mckinney was charged with the following offenses:
- Two counts, for violation of FSS 834.01: Resisting with violence.
 - Two counts, for violation of FSS 784.07(2B): Battery to a law enforcement officer.
 - violation of FSS 810.08: Trespass of an occupied structure after warning.

On 04/28/2024 at 23:06 (Specifically include facts constituting cause for arrest.)

On 04/28/24, at approximately 2306 hours, I, Ofc. Aguilar, responded to 2075 35th Ave. in reference to a disturbance. On scene, I made contact with Cpl Brumley (#462) who had a white male later identified as Anthony Hobgood detained on the ground. Hobgood was then placed in the back of my patrol vehicle. While interacting with Hobgood and transporting back to my vehicle I detected the strong odor of an alcoholic beverage emitting from his person and slurred speech.

I then made contact with Charles Dolly who was involved in a physical altercation with Dolly. Dolly directed me to his left forearm where I observed an imprint he stated was obtained from Hobgood biting him. Hobgood informed me the above-mentioned residence is where his girlfriend of four years, Penny Mora resides. Hobgood stated upon arriving at the residence he parked his vehicle in the front yard and observed Mora and Hobgood standing next to each other outside the residence. Dolly stated upon exiting his vehicle he then approached them and asked, "What was going on?" Dolly said that Hobgood approached and began to physically push him multiple times. Dolly stated that Hobgood was also yelling that he needed to leave the residence and that he was going to fight him. Dolly stated he then began to wrestle Hobgood in order to defend himself and was able to successfully pin him onto the ground. At this time, the disturbance progressed onto the road of 35th Ave.

Dolly stated he eventually let go of Hobgood because he did not want to fight. Dolly stated he then observed Hobgood run towards the rear of his vehicle (beige Acura utility bearing Florida tag #Z433XG) and open the trunk. Dolly stated he then observed Hobgood retrieve what he initially described as the silhouette of unknown large object. Dolly stated he then observed Hobgood turn towards him and state, "I'm going to kill both of you ." Dolly stated he was approximately two car lengths away from Hobgood at this moment and informed me that he believed it was something he could not defend against. Dolly stated he then moved towards the front door of the above-mentioned residence in order to escape Hobgood. Dolly stated that he was in fear for his life and after finding out the front door was locked, he then grabbed a broom that was located nearby in order to defend himself. Dolly stated as Hobgood approached, he then observed Hobgood holding an unidentifiable orange object over his shoulder. Dolly stated that Hobgood then used the orange object to push him up against the front of the residence. Dolly stated he was then able to grab a hold of the orange object and disarm Hobgood. Dolly stated they once again began to wrestle. Dolly stated he then observed Mora attempting to separate them. Dolly stated he observed Hobgood throw Mora two separate times while she attempted to break up the fight. Dolly stated he was able to successfully pin Hobgood and advised that is when he was bitten twice. Dolly stated he did not want to pursue criminal charges against Hobgood and refused any medical services. Dolly did not want to provide a written witness statement. Dolly directed me towards the front yard where the orange object was inserted into the ground. I then retrieved an approximately three foot long orange metal wrecking bar. I showed it to Dolly who confirmed it was the item Hobgood used in the incident and was holding over his shoulder.

I then made contact with Mora who also stated she was at the residence with Hobgood when Dolly pulled up. Mora stated upon Dolly exiting his vehicle, she observed Hobgood attack Dolly. Mora stated that Hobgood does not get along with Dolly due to him thinking he is too old for Mora. Mora further elaborated that Hobgood was the one who initiated the physical altercation and stated that he also began choking Dolly. Mora stated she attempted to separate the incident and while doing so fell to the ground. Mora stated she was never thrown to the ground by Hobgood. Mora stated she was eventually able to separate Dolly and Hobgood. Mora stated immediately after she observed Hobgood retrieve what she described as a large metal object. Mora was not able to advise where Hobgood retrieved the item. Mora advised she observed Hobgood running towards Dolly with the metal object over his shoulder and that they continued fighting near the front of the residence. Mora was not able to provide further details and refused any medical treatment. Mora did not want to provide a written statement.

I then made contact with Hobgood who was read his Miranda Warnings and agreed to answer my questions. Hobgood stated that he was with Mora near the front yard of the above-mentioned residence. Hobgood stated he then observed Dolly pull into their front yard and exit his vehicle. Hobgood stated he approached Dolly and inquired as to why he was at the residence. Hobgood stated he informed Dolly that if he had a problem he needed to say to his face. Hobgood stated that Dolly did not want to talk but instead started getting affectionate with Mora. Hobgood stated he then began pushing Dolly, which then led to physical struggle. Hobgood stated the last thing he remembers was both of them choking each other and then being yelled at by responding law enforcement. Hobgood stated he blacked out and did not recall any further details. Hobgood refused any medical treatment and refused to provide a written statement.

Based on the above-mentioned circumstances, Hobgood was placed under arrest for violation of F.S.S. 784.021 Aggravated Assault and F.S.S. 784.03 Battery then transported to the Indian River County Jail without further incident. Body camera video of the incident was submitted into a secure file at the Vero Beach Police Department.

PROBABLE CAUSE STATEMENT

I Ofc. Luna 445, responded to the area of 3306 U.S Hwy 1 in reference to a disabled vehicle blocking the right southbound lane of U.S. Hwy 1. On scene, I made contact with the passenger of a White Chrysler Van bearing FL Tag#55GJR, Kurt Hansen, who advised the vehicle he was traveling in ran out of fuel and the driver walked away to purchase gasoline. Hansen further stated the driver of the vehicle was the registered owner, Aja Puglisi and were coming from her place of employment located in the 4000 block of U.S Hwy 1. Let it be noted while speaking with Hansen I observed him to have red glassy eyes, slurred speech and could smell an odor of alcoholic beverage emitting from his person. Hansen also stated an hour prior to making contact with him, he had consumed a 6 pack of beer.

While on scene, I made contact with a witness and caller identified as Steve Vertil, who stated he was in the area and observed the Chrysler Van with Hansen in the driver seat and the vehicle on, in the right lane of travel on U.S Hwy 1. Vertil stated Hansen proceeded to exit his White Chrysler vehicle and observed him to have loss of balance and slurred speech when speaking with him. Vertil advised Hansen ran out of gas and needed assistance.

Due to Hansen having red glassy eyes, slurred speech and being able to smell an odor of alcoholic beverage emitting from his person I asked if he would be willing to participate in a series of Standard Field Sobriety Test's to which he agreed. The results are as follows:

HGN: While Hansen was conducting the exercise, I observed him move his head multiple times during the exercise and have nystagmus prior to 45 degrees. Alcoholic beverage could also be smelled emitting off his person.

Walk and turn: Hansen began the walk and turn with his hands stretched out to and walked before I finished the period of instructions for said task. Once in the correct position for the walk and turn Hansen stated "I would fall on my ass if I do it" and did not wish to attempt the exercise.

One Leg stand: Hansen stood on his left foot and stretched his arms out before the exercise was explained. Hansen repeated the above when I finished explaining the instructions. He was not told to begin. Hansen once again repeated to stand on his left foot and stretch his arms out before being instructed to begin (3x total). On scene, I made contact with Jessica Jones (victim). Ms. Jones was crying and I observed that her lip was busted with fresh blood visible. Ms. Jones advised me that she just was involved in an altercation with her boyfriend, and that her boyfriend struck her in the face. I observed that Ms. Jones had a small laceration on her lower lip, and small abrasions on her arms. Ms. Jones identified her boyfriend to me as Marcus Grier (B/M DOB: 08/01/1980). According to Ms. Jones, she has been dating and living with Mr. Grier for the past two years.

I asked Ms. Jones what happened and she advised me of the following:

At approximately 06:40 hours, Ms. Jones was preparing to leave the residence to drive to work. Mr. Grier wanted to provide Ms. Jones a ride to work in his caravan, while Ms. Jones wished to drive herself to work in her own personal vehicle. Mr. Grier was upset about this and prevented Ms. Jones from accessing the keys to her car. Mr. Grier then walked towards the entrance to the residence and towards her vehicle that was parked in the parking lot. Ms. Jones told me that she then threatened to contact law enforcement if Mr. Grier did not provide her with her keys. Ms. Jones told me that Mr. Grier became angry with the fact that Ms. Jones threatened to get law enforcement involved. Ms. Jones stated that Mr. Grier then approached Ms. Jones and Mr. Grier struck her near her mouth with his fist.

Ms. Jones clarified to me that she was able to recover her car keys and that Mr. Grier had departed from the scene in his silver Dodge Caravan (FL tag #Z441QD). 




I then made contact with bicycle operator Antravious McBride. McBride placed his bicycle and belongings in the grass by his own decision to remove himself from the roadway. I notified McBride of the reason for my stop and asked for consent to search him and his belongings. McBride denied consent to having his person and belongings searched. I then requested IRC SO K9 D/S Le to respond and assist with my traffic stop.

K9 Le conducted an exterior sniff of the bicycle for the odor of narcotics to which he stated there was a positive alert on the bicycle (IRC SO Case #2024-45787).

I then conducted a search of the bicycle. On the rear of the bicycle there was a basket with a small green cloth bag and other assorted items. Upon searching the green bag I located drug paraphernalia, 2 cut straw that were slightly burnt and had white powder residue inside.

I then conducted a probable cause search on McBride's person and his black back pack that he placed on the ground. Prior to me beginning my search, McBride stated that he had fentanyl in a small pocket on his left pant leg along with more paraphernalia. McBride also stated that he regularly uses Fentanyl. During my search of McBride's person I located folded up tinfoil with a burnt substance located in the area McBride previously stated. I then utilized an agency issued field test kit to test the substance from the tinfoil. The field test it tested positive for the presence of Fentanyl.

I then placed McBride under arrest for violation of FSS 893.13(6a), possession of a controlled substance. McBride was also issued a citation for violation of FSS 893.13(6a), possession of a controlled substance (citation #AJH04UE).

McBride was also charged with violation of FSS 893.147, possession of drug paraphernalia/equipment.

I continued my search of McBride's black backpack and located several other pieces of tinfoil with a burnt substance located on each piece of tinfoil. I also located several cut straws and glass pipes with white powder residue inside the backpack.

I then transported McBride to the Indian River County Jail without incident. Once at the jail McBride was checked by jail medical staff. Jail medical staff requested that McBride be taken to the hospital for medical clearance. I then transported McBride to the hospital where he was cleared to return to the jail by hospital staff. I then transported McBride back to the Indian River County Jail without incident.

This incident was captured on VBPD body worn camera and pictures were uploaded to VBPD evidence library.
