NARRATIVE

On Tuesday May 26 2026 at approximately 1643 hours, I responded to 9056 85th Street in reference to a disturbance. While enroute dispatch advised a subject had struck the caller in the face and threatened him with a firearm. Upon arrival I made contact with Traviz Fezette who advised the following in substance:

Travis works for Amazon and was delivering packages in the area. Travis was attempting to turn his vehicle around across the street from 9056 85<sup>th</sup> Street and accidentally backed into the ditch getting his vehicle stuck. While waiting for assistance to get his van out of the ditch an elderly male walked out of the residence holding a black pistol screaming at him and his friend. Travis described the pistol as a black pistol which looked like a Glock. Travis was unable to understand what the male was saying but was in fear the male was going to shoot him. The male then went back inside and came back outside a short time later. When the male came back outside, he began apologizing to Travis and began rolling around in the dirt. The male then walked off out of site.

After Travis' work partner left Travis was waiting by himself and the male walked up to him. The male began yelling at him that he needs to leave and he was going to call the cops. As Travis was sitting in his vehicle, the male walked up to the driver's side window. The male reached through the driver side window and struck Travis in the face with his right fist. After striking Travis the male then walked back inside.

Two passerbys witnessed Travis being struck in the face and stopped to check on them. As Travis was talking to the passerby the male then walked out of the residence with a "long gun rifle". At that time Travis got into the passerby's vehicle and drove down the street to meet with deputies.

Travis described the male as an older male in his 60s. Travis was shown a photograph of the current resident of the house, Gregory Orsini. Travis advised the male in the picture was the male who struck him in the face.

Once Gregory was in custody Travis confirmed a second time that Gregory was the subject who waved the firearm at him and struck him in the face.

While speaking to Travis he had a small laceration to his forehead where he was struck.

NARRATIVE

On Tuesday, May 26, 2026 at approximately 0336 hours I conducted a traffic stop in the area of the 6200 Block of 20<sup>TH</sup> Street, Vero Beach, Florida 32966.

I observed a blue SUV bearing Florida License Plate Z59GAK (Vin 3CZRU5H18MM731147) to have no rear illuminated lighting equipment while traveling West on State Route 60 (20<sup>th</sup> Street). I proceeded behind the vehicle where I continued to observe the violation as no brake, rear, or registration lights were illuminated. I activated my emergency equipment on the western side of the Indian River Mall, to include the occasional activation of my emergency siren. The vehicle and its' operator continued west giving no indication to yield to my activated red and blue strobing lights as a sign of authority.

After bypassing two well-lit turn lanes, which would have been a safe and reasonable location to stop, the vehicle continued through the intersection of 66<sup>th</sup> and SR 60, before eventually pulling over in the turn lane to a closed business. This distance and lack of response to activated lights and siren behind a motorist I found to be unusual as there were numerous opportunities to stop in a safe location.

Upon contacting the driver and sole occupant of the vehicle from the passenger side of the vehicle I noted the driver to have visually clammy skin and she appeared to have a light amount of sweat forming on her forehead. I requested her driver's license, registration, and insurance. She appeared uncertain as to the location of the requested documentation, handed me a small pile of papers, and asked if both registrations were present. I placed all but the current registration in to the vehicle and again requested her driver's license. Upon request of her driver's license she picked up a pink and brown purse where I immediately observed a Glock pistol in the floorboard of the vehicle. I advised her not to pick up the gun. I then asked: "Is there a gun in your purse?" "Uh, no sir." While holding and looking at the pink / brown purse.

The driver then informed me there was another gun in the vehicle somewhere.

I then utilized a distracting technique to round the vehicle where I ordered the driver out of the vehicle. She brought the pink/brown purse with her. I requested her to place the bag on the hood of my vehicle as she retrieved her license from there, to ensure she did not produce a firearm or other deadly weapon. Immediately upon her opening the bag, in the top center of the bag, I observed a large quantity of drink straws which appeared to have been cut to a length between 2-5 inches and burnt aluminum foil. This is commonly utilized in the recreational consumption of controlled substances and referred to as a "hooter" where a piece of tin foil is heated with the narcotics on it and the fumes are inhaled.

I ordered her to place the bag down, and in an effort to ensure I would not become ill or injured by loose fentanyl, requested to know what was on the straw. The driver, later identified as Ms. Luz Herrera, informed me the

substance was cocaine and the bag was not hers.

I detained Ms. Herrera in handcuffs and ordered her to sit on the bumper of my patrol vehicle. As I began searching the bag where a loose wrapper fell out of the bag drawing my attention to the ground of my vehicle, where I recovered a small baggie (approximately 1.1 grams in packaging) of a greyish-white powdery substance which I immediately recognized through my training and experience to be consistent with fentanyl – a controlled substance. This substance later tested field presumptive positive for the presence of a fentanyl.

An exhaustive search of the bag revealed a large quantity of straws and burnt foil, consistent with narcotic use. An exact count of straws will be included in my case report.

A search of the vehicle revealed more loose burnt foil, 2 straws by the passenger side floorboard, a loaded and chambered .40 caliber Glock pistol – with two additional loaded magazines in the driver door, a silver and black .38 caliber taurus revolver; and under where she was sitting was a red towel, which when moved revealed 32 \$100 bills. In the center console I recovered 55 \$5 bills, 17 \$10 bills, 3 \$20 bills, and 11 \$1 bills.

Deputy D. Magill conducted an interview with Ms. Herrera while I continued my search and testing of the recovered drugs. Deputy D. Magill advised me that Ms. Herrera was denying ownership of the purse despite my observations which put the purse in the firm care and custody of Ms. Herrera. Below is his supplement:

“On May 25, 2026, at approximately 2138 hours, I responded to 6300 20th Street, Vero Beach, Florida, as back up to Corporal Chamberlain’s traffic stop.

Upon arrival, Corporal Chamberlain informed me he had located suspected fentanyl, two (2) firearms, and several thousand dollars of US currency on the driver’s seat.

I looked inside the vehicle, and located more US currency inside the center consul, and tin foil with burnt residue on the floor board of the passenger seat.

I conducted a post Miranda interview with Luz, who advised she understood her rights and wished to talk. Luz advised she had recently become homeless and was staying at the Vero Beach Inn. I asked Luz about the items Corporal Chamberlain had located in her vehicle. Luz advised the vehicle belonged to her ex-step dad, and that the firearms located in the vehicle belonged to him. Luz said that when her ex-step dad let her use the vehicle, he did not remove the firearms. I asked Luz about the suspected fentanyl that was located, she said it belonged to her friend that was just in her vehicle. I asked Luz what her friends name was, which she did not provide. Luz said the bag in the vehicle belonged to her un-named friend.

I asked Luz about the US currency located in the vehicle, she said it belonged to her. I asked Luz if she had

a job, she informed me she was a finger nail tech and painted nails. I asked her where she worked, she advised she was self-employed. I inquired about the last time she worked; Luz informed me she has not worked in approximately two (2) months.

In an effort to identify the un-named friend who Luz said the suspected fentanyl belonged to, I stopped my interview with her and went to look inside the bag.

Inside the bag were items of clothing, which had fresh puke on them, and tin foil with burnt residue.

I informed Corporal Chamberlain what Luz said, and he informed me when he conducted his traffic stop and asked for her driver's license, Luz grabbed the aforementioned bag, at which point he noticed drug paraphernalia inside.

While Corporal Chamberlain tested the white powdery substance he located, Deputy Green and I counted the US currency that was located in the vehicle.

The following is a breakdown of the US currency.

Corporal Chamberlain departed the scene with Luz.



This concludes this Deputy's involvement in this investigation."

I placed Ms. Herrera under arrest for the following crimes: Possession of a controlled substance 893.13; Possession of a Firearm in the commission of a Felony 790.07; and Possession of Drug Paraphernalia.

Once having arrived at the Indian River County Sheriff's Office Jail Complex, a Stolen Vehicle call for service was in pending. I, out of curiosity, clicked on the call for service where I noted the address to be the same as the registered address of the vehicle which I had just stopped and made a subsequent arrest from. I requested Deputy M. Ciofalo respond to the scene where I was informed the rightful owner of the vehicle, firearms, and currency wished to pursue criminal charges for the following crimes after speaking with Deputy Ciofalo and being advised of his findings. Below is Deputy Ciofalo's supplement:

"On May 26th, 2026, at approximately 0454 hours, I dispatched 1225 Normandie Way, Vero Beach in reference to a stolen vehicle. It should be noted, Cpl. J. Chamberlin conducted a traffic stop at 0336 hours, on a 2021 Honda bearing Florida registration Z59GAK in the 6300 block of 20th St., Vero Beach. The operator was identified Luz Herrera where she was subsequently arrested for other charges. This vehicle was the vehicle was being reported stolen at 0454 hours.

I responded to the residence, where I began to speak with Gerald Berkheimer. Gerald explained he knows Luz, where he stated she has been down on her luck. He stated she called him tonight at around 0000 hours, and requested his help. Gerald stated he brought Luz back to his residence, where he allowed her to shower, eat, and lay her head. He explained Luz does not have access to his vehicle, nor was she allowed to take the car. His vehicle was identified as the Honda.

Gerald explained he had \$5,500 USD in all \$100 bills in his office. We checked the envelope, which only had \$2,300 in the envelope. Therefore, \$3,200 was stolen. Gerald also explained he had approximately \$300-\$400 in his center console. He explained this money had a rubber band around it.

Gerald explained he had two firearms within his vehicle, one which was identified as a Glock, and the second being a .38 caliber.

It should be noted, Cpl. Chamberlin advised he discovered \$3,716.00 dollars in the vehicle at the time of the traffic stop. Cpl. Chamberlin also advised of the discovery of two firearms, one identified as a Glock and one identified as a .38 caliber revolver.

Gerald was given a transport to his vehicle by Dep. Gadacz, where he took custody of it.

A stolen vehicle affidavit was completed, which was turned into IRCSSO Records.

This incident was recorded via Axon camera.

This concluded my involvement in this incident.”

Based upon the totality of the investigation conducted by deputies on scene and in response to the new stolen vehicle call for service’s subsequent investigation, additional charges of: Grand Theft Motor Vehicle; Grand Theft (Currency taken); Grand Theft of a Firearm x2 were placed.

I attempted to interview Ms. Herrera at the jail. During this I advised her again of her constitutionally protected rights in the form of a Miranda Warning, where Ms. Herrera claimed that “Mr. Gerri” had given her permission previously to use the vehicle but to have it returned by the end of the weekend. Ms. Herrera again attempted to state that she received the currency from pawn transactions. When I pressed further, she informed me she no longer wished to answer questions.

More detail will accompany my detailed case report.

The straws were counted along with the foil and placed in to evidence, both firearms, the associated magazines / ammunition, and currency were returned to their rightful owner, Mr.

My body worn camera was ACTIVE.




NARRATIVE

On Tuesday, May 26, 2026 at approximately 1521 hours, Deputy Whittington responded to 5800 20<sup>th</sup> Street (Target) in reference to a shoplifting.

When Deputy Whittington arrived, he made contact with Jasmine Skoubis the asset protection agent for the Target location, Jasmine stated the following in summary;

Jasmine advised that she began to monitor the subject as he entered the male clothing area of the store. Jasmine observed the male subject select several clothing items from the display shelves. Jasmine continued to monitored the subject as he concealed the items inside of the backpack that he wearing. The male suspect left the clothing area and began to walk towards the front of the store. As the male suspect was exiting the store Jasmine made contact with the suspect and identified herself. The male suspect advised that he was not going into the room with her and walked out of the store passing all points of sale with the clothing that he concealed inside his backpack.

Jasmine notified law enforcement at that time.

Jasmine informed Deputy Whittington that the items taken were identified as; five-white tank tops, six-PSD boxers, three black tank tops and one pair of night pants bringing the total value to \$151.00.

I was dispatched to a follow up at Target, at approximately 1800 hours, I made contact with Jasmine, who informed me that she observed the male who stole the items at the McDonalds, located at 5875 20<sup>th</sup> Street, Vero Beach, Florida, across the street from Target. I canvassed the area, but was unable to locate the individual.

I went to Target and met with Jasmine and informed her I was unable to locate the individual. I asked Jasmine to pull up the video, so I could take a picture of the suspect. I gave Jasmine my telephone number and informed her that if she saw the individual in the area to contact me.

At approximately 2025 hours, Jasmine contacted me and informed me she had eyes on the suspect in front of McDonalds again, and he was wearing all black. I responded to the area and began searching. RTCC advised they observed the male crossing the intersection at 20<sup>th</sup> Street and 58<sup>th</sup> Avenue, and walking towards Burger King, located at 5790 20<sup>th</sup> Street, Vero Beach, Florida.

I informed responding Deputies that I observed him entering inside Burger King. I waited until Sgt. Flores arrived before approaching. Sgt. Flores and I entered Burger King and were unable to locate the suspect. I asked the female, later identified as Tanyah Simmons who I observed walk inside with the suspect, where he went. One of the Burger King employees informed me that he went out the drive thru window when we pulled up. I asked Tanyah what the males name was, she informed me, Jermaine Patterson, who was later identified as Ivan Jermaine Patterson.

Deputies searched the area, and spotted Ivan at the intersection of 20<sup>th</sup> Street and 58<sup>th</sup> Avenue, heading west, wearing a gray tank top and black shorts. I informed Deputies that he was observed wearing the same clothing earlier in the day.

I entered into the parking lot of McDonalds from the rear, and observed Ivan sitting at a table in the north west corner of McDonalds. I informed Deputies in the area, and as we entered into the parking lot, Ivan fled on the site of law enforcement and ran east towards Chipotle, located at 5855 20<sup>th</sup> Street, Vero Beach, Florida.

**NARRATIVE (Continuation)**

Ivan attempted to hide behind a car in front of Chipotle, as Deputies closed in. I exited my marked patrol car, wearing my agency uniform with SHERIFF clearly displayed in bold 3-inch yellow letters and began giving Ivan law commands to get on the ground. Ivan imminently began to run north, back towards TARGET. I chased Ivan across 20<sup>th</sup> Street, deploying my agency issued taser in an attempt to stop him. As I chased Ivan, Corporal Chamberlain was also chasing Ivan, and giving him commands to stop, which he did not.

Ultimately, I was able to chase Ivan into the Target parking lot, where I order him to the ground, while pointing my taser at him. Corporal Chamberlain placed him into handcuff restraints as I kept him at taser point. I discovered that 3 of my taser probes were stuck in Ivan's backpack he was wearing.

Ivan was secured in the back of Corporal Ballester's patrol car. I read Ivan his rights from my agency issued MIRANDA card. Ivan advised he understood his rights and was willing to speak with me.

Ivan admitted to taking the items from Target, and stated he was homeless and needed clothes.

I made contact with Jasmine at Target, and informed her we caught the suspect, Jasmine provided me with a list of items taken by Ivan. I went back to the scene and recovered the items taken, plus an additional pair of pants that Jasmine was unaware of, which brought the total to \$176.00. I brought the items back to Target and turned them over to Jasmine.

Jasmine requested Ivan be trespassed from the location, which Corporal Chamberlain did.

This investigation was captured on my body worn camera.

This investigation is cleared by arrest.
