

NARRATIVE

On 12/3/2025 at approximately 0158 hours, I was dispatched to Wawa at 4495 US-1, in reference to a disturbance in the parking lot. While enroute, Public Safety Dispatch stated a male suspect had threatened employees, and was Southbound on Old Dixie Highway.

When Deputy Martin and I arrived, we were met outside by Anna Johnson who is the manager at Wawa. She stated prior to our arrival, a black male had got into a physical altercation with a female in the parking lot. Anna stated when she saw the incident occur, she went outside and yelled at the male to stop stating she was [REDACTED] Anna said the male then walked toward her in an aggressive manner stating, "Bitch I'll beat your black ass too, I'm Michael Reese you don't know who I am." Anna said the male got within inches of her face, and she felt like he was about to hit her, when another employee started yelling at the male. Anna stated this caused her to feel a great amount of fear to her life and safety. Anna stated she was in so much fear that she went inside the store and locked the doors. While speaking with Anna, she was visibly crying and shaking uncontrollably still in fear. Anna stated she wished to pursue criminal charges for assault if the man was able to be identified. She also stated she would like the male subject trespass from the property.

Anna was able to show the surveillance video of the incident. On the video a black male was seen walking towards a white female's vehicle that he pulled into the parking lot with at the same time. The male got into an argument with the female and pulled her out of the vehicle multiple times and struck her in the face. Anna and another employee are seen exiting the store, and the black male walks towards them in an aggressive manor. After a few moments, the male enters a Hummer parked in the parking lot and drives away. It should be noted the female the male battered in the parking lot was unable to be identified and nobody has reached out to the Sheriff's Office to be a victim. The male was identified as Michael Reese. It should also be noted that prior in my assigned patrol shift, I had a previous encounter with Michael under agency case# 2025-128841. Michael was seen on video wearing the same green t-shirt, brown pants, and baseball cap that he was wearing during my previous encounter with him in the shift.

I spoke with Travis Blowers, who was the other employee that was outside in the parking lot during the incident. Travis stated he witnessed the entire altercation, and could be a witness. He confirmed and reiterated the statements Anna previously gave about the incident.

While speaking with Anna and Travis in the video surveillance room, another employee rushed in stating that Michael had returned to the store and was inside.

Deputy Martin and I went to the lobby of the store and placed Michael in custody. Michael was escorted to my patrol vehicle and a search of his person was conducted. Inside Michael's front left pocket, a small bag containing 7 multi colored circular tablets were found along with a large amount of cash. I read Michael his Miranda Rights from my Indian River County agency issued Miranda Rights card. Michael stated he understood his rights. When asked if he wanted to speak about what occurred, he stated there was nothing to speak about. This concluded my questioning of Michael.

A drug field test was conducted on one of the tablets, and it tested positive for the presence of Fentanyl.





Mitchell was taken into custody and transported to the Cleveland Clinic Emergency Room to be medically cleared as Mitchell advised he was suffered from an infected wound from his past accident when he was struck by a vehicle. I observed Mitchell's leg to be swollen and oozing. Mitchell also had a cast on his right hand and a back brace.

While at the ER, Corporal Chamberlin conducted a secondary search of Mitchell's person search incident to arrest for the safety area ER staff. There were suboptimal conditions on scene due to being in a heavily wooded area and Mitchell inability to stand. Corporal Chamberlin located a pouch in the crotch area of Mitchell. After Corporal Chamberlin extracted the pouch from the boxers of Mitchell, Mitchell spontaneous uttered that he was an addict, indicating that he was a drug addict and there were narcotics in the pouch.

The pouch contained a vial of a crystal rock and crystalized grainy powder that appeared to be methamphetamine. The substance was tested with my agency issued test kit and tested positive for methamphetamine. The crystalized methamphetamine was weighed to be 2.62 grams. The solid rock portion of the methamphetamine was not weighed on scene and will be weighed at a later date.

Pictures of the pouch and substance was submitted to evidence.com. The substance was submitted to evidence by Corporal Chamberlin.

Body worn camera activated.


