On April 25, 2025, at approximately 1802 hours, I was conducting routine patrol. While in the area of 49th Street and Old Dixie Highway, I observed a white 2024 Kia Sorento that bore a Florida license plate of R4GGH stopped just south of the intersection mentioned before.

It should be noted, there was a train that was slowly moving that was causing a traffic to be at a standstill at the intersection. The Kia Sorento was behind a few cars, so it put its left turn signal on, drove over the double yellow line at the, drove down the wrong side of the road, and then went east bound at the intersection, switching lanes within the intersection. Based on what on what I observed, I conducted a traffic stop.

During the traffic stop, contact was made with the driver and sole occupant of the vehicle, Jermie Bingham. Jermie exited the vehicle and walked to the back of the vehicle and opened the trunk. I told Jermie to get back into his vehicle since I was conducting a traffic stop. While the vehicle doors were open, I immediately detected an overwhelming odor of fresh burnt cannabis emitting from the vehicle.

Once contact was made with Jermie when he was in the driver seat, I informed him of the reason why I conducted the traffic stop. Jermie said he understood why he was stopped and he was sorry. I told Jermie the odor of fresh burnt cannabis was overwhelming and asked him when the last time he smoked cannabis was. Jermie said he smoked "a few hours ago" and he did not have a medical marijuana license, nor was the marijuana purchased from a medical marijuana dispensary. Jermie went on to say he had approximately one gram of marijuana still in the vehicle.

Based on the smell of fresh burnt cannabis emitting from Jermie's vehicle and Jermie's admission of possessing marijuana that was not medical marijuana, I conducted a search of the vehicle. Just prior to conducting the search, Jermie stated he had hydrocodone in pill form located in the vehicle as well. Jermie confirmed he did not have a prescription for the pills and he knew he should not have them, but he suffers from back pain and does not have insurance to get them prescribed to him. Jermie informed me the marijuana and pills would be located inside the center console of the vehicle. I was able to locate the marijuana, a marijuana pipe with what appeared to be burnt cannabis inside, and sixteen (16) pills in a black bag where Jermie said they would be. The white pills were a circle shape and had 512 imprinted on one side of the pill and a line on the other side.

I conducted a search via Drug.com of the pills located in Jermie's vehicle which revealed the pills were identified as Acetaminophen and Oxycodone Hydrochloride. According to the website, the pills are supplied by Mallinckrodt Pharmaceuticals. It was also revealed the Acetaminophen/Oxycodone is used in the treatment of chronic pain; pain and belongs to the drug class narcotic analgesic combinations. Acetaminophen/Oxycodone is classified as a Schedule 2 controlled substance under the Controlled Substance Act (CSA).

Based on the information above, I found probable cause Jermie was in violation of F.S.S 893.13, possession of a controlled substance. Jermie was provided a citation for the possession of a controlled substance (AJSS7XE) and a written warning for driving on the wrong side of the roadway. Jermie was arrested and later transported to the

 On 04/26/2025 at 02:53 (Specifically include facts constituting cause for arrest.)

Officer Irwin of the Sebastian Police Department conducted a traffic stop for a reckless driver at the 1800 block of US Highway 1 in Sebastian Florida. Officer Irwin updated the location of the final stop to be near the 13000 block of US Highway 1 northbound.

Upon my arrival to the scene, Officer Irwin stated while at the intersection of US1 northbound and Sebastian Boulevard east bound, he observed a grey truck quickly accelerate at a high rate of speed northbound on US Highway 1. Officer Irwin stated he turned northbound on US1 and began to catch up with the vehicle. Officer Irwin advised that he paced the vehicle at 73 mph in a posted 35 mph zone for approximately one quart mile. Officer Irwin also stated he observed the vehicle swerve over the solid white line as well as the white checkered line multiple times. Officer Irwin stated after he activated his emergency lights in attempts to stop the vehicle, the truck continued to travel on the shoulder of the roadway for approximately 500 yards before coming to a stop. Officer Irwin advised once the vehicle came to a complete stop, the driver was ordered to shut the vehicle off and remove the keys. Officer Irwin stated that the driver was unable to shut the vehicle off due to the vehicle not being placed in park before trying to remove the keys from the ignition. Officer Irwin further advised that the driver was then able to reapply the brakes, place the vehicle in park, and turn the vehicle off. Officer Irwin then advised he immediately could smell the odor of an alcoholic beverage emitting from the driver's breath and also could observe the driver's glassy, bloodshot eyes.

I then made contact with the driver of the vehicle, who was identified by his FL driver's license as Joseph G. Del Giorno. Joseph agreed to perform a series of standardized field sobriety exercises at this time. I began the exercises by checking Joseph's eyes for signs of horizontal gaze nystagmus. Joseph appeared to have equal pupil size upon initial observation. Joseph immediately showed an inability to follow the stimulus. While performing this exercise, I observed a lack of smooth pursuit in both of Joseph's eyes. I also was able to observe distinct and sustained nystagmus at maximum deviation in both eyes as well as onset of nystagmus prior to 45 degrees in both eyes. It should be noted that during this exercise on multiple occasions, Joseph turned his head towards the direction of the stimulus and also failed to follow the stimulus on multiple attempts.

I then began to explain the walk and turn exercise, where Joseph was unable to maintain the starting position as instructed. Upon start of the exercise, Joseph only counted step one and step nine. Joseph then made an improper turn and did not walk heel to toe during any of second series of nine steps.

During the one leg stand exercise, Joseph was unable to maintain the starting position as I demonstrated to him and began attempting the exercise before instructed to do so. During the instruction, Joseph picked up his left foot and bent it 90 degrees to the rear before I finished giving instruction. Once instructed to begin the exercise, I observed Joseph swaying left and right. Joseph placed his left foot down during the exercise and began counting over again from one thousand one.

Based on my observations during these sobriety exercises, and the description of Joseph's driving patterns provided by Officer Irwin, Joseph was placed in the rear passenger seat and transported to Indian River County Jail for driving under the influence of alcoholic beverage or controlled substance. Joseph's lack of ability to follow instruction and perform the exercises throughout the entirety of the incident have led me to believe that his normal faculties are impaired while in actual physical control of the vehicle.

Once at the Jail, Joseph provided a breath sample which showed his blood alcohol level at 0.167 on the first breath sample followed by a 0.164 breath sample.



On 04/26/26, at approximately 0410 hours, I, Ofc. Retiro #419 responded to 2333 Indian River Blvd in reference to a disturbance. Upon arrival, contact was made with the complainant, Gwen Simmons, who advised she had been woken up by the sound of someone banging on windows and yelling. Gwen stated she observed a male individual, later identified as Caleb Phillips, become belligerent and had begun to aggressively bang on the windows of various apartments while continuously yelling, waking multiple neighbors. Gwen advised Caleb's disturbance caused her to exit her residence, for she was unable to sleep with her "peace and quiet" having been disrupted. Gwen also mentioned that similar incidents had occurred on previous nights and that it has become an ongoing issue with Caleb causing multiple disturbances in the past.

Caleb was located nearby in the Parc 24 parking lot (2345 Indian River Blvd). Upon speaking with Caleb, he advised he had stopped at the apartment complex to help a friend walk a dog. Caleb admitted to banging on windows to the apartment complex in an attempt to gain some assistance. His story remained unclear due to him also stating he had been called over by a friend to help watch a dog but had exited the apartment complex to urinate outside. Upon asking why he did not just utilize the bathroom in his friend's apartment he could not provide a straightforward answer. Upon asking if he could provide the apartment number of his friend, he again would not provide an answer, but deflected and advised he had just been stopped and called over to help a friend watch a dog.

Caleb was able to provide a name of "Krista" who he advised he had been friends with and would at times watch their dog. With assistance from VBPD dispatch, we were able to learn the homeowner of Apt. 108 was an individual by the name of Krista Reeves. Multiple attempts to contact Krista Reeves were unsuccessful. VBPD dispatch also advised that an active TAW was in place for Caleb for the apartment complex. Previous call history also showed Caleb involved in a prior disturbance at the same residence where he had refused to leave the property. Ref VBPD CFS 011925-31.

While detained for Disorderly Conduct, Caleb advised he had left some property near the apartment complex, upon returning to locate his property, Caleb began to become agitated and pace the area. At one point, Caleb was seen almost knocking on another apartment window. Caleb was ultimately placed under arrest for Disorderly Conduct. While cuffing Caleb, he physically resisted by tensing and pulling his arms away causing us to fall to the ground where he still remained non-compliant to verbal commands and continually kept his arms tensed and unmoving from his sides. Eventually, Caleb was handcuffed and escorted to a patrol car.

Once at a patrol car, Caleb continually made attempts to resist by refusing to comply with verbal commands to get into the patrol car. Caleb was ultimately assisted into the patrol car. While attempting to get him into the patrol car, Caleb purposefully head butted Ofc. Covarubias who was assisting Caleb into the patrol car.

Caleb was subsequently taken into custody and charged with Disorderly Conduct FSS 877.03

Whoever commits such acts as are of a nature to corrupt the public morals, or outrage the sense of public decency, or affect the peace and quiet of persons who may witness them, or engages in brawling or fighting, or engages in such conduct as to constitute a breach of the peace or disorderly conduct.

Caleb was also charged with Battery on LEO FSS 784.07 - Actually and intentionally touches or strikes another person against the will of the other. "Law enforcement officer" includes a law enforcement officer defined in s. 943.10

Caleb was transported to the Indian River County Jail for booking.

NARRATIVE

On April 26, 2025, at approximately 1532 hours, I was dispatched to [REDACTED] in reference to a disturbance.

Upon my arrival, I made contact with Keilani Sinclair who advised that she was six weeks pregnant. She advised that she was in the bedroom with [REDACTED] Hunter Clayton, whom [REDACTED]. She said while she was in the room on the phone with her sister, Clayton began insulting her. She said she got up and attempted to go to the bathroom and Clayton pushed her onto the bed. Sinclair advised that she told Clayton not to push her because she was pregnant. Sinclair advised that she stood up again and Clayton began smoking marijuana in the room. Sinclair advised that she told Clayton not to smoke in the room. She said she grabbed the smoking glass pipe, threw it onto the ground, and broke it. Sinclair advised that she became upset that Hunter was pushing her around and with a closed fist, she hit Clayton on the side of his head. Sinclair advised that Clayton pushed her onto the bed again. Sinclair advised that Clayton exited the room out of their bedroom window and sat on the front porch. Sinclair said she asked Clayton to leave the property but Clayton entered the house again and chased Sinclair to the bedroom. Sinclair stated that while she was on the phone [REDACTED] the suspect grabbed her phone and threw onto the ground which cause the phone screen to shattered and not turn on, hindering her from continuing her contact with emergency services.

I made contact with Clifford Johnson and he advised that he did not witness any physical altercation but heard both parties arguing very loud. Johnson advised when Sinclair asked Clayton to leave, he did not want to leave. Johnson advised that he grabbed a hammer and told Clayton to leave. He advised Clayton sat on the chair and was quiet. John said he returned to his room and the verbal argument stopped.

Sinclair advised that the value of her I-phone 16 Pro Max is \$1400. I entered the bedroom of Clayton and Sinclair and noticed an ultrasound photo on the wall which was taken on April 23, 2025.

Clayton fled the scene prior to law enforcement arrival.

At approximately 1851 hours, Clayton was located and placed under arrest. He was transported to the Indian River County Jail. Once we arrived to the county jail. Post Miranda, Clayton stated that while he was in the bedroom Sinclair was on the phone with her sister talking about a therapy session her father canceled. Clayton said he made a comment about the father missing the session and Sinclair became upset. Clayton said Sinclair punched him in the face and begun destroying his property. He said at that point he exited through the bedroom window and walked around the neighborhood to give Sinclair time to cool off. Clayton said he returned back home and Sinclair was still upset. Clayton said Sinclair threatened to call law enforcement and because he said he was going to call law enforcement. Clayton advised that he never damaged Sinclair phone and she known to lie and was having a manic episode.

I found Hunter Daniel Clayton in violation of Florida Statute:

On 04/26/25 at 1858 hours, I, Ofc. Kuehn, was dispatched to 526 21st Street (Fresh Market) in reference to a vandalism complaint. The complainant, Georgina Whu, informed Vero Beach Police Telecommunications that a male had walked up and flattened a tire to her vehicle. Mrs. Whu described the male subject as wearing a camouflage hoodie with blue jeans and wearing a backpack. Mrs. Whu stated the male had a knife or something in his hand and was last seen walking towards 21st Street near Wells Fargo (600 21st Street).

Prior to my arrival, Ofc. Aguilar, Ofc. Doty, and Ofc. Covarrubias arrived on scene and came into contact with a white male subject fitting the aforementioned description provided by Mrs. Whu, on the west side of ABC Fine Wine and Spirits (602 21st Street). Upon my arrival, the white male subject was in the process of being detained and was later identified as Lester Kelly Elder (DOB: 12/28/90). Once Mr. Elder was detained, I responded to the parking lot of Fresh Market (526 21st Street) to make contact with the victim, Mrs. Whu.

According to Mrs. Whu, at approximately 1856 hours on 04/26/25 she and "EW" were in her silver 2024 Hyundai Palisade (Florida tag# KARR44) preparing to back out of a parking space to leave Fresh Market. Mrs. Whu stated as she was in the process of backing up she observed a male wearing a camouflage hoodie with a backpack and blue jeans approach the rear driver side of her vehicle. Mrs. Whu stated the male walked very close to her vehicle at which time she observed his face briefly in the rear view mirror. Mrs. Whu stated as she was in the process of locking her car doors she heard a loud pop. Mrs. Whu stated she observed the male to have a black object in his hand that he held at chest level. Mrs. Whu stated that once she heard the pop the male continued walking away from her vehicle and when he was significantly far enough away she and "EW" exited the vehicle and walked to the front of Fresh Market and contacted the police.

While speaking with Mrs. Whu and "EW", Ofc. Doty arrived to assist me. On scene, Ofc. Doty was able to view camera footage from Fresh Market for the parking lot and see if this incident had been captured on video. Later, Ofc. Doty informed me that there was video for this incident which was captured on my body worn camera. In the video at 1857 hours on 04/26/25, I observed a male matching the description provided by Mrs. Whu walking up to the rear of the vehicle on the driver side. I observed the male to appear to stop momentarily at the drivers side rear tire and suddenly the vehicle appears to drop. I then observed the male to continue walking in a westerly direction away from the vehicle while attempting to put something in his pocket.

While speaking with Mrs. Whu, I observed the damage to her vehicle which consisted of a flat left rear tire that appeared to have an approximately 3" cut in the tire. I was later informed that the tire cost approximately \$350.00 when purchased new.

After photographing the damage to the vehicle, Mrs. Whu was asked if she would be able to identify the individual if she were to see him again. I then read verbatim the Vero Beach Police Department Show-Up Instructions to her which she signed. Once signed, I transported Mrs. Whu to the parking lot on the west side of ABC Fine Wine and Spirits (602 21st Street) where she was presented with an individual (Lester Elder). Mrs. Whu identified Mr. Elder as the individual she observed near her vehicle by stating "Yup, that's him."

Once identified, I returned Mrs. Whu to Fresh Market and responded back to ABC Fine Wine and Spirits. On scene, I made contact with Mr. Elder and attempted to conduct a post Miranda interview, however, Mr. Elder would not verbally answer if he understood his rights therefore no interview was conducted. I then informed Mr. Elder he was under arrest for Criminal Mischief in violation of F.S.S. 806.13.

It should be noted a black handled pocket/folding knife was taken off of Mr. Elder's person. The knife was later placed into evidence at the Vero Beach Police Department.

Once under arrest, Mr. Elder was transported to the Indian River County Jail for booking, processing and to be held on a \$500.00 bond.

This incident was captured on body worn camera and later downloaded into a secure file at the Vero Beach Police Department.

NARRATIVE

On 04/26/2025 at approximately 2024 hours, I was dispatched to [REDACTED] in reference to a disturbance.

Upon arrival on scene, I made contact with Jessica Sessions, she advised that [REDACTED] (Anthony Palladino) had pushed her against a wall during an argument. Ms. Sessions advised that her and Palladino had gotten into an argument over money, during this argument Palladino became aggressive, grabbed her and pushed her against the wall. After this occurred, she advised that [REDACTED] heard the argument become physical and [REDACTED]. Both her and Palladino waited outside for Law Enforcement to arrive. Ms. Sessions advised that her and Anthony Palladino [REDACTED]

Upon examining Ms. Sessions, I observed multiple marks on her leg and her right arm that are consistent with being grabbed and pushed up against a wall. She complained of chest pain from the push but advised there were no visible marks on her chest from it. Ms. Sessions declined EMS on scene. I took pictures of the injuries to Ms. Sessions and uploaded them to Evidence.com

Cpl. Quaglia originally interviewed Palladino, according to him, it was just a verbal argument and nothing became physical. Palladino advised that he never put his hands on Ms. Sessions during the argument.

I placed Palladino in custody and put him in the back of my patrol car, I Mirandized him and he advised that he understood his rights and wishes to speak to me. Palladino advised that he and Ms. Sessions got into an argument over money, he advised that during the argument she progressively got more irate and began throwing things. Palladino advised that she punched him in the face and smacked him in the face, he advised the only time he put his hands on her was to keep her away from him.

I examined Palladino's face and noticed no visible marks or bruising to validate that he had been punched or had been struck in the face.

I made contact with the [REDACTED] originally (Jacob Palladino). He advised that there have been many different times where [REDACTED] (Anthony Palladino) had struck [REDACTED] (Jessica Sessions). He advised that on today's date he heard the argument begin and then heard it become physical, this is when he advised that Ms. Sessions told him to [REDACTED] due to Anthony Palladino placing his hands on her. He advised he did not physically see the altercation but heard it from another room.

Due to the physical marks on Ms. Sessions and her statement, I found probable cause to charge Anthony Palladino with Battery, F.S.S (784.03.1a1.[2560]).

NARRATIVE

On Saturday, April 26th, 2025, at approximately 1658 hours, I responded to [REDACTED] in reference to a past disturbance call for service. Upon arrival, I contacted D/S Hubbard and the complainant identified via Florida identification card as Crystal Wilson.

Crystal explained yesterday, on Friday, April 25th, 2025, she was at [REDACTED] house who she knows as Demetrius. She advised she was hanging out with Demetrius and [REDACTED] at roughly 0500 hours. Crystal explained her and Demetrius have been [REDACTED] but are not dating and do not reside together. She advised after [REDACTED] her and Demetrius got into a verbal altercation over a lack of communication for a week, leading to Demetrius punching her in the face. Crystal advised Demetrius beat her and she struggled to get away, but finally was able to vacate Demetrius's residence. She advised she did not call immediately cause she was in fear of him.

While speaking with Crystal, I observed her to have black and blue bruising to both eyes, her nose, and laceration above her left eye. Her left eye appeared to be slightly swollen underneath the eye and to the eyelid/eyebrow area. Crystal advised Demetrius made further comments about harming her worse throughout the struggle.

She pointed out the address the incident occurred at which was identified as 4665 38th Avenue. After conducting a cleared call search in Indian River County Sheriff's Office database, Demetrius Vashon Bostic, a black male born on December 4th, 1984 was listed as a resident.

Myself and Deputy Hubbard attempted to make contact with Demetrius at 4665 38th Avenue but were met with negative results.

I contacted Indian River County Sheriff's Office Real Time Crime Center to create a photo line-up for Demetrius. Deputy Sides administered the photo line-up to Crystal where she positively identified Demetrius as the male who punched her in the face causing her injuries.

Based on the statement given by crystal and injuries sustained, Demetrius violated F.S.S. 784.03 Battery (dating violence). Due to Crystal and Demetrius [REDACTED] this incident meets the criteria for dating violence.




NARRATIVE

On Saturday, April 26, 2025, I Deputy Martin responded to 66 Woodland Drive in reference to an auto crash with no injuries. Dispatch advised that a caller was reporting a vehicle had crashed through a building.

Upon my arrival, I was notified by other deputies on scene that it was a single vehicle crash with no injuries. I was also told that the driver of the vehicle appeared to possibly under the influence of alcohol. When I first made contact with the male, he appeared to have slurred speech and slow body movements. I was advised by a witness on scene that the male I was talking to was in the driver seat of the vehicle of the crashed car. I could detect an odor of alcohol emitting from the males' breath as he spoke to me. I asked the male if he would be willing to participate in field sobriety exercise to see if he is impaired beyond his normal faculties. The male named Joseph B. Santaniello stated that he would be willing, and would spontaneously utter that he had been drinking tonight.

I then, read Santaniello his Miranda warnings from my agency issued Miranda warning card. Santaniello stated that he understood his rights that I read to him, and he was willing to speak with me. Santaniello stated that he had 2 beers at a bar in Fort Pierce prior to the crash. After questioning Santaniello I attempt to complete field sobriety exercises.

I at first attempted to complete the first exercise, but Santaniello failed to listen and follow instructions and attempted to walk away from myself during the examination. I then completed exercises in the Indian River County Jail. Santaniello stated to me that he did have medical issued with his heart, but did not state what condition would affect the exercises that pertain to balance and coordination.

These are my results:

Horizontal Nystagmus

After explaining the instructions of the exercise and Santaniello stating he understood I observed lack of smooth pursuit in both left and right eyes. I observed nystagmus at maximum deviation in both left and right eyes. I observed I observed nystagmus prior to 45-degree deviation in both left and right eyes. Santaniello required multiple instructions not to move his head and to use his eyes only.

The Walk and Turn

I had to explain the instructions of the exercise to Santaniello multiple times and allowed him to stand at an improper starting position while I demonstrated the exercise. While completing the exercise Santaniello failed to complete heel to toe steps while walking. Santaniello failed to count out loud while conducting the entire exercise as instructed. Santaniello completed the improper number of steps as instructed. Santaniello did not complete the correct turn as instructed. Did not keep hands down by his side while completing the exercise.

The One Leg Stand

After explaining the instructions of the exercise and Santaniello stating he understood I observed him not follow instructions if he needed to put his foot down. In the middle of the exercise Santaniello stop attempting the exercise and

began to argue. Santaniello then attempted the exercise again where he had to be instructed to count out loud as originally instructed. Santaniello continued to be argumentative, and it appeared that he could or would not attempt to complete the exercise any further.

Finger to Nose

After explaining the instructions of the exercise and Santaniello stating he understood I observed him consistently not place either index finger in the same place as instructed. Santaniello would keep his index finger on his nose until he would be informed of the instructions again. Santaniello would continually use the tip of his finger to touch his nose instead of the pad of his finger as instructed. Santaniello would never place the pad or index of his finger in the same place as instructed.

After the exercises were completed, a lawful sample of his breath was requested by Deputy J. Hiss ID#: 5730 Breath test operator. Santaniello gave 2 samples of breath, the first reading at a 0.139 BAC and the second reading at 0.124 BAC. Due to the totality of the circumstances that Joseph B. Santaniello was in actual physical control of a motor vehicle and was involved in a crash. That Santaniello blood alcohol content was above the legal limit of 0.08. That Santaniello caused property damage from the crash he was involved in. Santaniello was placed under arrest for FSS 316.193(3)(C)1 DUI with property damage misdemeanor with a bond of \$500.00 USD reference to DUI citation AJ8SVZE.





NARRATIVE

On April 26, 2025, at approximately 2323 hours, I conducted a traffic stop on the 1600 block of Old Dixie Highway, Vero Beach, Florida, on a white BMW 330ci bearing Florida tag CK29EN for running the traffic light on the 800 block of Old Dixie Highway.

Upon making contact with the sole occupant of the vehicle, I identified myself and explained the reason for the stop. The driver of the vehicle identified as Johnathon Garret Eison, stated that he knows he doesn't have insurance on the vehicle and that he hasn't switched the insurance over yet. I then ran a query with a Missouri ID card that Eison provided and it yielded a suspended license out of Missouri. The tag also comes back to a different vehicle (Gray Jeep) that Eison admitted was his old vehicle. Eison then admitted to knowingly driving with a suspended license, not registering his vehicle, and failing to insure the vehicle.

I then placed Eison in handcuffs that were double locked and checked for proper fitment. Eison was transported to The Indian River County Jail with out further incident.

Based on my investigation I have probable cause to charge Johnathon G. Eison with:

1. F.S.S. 320.02(1) operating without motor vehicle registration, Citation # AHMRUZE
2. F.S.S. 322.34(2)(A) Knowingly DWLSR (1st), Citation # AHMRUYE

 On 04/27/2025, at 00:12 (Specifically include facts constituting cause for arrest.)

On 04/27/25 at approximately 0012 hours, I, Ofc Aguilar, responded to the intersection of the Indian River Blvd. and Barber Bridge in order to assist Ofc.Kuehn with his traffic crash investigation. On scene, I made contact with a witness/complainant of the incident, Aaron Lopez. Lopez stated prior to the incident he was located at the above-mentioned intersection in his black Jeep utility bearing (Florida tag# PGS0Q) facing southbound on the Indian River Blvd. Lopez stated while stopped at the red light of the intersection, he then observed a set of lights and vehicle proceed westbound from the Barber Bridge and off the roadway into a wooded lot that was located to the west of the intersection. Lopez stated he then exited his vehicle and observed a black Chevy pickup bearing (Florida tag# Y27REI) crashed into the wooded lot. Lopez stated he then yelled out to the Chevy pickup truck and asked if they were okay. Lopez stated he then observed the later identified, William Holman exit from the driver's seat of the Chevy pickup. Lopez stated that Holman informed that he was okay and that he was the only occupant within the Chevy pickup. Lopez was also on the phone with emergency services.

I was informed by Ofc.Kuehn that he had completed his traffic crash investigation. I then made contact with Holman who was unsteady on his feet and had the strong odor of an alcoholic beverage emitting from his person while away from his vehicle. Holman also had slurred speech. I then informed Holman that based on my observations and the completion of the traffic crash investigation that I was going to begin a criminal DUI investigation. Holman understood and I asked if he would be willing to perform standardized field sobriety exercises in order to confirm that he was capable of safely operating a motor vehicle. Holman agreed and stated that he did not have any physical limitations that would prevent him from completing the exercises. Holman stated that he was not diabetic but did complain of pain to his right arm. Holman advised that he did not have any medical conditions with his eyes and that he was wearing contacts.

Instructions for each exercise were read verbatim from an SFST note sheet and were demonstrated prior. Holman also understood the instructions for each exercise prior to commencing. The results were as follows:

Horizontal Gaze Nystagmus

- Lack of smooth pursuit in both eyes
- Distinct and sustained nystagmus at maximum deviation
- Onset of nystagmus prior to 45 degrees

Walk and Turn

- Cannot keep balance while listening to instructions
- Starts too soon
- Does not touch heel to toe
- Uses arms to balance
- Improper turn
- Incorrect number of steps (10)

One leg stand

- Sways while balancing
- Uses arms to balance
- Puts foot down
- Does not look at elevated foot

Based on the above-mentioned circumstances, Holman was placed under arrest for violation of F.S.S. 316.193 (Driving under the Influence citation #). Holman was then transported to the Indian River Cleveland Clinic for medical clearance and then the Indian River County Jail. While at the Indian River County Jail, I then conducted a 20-minute observation period on Holman. I then requested that Holman provide a lawful sample of his breath for the purpose of determining its alcohol content. Holman responded "nope". I then read Holman his Implied Consent warnings and again asked Holman if he would be willing to provide a breath sample. Holman advised multiple times that he would not provide a comment and wished legal representation. Holman was then transferred to Indian River County Jail staff.

Body camera video of the incident was submitted into a secure file at the Vero Beach Police Department.
