


NARRATIVE

On Tuesday, May 13, 2025, at approximately 1220 hours I was dispatched to 1459 20th Street in reference to a violation of a no-contact order. Upon arrival, I contacted the complainants, Valerie A. Muth and Carmen P. Carpio. They reported observing Milton Leroy Grier at [REDACTED] despite an active no-contact order issued by Judge R.D. White on May 11, 2025.

Valerie and Carmen explained that they were at Jimmeara Grier's residence [REDACTED] to conduct a welfare check when they saw Milton park his vehicle at [REDACTED]. He then walked across to [REDACTED] and tried to enter the home through the front door but was unsuccessful.

While speaking with Valerie and Carmen, I requested Deputy Newman to locate Milton at [REDACTED]. Upon his arrival, Deputy Newman found Milton standing in the driveway of Jimmeara Grier's home.

As Milton was located within 500 feet of the victim's residence, I placed him under arrest for violating his pretrial release conditions (312025CF000520AXXXVB), which prohibit him from approaching the victim's residence. Milton acknowledged his awareness of the no-contact order, having signed the relevant form prior to his release from custody.





NARRATIVE

On May 13th, 2025, at approximately 1229 hours, I responded to 1195 U.S. Highway 1 (Dollar Tree) in reference to a disturbance with EMS needed.

While I was enroute, a complainant advised public safety dispatch that a physical disturbance occurred at Dollar Tree between a vagrant male and an employee. The complainant stated to public safety dispatch that the male attacked the caller's manager who needed medical attention by EMS. The vagrant male was described as a white male wearing a brown hat, black shirt, black pants, a blue backpack and flip flop type sandals. The male was last seen walking southbound on U.S. Highway 1. Sergeant D. Rodriguez made contact with the victim at the store and then advised via radio traffic the male had a beard.

I immediately responded to the area to locate the suspect. Reserve Deputy Sheriff J. Hartley observed a male matching the description of the suspect walking southbound on U.S. Highway 1 at the approximate 999 block (Dyer Mazda). The male was shirtless at the time but had a beard and a blue drawstring type bag. The male made a spontaneous statement that he was the victim in the incident at Dollar Tree. D/S Hartley detained the male in hand restraints while I made contact with the victim. The male was identified as Todd Gais by his Florida ID card.

I then made contact with the victim, store manager Chris Isler, district manager / witness Nichole Pushman and Dollar Tree Trainer / witness Christina Ward. I conducted separate interviews of all three.

Pushman stated the following in essence: the three employees were taking a break outside of the store at the front entrance. The suspect approached Isler after rounding a support pillar, muttered something to Isler and got up in his face and then began to scream at him. The suspect then became very angry and pushed Isler several times with both hands. After pushing Isler, the suspect attempted to land a "haymaker" type punch which may have missed, however Pushman was unsure. Isler's glasses were knocked off in the physical confrontation. Pushman described the suspect as a male with a white beard and a drawstring type bag with a vape pen.

Ward stated the following in essence: the three employees were taking a break outside of the store at the front entrance. The suspect approached Isler after rounding a support pillar, muttered something to Isler and got up in his face and then began to scream at him. The suspect then became very angry and pushed Isler several times with both hands. After pushing Isler, the suspect attempted to land a "haymaker" type punch. Isler ducked the punch but was struck.

Isler stated the following in essence: He was taking a break with several employees (Ward and Pushman). The suspect approached Isler after rounding a support pillar, attempted to spit at him, which missed and was verbally aggressive. The suspect pushed Isler with both hands and one of the pushes knocked off Isler's glasses. Isler then ducked a "haymaker" type punch which the suspect threw at him. I did not observe any injuries to Isler.

I then transported Isler to Gais' location for a show up at Dyer Mazda. I informed Isler that this may or may not be the suspect. Isler immediately identified Gais as the suspect.

I returned to Gais and read him his Miranda rights. Gais waived his rights and agreed to an interview. Gais stated he was attempting to purchase food at Dollar Tree and believed Isler was saying derogatory things about his daughter. I asked Gais

On Tuesday, May 13, 2025 at approximately 1252 hours I responded to [REDACTED] in reference to a disturbance.

While en route to the scene, call comments advised that a male had strangled a female and was last seen leaving the area in a red shirt.

Upon my arrival, I observed the victim, Ms. Niyah Bailey, visibly upset, with apparent injuries to her neck. I then observed a male further off in the distance matching the suspect description, I asked Ms. Bailey if that was the male in question, to which she stated yes. I requested the next unit on scene make contact with my victim as I proceeded to the suspect.

I made contact with the male, now identified by Florida ID card, as Mr. Jerome Staines, who advised me of the following in summation during a sworn recorded statement:

Mr. Staines and Ms. Bailey [REDACTED] Today, following an argument, Ms. Bailey began to pull Mr. Staines' clothing off of the hangars in the closet.

Mr. Staines stated he then grabbed her, then shoved her off where she then reportedly fell in to a wall.

Mr. Staines informed me he then grabbed Ms. Bailey and forcefully removed her from his apartment. Mr. Staines later admitted that he grabbed Ms. Bailey by the neck and head – when describing the incident, he made a motion with his arm which signaled a head-lock style motion.

Mr. Staines then stated Ms. Bailey struck him in the face following this incident.

Mr. Staines stated he threw [REDACTED] and that he paid for the phone that was broken.

I then spoke with Ms. Bailey who informed me of the following during a sworn recorded statement in summation:

Ms. Bailey and Mr. Staines [REDACTED] As she was taking his clothes off of a hangar in the closet Mr. Staines grabbed her around the neck and pulled her out of the residence.

She described Mr. Staines' arm as being around her neck the entire time where she then stated she felt dizzy and as if she was going to pass out- posing a risk of great bodily harm. Ms. Bailey described this incident as taking approximately two to three minutes. After this, Ms. Bailey stated that Mr. Staines destroyed her phone. Ms. Bailey informed me she pays for the phone and the bill, and that the total value

of the phone was between 200-300 dollars.

Ms. Bailey was treated by Fire Rescue for her report of strangulation. I noted that Ms. Bailey's account of the strangulation was consistent with that which has been previously described by victims of strangulation.

Mr. DShaun Staines, the brother of Mr. Jerome Staines, provided a statement which was difficult to decipher, as he stated that he had seen everything, however, he later admitted he was on the stairwell and only saw part of the event.

I observed visible injuries to Ms. Bailey's neck, such as a large red scratch on the left side of her neck and what appeared to be slight discoloration around her neck which further corroborated her statement. Based upon this, admittance by Mr. Staines as to grabbing Ms. Bailey by the neck, throwing her, and grabbing her first, and further affirmed by Ms. Bailey's accounting of events; I determined Mr. Staines to be the primary aggressor in this incident of Domestic Violence. I observed Ms. Bailey's phone to be damaged to the point where it can no longer be used.

Based upon the totality of the circumstance, to include the damaged phone, statements by both parties, visible injuries observed on scene, and Ms. Bailey's report of her ability to breathe being impeded by Mr. Staines' arm around her neck, I established probable cause to arrest Mr. Jerome Staines for the crime of Battery Domestic Violence by Strangulation F.S.S 784.041.2(a) and Criminal Mischief F.S.S 806.13.

Katz was found inside the restroom of the Dunkin Donuts and ultimately admitted to returning to Space Coast after the trespass warning was issued.


Katz was arrested under F.S.S 810.08(2)(a) - Trespass in Structure or Conveyance,

A search subject to arrest of Katz's property relieved a used syringe, which is known to me to be directly correlated with using illegal narcotics. I additionally discovered a clear plastic baggy containing a crystal-like rock substance which I believed to be methamphetamine. A preemptive field test of the substance yielded a positive result for the presence of methamphetamine. The substance weighed 0.58g in the clear baggy.

Katz was additionally charged under F.S.S 893.13 Possession of a Controlled Substance and F.S.S 893.147.1[3768] Possession of Drug Paraphernalia.

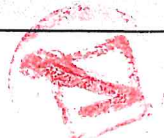

On Tuesday, May 13th, 2025 at approximately 1754 hour I responded to 1200 Old Dixie Hwy in reference to an auto accident involving a motorcycle and a vehicle.

Upon arrival I made contact with Corporal Barcaro. The defendant, Aaron Dunbar, was already detained and secured inside of Corporal Chouinard's patrol. Cpl. Barcaro stated that upon arrival she observed Dunbar pushing his motorcycle southbound on Old Dixie Hwy from 12th Street. She advised that she observed minor scrapes on his body and that he matched the description of the person involved in the auto accident. She stated she made contact with Dunbar who acknowledged that he was involved in the collision and claimed that the victim had struck him and fled the scene.

I made contact with Cpl Chouinard who provided the following statement:

"On May 13th, 2025, at approximately 1726 hours, I responded to the intersection of Old Dixie Highway and 12th Street in reference to a crash with injuries. Public safety dispatch advised the crash involved a motorcycle and a Nissan pickup truck. Public safety dispatch further advised the motorcycle was on fire.

As myself and Corporal B. Barcaro arrived on scene, I attempted to visually scan the area for the motorcycle / rider to possibly render aid. I then observed the motorcycle rider pushing the motorcycle down the east shoulder of Old Dixie Highway. This was well south of the intersection at 11th Place. The rider appeared to be leaving the scene of the crash. At this point, I did not locate the other vehicle involved.

Corporal Barcaro identified the motorcycle rider as Aaron Dunbar, date of birth 9/6/1971. The motorcycle was bearing Florida tag MWYS97. Dunbar claimed he was struck and the other vehicle left the scene. I then spoke with a witness to the crash, Gregory Sanders, who was parked on the west shoulder of Old Dixie Highway. Sanders advised me the motorcyclist was involved in a crash with another vehicle. I instructed Sanders to wait for a Deputy to speak with him.

I returned to the intersection to search for the Nissan pickup. I located the Nissan pickup (bearing Florida tag Y25DDT) and the driver, Donald Zeuch (date of birth 2/15/1954). Zeuch stated he was traveling east on 12th Street in the inside lane approaching the intersection of Old Dixie Highway when the motorcycle and rider exited the parking lot of 1201 Old Dixie Highway (7-11 Store). Per Zeuch, the motorcyclist entered into the direct path of travel of his vehicle. The motorcycle then struck the left rear tire of his vehicle, deflating the tire and damaging the rim. I observed a deflated tire and scrape damage to the rim. Zeuch advised the motorcyclist left the scene and made no effort to provide him with all information required in a traffic crash. It should be noted that Zeuch's truck was parked in an obvious post-crash area that had direct line of sight to where the crash occurred. I advised Corporal Barcaro to place Dunbar under arrest.

I returned to Corporal Barcaro and spoke with Sanders. Sanders accounts of the crash were the same as Zeuch. Sanders identified the motorcyclist as Dunbar."

Cpl. Barcaro stated that incident to arrest she located a small clear plastic baggie inside of Dunbar's right pant pocket. Cpl. Barcaro and Cpl. Ruiz both stated that it is their opinion based upon their training and experience that the substance appeared to be crystal meth. The baggie was weighed and it was approximately 14.02 grams. I conducted a presumptive




NARRATIVE

On Tuesday, May 13th, 2025 at approximately 1626 hours I responded to 14415 US Highway 1, Sebastian Gardens Inn & Suite Motel in reference to a past auto burglary.

Upon arrival I made contact with the victim Dustin Woods. Woods stated that he captured a male subject that was identified as Steven Soltysik forcing entry and going into his locked toolbox that was in the bed of his vehicle. Woods stated that he did not give consent or permission to Soltysik to make entry into his vehicle or toolbox. On the video I observed a male that I positively identified as Soltysik due to previous personal encounters with him on recent calls for service. Woods was also able to identify Soltysik through his personal previous encounters. On the surveillance footage I observed Soltysik walking around Wood's vehicle. I observed him walk on the passenger side of the vehicle and attempt to open the locked toolbox. He is observed trying to force it open. He walks over to the driver side and continues to attempt to force entry into the locked toolbox. He is able to break open the lock and begins to rummage through the toolbox. The estimated damage to the toolbox is \$486.00. Woods vehicle is a white Ford F150 bearing FL Tag# GVG82.

It should also be noted that I responded to a disturbance at the same location in reference to a past disturbance involving the two parties on May 12, 2025. During this incident, Woods advised Soltysik accused him of stealing his toolbox which was proved false once he provided me with receipts of his proof of purchase. It should be noted that Woods locked the toolbox in front of me. Woods stated that Soltysik was going to respond to the Motel on 5/13/2025 to speak with him about the toolbox. Woods stated he did not want to talk to Soltysik about the incident and that he did not have permission to enter his vehicle and observe the toolbox.

I then made contact with a witness, identified as Blaze Howe. Howe stated he was present when Woods purchased the toolbox. Howe stated he confronted Soltysik via text message in reference to the auto burglary, in which Soltysik stated he did not care that the incident was captured on video.

Deputy Matthews and I then made contact with Soltysik at 928 Canal Circle. I advised Soltysik of his Miranda warnings, in which he acknowledged and declined to speak with me. I placed Soltysik in handcuffs and in the back of my marked patrol vehicle. It should be noted that one of Soltysik's roommates, who did not want to identify himself, was present throughout our contact with Soltysik and advised Soltysik traveled to the Motel to look at the toolbox.

The video camera footage, text messages and proof of purchase were all uploaded via AXON Capture. Blaze and Woods both provided me with verbal sworn statements.

Based upon the totality of the evidence I placed Soltysik in custody for the following:

- Violation of FSS 810.02(4)(b) – Burglary of an unoccupied conveyance. Soltysik forced entry into Woods vehicle causing damage to the toolbox. Soltysik was informed on the previous day that the toolbox did not belong to him. Despite being informed by law enforcement on 05/12/2025 that it was not his, he returned with the intent to commit a crime by forcing entry into the locked toolbox and rummaging through the contents within.
- Violation of FSS 806.13(1)(b) – Criminal Mischief. Soltysik caused an estimated \$486.00 in damage to Woods toolbox.
