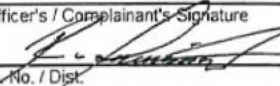
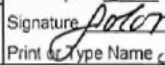

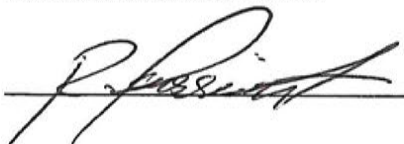

On **09/03/2026** , at **03:03** (Specifically include facts constituting cause for arrest.)

On September 2, 2026, at approximately 2320 hours, I was dispatched to the 2000 Block of U.S. Highway 1, Sebastian, Florida 32958, in reference to a train versus pedestrian accident.

Upon my arrival at the train tracks, I observed a white male wearing shorts and a white shirt walking with what appeared to be an employee of the train. I observed Corporal Keskinen #410 approach the two males. As I approached, Corporal Keskinen advised the male wearing a white shirt to walk off the train tracks and to me. Corporal Keskinen advised me that, as he approached the male wearing the white shirt, he observed him in the middle of the train track between two white signs that read "No trespassing." Corporal Keskinen advised the male that he needed to walk to me several times. The male stood in the middle of the train tracks and argued with Corporal Keskinen. I approached the male and requested that he walk with me to my nearby patrol vehicle off the train tracks. Corporal Keskinen advised me that the male was Jesse David Caron. Corporal Keskinen advised he knew Jesse from previous incidents. Jesse was still being uncooperative and stated that his wife was dead and that he was going home. I told Jesse several times we would locate his wife, but he needed to exit the tracks and speak with officers. At this time, I placed one of my hands on Jesse's shoulders and pointed him off of the railroad tracks. Once Jesse was just off the tracks, he fell to the ground crying. While on the ground, Jesse stated his wife was struck by the train right in front of him. Jesse stated it was his fault and continued to cry.

At this time, EMS and other officers arrived at the scene and began to attempt to locate the missing female who was possibly severely injured. At this time, Jesse stood up, and I again advised him that we needed to move away from the train tracks. Jesse turned and faced me. I observed Jesse square off his stance, push his chest out, and bow out his arms in what appeared to be a fighting stance. I again advised Jesse that he needed to get off the train tracks, but Jesse stated he was going home. I advised Jesse that he could not go home at this time due to the investigation and his being a witness. Jesse again stated he was going home and attempted to walk toward me.

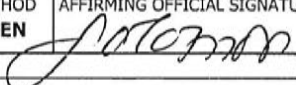
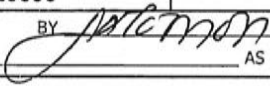
When Jesse walked towards me, he got so close that I had to place one of my arms against Jesse's chest to keep a safe distance while attempting to get control of Jesse's arms. I pushed Jesse backward, and he began to attempt to walk away from me and toward the search party, stating he was going home. As Jesse began to walk away, I was able to get control of one of Jesse's arms. At this time, Officer Venegas #420 had to abandon the search for the missing female and assist me with controlling Jesse. Officer Venegas took control of Jesse's other arm as he continued to tense his arm and pull away from us. At this time, Officer Venegas and I placed Jesse onto the ground and began to attempt to restrain him. Jesse continued to attempt to pull his arms away and tense his body in an attempt to defeat our efforts to restrain him. At this time, Corporal Keskinen also abandoned the search for the missing female and assisted in fully controlling Jesse. Jesse was placed into mechanical hand restraints. Officer Venegas and I attempted to walk Jesse to my patrol vehicle, while Corporal Keskinen rejoined the efforts to locate the missing female.

While attempting to walk Jesse to my patrol vehicle, he continually pushed and pulled away from officers. Jesse also continued to tense his arms. Once at my patrol vehicle, Officer Harris #450 and I had to hold Jesse while Officer Venegas conducted a search of his person. During the search, Jesse continued his irate behavior and pulled away from the officer. After searching Jesse, I attempted to place him into the rear of my patrol vehicle, but the male refused to enter. Once the male was in the rear seat of my patrol vehicle, he continued to be irate and uncooperative with officers. Soon after, I was advised via radio that the female was discovered deceased.

Officer Venegas attempted to interview Jesse, but he continued to be uncooperative and yelled profanities at the officer. Eventually, Officer Venegas was able to get a statement from Jesse, in which it was determined he was the last person to observe the deceased female alive. Jesse was held at the scene until Detective Sergeant Garrison #233 arrived. While waiting for Detective Sergeant Garrison, Jesse repeatedly stated it was his fault his wife was dead. Upon Detective Sergeant Garrison arriving at the scene, she attempted to speak with Jesse, but he was uncooperative. Detective Sergeant Garrison attempted to get resources for Jesse, but he denied all services. Detective Sergeant Garrison attempted to get Jesse a way home, but he stated, "Take me to jail." When asked where he lived, Jesse would only provide a road but would not provide the house number.

Jesse was placed under arrest and was transported to the Indian River County Jail. While en route to the jail, Jesse continued to yell profanity at officers and made suicidal statements.

No further action was taken by this officer.
