#### NARRATIVE

On October 18<sup>th</sup>, 2024, at approximately 1844 hours, I responded to the area of 1400 US Highway 1, Vero Beach, Florida, in reference to a DUI investigation.

Upon arrival, I made contact with Corporal Ruiz #4491, who stated he conducted a traffic stop on a white Dodge van (AL tag 58ADYUM) for running a red light. Corporal Ruiz advised he could detect the odor of marijuana coming from the driver, who was identified as Mr. Jonathan Postell II, by his Florida driver's license. Corporal Ruiz also stated that Mr. Postell also appeared to have a green discoloration to his tongue and also explained that Mr. Postell stated he recently smoked marijuana.

I subsequently made contact with Mr. Postell. While speaking with Mr. Postell, I could detect the odor of marijuana emitting from his person, he also had glassy eyes, and appeared to have tremors.

Based on my observations, I requested Mr. Postell complete Standardized Field Sobriety Exercises (SFSE). During the medical questionnaire, Mr. Postell advised that he does not take any medications and is not being seen by a doctor or dentist. Mr. Postell did state that he has astigmatism.

The first exercise was the Horizontal Gaze Nystagmus exercise. I explained the instructions for the exercise and Mr. Postell stated he understood and did not have any questions. During the instructions, Mr. Postell had to be instructed multiple times to keep his arms down by his side. I did not observe lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, or onset of nystagmus prior to 45 degrees. However, I did witness lack of convergence in Mr. Postell's left eye.

The next exercise was the Walk and Turn exercise. I explained the instructions and demonstrated the exercise, and Mr. Postell stated he understood and did not have any questions. During the exercise, Mr. Postell started before being instructed to do so, stepped off the line, did not touch heel-to-toe, and made an improper turn.

The third exercise was the One Leg Stand. I explained the instructions and demonstrated the exercise, and Mr. Postell stated he understood and did not have any questions. During the exercise, Mr. Postell used his arms to regain balance. He also did not follow instructions and counted incorrectly and did not watch his foot. He also appeared to have tremors throughout the exercise.

The final exercise was the Modified Romberg. I explained the instructions and demonstrated the exercise. Mr. Postell stated he understood and did not have any questions. During the exercise, Mr. Postell estimated 30 seconds elapsed after 24 seconds.

Based on my observations, Mr. Postell was placed under arrest for DUI. He was placed into handcuffs that were checked for proper fit and double-locked. He was subsequently transported to the Indian River County Jail.

After arriving at the jail, Mr. Postell provided two breath samples, with the following results: 0.000 and 0.000. Based on



Upon my approach to the vehicle, I smelled the strong odor of burnt marijuana emitting from it.

While conducting my investigation, I identified Darel Destinoble was an occupant in the vehicle. Darel is currently on felony probation reference robbery with a gun/deadly weapon F.S.S. 812.13(2)(b) (Broward County case no. 2302032).

Upon learning of Darel's probation status, I called his probation officer, Sharola Hall DOC #01985, who advised that Darel, who does not reside in Indian River County, but Broward County, is violating a stipulation of his probation to not leave the county without permission. Sharola further advised Darel was never granted permission to leave the county. Moreover, Darel is not to be around narcotics. Darel was in a vehicle emitting the odor of freshly burnt marijuana. There was a tray of "shake" (marijuana flakes) under the driver's side seat approximately where his feet were.

A subsequent teletype query would reveal additional information that Darel was a fugitive from justification an active warrant out of Georgia for which extradition is being sought.

Due to these aforementioned facts, I found Darel in violation of his probation and probable cause was developed for F.S.S. 948.06, Violation of Felony Probation and F.S.S. 941.02 Fugitive from Justice.





#### NARRATIVE



Upon arrival I observed the defendant Richard Robert Turnbull standing by with Deputy Portocarrero. I observed Turnbull acting belligerent while in public. Turnbull's neighbor was attempting to keep him calm and told him that he needed to stop and relax. Deputy Portocarrero advised him of the same. I stepped away from Deputy Portocarrero and approached Deputy Matthews to see if he needed assistance. I could hear Turnbull shouting loudly numerous profanities and arguing with Deputy Portocarrero. While walking towards Deputy Portocarrero and Turnbull I could hear Turnbull shouting loudly, "Fuck you, fuck this", and numerous profanities loudly.

I approached Turnbull and informed him that he needed to stop acting disorderly and shouting profanities. I informed Turnbull that was he causing a public disturbance. Turnbull was warned by four deputies about his behavior and demeanor while in public. Turnbull's behavior was of such a nature to corrupt the public morals, outrage the sense of public decency, and affected the peace and quiet of persons of persons who witnessed it. There were numerous adults and children outside who witnessed Turnbull's irate behavior. I informed Turnbull that if he continued, he would be detained. Turnbull turned around and began to quickly walk away from me towards his residence. I moved towards Turnbull and grabbed his arms and he began to tense up. I forcibly restrained Turnbull's arms and took him down to the ground where he was secured him handcuffs without further incident.

Incident to arrest I searched Turnbull's left pant pocket of his jeans. Inside of his left pocket I located the following:

- 2 rounds of 40 caliber S&W rounds of ammunition
- 1 round of Cavim 92, .308 caliber rifle ammunition

A criminal history check through dispatch revealed that Turnbull is an 11 time convicted felon with his most recent conviction being on 10/20/2017 for aggravated battery.

Deputy Matthews advised that upon his initial arrival during his investigation Turnbull was acting disorderly and shouting profanities and had to be instructed to remain calm.

Based upon the totality of the evidence Turnbull was taken into custody for the following:

P1/1/1/20149

- -Violation of FSS 877.03, Disorderly Conduct.
- -Violation of FSS 843.02, Resisting Arrest without Violence.
- -Violation of FSS 790.23(1)(a), Felon in Possession of Ammunition

Turnbull was transported by EMS to Cleveland Clinic for medical clearance as a result of injuries sustained in the disturbance and not as a result of this arrest. Upon receiving medical clearance, he was transported to the Indian River County Jail for booking.

#### NARRATIVE

On October 19, 2024 at approximately 18:08 hours, I responded to 755 4<sup>th</sup> Street (Chevron gas station), in reference to a trespass call for service.

Upon my arrival, I observed a Hispanic male arguing with the clerk at the counter inside the Chevron gas station. I spoke with the complainant who was identified as Joshua M. Shannon who was an employee at Chevron. Joshua stated that the male appeared to be intoxicated and came into the store being irate. Joshua stated the individual was disrupting the place of business and was being loud making concerning statements. Joshua stated the male individual made statements that he wanted to fight him and people in the store. Joshua stated he told the Hispanic male individual to leave the store numerous times, but each side the individual refused and stayed inside and continued to cause a disturbance. The Hispanic male individual that was causing issues inside the gas station and refused to leave, was later identified as Rafael-Eduardo Soto JR.

Rafael stated he had been drinking and was intoxicated. Rafael advised he came to the store to exchange some of his small bills for big bills. Rafael's statements were inconsistent due to him being highly intoxicated. Joshua wanted Rafael trespassed from the Chevron and to not return back. 



#### NARRATIVE

On 10/20/2024 at approximately 0417 hours, I responded to 800 20th Ave in reference to a Accident Unknown.

Upon arrival, I made contact with Corporal Ruiz who advised he required assistance with translating on scene. I made contact with Luis Hernandez (arrestee) driver of a Gray Toyota bearing FL Tag #7868UG. Luis advised he was traveling northbound on 20th Ave and had a green light when he approached the intersection he T-boned Kurt Knappman (witness) the driver of a blue Honda bearing FL Tag #48DTYR, causing Kurt's vehicle to rollover. Kurt was transported to local emergency room with complaints of neck and back pain. Luis was determined to be the primary cause of accident for running a red light.

Upon completion of the Crash Investigation, I advised Luis I was changing hats and conducting a criminal DUI investigation, he was read his Miranda rights and acknowledged that he understood. Luis continued placing his hands in his pockets in what appeared to be an attempt to keep him from swaying. His eyes were bloodshot and watery, I could smell a distinct odor of an alcoholic beverage emitting from his exhaled breath and person. Luis's movements were lethargic and his speech was mumbled and slurred.

While interviewing Luis, he denied having any medical conditions including being diabetic or epileptic. Luis advised he does not currently take any medication. He stated he had about two mid-size Corona beers earlier at night with his dinner. When asked where he was coming from and where he was going, Luis pointed North and advised he was coming from Oslo Rd, however, that road was oriented south of where he was pointing. I advised Luis of the exercises I would conduct and he acknowledged.

During HGN, I observed equal pupils, resting nystagmus, and equal tracking. Luis demonstrated a lack of smooth pursuit, Distinct and sustained Nystagmus at maximum deviation, and Onset of Nystagmus prior to the 45 degrees.

During the Walk and Turn, I observed Luis use his arms to balance by moving his arms atleast 6 inches away from his body, he conducted an improper turn, and took an incorrect number of steps.

During the One leg stand, Luis swayed while balancing, used his arms to balance (moved more than 6 inches from body), and put his foot down.

Based on the totality of the circumstances, Luis was placed under arrest for DUI property damage, and Driving with No valid DL (never had one issued). Luis was transported to the Cleveland Clinic ER to be medically cleared prior to incarceration.

Luis was transported to the County Jail where he provided a sample of his Breath to determine the alcoholic content. He blew a BAC of .160 and .152. Luis was cited for DUI/property damage and NO DL (never issued).

On On 10/19/2024, at approximately 19:38 hours, I was traveling westbound on the Barber Bridge and observed a Chevy Suburban pass me with no visible tag lights. I followed behind the vehicle and conducted an inquiry on the license plate displayed. I discovered that the tag attached to the gold Chevy Suburban (FL tag #CI40ID) was actually registered to a blue Ford Taurus. The registered owner of the Taurus was a Michael Mccarthy, and it displayed that he did not have a valid drivers license. I attempted a traffic stop on the aforementioned vehicle in the 3500 block of Indian River Boulevard. The driver did not pull over and continued its path of travel for several blocks. I had to blare my siren and the driver finally came to a stop near the 4000 block of Indian River Boulevard. I then made contact with the sole occupant, Michael Mccarthy (W/M DOB: 11/29/1989). While speaking with Mr. Mccarthy from the passenger side of the vehicle, I could visibly see Marijuana bud scattered across the center console and passenger seat. Mr. Mccarthy claimed to have a Medical Marijuana Card, but he informed me that he did not actually possess the card with him. I had Mr. Mccarthy step out of the vehicle to speak with me regarding the status of his license, and the Marijuana. When I mentioned the status of his license, Mr. Mccarthy claimed to not have knowledge of the suspension. Mr. Mccarthy recently obtained a new license, and he admitted that he also had a change of address (approximately two weeks ago). I then conducted a search of Mr. Mccarthy's vehicle. During my search, I located a small amount of Marijuana and the original prescription packaging (which was discarded in the vehicle). On the top of the passenger seat (within reach of the driver), I located an empty cigarette box that contained a glass pipe. I observed that the pipe had burnt residue and "chore boy" copper stowed inside the pipe. I recognized that this glass pipe was utilized to smoke narcotics. I additionally located a backpack that possessed one of Mr. Mccarthy's identification cards and Narcan Spray. At this time, I detained Mr. Mccarthy in handcuffs and advised him of his Miranda Rights. Post-Miranda, Mr. Mccarthy admitted to having previous drug usage, but denied using Opioids. Mr. Mccarthy would not elaborate on any recent drug usage and became reserved with his answers. Regarding the Chevy Suburban, Mr. Mccarthy claimed ownership of the vehicle, and he advised me that he has own the vehicle for several weeks. Mr. Mccarthy clarified that he drives the vehicle and that he had possession of his vehicle for the last few days. I conducted multiple chemical tests on the residue contained within the glass pipe. I later received a positive reaction for the presence of Cocaine. During my investigation, I discovered that the Chevy Suburban was unregistered. I informed Mr. Mccarthy that he had a seize tag order and that the vehicle was going to be towed because it was unregistered. Mr. Mccarthy was upset and uttered that he just placed the tag to his "Ford" onto the Chevy. Mr. Mccarthy then admitted to knowingly placing his old tag onto the Chevy Suburban. Mr. Mccarthy never completed a proper transfer, and he also failed to register the Chevy Suburban. An inquiry on Mr. Mccarthy's driving history revealed a lengthy history of violations. Mr. Mccarthy reinstated his previous suspension on 08/13/2024. His current suspension was effective 09/03/2024. Given the totality of the facts, I placed Mr. Mccarthy under arrest for the following: - Violation of FSS 893.147(1) Possession of drug paraphernalia. - Violation of FSS 320.02 Failure to register a motor vehicle (FL citation #AKDBZCE) - Violation of FSS 320.261 Attaching registration license plate not assigned unlawful (FL citation #AKDBZBE) I also issued Mr. Mccarthy: - FL citation (#AKDBZEE) for violation of FSS 322.34 Unknowingly operating a vehicle while license suspended. - FL citation (#AKDBZDE) for violation of FSS 322.19 Fail to change address on license. - One written warning for the tag light. On 10/18/24 I, Ofcr. S. Gonzalez (471), responded to Pur Recovery, a privately owned substance abuse treatment facility, located at 1556 Higland Avenue, Vero Beach, Indian River County, Florida regarding a disturbance.

I was informed male subject had been told leave the premises but was refusing to do so.

Upon arrival, I made contact with Selena, the Medical Assistant on duty who advised that a client had been informed that due to his medical condition, he would not be allowed to remain at the facility and that he needed to call for a pre-assessment to transfer to another facility but was refusing to either call for the preassessment or leave the premises and was being verbally aggressive towards staff.

I then entered the facility and made contact with the subject whom I later identified as DARRELL E. CUMMINGS by his Florida issued identification card.

Mr. Cummings further stated that he had been to and released from the hospital earlier in the day due to a fall and that upon returning, he was informed that he was no longer able to remain at the facility.

I then spoke with the Director of Operations, La'Reese Felix who informed me that due that the facility was not equipped to treat him or have him at the facility. In addition, Ms. La'Reese expressed concerned over his behavior towards staff.

I subsequently managed to get Mr. Cummings to place the call for the pre-assessment for the new facility. I was informed that since Mr. Cummings was doing the pre-assessment, the no longer required our presence.

At approximately 1930 hrs., I was dispatched to the facility a second time regarding another disturbance involving Mr. Cummings.

Upon arrival, I made contact with Mr. Donald Robinson, the on duty Behavioral Health Technician; also present were officers Wickert and Lune

Mr. Robinson stated that he had was trying to get Mr. Cummings to the hospital because he was no longer allowed to stay at the facility but that he was refusing transport and further refusing to leave the facility.

I subsequently spoke with Ms. Felix who reiterated that Mr. Cummings had been discharged due to as well as his behavior towards staff and that despite being told multiple times to leave.

In the hopes that they would find a medical reason to transport him to the hospital for treatment, I requested an EMS response to assess Mr. Cummings; however, EMS determined that Mr. Cummings was not in need of medical treatment and he was otherwise refusing transport.

Ms. Felix, in her capacity as Operations Director, instructed & authorized Mr. Robinson to sign a Blanket Trespass Affidavit.

I then made contact with Mr. Cummings and reiterated to him several times that the facility had discharged and that the facility wanted him to leave the facility. Mr. Cummings adamantly maintained that he was not going to leave and refused to do so despite my best efforts to get him to go to the hospital or

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 10/20/2024 (Specifically include facts constituting cause for arrest.)

On October 20th 2024, at approximately 1630 hours, I was dispatched to 600 Turtle Run Drive APT-102, Sebastian, Florida in reference to a female who may have taken prescription drugs in an attempt to commit suicide.

Upon my arrival, K9 handler Smith and myself were met by, Juliette Dalessandro, who advised that her mother, Teresa Dalessandro, has been make suicidal threats scene Friday (10/18/2024). Juliette advised that her boyfriend drove her to Teresa's residence that Friday, but Teresa quickly became irate at her due to Juliette's boyfriend being present. Juliette advised that due to her mother's behavior her boyfriend and herself left the residence, but did not call law enforcement.

Juliette advised on today's incident (10/20/2024), her mother called her and threatened self-harm again. Juliette advised that her mother then turned off her phone. Juliette advised that when Teresa turned her phone back on, she text Juliette "I love you I am going to sleep forever now" and in another text message stated "too, late now I already took the pills damage has been done".

It should be noted that Juliette advised Teresa has a history of self-harm.

Law Enforcement then attempted to speak with Teresa, but she refused to let Law Enforcement to explain the situation to her or answer any questions. As Law Enforcement tried to speak with Teresa, she became irate and started yelling at Law Enforcement. Indian River Fire Rescue engine 8 arrived on scene to attempt to check Teresa's health. Teresa continued to escalate and then became extremely irate with EMS personnel to the point that law enforcement had EMS personnel stand by outside the residence.

Due to having the text from Teresa threatening self-harm and her refusing to see medical personnel for help, Law Enforcement decided to take Teresa to Cleveland Clinic for an involuntary backer act.

When law enforcement asked Teresa to get up out of her bed, she did so and walk approximately two feet in the direction of law enforcement. Teresa then grabbed a large wooden cane in a manner that made law enforcement fearful law, she would strike then. Law enforcement attempted to ask Teresa to put the cane down, but she refused. Law enforcement then attempted to remove the cane from Teresa's position. At that time Teresa held the cane tightly and attempted to pull away for law enforcement.

Law enforcement officers were able to remove the cane from Teresa's position. Law enforcement then attempted to place mechanical hand restraints on Teresa, but she tensed her arms and pulled away from law enforcement. Due to Teresa's resistance to law enforcement, officers placed her face down of the near by bed and used joint manipulation to get Teresa's arms behind her back. Teresa kicked K9 handler Smith and myself continually by bending her knee backwards and using the heal of her foot.

Law enforcement call for assistance form Cpl. Radock.

Teresa slipped her right hand out of the mechanical hand restraint and started to push herself up off the bed in an attempt to free herself. Teresa continued to kick officer, at on point striking myself in the groin.

At this time Cpl. Radock arrived on scene, Cpl. Radock was able to secure Teresa's legs and stop her from kicking. Law enforcement was able to resecure Teresa's right hand in the mechanical hand restraint.

Law enforcement attempted to have Teresa stand up, but she made her legs go limp and put her full body weight on officers. Law enforcement discovered am office chair with wheels, and placed Teresa in it, so officers did not have to carry her. Teresa refused to pick her feet up off the ground and began to try to push the chair backwards in an attempt to defeat officers' effort to take Teresa to the patrol vehicle.

Cpl. Radock picked Teresa's feet off the ground so officers could push her outside the residence. Teresa then kicked Cpl. Radock in his upper chest causing him to stumble backwards. At this time, officers pick Teresa up and carried her to the patrol vehicle.

Via dispatch, I made contact with Indian River County Sheriff department and asked for deputies to meet me at Cleveland Clinic to help bring Teresa inside.

Upon arrival, two deputies assisted me in removing Teresa from the patrol vehicle, due to her still being irate and combative.

After Teresa was brought into a hospital room, due to her behavior she was handcuffed to the bed. Teresa started being irate with hospital staff by yelling and cursing with them. Teresa was giving medicine to help calm her down. Hospital staff turned off the lights to Teresa's room and partly closed the door in an effort to help calm her door
