NARRATIVE

On August 4, 2026, at approximately 0513 hours, Corporal Ballester and I were traveling eastbound on State Road 60 traveling 45 Miles Per Hour (MPH) behind a vehicle in the number one lane.

We observed a gray pickup truck pass us in the number three lane. I visually its speed at 56 MPH in the posted 45 MPH zone. While attempting to pace the vehicle to gain an accurate speed my Axon Automatic License Plate Reader (ALPR) notified me of a Florida Sanctioned Driver. Upon a DAVID query it was discovered one of the registered owners was suspended. Due to the darkness and inadequate light in the area I was unable to confirm the driver. I was able to pace the vehicle at 54 MPH in the posted 45 MPH zone. Upon a further query into Johnathan's E-Citation history, it was discovered he was issued an Unknowingly Driving While License Suspended (DWLS) citation without knowledge on 04/30/2026 (AMNZ93E).

I initiated a traffic stop and made contact with the driver who was identified by a photo on DAVID as Johnathan Gutierrez. I asked Johnathan for his driver license, registration, and vehicle insurance. Johnathan verbally stated he did not have his driver license. Based on my training and experience this is common with individuals who have relinquished their license or had their license taken by a law enforcement officer. I asked Johnathan if his license was suspended, canceled, or revoked. Johnathan did acknowledge his license was suspended. While waiting for a second deputy, I inquired about Johnathan's vehicle registration and insurance. Johnathan was unable to provide the documents when requested. Furthermore, I inquired as to why Johnathan was operating a motor vehicle on the road to dispel my belief that he was traveling due to an active emergency. Johnathan stated he was traveling to turn in medical paperwork to his employer Piper Aviation.

With a secondary deputy on scene, I removed Johnathan from the vehicle and placed him in hand restraints ensuring they were double locked and safety checked. Johnathan searched and subsequently placed in the rear of my patrol vehicle.

Johnathan was transported to the Indian River County Jail where he was turned over to booking staff.

Based on the facts and circumstances listed above I do believe Johnathan Gutierrez did and knowingly violate

NARRATIVE

On Tuesday, August 4, 2026 at approximately 1108 hours I responded to 6280 20th Street (Verizon) in reference to a holdup alarm.

Upon my arrival I made contact with Mary Manley-Bryant who advised that a customer and [REDACTED] were involved in an altercation on the outside of the store. Mary advised that she believed that the male subject of the incident is the [REDACTED]. Mary pointed out the customer who is identified as [REDACTED].

I spoke [REDACTED] on the exterior of the business who advised that while she was inside of the Verizon store when [REDACTED] Zachary Barnett arrived at the location and snatched her phone from her. [REDACTED] advised that the phone is in her [REDACTED] name but she was here to exchange the phone due to her wanting to leave [REDACTED]. [REDACTED] continued, she stated that she and Zachary went outside of store and into the parking lot and Zachary was going through her phone. During the altercation Zachary slammed the phone on the ground causing the screen to crack [REDACTED] advised that she was told by the lady with gray hair (Mary) that he grabbed her and pushed her. [REDACTED] advised that she was unaware that Zachary grabbed her or pushed her. [REDACTED] advised that everything happened so fast [REDACTED] advised that Zachary left the scene in a white Tesla and is possibly on his way back to the residence. [REDACTED] advised that if Zachary did push her, it was to keep her from getting to the phone [REDACTED] advised that Zachary thinks that [REDACTED]

I did not observed any injuries on [REDACTED]

[REDACTED] advised that the altercation has been going on since a couple of days ago when she found him trying to buy a bag of cocaine. [REDACTED] advised that Zachary has been sober most recently and that he has been upset that she caught him.

I spoke with Mary once again and she advised that the altercation occurred outside in the parking lot. The whole altercation occurred outside in the parking lot. Mary advised that she intervened to separate the two people and to protect [REDACTED] (get her inside of the store). Mary advised that she observed a white Tesla pull into the handicap parking spot and the driver get out of the vehicle. Mary observed the driver argue with [REDACTED] and grab her and shove her. The driver of the Tesla slammed [REDACTED] phone on the ground and left the scene.

Mary provided a written statement to her observations of the incident.

[REDACTED] provided a written statement for the incident.

I spoke with Kaitlyn Stein an employee of the Verizon store who provided the following written statement; man ran out, girl ran out after him because he took her phone and she was trying to get it back. Man threw phone at floor smashing it and was pushing and shoving the girl.

I responded to [REDACTED] and made contact with Zachary. I read Zachary his Miranda Warning from the preprinted agency issued card. Zachary advised that he understood his Miranda Warning and agreed to speak

It should be noted that Zachary provided the same statement prior to being read his Miranda Warning.

I did not observe any physical injuries on Zachary.

I placed Zachary under arrest for battery Domestic violence F.S.S. 784.03 and transported Zachary to the Indian River County jail for further processing.

John was transported to Indian River County Sheriff's Office without incident.

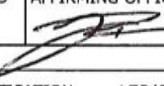

PROBABLE CAUSE STATEMENT

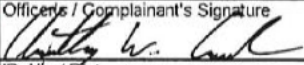
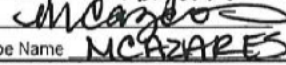
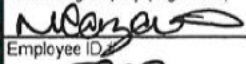

NARRATIVE

On Tuesday, August 4th, 2026, at 2204 hours, I conducted a traffic stop on a white in color Nissan sedan bearing FL/ T7CVN, for speeding. Upon making contact with the driver, I requested the driver to provide me with his driver's license, vehicle registration, and proof of insurance. The driver advised he did not possess his driver's license at the time of the encounter, but provided me with his name and date of birth; identifying himself as Reid T. Van Nostrand. Van Nostrand provided me with registration documentation, but was unable to provide me with proof of insurance. It should be noted that I conducted a query search through FCIC/NCIC databases, as well as D.A.V.I.D. prior to the traffic stop and confirmed the vehicle did not have insurance attached. While speaking with Van Nostrand, I requested for him to exit the vehicle and stand at the front of my agency issued marked patrol vehicle; too which he complied. I then asked Van Nostrand if he consented to a search of the interior of the vehicle too which he refused. After noting Van Nostrand's refusal, I requested K9 Deputy McKay to walk his K9 partner around the vehicle, resulting in a positive alert.

Subsequent to the K9's positive alert, K9 Deputy Williams and myself conducted a search of the interior compartments of the suspect vehicle. It should be noted that while searching the interior of the vehicle, Van Nostrand advised that there was marijuana inside a black bag inside the vehicle. Assisting deputies and myself searched the aforementioned bag and located a smoking pipe with burnt residue, and a plastic container containing approximately 2.1grams of suspected loose marijuana. I collected the suspected marijuana and utilized an agency issued field drug test kit to test the green leafy substance, resulting in a positive test result for the presence of marijuana. Van Nostrand was detained without incident.

It should be noted that I requested Public Safety Dispatch (PSD) to check to see if Van Nostrand possessed a valid medical marijuana card. PSD advised that Van Nostrand did not possess a valid medical marijuana license.

Though my investigation, I found Reid T. Van Nostrand, to be in violation of;

- FSS 893.13(6)(b) possession of marijuana not more than 20g (citation #ANUOYJE)
- FSS 893.147(1)(b) possession of drug paraphernalia
- FSS 324.221(2) failure of owner/operator to maintain required insurance (citation #ANUOYKE)
