NARRATIVE

On September 8th, 2025, at 0305 hours, I responded to the 2700 block of 20th Street in reference to a DUI investigation.

Upon arrival, I made contact with Deputy Consalo, who advised me of the following:

"On September 8, 2025, at 0257 hours, he stepped out with a disable vehicle described as a pewter colored Chevy Suburban bearing FL/CN11IU, at the 2700 block of 20th Street for traveling 5mph in a posted 45mph with their hazards on, and their front right wheel almost falling off the vehicle due to a faulty wheel hub assembly. Upon approaching the vehicle, deputy Consalo observed the front seat passenger retrieve a Corona beer from the driver's hand and place it behind the driver seat in an attempt to hide it from his view. Due to the occupants only speaking Spanish, deputy Consalo requested a Spanish speaking deputy to assist".

I then made contact with the driver, later identified via a Mexican driver's license as Sesbazar Contreras Saldivar. I asked Sesbazar if he possessed a Florida driver's license, to which he stated he was never issued one. I further asked if he had ever held a driver's license or identification card in Florida, and he responded, "No."

During my interaction with him, I observed several open Corona beer bottles with condensation on them in the back seat, behind both the driver and passenger seats. I also observed a Corona box located in the middle of the passenger seat.

While speaking with Sesbazar, I detected a strong odor of an alcoholic beverage emitting from his breath, and I observed his eyes to be bloodshot. Based on these observations, I became concerned that Sesbazar was impaired beyond his normal faculties by alcoholic beverages and/or chemical or controlled substances.

To dispel my concerns, I requested that Sesbazar participate in a series of standardized field sobriety exercises, to which he agreed. I asked him a series of medical questions to ensure he was physically able to complete the exercises. Sesbazar stated that he had no physical defects, was not injured, did not wear glasses or contact lenses, and had no history of traumatic brain injuries.

I explained and demonstrated each exercise proficiently before Sesbazar attempted them, confirming his understanding prior to the start of each.

The following exercises were performed:

1. Horizontal Gaze Nystagmus (HGN) – No resting nystagmus was observed. Equal pupil size and equal tracking were observed in both eyes. Lack of smooth pursuit was observed in both eyes. Sesbazar failed to maintain tracking several times, stared at me, or lost visual contact with my finger but eventually regained it. He moved his head multiple times while tracking. Distinct and sustained nystagmus at maximum deviation was observed in both eyes. Onset of nystagmus prior to 45 degrees was observed in both eyes. Vertical Gaze Nystagmus was not observed, though he moved his head during both attempts.
2. Walk and Turn – A straight lane line was used for this exercise. When asked, Sesbazar confirmed the line

was straight and acknowledged understanding the instructions. He chose to perform the exercise with his shoes on. While walking east, he did not miss heel-to-toe steps; however, he began counting at "step 2." When rotating and walking west, he again began counting at "step 2."

3. One-Leg Stand – Sesbazar elected to keep his shoes on and raised his right foot. He counted correctly until he reached "one thousand seventeen," at which point he said "two thousand eighteen."
4. Finger-to-Nose – Instructions were explained and understood, with no questions from Sesbazar. When directed to touch his nose with the tip of his finger, he missed initially but quickly corrected himself. He did not place his finger down between each sequence of events as instructed.

Overall, Sesbazar performed poorly on all field sobriety exercises.

Based on my investigation, I determined that probable cause existed that, on September 8th, 2025, Sesbazar was in actual physical control of a motor vehicle while under the influence of alcoholic beverages and/or chemical or controlled substances, and that he was impaired beyond his normal faculties, rendering him incapable of operating a vehicle safely.

At 0322 hours, Sesbazar was arrested for DUI and No Valid Driver's License. He was advised of the charges, taken into custody without incident, and transported to the Indian River County Jail for booking.

Upon arrival at the jail, I assisted Deputy Rodriguez by translating. Sesbazar agreed to provide a breath sample. At the conclusion of the test, his breath alcohol concentration (BrAC) was measured at 0.060 and 0.056 grams per 210 liters of breath.

At the conclusion of my investigation, I determined that probable cause existed that Sesbazar Contreras Saldivar violated F.S.S. 316.193 – Driving Under the Influence.

The following Uniform Traffic Citations were issued:

- ACIZ3FE for F.S.S. 316.193(1)(a) – Driving Under the Influence (Misdemeanor)
- AM2MAYE for F.S.S. 322.03(1) – No Valid Driver's License (Never Issued)



NARRATIVE

On September 8, 2025 at approximately 0920 hours, I responded to 1340 US Highway 1, IThink Credit Union, Vero Beach in reference to a suspicious person.

Public Safety Dispatch advised that a black male was causing a disturbance and asking for money from a nonexistent account. The complainant Jody Kisler, the store manager for IThink Credit Union, advised the male later identified as James Brown, by his Florida ID card, came into the business and asked to withdraw \$80,000 from an account that does not exist. He then told the manager that he would give her \$8,000 if she would give him the \$80,000. She then called law enforcement and asked for the Mr. Brown to leave.

Upon my arrival at approximately 0923 hours, James Brown was standing at the front door of the business, I asked James to leave as the staff wanted him trespass from the property and he was to leave and never return or he would be subject to arrest. I completed the trespass affidavit, and while speaking with Mrs. Kisler, James was pacing in from of the business on the sidewalk. Due to his behavior and the staff being scared of the male. I stood by inside the business with the staff. At approximately 0943 hours, James walked back up to the front door of the business and started pulling on the door and asking to come inside. When I walked out the front door, James asked me if he could go inside. I informed him that I just told him no more than 20 mins prior to this interaction that he was formally trespassed from the property and he was not to return. I then placed James into physical hand restraints and transported him to the Indian River County Jail.

James is being charged with one count of trespass after warning for willfully and intentionally entering and remaining on the property of 1340 US Highway 1 after being lawfully issued a trespass warning for the premises by law enforcement.
