

On Friday June 5th, 2026 at approximately 1400 hours, I responded to 719 Barber Street in reference to a domestic disturbance. Aaron Bleiler reported his wife Natalia Delgado struck him in his shoulder.

Upon arrival, Aaron told me last evening as he and his wife Natalia were discussing a family plan for them to work towards, their conversation became heated. To avoid any conflict, Aaron walked away from Natalia, closed the bedroom door, entered the bathroom and closed that door. Moments later, Natalia entered the bathroom and confronted Aaron on why he walked away from her. At this time, Aaron was sitting on the toilet. As Natalia was questioning Aaron, she struck him on his shoulder with an open hand. Aaron was able to walk away from Natalia without further incident and sat outside to calm down and to question Natalia's actions. I asked Aaron if he wanted to be touched in that manner and he stated no. I then spoke with Natalia.

I explained to Natalia the reason for my contact. Natalia informed that she and Aaron did engage in a verbal altercation last evening and at some point during the argument, she touched/slapped Aaron's shoulder. Natalia stated that Aaron wasn't listening to her and she wanted to get his attention. Natalia proceeded to tell me that she messaged a friend of hers stating that she struck Aaron while they were discussing a child custody and a family plan.

Natalia was transported to the IRC Jail.

NARRATIVE

On Friday, June 5, 2026, at approximately 1614 hours, I Corporal Martin, responded to 5085 45<sup>th</sup> Street at the El Torito food market store. Indian River County dispatch advised that a caller was reporting that disturbance was occurring with a customer who was refusing to leave the store. Caller described the male as wearing a blue shirt.

Upon my arrival, I observed a black male wearing a blue t-shirt outside of the store. The male would enter a vehicle and then exit the vehicle as I approached. The male was holding a cylindrical object with a paper towel covering it. I identified the object as an open Budlight beer can, which appeared to be open. The male was later identified as Nicholas P. Gibson DOB: 09/02/1981. While speaking to Gibson I could smell the odor of alcohol emitting from his breath as he spoke, and could hear him slurring his speech. Gibson would begin to speak with me and then turn to a bystander nearby who was sitting in the vehicle and begin to yell at him. Gibson would only state that he was having a bad day and that he was yelling people inside of the store.

I then, spoke with the employee of El Torito food market store [REDACTED] Odalys H. Gutierrez DOB: 01/05/1998. Gutierrez stated to me that the male who I was just speaking to was the male who she called about. Gutierrez stated that Gibson entered the store at around 1600 hours, and upon entering appeared to already be intoxicated. Gibson stumbled into the store causing a sauce bottle sitting on the cashier counter to fall and break on the floor. Gutierrez stated that she did not care about the bottle breaking, and Gibson went to the fresh food area of the store. There he was aggressive towards the workers who were at the fresh food counter and began to threaten them.

Gibson was accompanied by two other males who were seen in the vehicle Gibson was entering and exiting in upon my arrival. The males who wanted to remain unnamed stated that Gibson was threatening to fight them and they wanted to leave. Gutierrez would continue to state that Gibson would start to verbally threaten other customers in the store who were shopping and not interacting with him. Gutierrez then stated that Gibson would leave the store without paying for the Budlight beer that I saw in his possession during my initial contact with him. Gutierrez stated that he swiped a card at the card scanner, but the transaction was declined. Gutierrez stated that she informed Gibson that the transaction was not complete and he did not pay for the merchandise, but Gibson continued to argue and would later leave the store without paying for the item. The item was a beer can with the price of \$4.44 USD.

Due to the totality of the circumstances, that Nicholas P. Gibson DOB: 09/02/1981 actually and intentionally took possession and carried away merchandise from a merchant. Nicholas Gibson did so with the intent to deprive the merchant of possession, use, benefit, or full retail value of the

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 06/05/2026 at 20:37 (Specifically include facts constituting cause for arrest.)

On June 5, 2016, at approximately 1746 hours, I responded to 509 U.S. Highway One, Sebastian, Florida 32958 (Sebastian River Car Wash), in reference to Corporal (CPL.) McElvy #482 requesting assistance on a traffic stop.

Upon my arrival, I observed a red sedan bearing Florida registration plate 92FTDV and a female standing at the rear of the vehicle speaking with Officer Vazquez #449. I made contact with CPL. McElvy, who advised me she was behind the red sedan at the intersection of U.S. Highway One (Northbound) and County Road 512 (Eastbound). CPL. McElvy advised me she observed the traffic light to be green, but the red sedan was at a complete stop. CPL. McElvy advised she attempted to honk at the vehicle, but the vehicle did not move. CPL. McElvy advised she then observed the vehicle's left-hand turn signal to be on. It should be known there is a sign on a pole and a sign on the light pole that advise no left-hand turn and no U-turn due to County Road 512 being one-way traffic eastbound. CPL. McElvy advised the vehicle remained stationary through the entire green light cycle. CPL. McElvy advised when the traffic light turned red, the vehicle remained stationary for approximately four seconds, then, as eastbound traffic began to move, the vehicle made an illegal U-turn, now going southbound on U.S. Highway 1. CPL. McElvy advised she activated her patrol vehicle's lights and sirens.

CPL. McElvy advised the vehicle began to coast at a slow speed for approximately 300 feet, not stopping for her emergency lights and sirens. CPL. McElvy advised the vehicle then turned into 509 U.S. Highway One (Sebastian River Car Wash). CPL. McElvy advised she approached the driver's side of the vehicle and observed a female to be the sole occupant of the vehicle. CPL. McElvy advised she requested the female's driver's license, the vehicle's current registration, and current proof of insurance. CPL. McElvy advised the female provided her with the vehicle's registration. CPL. McElvy advised the female to stop and asked her what else she needed. CPL. McElvy advised the female she needed her driver's license and proof of insurance. CPL. McElvy advised the female, then provided her with her Florida-issued driver's license and again stopped for several seconds and asked what else CPL. McElvy needed. CPL. McElvy advised her she needed current proof of insurance. CPL. McElvy advised the female to retrieve her cell phone and began to open her insurance app. CPL. McElvy advised the female then began to just stare at the login page for the insurance app. CPL. McElvy advised the female continued to just stare at the login page until another officer arrived. CPL. McElvy advised that after giving the female an ample amount of time and showing her the vehicle's current insurance, she returned to her patrol vehicle.

CPL. McElvy advised that once at her patrol vehicle, she identified the female by her Florida-issued driver's license as Le Anne Williams. CPL. McElvy advised me that while speaking to Williams, she observed a fruity odor emitting from her breath. CPL. McElvy advised she believed Williams was intoxicated. CPL. McElvy advised that just prior to my arrival, Sergeant Melius #208 arrived on scene. CPL. McElvy advised that Sergeant Melius and Officer Vazquez requested Williams to exit her vehicle. CPL. McElvy advised Williams complied and exited the vehicle.

CPL. McElvy requested me to complete Field Sobriety Exercises with Williams.

I asked Williams if she would complete Field Sobriety Exercises. Williams stated she would. I asked Williams if she had any medical conditions that would prevent her from completing the exercises. Williams stated she did not. I asked Williams if she wore glasses or contacts. Williams stated she was wearing contacts.

For the horizontal gaze nystagmus exercise, I requested Williams to remove an earpiece cellphone she had hanging loosely from her ear. William removed the earpiece cellphone and when I asked her to hand it to Officer Vazquez. Williams refused and attempted to place it into her pocket but was struggling to get her pocket open. I again advised Williams to give the earpiece cellphone to Officer Vazquez, but she put it into her pocket. At this time, Officer Vazquez and I removed the earpiece from Williams' pocket, and we continued with the exercise. I demonstrated the starting position for the exercise to Williams. When asked to place herself into the starting position, Williams placed her feet approximately four inches apart and held her hands behind her back. I continued to demonstrate the starting position and requested Williams to place her feet together and her hands down by her side. Williams rolled her eyes and fully placed herself in the starting position. While attempting to explain the exercises to Williams, she was extremely uneasy on her feet and was swaying her whole upper body from side to side and forward and backward. At one point while explaining the exercise, Williams lost her balance and fell forward. Sergeant Melius attempted to catch her to stop her from falling, but Williams regained her balance before fully falling over.

Once I explained the exercises to Williams, she stated she understood. I observed a lack of smooth pursuit in both of Williams' eyes, and Williams would move her head. When I attempted to check Williams' eyes at maximum deviation, Williams would look at the stimulus for approximately one second before looking at me and making a face or rolling her eyes. I advised Williams to not look at me and to continue to look at the stimulus. Williams stated she understood, but still continually would look at the stimulus for approximately one second and then look at me and make a face or roll her eyes. I advised Williams that if she continued to not complete the exercise on purpose, she would be placed into custody. Williams then continued her behavior, purposefully not completing the exercise. At this time, I placed Williams into mechanical hand restraints.

Once Williams was out of the way, beside CPL. McElvy's patrol vehicle, I observed the strong odor of alcoholic beverages emitting from her breath. CPL. McElvy completed a search of Williams' person. CPL. McElvy discovered two white pills in

Williams' left front pocket; the rest of the search ended with negative results.

At this time, CPL. McElvy and I attempted to walk Williams to my patrol vehicle, but Williams stated she would not walk through the grass. Williams began to walk but then stopped and began to drag her feet and put her full body weight onto CPL. McElvy and me. CPL. McElvy and I then placed Williams onto the ground and asked her to walk. Williams was irate and yelling and refused to walk under her own power to the patrol vehicle. At this time, I physically picked up Williams and carried her to my patrol vehicle. Once at my patrol vehicle, Williams was willing to stand and place herself into the patrol vehicle. While CPL. McElvy checked the rear seat of the patrol vehicle, Williams continually pulled away from me and yelled at officers.

At this time, the pills that were found in Williams' front left pocket were run through the Sebastian Police Department's Dispatch Center. The Dispatch Center advised the pills matched the description of Tramadol Hydrochloride, a Schedule IV narcotic that was prescription only.

I transported Williams to the Indian River County Jail without further incident.

Once at the Indian River County Jail, Indian River County Deputy Solomon asked Williams if she would consent to a test of her breath. Williams stated she consented. Deputy Solomon advised me that Williams' first breath alcohol test sample results were 0.206 BAC, and the second was 0.219 BAC.

No further action was taken by this officer.

NARRATIVE

On June 5, 2026, at approximately 1941 hours, I responded to the area of Old Dixie Highway and 8<sup>th</sup> Street, Vero Beach, Florida, 32962, in reference to a reckless driver.

Someone called Public Safety Dispatch to report that a Blue Kia just left the Speak Easy bar and was swerving all over the road. The caller followed the blue Kia until it parked in the Wawa parking lot at 1180 US Highway 1.

I located the blue Kia bearing Florida tag Y42DMD in the Wawa parking lot, and observed a white female in the driver's seat. I approached the vehicle and made contact with Ms. Barbara Resha, who was still seated in the front driver's seat of the vehicle. I greeted Barbara, and I could detect the strong odor of alcoholic beverages emitting from her breath as she spoke. Barbara's speech was also heavily slurred. I could not see Barbara's eyes as she was wearing sunglasses.

I asked Barbara if she consumed any alcohol this evening. She stated she consumed two to three beers in the past few hours. She finished consuming her last beer approximately twenty minutes ago. I asked Barbara to step out of the vehicle, and she appeared unsteady as she did so. Once Barbara took off her sunglasses, I observed her eyes to be bloodshot, watery and glassy. I asked Barbara if she was willing to participate in standardized field sobriety exercises, and she replied yes. I asked her several medical questions to ensure Barbara was not injured or ill, and she replied no to all my questions.

I explained the instructions to the horizontal gaze nystagmus exercise to Barbara, and she stated she understood my instructions. Equal pupil size and equal tracking were noted in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation and the onset of nystagmus prior to 45 degrees were observed in both eyes.

I explained and demonstrated the instruction for the walk and turn exercise, and Barbara replied she understood them. During the walk and turn exercise, Barbara failed to walk heel to toe, and raised her arms to balance.

I explained and demonstrated the instructions for the one leg stand exercise and Barbara replied she understood them. During the walk and turn exercise, Barbara put her foot down several times, and raised her arms to balance. Barbara also just stopped counting at one point and appeared to give up on the exercise, then she began again.

I asked Barbara how she felt she did on the exercises, and she stated not good. I asked Barbara if she felt it was a good idea to consume beers and drive a vehicle, and she replied no.

Barbara was placed under arrest for DUI and transported to the Indian River County Jail. After a 20-minute observation period, Deputy Solomon requested that Barbara provide a lawful sample of her breath to determine its alcohol content. Barbara refused to provide a sample of her breath, so, Deputy Solomon read her an implied consent warning. After being read implied consent, Barbara still willfully and knowingly refused to provide a lawful sample

On June 5th at approximately 1909 hours, I was dispatched to 2001 US Highway 1, Sebastian, Florida, 32958 (Walmart) in reference to a shoplifting. The complainant, Dawn Ethier, with loss prevention, stated a female was cooperative and was in the loss prevention office.

Upon arrival, I made contact with Dawn. Dawn stated the female, identified by a photo of her Florida Driver License as Samantha Giresi-Hopping, was sitting on the bench was shopping and failed to pay for multiple items and put multiple items in her purse. Dawn explained that Samantha walked into the store with her black purse and a shopping bag from another store.

I asked Samantha why she took the items and she responded she accidentally placed an item in her purse and was going to make a stir fry. Samantha was confronted on her actions being intentional and not accidental. Samantha then confirmed she placed items in her purse and hid the meat in the cart intentionally.

I asked Samantha if she would allow me to search her purse to make sure there is no more stolen items in her purse. Samantha then stated "Sure" and that there was nothing else in there stolen. I searched the purse and found a blue tampon tube (plunger part) that appeared to have white powder residue in the inside. I asked Samantha what she used the blue tampon tube for. Samantha stated that she used it to snort Xanax.

I found probable cause to charge Samantha with one count of Possession of Drug Paraphernalia and one count of Petit Theft. She was placed in handcuffs and transported to the Indian River County Jail.

NARRATIVE

On Friday, June 5, 2026, at approximately 2110 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of 27th Avenue SW and 9th Street SW, Vero Beach, Indian River County, Florida.

While traveling southbound on 27th Avenue SW, I was approaching 9th Street SW (Oslo Road). During this time, a white SUV just a few vehicles in front of me make a lane change in to the right turn lane. The vehicle rapidly accelerated through the intersection and passed multiple vehicles, making a lane changed within the intersection, cutting off other vehicles, to continue southbound.

During the traffic stop, Ms. Amber Mayor was identified as the driver of the vehicle. Ms. Mayor provided her license and insurance for the vehicle.

Upon running the VIN for Ms. Mayors vehicle, it is not assigned a tag at the moment. The tag attached to her vehicle was previously assigned to her vehicle, but is no longer assigned. There is history with the vehicle where other IRCSSO deputies conducted a traffic stop on the vehicle yesterday, June 4th, 2026 (2026-00058889). When questioned about the vehicle not being registered, she advised that the deputies who stopped her yesterday advised her that there was an issue with her tag, and that she needed to get it fixed. Ms. Mayor stated she made an appointment with the DMV to get it fixed. Upon asking her to provide the proof of the appointment, she later recanted her statement and stated she was going to but never completed the online appointment request.

While completing the traffic stop, Deputy Shaw and his narcotics trained canine arrived to the traffic stop. Ms. Mayor was removed from the vehicle by Deputy Shaw. During this time, she requested to keep her purse with her. Deputy Shaw deployed his narcotics trained canine and conducted a free air sniff around the vehicle. His canine provided a positive alert for the presence of narcotics within the vehicle.

During a probable cause search of the vehicle, a glass pipe with a white residue and burnt ends was located within the center console of the vehicle.

A probable cause search of Ms. Mayor was then conducted. After grabbing Ms. Mayor's purse, she started to close the distance between the two of us. When I advised that I would be searching her purse, she was reluctant and advised me multiple times that she did not consent. Ms. Mayor kept approaching. Due to safety reasons, she was placed in handcuff restraints. During this time, Ms. Mayor spontaneously admitted that there was a pipe used to smoke methamphetamines within the purse.

Upon opening the purse, I located a glass pipe with a white crystalized residue within the pipe consistent with someone using it for methamphetamine.

Based on the above statements, I believe there is probable cause to arrest Ms. Amber Mayor for the offense of Possession of Drug Paraphernalia, pursuant to FSS 893.147.1, and failing to register a motor vehicle, pursuant to FSS 320.02.1

On June 6th, 2026, at approximately 0024 hours, I observed a tan 2004 Lincoln Navigator bearing Florida tag 57ETEM traveling north in the 900 block of US Highway 1 with only one operational headlight. Due to this equipment violation, I conducted a traffic stop on the vehicle in the 1300 block of US Highway 1.

Contact was made with the driver, identified by her name and date of birth as Jessica Conny. Also in the vehicle was the front seat passenger, identified by his Florida driver's license as Emmanuel Relford. I advised Jessica the reason for the stop and requested her license, registration and insurance. She was unable to provide any of the requested documents.

During the course of the traffic stop, K9 Officer Smith arrived on scene and deployed his K9 partner Ghost to conduct a free air sniff of the exterior of the vehicle. Upon doing so, I was advised by Officer Smith his K9 partner positively alerted to the odor of controlled substances emanating from the vehicle. Due to this, a probable cause search for contraband was conducted.

Upon conducting the search, I located a small blue straw containing trace amounts of a white powder substance in the driver side door. I know based on my training and experience straws are commonly used as drug paraphernalia to ingest controlled substances such as fentanyl, crushed pills and cocaine hydrochloride through the nose. This was directly next to where Jessica was seated. The exterior part of the door was removed due to the driver side window being completely broken. The straw placed in this part of the door was not immediately visible. Jessica was placed in mechanical restraints at this time. No other contraband was located during the search.


Jessica was advised of her Miranda Rights which she understood. Post Miranda, Jessica denied ownership of the straw and stated she lets other people drive her car. Jessica stated she used to use heroin and fentanyl and would ingest it by snorting it, however has not done so in a while.

Due to locating the small blue straw which contained a trace amount of a white powder substance directly next to where Jessica was seated, Jessica was placed under arrest for violation of FSS 893.147 (1) POSSESSION OF DRUG PARAPHERNELIA.

Jessica was transported to the Indian River County Jail without incident.

**NARRATIVE**

While further conversing with him, he granted me consent to search his vehicle. After having him exit the vehicle, I began to search the vehicle. Directly under the front driver seat, was a small Ziplock baggie with a white rock-like substance that I identified through my training and experience to be Crack-Cocaine. The substance was field tested and revealed a positive result for a Cocaine base.

In a post Miranda Warning interview with Derrick, he said he did not know the drugs were inside of the vehicle and claimed they belonged to some females that were in his vehicle the night prior.

I charged Derrick with violation of FSS 893.13.6D Possession of a Controlled Substance and FSS 322.34(2)(A) Driving While License Suspended with knowledge and booked him into the Indian River County Jail.

On Saturday, June 6, 2026, at approximately 1952 hours, I, Deputy A. Henry #6339 responded to 326 15th Avenue, Vero Beach, Indian River County, Florida, in reference to suspected DUI that occurred at Vero Bowl located at 929 14th Lane, Vero Beach, Florida.

Prior to my response, Mr. Jason Belchner called in to report a suspected drunk driver leaving the establishment. Mr. Belchner is a manager at Vero Bowl. Mr. Belchner provided the tag of the suspect vehicle, being Florida Z03BER. He advised the vehicle was last seen heading southbound on US Highway 1.

Using FCIC/NCIC, I observed that this vehicle was registered to Mr. John Davis, with an address of 326 15th avenue, Vero Beach. I then responded to that address to see if the vehicle was there.

Upon my arrival, I observed the vehicle in the driveway and a white male on the ground. Upon closer inspection, the male was face first in the ground, with his butt up in the air. It appeared that the male had fallen and was bleeding from the head. The male was observed to have a black vehicle key in his left hand.

Deputy Neill #6317 and I spoke with the male, who identified himself as John. John was later identified as Mr. John Davis from his Florida License. I observed watery bloodshot eyes, the distinct odor of an alcoholic beverage emitting from his breath, and a slurred speech. Deputies asked Mr. Davis if he needed medical attention or to have deputies assist him with getting up, which he denied both. After waiting for Mr. Davis to get up on his own, he stated he would eventually get up. Deputies told Mr. Davis that he had to either sit up or we would be calling Fire Rescue to check him out, Mr. Davis then sat up.

I continued to conversate with Mr. Davis, while Deputy Neill made contact with Mr. Belchner by phone. I asked Mr. Davis if he was able to stand up to his feet which he stated maybe, I asked him if he need assistance, which he stated no. I then stated I don't think you are able to stand Mr. Davis, which he then quickly jumped up from a seated position and quickly had to steady himself against his vehicle due to the inability to stand.

Mr. Davis made many comments stating, "he fucked up."

Based on my training knowledge and experience, I requested Mr. Davis to submit to Standardized Field Sobriety Exercises, which Mr. Davis would follow-up with a question of his own "What happens if refuse, do I lose my license?" Mr. Davis was asked multiple times if he would submit. Mr. Davis was informed of his Taylor Warnings; he was asked one more time if he was willing to submit to SFSE's. Mr. Davis again attempted to answer with a question. Mr. Davis was then placed under arrest for Driving

Mr. Davis was secure inside my patrol vehicle, while Deputy Neill and I conducted a search incident to arrest of Mr. Davis's vehicle he was seen driving, during the search Deputy Neill located an empty mini spiced rum bottle in the seat pocket of the front passenger seat, which is in arm reach of Mr. Davis while his is operating the vehicle. Upon further searching the vehicle, deputies located a receipt from the Vero Bowl & Vero Stix for June 6, 2026 at 5:24pm. He purchased 4- Jack Daniels for 31.00 along with food items to total \$56.55, he used his Space Coast Credit Card ending 4370, which was located in his wallet.

I then spoke with Deputy Neill who informed me what Mr. Belchner stated the following in his phone conversation. Mr. Belchner advised that a white male, with blue eyes, very short hair, wearing a white-collar shirt and khaki shorts was within the located bothering customers. He was attempting to have conversations with guests that he was not friends with, causing some minor disturbances with them by bothering them, or blocking bowling lanes. While there, this white male had one shot from the bartender. He had a shot of Jack Daniels at 1855 hours. They provided him the drink and then cut him off, because they believed he was too intoxicated to consume anymore. A short time later, the male started to leave the establishment. Mr. Belchner followed him. Seeing that the male was going to get in to a vehicle, he attempted to stop him. The male stated he was going to talk to someone and needed to leave. Mr. Belchner attempted to persuade him again to not drive. The male stated go ahead and call the cops then. Mr. Belchner then took a photo of his tag and [REDACTED]

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 06/07/2026, at 23:16 (Specifically include facts constituting cause for arrest.)

On June 6th, 2026, at approximately 0021 hours, I, Ofc. Z. Dominguez, responded to [redacted] in reference to a disturbance.

Upon arrival, I spoke with the victim, later identified as Aaron Doby. Doby advised he was involved in a verbal altercation with the defendant, later identified as Martina Shaw. During this verbal altercation, Doby advised he attempted to lie down on the couch and pulled the blanket over him to sleep, when Shaw threw a cup of bleach on him and took his phone. Doby then claims he got up to rinse the bleach off his face in the sink and tried to go back to sleep. Upon lying back down, Doby said Shaw grabbed a container of bleach and poured the rest on him. Doby advised he ran for his phone and tried to leave the residence in an attempt to call law enforcement. While descending the exterior steps of the residence, Doby stated he was hit in the back of his head with a can of tomatoes by Shaw. While interviewing Doby, no injuries were observed on his person, and he declined EMS services. However, it should be noted that while speaking to Doby, a strong odor of bleach/chemical product emitted from his person.

I then examined the exterior staircase, observed a dented can of tomatoes at the bottom of the stairs, and photographed it. Shortly thereafter, I entered the residence and observed an empty/folded bottle of bleach on the kitchen counter. In the living room area of the residence, the floor near the couch also contained puddles on the floor that were photographed. It should be noted that a strong odor of bleach/chemical product emitted from the residence upon entry as well.

I then spoke with the defendant, Martina Shaw. I mirandized Shaw who acknowledged she understood her rights. Shaw said she was involved in a verbal altercation with Doby throughout the evening. Shaw stated she was pushed to the ground leading to her taking Doby's phone and throwing the cup of bleach on him. Shaw also admitted to dispensing the remaining container of bleach and throwing the can of tomatoes at the back of Doby's head. When explaining this, it should be noted that Shaw stated "If I had known I was going to jail, I would've done more to him." Shaw declined to speak further on the incident at this time.

At this time, Shaw was placed under arrest for Domestic Battery, in violation of F.S.S. 784.03 and transported to the Indian River County Jail for booking, no bond.

Photographs of Doby's injuries and the scene were taken and he was issued a DV packet. A DCF report was also filed at the time of the incident.

This incident was captured by my department issued Body Worn Camera (BWC) and photographs were uploaded to VBPD Evidence Library.

NARRATIVE

On Saturday, June 6, 2026, at approximately 2340 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of 10<sup>th</sup> Street SW and 19<sup>th</sup> Avenue SW Vero Beach, Indian River County, Florida.

While sitting in the area, I observed an older model White Honda Civic leave the BP gas station located at 1999 9<sup>th</sup> Street SW. The vehicle failed to stop or slow down upon leaving the gas station and entering 19<sup>th</sup> Avenue SW. Additionally, the vehicle did not have any lights on while operating upon the roadways.

I made contact with the driver, who was later identified as Mr. Claudio Jimenez by his Florida driver's license. While speaking to Mr. Jimenez, he was making furtive movements and reaching for items before I could even identify myself. I asked Mr. Jimenez for current proof of insurance. Mr. Jimenez stated that he was only able to provide proof on his phone, but he did not have his phone on him.

During the traffic stop, I observed that Mr. Jimenez had glassy eyes, the odor of an alcoholic beverage emitting from his breath, and a slight slur in his speech.

I requested Mr. Jimenez to exit the vehicle. Mr. Jimenez confirmed that he had consumed alcohol today, but advised he consumed one buzz ball. He then willingly performed Standardized Field Sobriety Exercises (SFSE's). They go as follows:

Horizontal Gaze Nystagmus (6/6): Mr. Jimenez had a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and nystagmus onset prior to a 45-degree angle. He did not have resting nystagmus. Mr. Jimenez was able to follow the stimulus with both eyes, had equal tracking, and equal pupil size. Mr. Jimenez also moved his head multiple times throughout the exercise and had a sway in his stance where he constantly leaned to the right.

Walk and Turn (4/8): Mr. Jimenez missed touching heel to toe on multiple steps, and a improper turn by not keeping his foot planted, stepped off line, and stopped to steady himself.

One Leg Stand (3/4): Mr. Jimenez put his foot down multiple times, used his arms for balance, and swayed while attempting to maintain his balance.

I then advised Mr. Jimenez of his Miranda Rights. He advised he understood his rights and was willing to speak to me. Mr. Jimenez again confirmed that he had one small buzz ball earlier in the day. He advised that he is a recovering alcoholic, and lapsed today because today is the anniversary of his cousin's death. When asked how he felt driving, he responded with saying "all right". He went inside of the gas station that I observed him leaving from in order to purchase more buzz balls. Prior to leaving the store, he chugged one of the three he purchased prior to driving home.

Based on the clues of impairment, as well as my training and experience, I placed Mr. Jimenez under DUI. He was

PROBABLE CAUSE STATEMENT

On June 7th, 2026, at approximately 0425 hours, I observed a 2010 silver Subaru Outback bearing Florida tag FIXJ62 traveling south in the 1300 block of US Highway 1 with the driver side headlight out. Due to observing this violation, I conducted a traffic stop on the vehicle in the 1000 block of US Highway 1. It should be noted, once I got behind the vehicle in question it immediately pulled over before I ever activated my emergency lights or siren.

Contact was made with the driver and sole occupant of the vehicle, identified by her name and date of birth as Shayla James. I advised Shayla the reason for the stop to which she acknowledged the headlight was out and informed she has not had the money to replace it. I requested Shayla's license along with her registration and insurance, however she was only able to provide the registration and insurance. During my initial contact with Shayla, I asked her about her whereabouts and if she had anything illegal in the vehicle, specifically drugs. Shayla informed she did not but was unsure in her answer each time. I asked Shayla about specific controlled substances, to include marijuana. When asked about marijuana, Shayla stated she had a used glass pipe next to her seat. I asked Shayla to show me the pipe, to which she did. Upon doing so I did observe the pipe to have burnt marijuana residue inside of it. When asked if Shayla had a valid medical marijuana card, she stated she had one in the past however no longer had one at this time. This was later confirmed by Sebastian Communications.

Shayla was removed from the vehicle and a probable cause search was conducted, due to the glass pipe containing burnt marijuana residue. It should be noted, I asked Shayla if I would locate any other contraband in the vehicle multiple times and each time Shayla appeared respond in a nervous/unsure manner and would say "not that I know of." Shayla also initially informed me she was on her way to Fort Pierce to meet a friend. However, Shayla later stated she did not actually know the name of the person she was going to meet nor did she know the exact address, only the general area. Shayla stated she met this person online and was going to engage in sexual activity with them.

Upon conducting the search, I located a pill bottle with no name, no prescription sticker or doctor information on it, and instead was covered in Hello Kitty stickers. This was located underneath the radio in front of the gear shift in the center of the vehicle. When I opened the bottle, I observed a pre-rolled marijuana joint next to a lighter. Underneath this, I observed a white rectangular pill with no inscriptions on it. I recognized the shape of the pill to be consistent with Alprazolam/Xanax, and due to my training and experience, I know pills shaped such as Alprazolam/Xanax without any inscriptions or markings is common when it is pressed with fentanyl. As a result, the pill was field tested for fentanyl. This field test came back positive for the presence of fentanyl. Also located in the vehicle, specifically in the center console, I located a glass jar containing suspect marijuana. A large wad of cash along with various sex toys/equipment were located in the vehicle as well.

Shayla was advised of her Miranda Rights which she understood. Post Miranda, Shayla admitted the pill was given to her by a male in Vero Beach. She only knew the male by an internet name and was under the impression the pill given to her was a Xanax pill. Shayla stated she did not realize the bottle which contained the pill was inside of the vehicle which is why she responded to my initial questions in an unsure manner. Shayla stated she had never used Xanax before in the past.

Based on the facts mentioned above and totality of circumstances, I found probable cause to place Shayla under arrest for violation of FSS 893.13(6a) POSSESSION OF CONTROLLED SUBSTANCE (FENTANYL).

Shayla was transported to the Indian River County Jail without incident.

NARRATIVE

On Sunday, June 7, 2026 at approximately 1116 hours, I responded to 975 8TH CT SW, Indian River Co, FL in reference to a disturbance.

Upon arrival, I observed a black male (later identified as Thaddeus Bass III) just leaving, walking over to the abandoned lot across the street.

I met with Latoya Marshall, who stated the following in summary:

Latoya has an active Trespass After Warning (TAW) issued against her son, Thaddeus Bass III. Thaddeus showed up without permission, entered the house and started yelling at her and throwing things. Her verbally threatened her. He is currently across the street. He has been testing the line recently and showing up, trespassing, and wants charges pressed for Trespassing. She took a video of him inside the house today just prior to [REDACTED] She was concerned this might have turned physical.

I observed the suspect, Thaddeus, still across the street, pacing back and forth, stating he needs to go get his belongings. He kept trying to approach back onto the property and stated "I was just trying to get my stuff." I observed him talking to himself and appearing disturbed and upset.

Latoya showed me the footage on her cell phone. I observed the following:

The video's date was time-stamped today at approximately 1115 hours. Thaddeus is seen up close, inside the aforementioned residence, yelling at Latoya, "I'm going to shoot you."

I verified with IRC SO Dispatch if Thaddeus has an active TAW for this location, to which they confirmed he does.

I asked Latoya if she felt threatened or scared by his verbal threats, to which she responded no but that he would keep trying to come back in.

Thaddeus was placed under arrest, and while attempting to place the handcuffs on, became combative, irate and started yelling, then began lunging towards Latoya. I told him to stop and to calm down, to which he did not.

On June 7, 2026, at approximately 1537 hours, I was dispatched to 2001 US Highway 1 (Walmart), in reference to a shoplifting in progress. Dispatch advised the female suspect was wearing a white top with light color jeans with long dark hair.

Upon arrival, the Walmart Loss Prevention associate, Dawn Ethier was flagging myself and Ofc. Buffington down pointing to the female that was running away from her at the front entrance/exit to the store. The female matched the description and Ofc. Buffington yelled for the female to stop, activated his emergency lights and siren to which she did not stop, and continued running away from law enforcement through the parking lot. After a brief foot pursuit, the female was caught, detained, and placed into handcuffs which were double locked and checked for fit. The female was secured and placed into the rear of Ofc. Buffington's patrol vehicle. The female was identified as Sandy Fanucci-Campiglia by her Florida driver's license.

While speaking to the victim, she stated the following:

"I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store # was walking the floor when I came across this female known to ticket switch items (we have her in our system for five other events) when checking out, she scans the cheaper prices. This female made selections and then put the cheaper tickets on the items as she traveled through the store as I had surveillance on her through the store. When she goes into the self-checkout and proceeds to checkout, she scans the items with the cheaper stickers and when she is done and renders payment, she passes all points of sale with the wrong priced items and myself and Coach Cora as a witness approach her and ask her to come back inside with us, she pushes the cart aside and runs out of the store and through the parking lot where the officers had to chase her down. The amount for this incident is \$113.42. The items that she had ticket switched was a sander with the last four upc 3380, a can of 2 minute paint remover with the last four upc 0059, gorilla color changing putty with the last four upc 1907, a can of Klean Strip acetone with the last four upc 1815, some Kwikwood weld with the last four upc 8257, a sand disc with the last four upc 3721, a bottle of mineral spirits with the last four upc 0945, a putty knife with the last four upc 5410, a 19 in 1 multi tool with the last four upc 0538. A pack of wall repair kit with the last four upc 9348. A bottle of Krud Kutter with the last four upc 4300."

Dawn also stated the suspect was a known offender and identified her as Sandy by her first name due to prior encounters. Dawn stated the store wishes to pursue charges for all the past thefts Sandy committed at their store and will follow up with that information and statements at a later time. Dawn stated they wish to have Sandy trespassed to which she was and told she was trespassed. Dawn provided a copy of the receipts with the items listed that were stolen and also those that were purchased and refunded to Sandy. All items were recovered by Walmart on scene. Video footage of the incident will also be submitted for evidence.

Sandy was read her Miranda rights to which she stated she did not wish to speak regarding the incident. Sandys's property was taken on scene and brought with her to the jail.

Sandy was transported to the Indian River County Jail without incident.

Sandy was charged with the following: Petit Theft 2+ prior conviction (FSS 812.014(3C)), Resist Merchant FSS 812.015(6), and Resist Officer without violence FSS 843.02.

This incident is cleared by arrest.

NARRATIVE

On Saturday, June 6, 2026, at approximately 0718 hours, I responded to [REDACTED] in reference to a disturbance with injury.

Upon arrival, I met with Jeffrey Beam, who was hunched over, walking towards me. He was holding a bloody shirt to the back of his head. Jeffrey stated the following in summary:  
 Jeffrey was just turning around and thinks his brother, James Harrison, hit him from behind, striking the back of his head with a hammer. His head is hurting badly.

Jeffrey seemed slightly confused and having trouble remembering the event. I observed an open wound on the back of his head, bleeding, consistent with being hit by a hammer.  
 At this point, EMS arrived and began treatment.

D/S Hoffman met with James Harrison. After being read his Miranda Rights, James stated he did not hit brother with a Hammer.

I asked the female, Heather Campbell, standing next to James, if she saw who hit Jeffrey with the hammer. She pointed directly and only at James. I took her aside and asked her what happened.  
 Heather stated the following in summary:  
 James and Jeffrey were talking with each other in front of one of the compounds. Heather was walking by and said good morning to them. They said good morning back. Jeffrey stood up, turned around, and started to walk away from James. James then "roared" and hit Jeffrey in the back of his head with a hammer.

D/S Caperton met with another witness, Bobby House. Bobby stated the following in summary:  
 He was the one who [REDACTED] He did not witness the event but afterwards did see James walking around with a hammer in his hand.

I was also informed by our Dispatch that James Harrison had a valid Trespass After Warning (TAW) order for this location and address.

It should be noted that James and Jeffrey are half-brothers, however they have never resided together as a family.

Based on my investigation and witness statements, probable cause exists to arrest James for Aggravated Battery with Deadly Weapon and Trespassing an Occupied Structure.
