NARRATIVE

On August 24, 2026, at 20:42 hours, I Deputy D. Coon #6379 conducted a security check of Calmar shopping center at 5555 20th St in Indian River County. While driving through the parking lot, I was flagged down by Calmar employee, Derek Antonia Graham. Derek is a Calmar 'greeter', and he is typically posted at the grocery-side entrance/exit. He noticed a white female subject that was trespass-warned earlier today, and he asked me to investigate.

I then spoke with Calmar's Asset Protection Investigator, Sara Rene Bingo (AKA: "Scottie"). Scottie validated Derek's suspicion and added that the white female was a shoplifting suspect from earlier today. Deputy D. Harvey #6377 was summoned to Calmar during that incident at approximately 16:04 hours (Case # 2026-00090852). Deputy D. Harvey identified the white female as Kelly Marie Evans. Although Kelly was not arrested during that call, Deputy Harvey issued Kelly a formal trespass warning. Kelly received a copy of the trespass affidavit and left Calmar's property as requested. Scottie showed me a picture of Kelly from that incident; Kelly was wearing camouflage pants, black tank top, and a blue bandana on her head.

While reviewing this data, Kelly exited the grocery-side doors. She was wearing the same clothing and matched the photo that Scottie shared with me. I detained her based on reasonable suspicion that she was trespassing after warning. I then identified Kelly by her FOLSOM records. Kelly's trespass affidavit had not been processed by IRCSO Central Records yet; however, I was able to read Deputy Harvey's case report from his trespass call with Kelly. In that report, Deputy Harvey clearly stated the circumstances for his call to Calmar and the subsequent trespass warning that he issued to Kelly.

Based on the circumstances, there was probable cause that Kelly Marie Evans was trespassing at Calmar. I placed her under arrest for Trespass After Warning, U.S.A. 810.09 (1)(a)(1).

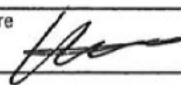

NARRATIVE

On August 25, 2026 at approximately 0010 Hours, I was notified of a disturbance at [REDACTED]

The caller [REDACTED] advised [REDACTED] took her car keys and was making threats to kill himself. [REDACTED] initially stated [REDACTED] Michael Emerson had left the scene, but notified our dispatcher he had returned to the house. [REDACTED] stated Michael was still parked in her driveway and wasn't exiting the car. As [REDACTED] approached the car, she stated Michael again drove off [REDACTED] described the car as a [REDACTED]

Myself and Deputy Edger located the vehicle attempting to leave the neighborhood and attempted to initiate a traffic stop. Deputy Edger activated his emergency flashing lights and positioned his patrol car in an attempt to block their exit. The vehicle made an evasive maneuver and drove around Deputy Edgars patrol vehicle and continued out to [REDACTED]. At this point I followed the vehicle with my emergency lights and audible siren activated and again attempted to signal to the driver to pull over. The vehicle continued to drive north on [REDACTED] reaching speeds of 40 mph. The vehicle then turned right onto 16th Street and eventually pulled over onto the shoulder near Westfield Circle.

I attempted to gain verbal compliance with the driver who remained seated in the driver seat of the car. The driver then identified himself and Michael, but refused all verbal directions to exit the car. While attempting to speak with Michael he made several comments about his life being over, and requested law enforcement on scene to shoot him.

While negotiating with Michael we were notified by Deputy Coon that probable cause existed for Battery (DV) and Robbery by Sudden Snatching.

Deputy Coon advised [REDACTED] denied Michael's request to borrow her vehicle due to him being under the influence of alcohol. [REDACTED] then stated Michael grabbed her by the shirt, and forcibly removed her car keys from her hand, breaking the key chain in the process.

Michael continued to ignore multiple commands to exit the vehicle and remained argumentative throughout the exchange. Eventually Michael was removed from the vehicle and secured in handcuffs. Michael was then transported to the Indian River County Jail without further incident.

Kayla said [REDACTED] jumped past Kayla by shoulder checking to get into [REDACTED]. Kayla said it was unknown if [REDACTED] retrieved the Cocaine. Then [REDACTED] exited the residence after retrieving [REDACTED] phone.

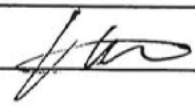
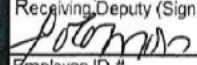

On August 25th 2026 at approximately 2259 Hours, I responded to the area of mile marker 146 South I95 in reference to a reckless driving complaint. The complainant, Anthony Malandro, advised he observed a green in color Volkswagen SUV stopped in the middle of CR512 near the I95 on ramp. The witness stated the driver appeared unresponsive and slumped over the steering wheel. Anthony stated when he attempted to wake the driver he immediately sped off. Anthony stated the vehicle struck a utility pole and continued south on I95 at a high rate of speed. Anthony attempted to follow the vehicle to provide additional updates, but stated he could not due to it reaching speeds in excess of 100mph.

While stationary on I95 near mile marker 146, I observed a SUV matching the suspect vehicle description traveling in the number 1 lane at a high rate of speed. I estimated the vehicle to be traveling 100 mph. I then used my agency issued Stalker Radar System to confirm. When activated the system emitted a loud, steady audible tone, confirming the radar signal and displayed a reading of 99mph.

As I attempted to initiate a traffic stop on the vehicle, they continued traveling south at a high rate of speed. The vehicle continued to drive in an unpredictable and erratic manner, and changed lanes multiple times without signaling. The vehicle eventually pulled over near mile marker 144 south I95.

Upon contact I identified the driver as Angelo Piner. I also observed what appeared to be fresh damage to the vehicle's front right bumper. While speaking with Piner, he could not sit still and appeared to be sweating profusely. Piner denied being involved in a crash and stated he was driving erratically because he was scared of people rummaging through his car. It should be noted Piner was the sole occupant of the vehicle at the time of the stop. I asked Piner if he recently consumed any drugs or alcohol. Piner confirmed earlier in the night he had taken prescription pain medication and also drank a few beers. While speaking with Piner his pupils remained pinpoint and unresponsive to light changes. Piner was then placed under arrest and transported to the Indian River County Jail for further testing.

After arriving at the jail, Piner was afforded the opportunity to conduct standardized field sobriety tests which he refused. Testing was not administered road side due to the inability to conduct them in a safe manner.

Jail staff then advised Piner of his rights under Implied Consent. When a breath sample was requested Piner again refused.

Deputy Edger responded to the initial incident location and observed a utility pole with damage consistent with what the witness observed.

Piner was charged with the following:

NARRATIVE

On August 25, 2026, at approximately 2146 hours, I conducted a traffic stop on a white GMC van bearing Florida Tag "DM92GA" after receiving a License Plate Reader (LPR) BOLO from Indian River Communications Center (Dispatch) referencing a stolen license plate out of Hernando County. The vehicle entered into the county from Brevard County, Florida. I observed the vehicle in the area of North Central Ave/Main Street, Sebastian, Florida, 32958.

Indian River County Dispatch confirmed the stolen tag with Hernando County Sheriff's Office. I confirmed the tag on the vehicle to be the stolen tag out of Hernando County prior to conducting my traffic stop.

I made contact with the driver and sole occupant of the vehicle Mrs. Mercy Hodkinson who was identified by her Tennessee License. Ms. Hodkinson was detained on scene; I then conducted a pat search of Mercy for weapons before placing her in the back of my patrol vehicle. I observed aluminum foil with burnt residue between the driver and passenger seat on a black tool box. Due to my training, knowledge and experience I know that to be commonly used as drug paraphernalia when heating up drugs.

Officer C. Hatton #432 of Sebastian Police Department arrived on scene to assist in the investigation and search of the vehicle. Officer Hatton advised me of the following: located Mercy's license in a wallet, which was in the front zipper pocket of a purse on the passenger seat. He also located keys in the purse that unlocked the black tool box which was located between the driver's and passenger's seat, upon opening it he located baggie with white residue and cut straws, which is commonly used items for drug use. For further information please see Officer Hatton's report (2026-1494).

Deputy Hackett #6318 arrived on scene to help with the investigation, he conducted field tests on the found drug paraphernalia located inside the vehicle, which field tested positive for the presence of Fentanyl.

I then read Mercy her Miranda Warnings, which she stated she understood and agreed to speak with me. Mercy stated she was borrowing the vehicle from her friend Samantha who lives in Barefoot Bay. Mercy did not know the license plate was stolen. Mercy stated she knew about the drug paraphernalia inside the van. But the van is commonly passed around and multiple people use it.

Deputy Kramer #6247 arrived on scene and conducted a person search of Mercy and located a cut straw with white residue in the front left pocket of Mercy's shorts.

Mercy was suspect of multiple warrants out of multiple jurisdictions to include Indian River County,

NARRATIVE

On August 25, 2026, at approximately 2250 hours, Cpl. Lang and I responded to the 300 Block of U S Highway 1, in reference to a disturbance.

Upon arrival I made contact with [REDACTED] whom stated she was on her way home in Fort Peirce after a physical altercation with [REDACTED]. She identified this male to be Devin Cunningham. [REDACTED] stated she [REDACTED]

[REDACTED] stated while she was driving Cunningham home from the gas station they were arguing. Once they arrived at his residence (625 18th Street, Vero Beach, Florida), the arguing continued. Cunningham walked around to the driver's side of the vehicle and opened the driver's side door where [REDACTED] was sitting. Cunningham stood in the way of [REDACTED] from closing the driver side door. She stated he continued to argue with her and out of nowhere, hit her in the face. She was unsure exactly where he hit her but believed it was in the nose. She did not recall if she was hit with an open hand or closed fist.

[REDACTED] stated after she was hit, she was able to get the car door closed and drive away. She stated he continued to grab the driver's side door handle as she was driving away.

While speaking with [REDACTED] I observed a small amount of blood dripping from her nose and dried blood on her chin. I also observed blood drops on the outside of the driver's side door. She stated she was unsure how blood got on the outside of the driver's side door.

I then made contact with Cunningham at his residence, 625 18th Street, Vero Beach. I read Cunningham his Miranda rights which he stated he understood and still wished to speak with me. Cunningham stated he was at a gas station where [REDACTED] picked him up. [REDACTED] brought Cunningham to his residence. Cunningham stated they were arguing all the way back to the residence. Once they arrived [REDACTED] was crying. Cunningham exited the passenger's side of the vehicle and walked over to the driver's side to hug [REDACTED]. Cunningham stated he hugged [REDACTED] and gave her a kiss on the forehead. She then hit him approximately 3 times in the face. Cunningham did not recall if he was hit with open or closed fists. Cunningham stated he pushed her to away to defend himself. Cunningham demonstrated to me what the push looked like. With the demonstration that was shown, it appeared to be a slapping motion rather than a pushing motion. Cunningham stated he was unsure of where he pushed her. He stated he did not see her nose bleeding and was unsure of how it started bleeding. Cunningham stated he was not blocking her and that she was free to leave at any moment. While speaking with Cunningham further, he stated he was in the way of [REDACTED] leaving the residence.

Cunningham stated he was hit in the left side of his face and his lip. I did not observe any injuries on Cunningham.
