NARRATIVE

On September 16th 2026 at approximately 0545 hours while working an extra duty detail at Cleveland Clinic Indian River hospital located at 1000 36th St. I responded to a subject trespassing on the property.

While responding to the area in which the subject was located, I was made aware that the subject now known to me as Deonte Parks had been discharged from the hospital at approximately 0000 hours and was currently refusing to leave the property.

Upon making contact with Parks, I was advised by hospital security that after being discharged earlier the previous detail deputy had escorted him off the property after his refusal to leave. Parks then returned to the property and began sleeping on one of the benches near one of the hospitals entrances. Security then made contact with Parks again advising him that he needed to leave the property or he would be trespassing when Parks failed to comply they notified law enforcement.

While in contact with Parks I explained to him that failure to leave the property would result in him being placed under arrest for trespassing. Parks who appeared to start to leave the property stopped and began walking in circles he continued this behavior multiple times for approximately fifteen minutes.

Based on the above it was determined that Parks had willfully entered and remained on property that was owned by another person, he had received notice to leave the property by a representative of the property and had refused to do so Parks was placed into custody for trespassing on property other than structure or conveyance.

Parks was transported to the IRC Jail where he was turned over to staff.

On **09/16/2026** , at **11:05** (Specifically include facts constituting cause for arrest.)

While conducting surveillance of a residence prior to the service of the search warrant, Detective Green and I observed Stidham leave the residence on a black street bike. We were both able to identify Stidham as the operator of the motorcycle from prior investigatory means. An FCIC/NCIC search of the attached Florida tag "SDRW86" returned as a black Dongfang DF200SST motorcycle registered to Stidham. Stidham returned with a valid Florida driver's license, however, with no motorcycle endorsement. A search of the Dongfang DF200SST prior to the stop also showed the motorcycle as a 200cc, which would require a motorcycle endorsement in the state of Florida to operate.

The motorcycle had left the residence, proceeding southbound on 11th Ct, then west on 26th St. As Stidham was navigating the intersection of 26th St and 11th Ct, he did not come to a complete stop at the posted stop sign and painted stop bar in the southbound lane of 11th Ct. VBPd Officer D. Farquharson #451 initiated a traffic stop for the above violations and made contact with Stidham, who was the operator and sole rider of the motorcycle.

I arrived on scene immediately after Officer Farquharson initiated the stop. During the stop, numerous knives were removed from Stidham's person. He was then taken into custody for the offense of operating a motorcycle without a valid motorcycle endorsement (F.S.S. 322.03(5)).

While conducting a search of Stidham's person incident to arrest, VBPd Officer J. Scroggin #483 located a combination brass knuckles/folding pocket knife concealed in Stidham's left rear pants pocket. Under F.S.S. 790.001, the definition for a "weapon" is "any dirk, knife, metallic knuckles, slungshot, bludge, tear gas gun, chemical weapon or device, or other deadly weapon except a firearm or a common pocketknife, plastic knife, or blunt-bladed table knife". F.S.S. 790.01(2) states "Except as provided in subsection (5), a person who does not meet the criteria in subsection (1) and who carries a concealed weapon or electric weapon or device, as those terms are defined in s. 790.001, on or about his or her person commits a misdemeanor of the first degree".

Additionally found during search incident to arrest, four (4) prescription pill bottles were removed from his pants pockets. Those pill containers were packed with different pills, and two of the four prescription bottles has no prescription label affixed. One of the labeled prescription bottles belonged to Stidham's GF Michele Vergho and the other labeled bottle belonged to defendant Stidham. Upon removing the prescription bottles from his pants, Stidham stated the unlabeled green pill bottles were not his and that they were his girlfriend's, Michele Vergho.

The prescription bottle in Stidham's name contained 117 round white pills with imprint "B10" identified by Drugs.com pill identifier as "Buprenorphine HCL 8mg" matching the description of the prescribed medication per the label. Mixed with those pills were 114 orange oval pills with the imprint of "153". Those pills were identified by Drugs.com pill identifier as "Logo (Actavis) 153 Buprenorphine HCL 8mg (sublingual)", a Schedule III controlled substance in the State of Florida. These pills did not match the description on the pill bottle which contained them.

One of the two unlabeled green prescription bottles found on Stidham's person contained 17 and one half round peach color pills with imprint "T 376". Those pills were identified as "Amphetamine and Dextroamphetamine 30mg", a Schedule II controlled substance in the State of Florida.

The second unlabeled green prescription bottle contained 50 whole round white pills with markings "RP b8", identified by Drugs.com pill identifier as "Buprenorphine HCL 8mg", a Schedule II controlled substance in the State of Florida. There were also numerous broken pills contained within matching the same description.

The orange prescription bottle with a prescription label showing the prescribed person as [REDACTED]

During the initial traffic stop, Stidham made the request for his attorney to be present. Due to his request for an attorney to be present, no interview was completed for Stidham during the traffic stop or search of his residence.

Upon completion of the initial traffic stop, Stidham's motorcycle was towed from the scene by Jerry's Wrecker Service and Stidham was transported to his residence by Officer J. Scroggin to be present during the service of the search warrant.

VBPd Crime Scene Technician M. Gasbarinni obtained photographs of the exterior of the residence, as well as the interior rooms of the residence prior to those rooms being searched. While searching the residence, the following items were located;

1. Black Smith and Wesson 9mm handgun (serial number HVF3926) found in a drawer of the living room coffee table. This handgun was loaded with six (6) 9mm rounds in the magazine and one (1) 9mm round loaded in the chamber of the weapon.
2. One (1) round of rifle ammo with headstamp "LC 22" found in a drawer of the living room coffee table.
3. Two (2) unloaded 12 gauge shotgun magazines found in the westernmost attic access of the residence.

The above listed items were seized pending further investigation. A copy of the signed search warrant, along with a carbon copy of the search warrant inventory, were both left on the dining room table of the residence.

With the above facts and findings, probable cause for the following additional charges to this investigation were present;

- Possession of Controlled Substance (F.S.S. 893.13(6a)). Stidham was issued Florida criminal UTC A0915LE for this offense.
- Carrying a Concealed Weapon (F.S.S. 790.01(2))
- Operating a Motorcycle without a Motorcycle Endorsement (322.03(5)). Stidham was issued Florida criminal UTC A0915KE for this offense.

Stidham was transported to the Indian River County Jail by VBPD Officer J. Scroggin without incident.

All found items of evidentiary value were submitted into VBPD Evidence.

NARRATIVE

On September 16, 2026, at approximately 2202 hours, I responded to the 600 block of 27th Avenue SW in reference to Deputy Moon's traffic stop.

Upon my arrival, I made contact with Deputy Moon, who informed me that she had conducted a traffic stop due to improper front light. I observed a cellphone hanging in the front of the bicycle. Masterson was informed to ride a bicycle at night he required an affixed front and rear light and reflectors, Masterson stated he understood.

While on scene, Deputy Moon conducted a records query of Masterson through Indian River County Public Safety Dispatch. Deputy Moon was advised that Masterson had an active warrant out of St. Lucie County for second-degree petit theft. Deputy Moon and I placed Masterson in handcuff restraints. Masterson was in violation of F.S.S. 316.2065(7) riding a bicycle with improper lights, and was issued citation # AM2LTYE, by Deputy Moon.

I then assumed custody of Masterson and continued the investigation. Masterson was informed that he would be searched incident to arrest. Masterson was then asked if he had anything on his person that would be harmful to my health. Masterson responded, "No." Masterson was read his Miranda rights, which he stated he understood and waived.

Post-Miranda warning, Masterson stated he might have burned foil inside his black backpack, which had been removed from his person at the time of his arrest.

A search of his black backpack yielded a small, clear plastic zip bag containing a white, powder-like residue. I then searched Masterson's person, including his shorts, with negative results. Shortly thereafter, Masterson stated he had additional substance inside his socks. Upon removing his sock, I located a clear plastic zip bag containing a crystal-like substance. Masterson stated the substance was "Fentanyl."

I conducted a field test of the substances located. The small, powder-like substance, with a package weight of 0.15 grams, tested positive for fentanyl. The second, crystal-like substance, with a package weight of 1.01 grams, also tested positive for fentanyl.

Based on the facts stated above, I found probable cause to charge Masterson with the following:

1. F.S.S. 893.13 – Possession of a Controlled Substance – No Bond – Citation #ANHB6LE
