The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
 On **06/10/2025**, at **01:00**

(Specifically include facts constituting cause for arrest.)

On 06/10/2025, at approximately 01:00 hours, I was patrolling along the 1500 block of 41st Avenue when I observed two males on bicycles pass by. The males were traveling eastbound on 14th Street from 41st Avenue, and I almost did not observe the cyclists because they did not have the appropriate lighting affixed to the front nor rear of their bicycles.

I positioned my patrol vehicle directly behind the cyclists and conducted a traffic stop for the above violation in the 3900 block of 14th Street. One male came to a complete stop, and the second male veered off of the road into the grass shoulder. I exited my vehicle and shouted out to the second male to return to the traffic stop to prevent him from driving away. The male acknowledged me and conducted an unusually wide turn around some bushes before driving back to me. The male then returned to me, and I advised both subjects the reason for the stop. I then requested for them to provide me with their identification. The first male (Michael Torres) provided me with his license. The second male that just circled back to me (Matthew Filanda) advised me that he discarded his wallet containing his identification behind the bushes that he circled around. At this time, K9 Officer Hatfield arrived to assist me on my traffic stop. I relayed to Officer Hatfield that Mr. Filanda claimed to have left his wallet behind these bushes nearby. Mr. Filanda then verbally guided Officer Hatfield to where he left his wallet. Upon locating the wallet, Officer Hatfield observed a rectangular, folded piece of aluminum foil sticking out of the wallet. Officer Hatfield had existing knowledge that folded aluminum foil is a common way to package and transport illegal narcotics. Officer Hatfield removed the foil from the wallet and observed a crystal-like substance inside. Officer Hatfield asked Mr. Filanda what was inside the foil, to which Mr. Filanda stated Fentanyl. At this time, I attempted to place Mr. Filanda in handcuffs. Mr. Filanda became very nervous, as he was moving and tensing up his arms. While I tried to gain control of his right arm, Officer Hatfield was standing nearby and witnessed Mr. Filanda toss a small clear plastic container behind him. The container landed near the rear tire of Mr. Filanda's bicycle.

Mr. Filanda was placed in handcuffs and he denied discarding the plastic container. The container that Mr. Filanda discarded was retrieved and located inside was a small circular blue pill, and a small plastic baggie with a white crystal-like substance. I then conducted a search of Mr. Filanda's person and located a pack of cigarettes with what I recognized to be a pipe concealed inside. The pipe was a hallowed plastic pen that had burnt residue. From my training and experience, I recognized that this hallowed pen is a common way to smoke illegal narcotics.

The property discovered was later field tested and revealed the following results:

- The aluminum foil containing a blue crystal-like substance field tested positive for the presence of Fentanyl. The total package weight with the foil was approximately 0.71 grams.
- The small plastic baggie with white crystal-like substance field tested positive for the presence of Methamphetamine. The total package weight with the baggie was approximately 0.50 grams.
- The small circular blue pill had MYX 943 imprinted on one side, and the number 10 imprinted on the opposite side. Using Drugs.com, the pill was identified as Diazepam 10 mg (a Schedule 4 controlled substance requiring a prescription).
- The residue inside of the hallowed plastic pen was collected with a sterile cotton swab. The residue on the cotton swap was then field tested and yielded a positive reaction for the presence of Fentanyl.

Based on the above facts, Mr. Filanda was charged with the following:

- FSS 893.13 Possession of a controlled substance- Suspected Fentanyl (FL UTC #AL1MNIE).
- FSS 893.13 Possession of a controlled substance- Suspected Methamphetamine (FL UTC #AL1MNJE).
- FSS 893.13 (6a) Possession of a controlled substance without a prescription- Suspected Diazepam (FL UTC #AL1MNKE).
- FSS 893.147(1) Possession of drug paraphernalia.

Mr. Filanda was subsequently transported to the Indian River County Jail for booking and processing.

On June 10, 2025 at approximately 02:38 hours, I observed a silver four door Hyundai Elantra (bearing FL tag JKFK67) roll through a stop sign at the intersection of 26<sup>th</sup> Avenue and 44<sup>th</sup> Place. The silver sedan continued westbound on 44<sup>th</sup> Place, rolled through another stop sign and proceeded to turn South on 27<sup>th</sup> Avenue. I observed the vehicle take off South down 27<sup>th</sup> avenue at a high rate of speed almost taking out neighbors' mailboxes and squealing the tires. I attempted to get closer to the vehicle and I activated my red and blue emergency lights on my marked agency issued patrol vehicle. The silver sedan proceeded to drive erratic and reckless at a high rate of speed throughout 4300 block of 27<sup>th</sup> Avenue area in an attempt to get away from law enforcement. I continued to follow the silver sedan and observed it turn Eastbound on 42<sup>nd</sup> Street. The silver sedan proceeded to drive all the way down 42<sup>nd</sup> Street Eastbound to the dead end where the roadway met Florida East Coast Railroad property. The silver sedan drove through the marked barriers and onto Florida East Coast Railroad property. The barriers had marked "No Trespassing" signs.

Once the silver sedan came to the dead end and drove onto FEC property, I observed approximately 5 black male individuals open the vehicle doors and exit the car running away from law enforcement. I observed the individuals running Northbound and Southbound down the railroad tracks. A perimeter was called out and set up to find the suspects that fled on foot.

A cellphone was found in the tree line near the car, where I observed two individuals run into. The cellphone was on and was playing music at the time I found it.

Deputy Daniel Magill and Brandon McKenzie arrived to the 4100 block of Old Dixie Highway where they observed two black male individuals running Southbound from the railroad tracks and exit the tree line to cross the road and head into the next set of trees on the South side of the roadway. Deputy Daniel Magill was able to apprehend the two black males and placed them into custody.

The black males were later identified as Qwan'Tavous Jarell Bythwood and Jovanta Tyrell Chambliss. Deputy Brandon McKenzie stated Chambliss advised to him that he had lost his cellphone when he exited the car to run away and jumped the fence that was in the tree line. Both Chambliss and Bythwood were captured together completely out of breath and covered in dirt and grass debris.

K9 handler Mindy arrived on scene to assist and deployed her dog. The dog tracked Northbound from the car into neighbor's yards, but due to rough terrain was unsuccessful. The dog tracked Southbound down the railroad tracks to the location where Chambliss and Bythwood were apprehended.

It was later found out that the vehicle was stolen out of St. Lucie County and the vehicle had a stolen license plate attached to it.

This incident was captured on my agency issued Axon body worn camera.

## NARRATIVE

On Tuesday, June 10<sup>th</sup>, 2025, at approximately 2057 hours, I was running stationary radar in the 600 block of South US Highway 1 on southbound traffic. I observed a black 2025 Volkswagen sedan (FL-RFKL85) traveling southbound in the 500 block of South US1 at a very high rate of speed. I visually estimated the vehicle to be traveling at 107 miles per hour in a posted 45 miles per hour zone. Using my Stalker DSR 2X front antenna in stationary mode, I received a digital readout of 110 miles per hour with a clear and concise audio doppler tone consistent with the readout.

I conducted a traffic stop on the vehicle, which pulled next to the Macdonald's at 754 S US Highway 1. I approached the driver and sole occupant, identified as Bryson Lasky, sitting in the driver seat. As I spoke to Bryson about the reason for the traffic stop, I could smell the odor of an alcoholic beverage coming from inside of the car. I also noticed his face was flush, his eyes to be glassy, and he had a slurred speech. Bryson said this was due to him having a stutter. He also appeared to be very nervous when I spoke to him, and he repeated some of the same statements. When I asked Bryson if he has consumed any alcohol tonight, he said he had not.

I asked Bryson to exit the vehicle, where I escorted him to the front of my patrol car. I asked him if he would consent to Standardized Field Sobriety Exercises to make sure he was okay to drive and he agreed to. The exercises I asked him to perform were the Horizontal Gaze Nystagmus, Walk and Turn, and the One Leg Stand. Bryson did not have any medical impairments that would keep him from performing these exercises. When I asked him if he had any prescription glasses or contact lenses, he said he has a prescription but does not wear them. The results performed are listed below.

## Horizontal Gaze Nystagmus (HGN):

- No resting Nystagmus, equal pupil size, and equal tracking
- Lack of smooth pursuit in both eyes
- Distinct and sustained nystagmus at maximum deviation in both eyes
- Onset of nystagmus prior to 45 degrees in both eyes
- As I moved my red DUI pen light in an upward motion, I noticed vertical gaze nystagmus

## Walk and Turn:

- He took an improper number of steps on his first series of nine steps, then another improper number of steps on his way back to the starting position
- When it came time to turn, he had to ask if it was time to do so

On Tuesday June 10<sup>th</sup>, 2025, at 2240 hours, I was advised by an assisting deputy that she observed two silver vehicles racing southbound on US Highway 1, from the 8500 block. Shortly after, I observed two silver cars matching the description that the assisting deputy provided, traveling south bound on US Highway 1, from the 8500 block. At 2042 hours, I conducted a traffic stop on a 2022 Nissan sedan, silver in color, bearing FL/ PIYG44. Upon making contact with the occupants of the vehicle, I was immediately met with a strong odor of burnt marijuana emitting from the interior of the vehicle. I requested their identification, too which they complied and provided me. While waiting for the driver, identified by her FL issued driver's license as Alexis Thompson, to produce valid vehicle registration and valid proof of insurance, Thompson asked why she was being pulled over.

I asked her where she was coming from and confirmed that she was traveling south bound on US Highway 1, and did in fact, travel through the intersection the assisting deputy advised that she previously saw the vehicles racing. I then informed Thompson that a deputy that was sitting at 8530 US Highway 1, observed them racing south on US1. Thompson admitting that she was racing the other silver sedan that continued south on US1 whenever I conducted the traffic stop.

After Thompson confirmed that she was racing, I then asked the her if she possessed a valid medical marijuana card. The driver stated she did not. I then questioned the occupants why I could smell the odor of burnt marijuana emitting from the interior of the vehicle. The passenger, identified by is FL issued driver's license as Marcelo Dejesus, stated that he was smoking marijuana with a friend of his. I then asked both subjects if there was any marijuana inside of the aforementioned vehicle too which both occupants stated that there was not. After advising that there was no marijuana inside of the vehicle, Thompson changed her statement and advised that there was. She then opened the center console to remove a small mason jar with a green leafy substance inside, along with a mushroom shaped smoking device.

I then removed both subjects from the vehicle and requested they stood by with assisting deputies while I conducted a search of the interior compartments of the vehicle. While searching the interior compartments of the vehicle, I located multiple opened and emptied bottles of alcoholic beverages, as well as several unopened bottles of alcohol. While searching the trunk of the vehicle, I located a small electronic smoking device (vape) that was tan in color. I observed the clear tank of the vape to contain a brown liquid. In order to determine the contents of the vape, I utilized an agency issued field drug test kit and tested the substance for the presence of THC. After testing the contents, the field drug test kit positively indicated the presence of Synthetic Cannabinoids.

- "Thompson was read Miranda warning and she advised she understood. Thompson advised she takes prescription medication daily which does not affect her ability to drive. Thompson denied drinking an alcoholic beverage.

Deputy Consalo placed drug paraphernalia and a glass container with a green leafy substance on the hood of his patrol truck. I questioned Thompson regarding the green leafy substance. Thompson claimed the items belonged to her friend and they had left it in her vehicle. I asked her regarding her fingerprints on the items and Thompson advised her fingerprints would be on the items as she had smoked it in the past. Thompson was asked if she had a medical marijuana card and she stated she does not have one."

It should be noted that Thompson invoked shortly after and refused to continue speaking with deputies. While enroute to the county jail, Thompson asked me if the other people were also being arrested. I asked Thompson which other people she was referring to and she replied by stating she was referring to the other people, allegedly her passengers' friends, that she was racing.

NARRATIVE

On Tuesday, June 10<sup>th</sup>, 2025 at approximately 2246 hours I was conducting traffic enforcement in the area of 8<sup>th</sup> Street / 8<sup>th</sup> Court. I observed an orange 2015 Hyundai Veloster bearing FL Tag #9240UG traveling northbound on 8<sup>th</sup> Court approaching the stop sign at 8<sup>th</sup> Street. I observed the Hyundai fail to stop at the stop sign at 8<sup>th</sup> Street. The Hyundai drove completely past the stop sign and stop bar and came to a stop at the roadway. The Hyundai began to travel westbound on 8<sup>th</sup> Street.

As I followed the Hyundai westbound, I visually estimated the vehicle to be traveling at approximately 38 mph in a posted 30 mph zone. I activated the front antenna of my Stalker DSR 2X radar unit and received a speed of 36 mph. I observed the Hyundai weaving left and right. The Hyundai crossed the center lane divider twice. I conducted a traffic stop on the vehicle and made contact with the driver Christopher Matthew Nemeth.

I began to inform Nemeth for the reason for the traffic stop. I asked Nemeth if he was feeling okay tonight, he began to look down and away. I asked Nemeth what was going on, he stated, "I'll be honest with you", he then began to have a blank stare and looked away. I asked him if he was suffering from a medical issue. I could smell the strong odor of an alcoholic beverage emitting from the inside of the vehicle. I asked him if he had been drinking, he stated that he has. He advised that he consumed some beers. I asked Nemeth how many drinks did he consume tonight, he stated, "Several". While he was obtaining his vehicle documents I asked Nemeth if he was a diabetic or epileptic, he stated that he is not. I asked him if he had any physical defects, he stated that he does not. I asked if he had any medical issues, he stated that he does not. I asked him if he uses any prescription medications and he stated that [REDACTED]

I requested Nemeth exit the vehicle. As he exited the vehicle, he held onto the driver's side door all the way to the rear passenger taillight to assist with maintaining his balance. While speaking with Nemeth outside and away from the vehicle I could smell the odor of an alcoholic beverage emitting from his breath as he spoke. I observed that he had bloodshot and watery eyes. I again asked him how many alcoholic beverages he consumed tonight, he stated, "Several". I asked him if several meant more than 5 and he stated yes. He advised that he consumed more than 5 Bud Light beers and that he had two Vegas Bombs (shots of liquor).

Based upon my observations I requested Nemeth submit to the field sobriety exercises, he stated that he would.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN) exercise. I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

-During his first attempt he had difficulty following instructions. I re-explained the instructions to him.

-During his second attempt I observed a lack of smooth pursuit in both eyes, I observed distinct and sustained Nystagmus at maximum deviation in both eyes, I observed Nystagmus prior to 45 degrees. I observed vertical gaze Nystagmus (VGN) in both eyes.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Nemeth was unable to maintain the starting position. During his two attempts he began to stagger and appeared that he would

wall over if he continued. When Nemeth would attempt to place his right foot in front of his left he immediately would stagger. Due to safety concerns based upon his level of impairment I stopped this exercise. I did not attempt the one leg stand exercise due to concerns for his safety.

The third exercise I demonstrated and explained was the Finger to Nose exercise, I gave the following sequence:

Left- Struck and held above left nostril.

Right- Struck under tip of nose, searched, held above right nostril.

Left- Struck below tip of nose, moved to tip of nose, held.

Right- Struck above right nostril and held.

Right- Struck with left finger and held tip of nose with pad of finger.

Left- Struck with left finger and held tip of nose with pad of finger.

Based upon the totality of the evidence Nemeth was taken into custody for violation of FSS 316.193(1) – DUI. Incident to arrest I asked Nemeth if he had anything illegal on his person or in his vehicle. Nemeth advised that he had a baggie of cocaine in his left pant pocket. I searched inside of his front left pocket and located a small clear plastic baggie that contained a white powdery substance that I believed to be cocaine based upon my training and experience. The baggie weighed approximately 0.28 grams. A presumptive field test was positive for cocaine.

Nemeth was transported to the Indian River County Jail for booking. At the county jail Nemeth provided two lawful breath samples. His first breath sample was 0.170 and his second breath sample was 0.168.

Nemeth was subsequently charged with the following:

-Violation of FSS 316.193(4), DUI 0.15 OR HIGHER (0.170 BrAC and 0.168 BrAC)

-Violation of FSS 893.13, Possession of a Controlled Substance (Cocaine)




**NARRATIVE**



Based on my investigation, I found probable cause to charge Sophia with F.S. 784.03 Battery Touch or Strike.

## NARRATIVE

On June 10, 2025, I responded to [REDACTED] in reference to a call for service involving harassment.

Upon arrival, I made contact with the victim, Sara Briggs, who advised the following in essence:

On June 9, 2025, Sara said she woke up to several messages about a Facebook post. The suspect, [REDACTED] made the posts. Sara showed [REDACTED] post, which had several different videos, photos, and statements about her. In one of the first posts, [REDACTED] posted a picture of Sara and a text message thread. Below is, in essence, the first post [REDACTED] made to Sara, stating the following:

"Sara Briggs, you fucked my ex-husband now you want to fuck my ex-boyfriend too? (Later in the post) You're lucky I ain't post all the fucking dirty ass nudes you were sending my ex-husband while I was fighting for my life getting sober. You better pray fucking God we never run into each other girl."

Another post showed Sara posing and wearing a white t-shirt, "FAFO," with an emoji covering her private area. The post states:

"She actually did get my clothes too. My bad. Can't make this shit up. Sara Brigg of Vero Beach, couldn't stay out of my lane wanted my whole life my ex-husband and no my boyfriend to so now we finna crash tf our together bitch."

After viewing all the posts, videos, and pictures, Sara contacted her lawyer to see what she could do. Sara advised [REDACTED] believes she slept with [REDACTED] estranged husband and [REDACTED] ex-boyfriend. Sara denied all claims and just wanted [REDACTED] to leave her alone. After Sara spoke to her lawyer, she was told to send [REDACTED] a cease and desist for defamation, slander, and 3rd party contact.

Sara sent the message on June 10, 2025, at 9:55 PM to [REDACTED] phone number [REDACTED]. In the message related to [REDACTED] Sara stated

"Dear [REDACTED] and Kelvin Jay Carlson, I am giving you a courtesy text letter whatever you wanna call this basically like a cease-and desist for the defamation, and slander."

After Sara sent the text message asking [REDACTED] to cease and desist, [REDACTED] replied. Sara advised in the text message that [REDACTED] threatened to harm her. Sara advised that she did not respond to [REDACTED] and was told by her lawyer to call law enforcement to report. Sara showed me the text message from [REDACTED] phone number [REDACTED]. The first message time stamp was on June 10, 2025, at 9:59 PM, ending with the last message being sent at 10:07 PM. The following messages are from [REDACTED] to Sara in chronological order:

- SENT 9:59 PM: "Oh I know this motherfucking bitch did not just fucking text me oh hell motherfucking no bitch I'll fucking snap your fucking neck you nasty junked out dirty cunt whore."
- SENT 10:02 PM: "I'ma fucking rip your face off how DARE you contact me you fucking stupid ass bitch."
- SENT 10:02 PM: "Oh you little fucking nasty bitch."
- SENT 10:03 PM: "Where are you at."
- SENT 10:03 PM: "A request from Apple for Sara's location."
- SENT 10:06 PM: "WHERE YOU AT BITCH."

I reviewed all eight messages [REDACTED] sent to Sara. I did not see any text messages from Sara responding to [REDACTED]. Sara advised that she is scared for her safety and believes [REDACTED] will harm her if she gets the chance. Sara stated she wanted to pursue criminal charges against [REDACTED].

Based on the evidence gathered, I had probable cause for the arrest of [REDACTED] for violation of Florida Statute 836.10 – Written or Electronic Threats to Kill, do Bodily injury.

[REDACTED] said that [REDACTED] got upset because Sara had messaged [REDACTED]. So, [REDACTED] said [REDACTED] responded to Sara via a text message stating, "I am gonna rip your face off." I reviewed the actual text message [REDACTED] sent to Sara. Which said, "I'll fucking snap your fucking neck." [REDACTED] admitted that [REDACTED] sent that text message to Sara. Which stated, [REDACTED] alleged she did this due to Sara threatening to call DCF on [REDACTED] children. I asked [REDACTED] if [REDACTED] understood that sending a written threat over text was a crime. [REDACTED] replied, "Yes."

NARRATIVE

On 6-11-25, at approximately 0112 hours, I, Deputy M. Mangel #5949, responded to the 5300 block of Old Dixie Highway, Indian River County, Florida, to assist Deputy D. Magill #6298 with a traffic stop.

Upon arrival on scene, Deputy Magill advised me that while conducting traffic enforcement in the area of the 4300 block of US Highway 1, he observed a tan Chevrolet Silverado, bearing Florida license plate Y15EFT, traveling at 56 miles per hour in a posted 45 mph zone. Deputy Magill is certified in the use of stationary and moving radar through a course approved by the Florida Department of Law Enforcement.

Deputy Magill stated that after positioning his patrol vehicle behind the suspect vehicle, he observed both driver's side tires cross over the double yellow lines that separate northbound and southbound lanes on US Highway 1. At the time, there was oncoming southbound traffic. The vehicle entered a lane designated for northbound travel but then came to a stop and positioned itself at an angle to turn west onto 53rd Street from US Highway 1.

Deputy Magill initiated a traffic stop and the vehicle came to a stop just west of the 5300 block of Old Dixie Highway. As Deputy Magill approached the vehicle on the passenger side, the driver's side door suddenly opened. The sole occupant of the vehicle, later identified as Sergio Cortes (DOB: 08-09-1994), exited the vehicle abruptly and stumbled out with his hands raised.

Deputy Magill said he observed Mr. Cortes to have bloodshot, watery eyes, and detected the strong odor of an unknown alcoholic beverage coming from his breath.

As I was speaking with Mr. Cortes, I observed several indicators of impairment. His eyes were bloodshot, watery and glassy. His speech was slurred, thick-tongued and difficult to understand. His face was flushed. I detected the strong odor of an unknown alcoholic beverage coming from his breath while outside and away from his truck. I asked Mr. Cortes if he consumed any alcohol and he told me yes. He said he was at work earlier in the evening and then went to Stix Billiard Club (939 14th Lane, Vero Beach).

While standing in front of Deputy Magill's patrol car, I observed Mr. Cortes to be unsteady on his feet and he displayed a noticeable orbital sway of approximately 2 inches from front to back and side to side. I observed a fixed gaze. I asked Mr. Cortes if he would be willing to participate in Voluntary Standardized Field Sobriety Tests to determine if he was safe to operate a motor vehicle and he told me no. I next explained to Mr. Cortes that refusal to participate in SFST's could lead to a license suspension and, in some cases, criminal charges. Mr. Cortes again refused to participate in SFST's. He told me that he had been through this before and knew the consequences of refusing.

Based on my training and experience, these are consistent indicators of alcohol impairment. Mr. Cortes was taken into custody. Mr. Cortes nearly fell over when attempting to place him into Deputy Magill's patrol car. Deputy Magill had to support Mr. Cortes so that he would not fall down due to his level of impairment. Mr. Cortes was transported to the Indian River County Sheriff's Office Jail where he refused to provide a lawful

NARRATIVE

On June 11, 2025, at approximately 0139 hours, I responded to [REDACTED] in reference to a reported disturbance.

Upon arrival, I made contact with the caller, later identified as Mindi Leigh Cain, who informed me that she had been involved in a verbal argument with her boyfriend, Matthews Thomas Waite, which escalated when he allegedly punched her in the mouth. Cain stated that she then began hitting Waite in an attempt to push him away. The altercation continued outside the residence, where she subsequently [REDACTED]

During my interview with Cain, I observed dried blood on the interior of her lips; however, there was no visible swelling, bruising, or any other injuries present. Cain stated she has been in an intimate relationship with Waite for over a year. [REDACTED]

I then made contact with Waite. He stated that the argument began over an incident from the previous week in which Cain caught him texting another woman. Waite stated that the argument escalated when Cain punched him and repeatedly pulled his hair and shirt. He advised that he eventually pushed her away in an attempt to stop her from hitting him in the face and also stated that he pushed her face away in an effort to prevent her from striking him further.

While interviewing Waite, I observed several scratches on his neck, a small bloody lump on his forehead, bloody scratches on his hand, and a bloody lip. Waite further informed me that Cain had been arrested approximately two months prior for domestic violence battery; however, he declined to pursue charges for that incident. A further query revealed that Cain was arrested on April 20, 2025, by the Vero Beach Police Department (VBPD) at the Mobil gas station located at 3341 Aviation Blvd for domestic violence battery. Refer to VBPD case number 2025000787 for additional information.

Waite also stated that during the argument in their bedroom, he attempted to leave, but Cain stood in front of the door and locked it, preventing him from doing so. He asked her multiple times to move aside, but she refused. Waite then requested to use the bathroom, which Cain allowed. However, when he entered the bathroom, Cain followed him inside and locked the door behind them. Waite again asked to leave, but Cain refused. After they exited the bathroom, Waite attempted to leave the residence, but Cain again prevented him from doing so. The altercation continued outside, at which point Cain [REDACTED]

I re-interviewed Cain and asked whether she had locked the bedroom door. She denied doing so and stated that Waite had access to the entire house. However, she did admit to standing in front of him when he attempted to leave the bedroom.

Based on the totality of the circumstances, I placed Cain in handcuffs and transported her to the Indian River County Jail for booking on the following charges:

1. Battery (Domestic Violence) – F.S.S. 784.03(1)(a)(1)




