NARRATIVE

On Tuesday, 08/18/2026, at approximately 2110, I responded to 4055 41st Avenue, Vero Beach, Florida 32960 (Indian River County Jail) in reference to a follow-up investigation regarding Indian River County Sheriff's Office Case#2026-84813.

It was brought to my attention that the Vero Beach Police Department took Randolph Rickey Lafond into custody on 08/15/2026 on Indian River County warrant #WR2026858. At the time of his arrest, Lafond was operating a company vehicle that he is issued as a take-home car. When the company received the vehicle after the arrest, a firearm was located inside the vehicle, which was turned over to the Indian River County Sheriff's Office. On 06/25/2026 Lafond was served a Domestic Violence Injunction which has a stipulation of respondent shall not possess or have in his care or control any firearm or ammo and shall surrender any to the IRCSSO.

Based on this information I made contact with Lafond at the Indian River County Jail and advised him of his Miranda rights, which he voluntarily waived and agreed to speak with me. Lafond advised me that he was currently working when he was stopped and taken into custody. I asked Lafond if that work vehicle, he was in is assigned to him, which he stated that he is the only person who operates the vehicle on a daily basis. I asked Lafond if he owns any firearms, to which me advised me that he does own one firearm which he keeps in his work vehicle. Lafond acknowledged that he violated his injunction when he to speak with the victim to rekindle their relationship, however stated he was unsure if he was allowed to have a firearm or not.

Based on the totality of the circumstances at the time of this investigation, Lafond was in possession of a firearm against a court order injunction. There is probable cause for a violation of the following offenses:

- F.S.S. 790.233 – Possession of weapon/ammo violating a domestic violence injunction.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On _____, at _____ (Specifically include facts constituting cause for arrest.)

On 08/19/2026 at 1342 hours I was dispatched to 2054 11th Avenue referencing a suspicious female refusing to leave a business property. Upon arrival I made contact with the complainant who stated suspect female was loitering on his property and was asked to leave. Suspect female told him no and to call the cops. While on scene complainant identified the suspect female who was on the sidewalk in front of his business. Suspect female was pushing a grocery cart while walking towards US Hwy 1 from 11 Avenue. Complainant stated he wanted the suspect female to be trespassed from his property.

Suspect female was asked to stop and to turn around. Suspect female continued to walk away and would not stop. I then went in front of the suspect female and told her to stop. Suspect female was speaking unintelligible and calling me the devil. I tried to calm the suspect female down and advise that she was not to be at the business anymore. Suspect female continued to yell unintelligibly.

I told the suspect to provide her name for the trespass which she said fuck you and pushed me. It should be noted that the suspect female had a lit cigarette and continued to puff and blow smoke in my face as well as motioning to push the lit cigarette in my face. I told the suspect female that she was being detained for identification and to turn around to be placed in handcuffs. Suspect female refused my order and resisted physically by pushing my hands away from her.

As I was placing handcuffs on suspect female she then kicked me in my right shin several times. Suspect female was then told she was under arrest. Suspect female continued to resist arrest while being handcuffed. After suspect female placed into handcuffs patrol Sgt. Hesse arrived on scene and assisted in controlling suspect female for a search incident after arrest. It should be noted that the suspect female again kicked me in right shin while leaning against the patrol vehicle. Suspect female refused to identify herself while in the backseat of my patrol vehicle.

Suspect female was transported to Indian River County Jail and charged with battery on law enforcement officer FSS 784.07. Upon arrival at Indian River County Jail staff was able to identify suspect female via rapid ID as: Kathy Bovett Onelli DOB 10/04/49

NARRATIVE

On August 19, 2026, at approximately 13:26hrs, I responded to [REDACTED] in reference to violation of injunction. The caller [REDACTED] stated [REDACTED] Evonta Richard, was at her residence, and stated she had an active injunction against him.

Upon arrival, I made contact with Richard, who was sitting on the front porch of the residence. Richard approached me stating he was attempting to retrieve his belongings from [REDACTED]. Richard made a comment that he was aware of the injunction. At this time, I detained Richard, placing him in handcuffs and escorting him to the back seat of my patrol vehicle.

As I approached the residence, [REDACTED] arrived on scene, and provided me her cell phone, which showed several text messages that had been received from phone number (561) 938-7892. The messages appeared to be from Richard, informing her that he would be coming to the residence for his things, to which [REDACTED] warned she would contact law enforcement. An Axon request was sent to [REDACTED] to submit screenshots of the message thread, to which completed.

A query of F/NCIC confirmed Richard was the respondent of an injunction (Case No. 26000635DV11), listing [REDACTED] as the protected person. Among the conditions of the order, it was listed that Richard was to stay away from [REDACTED] residence, and was to have no contact or communication with her (conditions 4 and 5). The F/NCIC response showed that the order had been served to Richard on July 14, 2026, and the order is to remain in effect until July 26, 2027.

Richard was transported to the Indian River County Jail without incident, being charged with FSS 741.31(4)(a) – Violation of Injunction.

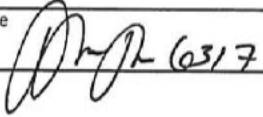
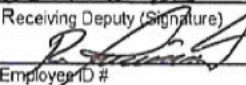

NARRATIVE

On , Monday, August 19th, 2026 at approximately 2045 hours, I, Deputy M. Neill #6317 was traveling westbound on County Road 512 near the 11200 block, Fellsmere, Indian River County, Florida.

While traveling westbound on County Road 512, I had a grey Nissan Altima drift in to my lane of travel. The vehicle was traveling eastbound on County Road 512. Due to the vehicle drifting in to my lane of travel, I had to take evasive action and leave the roadway in order to ensure a head on crash did not occur. While I left my lane, the vehicle drifted back in to its proper lane of travel.

I made a U-Turn to catch up to the vehicle. While turning around, I observed the Nissan Altima to be drift in to the oncoming lane of travel again. The vehicle then drifted across the whole eastbound lane of travel and started to leave the roadway to the right. I then activated my blue and red emergency lights to catch up to the vehicle and initiate a traffic stop.

As I was pulling up to the vehicle, it made a sudden maneuver to pull over. The driver for a unknown reason then turned off their headlights at the same time they were pulling over.

Upon speaking to the driver, I could immediately detect a strong odor of an alcoholic beverage emitting from the driver's area. I also observed the driver to have a heavily thick slurred speech, glassy eyes, poor dexterity and fine motor skills, and dilated pupils. I asked the driver, who was later identified as Mr. Timothy Moreno for his driver's license. Mr. Moreno started to dig around the vehicle but was unable to locate his license. I then asked Mr. Moreno to exit the vehicle based on his clues of impairment. After asking Mr. Moreno to exit the vehicle, he grabbed the gear shifter and attempted to manipulate the gear shifter. Not knowing if he was going to flee or not, I opened the driver's door of the vehicle and grabbed Mr. Moreno by the left arm. Mr. Moreno was escorted out of the vehicle.

While walking towards my patrol vehicle, Mr. Moreno stumbled and was unsteady on his feet. I asked Mr. Moreno for his name, as he was unable to provide me with his license. He originally advised "Timothy Moreno". I then asked him to spell Moreno. He replied back with stating "Timothy Moreno". I asked him to spell his last name again for a second time. He again replied "timothy Moreno". I asked a third time for him to spell Moreno. His response again was "timothy Moreno". I had to ask a fourth time for him to spell his last name. While speaking to Mr. Moreno, I could still detect the odor of an alcoholic beverage emitting from his breath and he was standing away from the vehicle.

Once another unit arrived on scene, Mr. Moreno agreed to perform Standardized Field Sobriety Exercises (SFSE's). These SFSE's go as follows:

Horizontal Gaze Nystagmus (6/6): Mr. Moreno had a lack of smooth pursuit, a distinct and sustained nystagmus at maximum deviation, and a onset of nystagmus prior to a 45 degree angle in both eyes. He did not have a resting nystagmus in either eye. He had equal tracking and equal pupil size in both eyes. During this exercise, Mr. Moreno

had a large back and forth sway in his stance.

Walk and Turn (5/8): Mr. Moreno could not keep his balance in the instruction stance, started too soon, did not touch heel to toe, made an improper turn, and took too many steps. During this exercise, I explained the instructions multiple times to Mr. Moreno. He was unable to complete the exercises as instructed, but stated he understood the instructions.

I explained the instructions to Mr. Moreno so that he could complete the One Leg Stand Exercise. Originally Mr. Moreno advised he understood the instructions, but then would not begin the exercise. When asked why he was not completing the exercise, he started repeating how he did not understand why he was here and that he had done nothing wrong. The instructions were explained three times. On the last explanation, Mr. Moreno spontaneously stated "just take me to jail".

Based on the clues of impairment, I placed Mr. Moreno in handcuff restraints. The handcuffs were checked for proper fit and double locked. Upon looking closer at his shirt, deputies noticed that it was actually inside out. Mr. Moreno was secured in my patrol vehicle.

During a search of his vehicle, I located a receipt for the Twisted Lime at 710 S US Highway 1, Vero Beach. The transaction was for one Yuengling beer at 1628 hours.

Mr. Moreno was transported to the Indian River County Jail. Deputy Solomon requested that Mr. Moreno provide a breath sample. Mr. Moreno originally agreed, but then refused. He was advised of implied consent by Deputy Solomon and again refused to provide a breath sample.

Mr. Moreno is being charged with DUI (Alcohol or Drugs), pursuant to FSS 316.193.1a, and for Refusing to Submit to a breath test, pursuant to FSS 316.1939.1E.
