On 5/19/2025, at approximately 1457 hours, I responded to _____ in reference to a disturbance.

Upon arrival, we made contact with Shemaar Campbell who advised the following: Sometime in the previous night, his mother Evelyn Stewart and his step father Kert Stewart were involved in a disturbance where Kert allegedly brandished a firearm. Police responded and investigated and where unable to affect an arrest. As a result of that disturbance, Evelyn moved Kert's clothes to another section of the house and changed the lock on the master bedroom door. Kert arrived home and was angered what Evelyn did. Kert kicked open the master bedroom door. Shemaar tried to calm him down and Kert was shouting "where is Evelyn". Kert went downstairs to _____ room (Shaenel Graham), and tried kicking her bedroom door in. Kert continued making multiple verbal threats of violence towards everyone in the house.

The following is a summary of Shaenel Graham's written statement: She rents a section of the house for \$1200.00 dollars a month from _____ Evelyn. She was inside her dwelling when she heard yelling in another part of the house. She heard Kert yelling "you don't know who I am, I isn't afraid of no police and where is she". At this time, she was in her room with _____ Kert then began kicking my bedroom door attempting to kick it down. When things got quiet, I began to leave the residence as she walked out, she observed Kert standing upstairs. Shaenel asked why he tried to kick her door down, he replied "You don't own any doors in this house."

Cpl. Dean observed an obvious shoe print/damage to the exterior of Shaenel's dwelling.

The following is a summary of the statement provided by Evelyn Stewart: she rents a section of the residence to _____ Shaenel. Other than Shaenel, Evelyn is the only person who has access to Shaenel's dwelling. Evelyn responded to the Sebastian Police Department to provide her statement. She was afraid of Kert's violent state.

My investigation revealed that Kert attempted to gain entry without permission into Shaenel's dwelling for the purpose of continuing his violent pursuit of Evelyn. All while Shaenel and her son were occupying the dwelling.

Kert was transported to the Indian River County Jail without incident.

NARRATIVE

On Monday, May 20th, 2025 at approximately 2135 hours, I, Deputy Sheriff Ramiro Doval responded to [REDACTED] in regards to a disturbance.

Prior to my arrival at the aforementioned address, I was on a separate incident when the complainant, later identified as Carlota Escobar Barrios made contact with me and advised me, she was in a physical disturbance with [REDACTED] while crying. I then followed Carlota to her residence.

Upon arrival at the Carlota's residence, she advised me she was in a physical altercation with [REDACTED] later identified as Acencion Covarrubias Santoyo, who was not present anymore and left the residence.

Carlota stated Santoyo and her have recently [REDACTED]

[REDACTED] She stated Santoyo would come as he pleases and stay the night with her. Carlota stated today, Santoyo arrived at her house demanding a phone which he bought her as a gift, Carlota stated she was not giving it back because she has sensitive information in the phone.

Santoyo then grabbed her forcefully by her arms, causing bruising and a small cut to her right inner arm, which appeared recent, causing Carlota to fall onto her knees on the front porch. Carlota then began to attempt to run away from him in order to get to safety.

I was able to speak to Santoyo over Carlota's phone, I asked him what happened, he stated he was over to grab a few things and his phone, which Carlota refused to give to him, he then attempted to grab the phone and is not sure if he caused any bruising on Carlota, but stated he did push her in order to grab the phone. I advised Santoyo if he could return to the residence to speak to me about what transpired, Santoyo agreed, I waited approximately 25 minutes and he did not return and then shut his phone off.

Carlota then called me a short time later and advised me Santoyo has returned to the residence and is willing to speak to me. I then responded to the residence and spoke to Santoyo, he stated he did not grab Carlota in anyway that would cause bruising or cuts. He stated he did attempt to grab the phone from her forcefully but does not remember causing any injuries to her.

Due to the statements made by Carlota and the physical evidence, I placed Santoyo under arrest for the following offenses;

Count 1.) Violation of F.S.S 784.03(1)(A)(1)- Battery (Domestic), when Santoyo pushed and grabbed Carlota by her right arm causing a small cut and bruising.

Santoyo was transported to the Indian River County Jail without incident.
