

### NARRATIVE

On Monday, April 28, 2025 at 0930 hours, I was actively patrolling the Publix shopping plaza located at 810 S US Highway 1.

As I passed the front of the store, I observed a Blue Toyota 4-door vehicle parked in the first space facing south. The sole female occupant was seen moving her body back and forth and side to side in an abrupt manner. As I passed further I could then see her head resting on the passenger side seat. Given this behavior, I was unaware if the female was having a medical episode so I turned up the second parking lane and came down the lane her vehicle was in to check on the subject. As my vehicle came to rest behind her's, my Axon license plate reader indicated an invalid license on the registered owner. Prior to exiting my patrol vehicle, I verified the DAVID photograph of the registered owner and determined it matched the description of the driver I observed as I passed.

I approached the driver who was visibly nervous at my presence and she stated she was just trying to charge her phone. I noted the keys were in the ignition with the radio on. In the center console was a visible "MXD" 22oz can of margarita mixed beverage. I asked the driver if she had been consuming alcohol and she stated the can was empty and from (2) days prior. I noted (2) additional unopened cans of the same alcoholic beverage in the passenger seat. I asked for the driver to identify herself with her driver's license to which she complied but in handing me the card she made a spontaneous utterance that her license was suspended. I asked her why she was driving around if she knew the license was suspended and she said she got into a physical fight with a male subject a couple days ago in Port St Lucie. I asked if she was hurt and she stated her back was painful on the right side. I offered to have EMS responded however she declined.

The driver was identified as Renee Christine Vaughn and her DAVID driver history did show a (6) month suspension for violation of chapter 893 controlled substance effective 12/16/2024 followed by two additional suspensions on 03/06/2025 and 04/08/2025 still requiring action. Renee has (2) previous driving under the influence convictions and (5) previous driving on a suspended license convictions as of this date. I found Renee Vaughn in violation of FSS 322.34.5 DWLS Habitual offender. Prior to placing Renee into custody, I requested consent to search the entirety of her vehicle after she admitted to having a drug pipe in the car. Renee was asked to exit the vehicle at which time under her right thigh, I observed a glass smoking pipe with copper "Chore boy" mesh inside. Based on my training and experience, I knew this to be a common pipe to smoke rock cocaine and methamphetamines. Renee did state that her preferred drug of choice in Methamphetamines however hasn't used since her relapse Friday. I placed Renee into hand restraints and secured her in my patrol vehicle.

A search yielded additional copper mesh material from a paper bag on the passenger seat but as I searched the driver side door compartment I observed a phone charger in the door. As I pulled the phone charger out of the door pocket and plastic bottle fell out and onto the ground. A later inspection revealed a small white rock like substance inside. A field test was conducted with an agency approved test kit which indicated a positive reaction to cocaine. The center console also yielded a white Styrofoam cup that had a yellow in color beverage that emitted the odor of an alcoholic beverage.

Given my initial observation of the driver in the parking lot, The paraphernalia, drugs and alcohol in the vehicle I transported Renee to the Indian River County Sheriff's Office for a further investigation for driving under the influence in addition to the current charges of possession of a controlled substance, possession of drug paraphernalia and habitual dwls.

At the Indian River County Jail, Renee submitted to field sobriety exercises and below are my findings;

### NARRATIVE (Continuation)

#### One Leg Stand:

- Subject understood instructions however lost balance and put foot down twice in first (3) secs.
- Subject then stated she was unable to proceed with the test due to having bad equilibrium and back pain.

#### The walk and turn:

- Subject understood instructions however could not maintain the starting position.
- On the first pass, the subject proceeded to take three steps, used her arms for balance and stepped off line twice. Subject then again stated her equilibrium was off and was preventing her from continuing this exercise.

#### The finger to nose (LRLRRL):

- Subject understood the directions however missed finger to nose on (4 of 6) attempts either hitting the bridge of her nose or missing to the left or right side.
- Subject nearly lose balance on the last attempt before being instructed to open her eyes.

A dexterity test was performed based on the subjects complaints of back pain and feelings of unbalanced equilibrium. The subject was instructed to chose whichever hand she wished to use and simply touch each finger to her thumb while counting 1,2,3,4 4,3,2,1 for a set of 5. The subject was asked to increase her speed as she proceeded with the exercise. Subject failed to increase speed and maintained her starting speed while confusing her middle finger and index finger on the final set.

Renee was asked to provide a lawful sample of her breath on the intoxylizer 8000 instrument by certified breath test operator D/S Rudolph of the Indian River County Sheriff's Office. Renee consented and provided (2) separate samples of 0.000/210L and 0.000/210L. Renee was asked to then provide a lawful sample of her urine to which she consented however was unable to provide a sample at that time. Renee was given the option for a blood draw to which she consented however two unsuccessful attempts by EMS to establish a good vein prevented obtaining a blood sample. Renee was then provided a second attempt to provide a urine sample to which she did. A DUI Drug citation was issued with results of a FDLE toxicology test pending.

Drug Recognition expert Cpl Chouinard was available to assess Renee however she declined to speak with him.




On April 28<sup>th</sup>, 2025, at approximately 1051 hours, I responded to 2036 13<sup>th</sup> Avenue Southwest in reference to a trespassing. Prior to my arrival, public safety dispatch advised that Stacie Wesley had returned to the residence after being formally trespassed per Indian River Sheriff's Office case number 2024-00124896. The caller / complainant was Brandon Wesley who is Stacie Wesley's brother and was calling on behalf of Stacie's parents who were at the home. Brandon advised public safety dispatch Stacie was now refusing to leave the residence

Upon arrival, I observed that Deputy Sheriff (D/S) R. Ferrer had Wesley detained in handcuffs near the front door of the residence. D/S Ferrer stated he observed Wesley inside the home after he arrived on scene.

I spoke with Wesley's parents, Debra and Mark Wesley. Mark stated Wesley just suddenly showed up at the residence today to collect some of her things that were left after she voluntarily left the residence pending a formal eviction. Debra and Mark further stated Stacie just randomly shows up at the residence causing disturbances which cause both Debra and Mark emotional distress. Debra and Mark wished to move forward on criminal charges of trespassing.

Based upon my investigation, I established that Wesley was in violation of the following Florida Statute:

F.S.S. 810.08 – trespassing occupied structure

I briefly reviewed the case file for IRCSO 2024-124896. D/S S. Barrientos advised the following in the case report:

**"I issued Wesley a trespass-after warning sheet, which she refused to sign. Wesley understood she would be subject to arrest if she were to return to the property."**

On Monday, April 28, 2025, at approximately 1316 hours, I responded to the area of Mile Marker 13, Eastbound State Road 60, in reference to an exhibition of a weapon.

██████████ advised she was traveling east on State Road 60, when a male in a red sedan got into a road rage incident and flashed a firearm out the window of the vehicle.

██████████ was able to provide the Florida Tag attached to the vehicle (FL/3MPE).

I observed the suspect vehicle traveling east on State Road 60 and conducted a traffic stop at the entrance to the Outlet Mall, 1824 94<sup>th</sup> Drive.

I made contact with the driver of the suspect vehicle, later identified as, John Locklair, who was advised he was stopped for a road rage incident. Locklair stated the vehicle he was involved in an incident with was driving too slow in the fast lane, and brake checked him.

I asked Locklair if there were any firearms in the vehicle, to which he confirmed, a black semi-auto 9mm pistol, that I took possession of.

Contact was made with the victims, driver, Mia Martinez, and passenger, Leah McKibbin. Both stated they were traveling east on State Road 60 in the fast lane, when they were traveling the same pace as a RV in the slow lane. I was advised Locklair's vehicle was tailing their vehicle, when he passed them, then began brake checking them. I was advised Locklair then slowed down, allowing them to catch up, when both observed the driver window of Locklair's vehicle down, and a firearm hanging out of the window. Both stated they were in fear for their lives and safety, and Martinez slowed down as soon as she saw the firearm, ██████████

Both described the firearm as black in color.

I then again made contact with Locklair, and advised him of his Miranda Rights to which he stated he understood and was willing to speak to me.

Locklair admitted to holding a firearm out of the window, but stated he never pointed it at the vehicle. Locklair stated he did this in case "they had something else in mind..."

Locklair was placed in hand restraints and transported to the Indian River County Jail for Aggravated Assault with a Deadly Weapon without incident.




## NARRATIVE

On 4/28/25 I was dispatched to [REDACTED] in reference to a possible disturbance in progress. Upon my arrival I made contact with a [REDACTED] in question. I was advised that the occupants of that apartment no longer resided there. I responded to the lease office at the apartment complex after verifying the residence was in deed empty. The lease office didn't have a forwarding address so I was about to clear the call. Dispatch informed me that the victim from my disturbance was back on the phone and informing me that the correct address was [REDACTED]. I responded back to the apartment and made contact with Ms. Raldaisia Scott. She informed me that [REDACTED] Andrevious Collins choked her twice as I drove through the parking lot the first time and then hit her in the face really hard after I left to go to the leasing office. She advised after he struck her in the left eye he got into a white Chevy Tahoe and provided this Deputy with a picture of the car. She also provided a direction of travel. This Deputy provided a short BOLO and the suspect vehicle and the suspect were located just West of 43AVE off SR60 by Sgt. Rodriguez and D/S Chouinard. The victim stressed numerous times that the suspect was just [REDACTED] and that she didn't like him that way and she wasn't going to call the cops until he hit her in the face while she was hold [REDACTED] in her arms. That is why she called us back and asked for [REDACTED] to be arrested.

This Deputy met D/S Chouinard at the county jail with the defendant, Andrevious J. Collins. He was identified by his FLID and recited Miranda Warnings. He stated he wished to speak to this Deputy about the incident. He denied that he ever choked the victim in this case. He did advise that he struck the victim in the face with his left open hand because she charged at him with a "big ass vase" and he thought she was going to hit him with it. He said when he struck the female in the face the baby was in the car seat in the living room on the couch. This Deputy did observe that the victim's left eye area was red and puffy, flush and raised, suggesting she was just struck under the eye area and left cheek area. She didn't have marks consistent with choke marks around her neck but her neck appeared red and irritated. The defendant informed this Deputy that he was seeing the victim and that they were more than friends. Based on the victim's written statement the defendant will be charged with violation of F.S.S. 784.031 (Battery by Strangulation) for intentionally placing his hands around the victim's throat or neck and applying pressure affecting her normal breathing and violation of F.S.S. 784.03 (Battery) for intentionally striking the victim in the left side of her face under her left eye with an open hand per his own statements to this Deputy against the victim's will while she held her baby as her written statement indicated and physical evidence suggests. A Domestic Violence Rights Packet issued because the victim advised multiple times that she was not dating or involved with the defendant in that manner. There will be no further information or investigation into this case. All incidents occurred within Indian River County FL.

On April 28, 2025, at approximately 2047 hours, Deputies responded to the Center for Advanced Eye Care, located at 3500 US Highway, Vero Beach, Florida, in reference to a suspicious incident.

Prior to arrival, the complainant, Ryan Rose, advised he heard a male yelling and screaming in the rear of the business.

Upon arrival, Deputy Santana made contact with Kenneth Patrician. While Deputy Santana was talking with Kenneth, I observed him profusely sweating, as if he just ran a marathon. Due to the current temperature to be approximately 75 degrees outside, I believed, based on my training, education, and experience, Kenneth to be under the influence of a controlled substance.

I asked Kenneth if I could search his backpack that was located on his motorcycle, bearing Florida tag SBTM63. Kenneth advised I could search the backpack. Located inside a 305-cigarette pack was a crackpipe and push rod. The crackpipe field test positive (FTP) for cocaine, with an agency issued drug test kit. Located inside another 305-cigarette pack, was a white rocky substance that field weighed approximately 1.22 grams, and FTP for cocaine with an agency issued drug test kit.

Kenneth was secured in handcuff restraints, checked for proper fit, and placed in the back seat of my patrol car. In the back seat of my patrol car, I read Kenneth his Miranda Rights, which he advised he understood and wished to talk with me. I asked Kenneth what the white rocky substance I located in the 305-cigarette pack was, which he advised it was crack.

This investigation was captured on my agency issued body worn camera.

This investigation is cleared by arrest of Kenneth, for possession of drug paraphernalia, and possession of a controlled substance (crack cocaine).
