

NARRATIVE

On Tuesday, June 24, 2025, at 1746 hours, while actively working for Indian River County Sheriff's Office in the capacity of a Deputy Sheriff, I responded to 8755 92nd Avenue in reference to a transport for New Horizon's Mobile Health Team.

While on scene, I was informed a black female later identified as Olga Savoie Pierre was [REDACTED] and needed to be transported to Cleveland Clinic Indian River Hospital. Pierre had not been informed she was [REDACTED] and became upset. She asked to lock up her room as she is currently residing in a boarding house.

Once inside the room, Pierre became agitated and shouted she was not going and that the team set her up. I attempted to explain to her she was going to be transported to the hospital. Pierre refused to cooperate. While attempting to get Pierre to stand up to move her outside and into my patrol vehicle she began to actively resist me. During that time, Pierre managed to get on top of me and wrapped her hand around my throat. Pierre was pushed away with my foot to her hip around and subsequently tased. Pierre was then placed in handcuffs and placed into the back of my patrol vehicle. Pierre was placed under arrest for battery on law enforcement officer when she placed her hand around my neck and applied pressure, while I was actively working in the capacity of a deputy sheriff in full uniform (agency issued).

Pierre was transported to Indian River County Jail for violation of Florida State Statute 784.07 for battery of law enforcement officer.

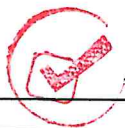

NARRATIVE

On Tuesday, June 24th, 2025 at 1955 hours, I was traveling Eastbound on 9th Street Southwest when I observed a silver Nissan Sentra bearing Florida tag# 54EXCF with an obstructed tag. I further observed the female passenger in the vehicle not wearing her seatbelt. I activated my emergency lights and conducted a traffic stop on the vehicle at the 800 block of US Highway 1.

Upon approach of the vehicle, I made contact with the driver and passenger of the vehicle, who were identified as David Arnett and Amy Welsh. Shortly after making contact with the occupants, I observed Welsh still did not have her seatbelt on. Welsh continued to pull out a plastic pipe with burnt residue. Through previous training and experience I identified the pipe as a crack pipe, which is an instrument used to consume narcotics.

Due to the previously mentioned both subjects were asked to step out of the vehicle.

I then placed Welsh in handcuffs and in the back of Corporal Mckenzie's marked patrol vehicle.

I then made contact with Welsh and advised her of her Miranda warnings, in which she acknowledged and continued to speak with me. Post Miranda, Welsh identified the pipe, as a crack pipe and stated she had just recently used it today to smoke crack. Welsh stated she used the pipe to smoke some crack she bought earlier in the day. Welsh stated she has been smoking crack for a while.

Due to the above mentioned, I criminally charged Welsh with the following charges:

F.S.S 847.193.1b Possession of drug paraphernalia

Welsh was transported to the Indian River County Jail without further incident.



On 06/24/2025 at approximately 2017 hours, I responded to a disabled/abandoned vehicle near the 600 block of Royal Palm Boulevard. Vero Beach dispatch advised there was an additional caller who observed an irate black male near the 800 block of Royal Palm Boulevard throwing contents of a wallet onto the ground and it was unknown if both calls were related. The male was said to be wearing floral shorts and a green hooded jacket.

Upon arrival, I located a small rectangular brown wallet on the street (700 block of Royal Palm Blvd). Upon picking it up, the wallet was empty. I then observed a female approach and she stated she was one of the callers. The female advised she observed a black male removing and throwing some contents out of the brown wallet. The female stated she observed the male kick a "For Sale" sign at one of the houses off Royal Palm Boulevard and saw him walking west bound before losing sight of him.

While speaking with the female, a vehicle occupied by two males, approached and stated they had called about a gold sedan with its blinkers on. The two males stated that the vehicle was unoccupied and parked in the middle of the road.

As I walked around the general area, I located several cards on the grass and located a Vero Beach High School identification card. The identification card had a name of Elisha McKenzie and a photograph of a black male. All cards were retrieved and placed inside of the brown wallet. I then drove eastbound on Royal Palm Boulevard where I located the gold sedan at the 600 block of Royal Palm Blvd. The gold sedan was a 2009 Saturn four-door with FL tag #: CC62CP. Upon provided Vero Beach dispatch the vehicle tag, I was advised the vehicle was registered to Elisha McKenzie (B/M DOB: 12/23/1998). As I approached the vehicle, the hazard lights were on and the vehicle engine was not running.

All information was relayed to the officers assisting with the call. Ofc. Hogue (#468) located the male matching the description at the Trinity Church (2365 Pine Ave). Ofc. Hogue advised that she attempted to make contact with the male and told him there was an active investigation in reference to this incident. Ofc. Hogue stated that the male was being in compliant but then identified himself as "Elisha." Ofc. Hogue stated that the male started running away from her after being told that he was detained. The male ran towards Granada Avenue and 23rd Street and onto the Trinity Church property (2365 Pine Ave). At that time, Sgt. Adamski (#496) was on scene and advised he observed Elisha pull on the door handle of the church, attempting to gain access. Elisha was eventually placed in handcuffs.

It should be noted that Trinity church was closed at that time and not open to the public.

I then arrived on scene and made contact with Elisha. Post Miranda, Elisha denied that the gold Saturn (FL tag #: CC62CP) belonged to him and stated he was schizophrenic. Elisha stated that he pulled on the church door handle in an attempt to get away/evade from law enforcement.

Based on the foregoing, Elisha McKenzie was placed under arrest for Loitering and Prowling F.S.S. 856.021 and Resisting without Violence F.S.S. 843.02.

Elisha was transported to the Indian River County Jail for booking and processing and to be held on a \$1,000.00 bond.

Elisha was also issued a citation (#AL1MQRE) for F.S.S. 316.194(1) - Stopping, Standing, or Parking outside of Municipalities.



NARRATIVE

On Tuesday, June 24, 2025, at approximately 2126 hours, I responded to [REDACTED]
[REDACTED] in reference to a disturbance with injuries.

Upon my arrival, I made contact with Ms. Kristy Medler (victim), who advised the following in substance: She was at her residence [REDACTED] when [REDACTED] Mr. Lucky McIntosh (Arrestee), began arguing with her. During the argument, Mr. McIntosh punched her in the forehead, causing a deep laceration. The injury was approximately an inch and a half to two inches long, was very deep, and was bleeding profusely. After he struck her in the forehead, he picked up a pair of scissors off of a table and began chasing her, while threatening to stab her. Mr. McIntosh was still within striking distance when he had the scissors and had the ability to stab her. Due to Mr. McIntosh just attacking Ms. Medler, she believed he would attack her again and harm her. She then left the residence and waited down the road to meet with law enforcement. Ms. Medler advised she was not in a relationship with Mr. McIntosh [REDACTED] Ms. Medler wished to press charges on Mr. McIntosh. She was provided a copy of her victim rights.

Ms. Medler was then transported to Cleveland Clinic by ambulance. I then responded to the hospital and spoke with the medical staff who advised Ms. Medler needed stitches due to the injury and there would likely be permanent disfigurement.

Photographs of Ms. Medler were taken using the Axon Capture application. The photographs were uploaded to Evidence.com.

While I was speaking with Ms. Medler, multiple other deputies responded to [REDACTED] and attempted to make contact with Mr. McIntosh. As they approached the residence, he opened the door and observed the deputies. They requested he speak with them and he stated he did not do anything wrong and refused to speak with law enforcement. He was ultimately arrested for felony battery and aggravated assault. Refer to the other deputies' supplements for further details.

Deputy Hackett then completed a search of Mr. McIntosh incident to arrest. Deputy Hackett located two clear plastic baggies, with a powdery white substance inside, which fell from his right pocket onto the ground directly between his feet and a third baggy was attached to his right hand. A clear plastic baggy was also recovered from his right pocket that contained a green leafy substance.




NARRATIVE

On June 24th, 2025, at 2236 hours, I responded to [REDACTED] in reference to a disturbance.

While en route, dispatch advised that the suspect, later identified as Cruz Brandon Storey, was allegedly abusing and hitting his girlfriend, later identified as, Jody A. Burnett.

Upon arrival, I made contact with Ryan Daniel Burnett, who stated he was in his bedroom when he heard his mother, Jody, and her boyfriend, Storey, engaged in a verbal argument. Ryan advised that at some point, he heard a loud noise consistent with the wall shaking, followed by his mother yelling, "Let me out," "Stop following me," and "Get away from me," as she moved toward the bathroom and closed the door. Ryan stated he remained in his room and did not witness the incident directly.

I then spoke with Jody Burnett, who stated she had been involved in a verbal argument with Storey, which escalated when he cornered her in the bathroom and refused to let her leave. Jody stated that she repeatedly asked Storey to move, but he refused. She was eventually able to exit the bedroom and lock herself inside the bathroom located near her son's room.

While speaking with Jody, I observed a small, bloody scratch on her right hand. When asked, Jody stated she did not know how she sustained the injury. She also advised that she and Storey have been in an intimate relationship for the past two years. While he frequently stays at her residence, he primarily lives elsewhere.

I interviewed the caller, Connor Burnett, who stated he heard the argument from his bedroom and exited to check on his mother. Connor reported observing Storey standing in the doorway between the bathroom and the bedroom, physically blocking Jody from leaving. He stated he heard Jody pleading with Storey to let her go, but Storey continued to block her. Connor then observed Storey using his chest to physically push Jody into the bathroom. At that point, Connor [REDACTED]

I made contact with Storey and advised him of his Miranda rights, which he stated he understood and decided to waive. Storey admitted to being involved in a verbal argument with Jody but denied placing his hands on her. He stated that during the argument in the bathroom, Jody pushed him out of the way to leave the bathroom. He claimed he did not know how she sustained the injury to her hand and added that they frequently argue and cops are always involved.

Based on the totality of the circumstances and the statements provided by witnesses, I placed Storey in handcuffs and transported him to the Indian River County Jail for the following charges.

1. Battery touch or strike (dating violence), consistent with FSS 784.03.1a1.
2. False imprisonment, consistent with FSS 787.02.1a.
