NARRATIVE

On Tuesday, June 24th, 2025 at 1955 hours, I was traveling Eastbound on 9th Street Southwest when I observed a silver Nissan Sentra bearing Florida tag# 54EXCF with an obstructed tag. I further observed the female passenger in the vehicle not wearing her seatbelt. I activated my emergency lights and conducted a traffic stop on the vehicle at the 800 block of US Highway 1.

Upon approach of the vehicle, I made contact with the driver and passenger of the vehicle, who were identified as David Arnett and Amy Welsh. Shortly after making contact with the occupants, I observed Welsh still did did not have her seatbelt on. Welsh continued to pull out a plastic pipe with burnt residue. Through previous training and experience I identified the pipe as a crack pipe, which is an instrument used to consume narcotics.

Due to the previously mentioned both subjects were asked to step out of the vehicle.

I then placed Welsh in handcuffs and in the back of Corporal Mckenzies marked patrol vehicle.

I then made contact with Welsh and advised her of her Miranda warnings, in which she acknowledged and continued to speak with me. Post Miranda, Welsh identified the pipe, as a crack pipe and stated she had just recently used it today to smoke crack. Welsh stated she used the pipe to smoke some crack she bought earlier in the day. Welsh stated she has been smoking crack for a while.

Due to the above mentioned, I criminally charged Welsh with the following charges:

F.S.S 847.193.1b Possession of drug paraphernalia

Welsh was transported to the Indian River County Jail without further incident.

On June 24th, 2025, at 2236 hours, I responded to to a disturbance.

While en route, dispatch advised that the suspect, later identified as Cruz Brandon Storey, was allegedly abusing and hitting his girlfriend, later identified as, Jody A. Burnett.

Upon arrival, I made contact with Ryan Daniel Burnett, who stated he was in his bedroom when he heard his mother, Jody, and her boyfriend, Storey, engaged in a verbal argument. Ryan advised that at some point, he heard a loud noise consistent with the wall shaking, followed by his mother yelling, "Let me out," "Stop following me," and "Get away from me," as she moved toward the bathroom and closed the door. Ryan stated he remained in his room and did not witness the incident directly.

I then spoke with Jody Burnett, who stated she had been involved in a verbal argument with Storey, which escalated when he cornered her in the bathroom and refused to let her leave. Jody stated that she repeatedly asked Storey to move, but he refused. She was eventually able to exit the bedroom and lock herself inside the bathroom located near her son's room.

While speaking with Jody, I observed a small, bloody scratch on her right hand. When asked, Jody stated she did not know how she sustained the injury. She also advised that she and Storey have been in an intimate relationship for the past two years. While he frequently stays at her residence, he primarily lives elsewhere.

I interviewed the caller, Connor Burnett, who stated he heard the argument from his bedroom and exited to check on his mother. Connor reported observing Storey standing in the doorway between the bathroom and the bedroom, physically blocking Jody from leaving. He stated he heard Jody pleading with Storey to let her go, but Storey continued to block her. Connor then observed Storey using his chest to physically push Jody into the bathroom. At that point, Connor

I made contact with Storey and advised him of his Miranda rights, which he stated he understood and decided to waive. Storey admitted to being involved in a verbal argument with Jody but denied placing his hands on her. He stated that during the argument in the bathroom, Jody pushed him out of the way to leave the bathroom. He claimed he did not know how she sustained the injury to her hand and added that they frequently argue and cops are always involved.

Based on the totality of the circumstances and the statements provided by witnesses, I placed Storey in handcuffs and transported him to the Indian River County Jail for the following charges.

- 1. Battery touch or strike (dating violence), consistent with FSS 784.03.1a1.
- 2. False imprisonment, consistent with FSS 787.02.1a.
