NARRATIVE

On Tuesday, April 08, 2025, at 2351 hours, I responded to the Sure Stay Promise hotel, 9330 19th Lane, Vero Beach, Florida, in reference to a disturbance. Communications advised two males were reportedly in a physical altercation in room 364 of the hotel, and one of the males had thrown the belongings of the other outside of the room.

Deputy Quint, K9 Deputy Mangel, Deputy Givens, and I arrived at the aforementioned location, whereas we met with the complainant, Scott Adelman, who informed us that him and his friend of a few days, Michael Dolberry, got into an altercation. Through the investigation into the disturbance, it was determined that no crime had occurred and no evidence of a crime existed beyond a verbal altercation. The property agent, Shannelle Pearson, informed me that the manager wanted both parties to be removed from the property, and trespassed due to them disturbing the guest. Pearson stated multiple guests had complained to management regarding the incident.

A Trespass Warning was completed and issued to both Michael and Scott, signed by Pearson as the property agent in place of the Manager.

Scott willingly vacated the property without incident; however, Michael refused to comply with commands stating, "I'm drunk, suffer with [REDACTED] and you are just going to arrest me as soon as I get into my car." Michael was advised not to get into his vehicle as he was clearly intoxicated, and also has a suspended driver's license which prevents him from driving.

It should be noted that as I interacted with Michael, I observed the following signs of impairment: Glossy, Watery eyes, slurred speech, and emotional instability.

It should be noted that Michael began to collect his belongings; however, as he was walking towards the elevator, he stated, "I'm not leaving you are just gonna have to take me to jail." Michael was provided numerous opportunities to comply with our request, and I reiterated that his failure to vacate the property after warning would result in him being arrested for trespassing after warning. Michael again stated, "take me to jail I'm not leaving, at least I will get three hot meals and a place to sleep."

It should be noted that Michael on multiple occasions walked down to the main lobby of the hotel to continue to yell at Scott who was vacating the property as instructed. Michael continued to pick at his arms, causing him to bleed throughout the hotel, while stating that [REDACTED]

Deputy Mangel and I placed Michael into custody and began transporting him to my agency issued patrol car. Once we arrived at my patrol car with Michael, he continuously refused to get into the patrol car, resulting in Deputy Quint, K9 Deputy Mangel, Deputy Givens, and myself having to force him inside of the vehicle. As we were getting Michael into the vehicle, on multiple occasions he attempted to kick and spit on Deputy Givens in an attempt to prevent us from closing the door of the patrol vehicle; however, no contact was ever made by kicking or spitting. Michael was eventually secured into my patrol vehicle on his side to keep from restricting his airway, and was transported to the Indian River County Jail for processing.

It should also be noted that all Deputies that interacted with Michael, were in our agency issued patrol uniforms, clearly marking us as Deputies for the Indian River County Sheriff's Office, and we were performing our lawful duties as such, and Michael was being placed into my marked agency issued patrol vehicle after being taken into custody.

Due to the facts and circumstances surrounding the incident, he actively resisted all commands and made every attempt to prevent us from placing him into my patrol car, and refused to vacate the property located at 9330 19th Lane, Vero Beach, Florida after warning; Michael is charged with the following:

Count 1: F.S.S. 843.02- Resist Officer Without Violence.

Count 2: F.S.S. 810.09- Trespass on Property After Warning.






NARRATIVE

On Wednesday, April 9th, 2025, at approximately 1755 hours, I responded to Christi's Fitness, 1250 Old Dixie Highway, Vero Beach, FL, in reference to a welfare check. (Statements are paraphrased)

While enroute, IRC SO Public Safety Dispatch stated it was regarding a female slumped over in her driver seat of a white Ford Explorer.

I arrived and began approaching the Explorer (FL-IU10RB), where I spoke to the female, identified as Tracie Poehler, sitting in the driver seat and in physical control of the car. I could immediately smell the odor of an alcoholic beverage coming from inside of the vehicle. I also noticed Tracie had bloodshot watery eyes and was very emotional. When she spoke to me, I continued to smell the odor of an alcoholic beverage coming from her breath as she spoke. when I initially began to speak with her, she uttered to me "I drink". I asked her if she meant she drinks alcohol, she said yes. When I was trying to obtain what was going on tonight, she continued to be emotional and it was hard to get proper answers from her. When asking her if she drank tonight, she said "something very simple". She told me it was alcohol when I asked her. When I asked her how much she drank, she said "like a little bit".

She was very slow motioned during my contact with her and had a slurred speech. She also had trouble asking simple questions.

When Corporal McKenzie arrived, I asked her to exit the vehicle so I could further my DUI investigation. She needed to be asked several times before she exited. I then asked her to walk over to Corporal McKenzie behind her car and she refused. At this point I placed her into custody.

I spoke to gym staff member, identified as Bryan Di Sabato, who told me they located unresponsive in her vehicle. Even though they banged on her window, she remained unresponsive for a while.

I transported her to the Indian River County Jail, where I could ask her to perform Standardized Field Sobriety Exercises (SFSEs) due to it being a more controlled environment. Upon arrival at the jail sallyport when I was gathering her property and securing my firearm, I could smell the odor of an alcoholic beverage there as well even though there was a prisoner partition separating the two areas.

In the jail DUI room, I asked her to perform SFSEs and she refused. I told her if she did not participate then I had no choice but to base my next decision off what I already saw and she continued to refuse.

At the request of Deputy Rodriguez, she consented to lawful test of her breath for the purposes of determining its alcohol content. Her first sample was .359 and her second was .365.

Based on this information, I charged Tracie with violation of F.S. 316.193.4 Driving Under the Influence .15 or Higher.





On Wednesday April 9, 2025 at approximately 1415 hours, I observed Lisa Crostarosa traveling south on US 1 from the 2000 block in a tan Kia SUV (tag JW8681).

I conducted a computer check of the tag and Lisa, who is the registered owner. The computer check advised Lisa was suspended as of 4/8/25 for failure to pay traffic fines. I was unable to catch up to Lisa due to heavy traffic on US 1. I was able to get behind Lisa at the intersection of Layport Drive and Fleming Street, where I conducted a traffic stop. I made contact with Lisa at the driver's door, who began to roll up her window. I ordered her out of the vehicle and placed her into handcuffs. I advised her she was under arrest. I then checked for double lock and fit.

I read Lisa her Miranda rights, which she advised she understood and was willing to talk to me. I asked her about the previous citations she received and she confirmed she was given notice and had knowledge.

Dispatch confirmed Lisa's license was suspended and notice was provided to her on 3/19/25.

Lisa was placed under arrest and seated in the rear of my patrol vehicle. She requested her dog be released to her roommate, Susan Newman. Susan responded to the scene and picked up the dog.

Officer Keskinen and I conducted an inventory of the vehicle. I located a capsule with an unknown white powder in it. The capsule was on the driver's floor board. I questioned Lisa about it, she stated it was a vitamin. I was unable to locate a bottle in the vehicle. The capsule was taken and will be sent for testing.

Lisa was then transported to jail for driving on a suspended with knowledge and while on the way she began to advise this was not a real crime. She advised her lawyer was going to take care of it and she plans on renouncing her US citizenship and drive as a US national. She further advised she did not have money to pay the fines, but did not want to hear me explain she could have contacted the courts to set up a payment plan. She continued to become upset and agitated.

The SUV was towed and the pill was entered into evidence for further testing.
