

NARRATIVE

On July 17, 2025, at approximately 0403 hours, I observed an occupied white Jeep SUV bearing Florida temporary tag DWI4344, parked in the middle of the parking lot of a closed business, located at 5135 US Highway 1, Vero Beach, Florida.

Due to thefts in the area, I made contact with the driver, Kayla Webb. I immediately noticed her blood shot water eyes, and I could smell an alcoholic beverage emanating off of her breath as she spoke to me.

I contacted TELETYPE to query Kayla, TELETYPE informed me Kayla had a nonextraditable warrant out of Indiana for failure to appear, reference possession of Marijuana.

After I conducted the query, I requested Kayla submit to the field sobriety exercises, she verbally stated that she would. Prior to beginning the exercises Kayla stated that he does not have any physical defects. I asked Kayla if he wore glasses or contacts, she informed me she did not.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN). I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

During her first attempt I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and Nystagmus prior to 45 degrees almost instantly. I observed vertical gaze Nystagmus in both eyes. During the exercise I had to keep reminding her not to move her head.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Kayla had difficulty maintaining her balance, and staying in the position she was instructed to. She swayed side to side, and raised her arms to stabilize herself.

During her first set of nine steps, Kayla took ten steps, she failed to count out loud as requested when she started and on step three, she stepped off of the line, During the second set of nine steps, Kayla took ten steps, she stepped off the line on steps, 1, and 5. Throughout the exercise Kayla failed to keep her feet, heel to toe throughout the exercise as I instructed.

The third exercise I demonstrated and explained was the One Leg Stand exercise.

During her first attempt she put her foot down 3 times, in the timed 30 second exercise. Throughout the exercise she utilized her arms for balance and continually swayed, until I informed her to stop.

Based upon the totality of the evidence Kayla was taken into custody for violation of FSS 316.193(1) DUI. Upon completion of the exercises, I advised Kayla of her Miranda Warnings from my agency issued Miranda Card, which she stated she understood and wished to speak with me. Post Miranda Kayla advised she was drinking liquor straight from the bottle earlier in the evening.

It should be noted prior to towing the vehicle, I conducted an inventory search of the vehicle, on the rear floor board I located a 1.75L bottle of E&J that was uncapped and nearly empty. On the front passenger floor board, I





I questioned Mirian on if she had ever been issued a driver's license she replied, No.



Due to the aforementioned dangers, his clear obstruction and a criminal investigation still taking place, I began to pursue into the residence to detain him. I grabbed him by his arm and he pulled away from me, subsequently, I forced him onto a nearby couch.

NARRATIVE

On July 17th, 2025, at 2148 hours, I observed a red F-150 traveling northbound on US HWY 1 past the 3600 block at excessive speeds. I immediately activated my emergency lights and sirens on my agency issued patrol vehicle and drove after the vehicle in attempt to conduct a traffic stop. It wasn't until the 3900 block of US HWY 1 where surpassed 100mph in attempt to catch up to the suspect vehicle, and observed the vehicle to traveling at the same / if not faster, speed than I was, weaving in and out of traffic. Once the suspect vehicle and myself went through the intersection of 41st Street and US HWY 1, the driver of the red F-150 slammed on their brakes, and eventually came to a stop just passed the 4200 block of US HWY 1.

Upon making contact with the driver, I told him to turn the vehicle off and step out; where I safely detained him without incident. I placed the driver in the rear passenger compartment of my agency issued patrol vehicle. Once the driver was detained, myself and an assisting deputy searched the interior compartment of the aforementioned vehicle. While searching the vehicle, I located 2 electronic cigarette (vape) canisters containing what I believed to be synthetic cannabinoids. I collected the two vape juice canisters and utilized an agency issued field test kit to field test them for the presence of THC. The field test kit turned orange upon contact with the substance indicating a positive result for the presence of THC. Additionally, while searching the interior passenger compartment of the suspect vehicle, I located a marijuana joint in the glove box. I emptied the contents of the joint into an agency issued field test kit to field test the joint for the presence of THC. The field test kit, again, turned orange upon contact with the substance indicating a positive result for the presence of THC. It should be noted that Hagerman did previously possess a FL issued medical marijuana card, that expired back in April of 2025.

I then made contact with the driver of the vehicle, identified as Jason D. Hagerman, and advised him of his Miranda Rights, via my agency issued Miranda Rights card. Post Miranda, Hagerman expressed his understanding of his rights and agreed to speak with me. Post Miranda, Hagerman stated he had just had an argument with his girlfriend which caused him to exceed the posted speed limit. Hagerman stated he believed he was only traveling 50-60mph, but when I questioned him as to why I had to chase after him for 6 blocks with my lights and sirens activated in excess of 100mph, he stated he did not realize I was attempted to pull him over.

Through my investigation, I found Hagerman to be in violation of;

- FSS 316.1922(1)(B) Dangerous excessive speeding, reference citation #A9EUT3E
- FSS 893.13(1a)(2) Possession of synthetic cannabinoids, reference citation #A9EUT2E
- FSS 893.13(6B) Possession of marijuana not more than 20g, reference citation #A9EUT1E






NARRATIVE

On Thursday, July 17, 2025 at approximately 2155 hours, I responded to the area of the RaceTrac located at 9490 108th Avenue, Vero Beach, in reference to a reckless driver.

The Indian River County Communications Center received a call from an anonymous caller advising the following: black F250/possibly DUI, driver white male wearing all red and was stumbling barely able to stand

Upon arrival, I was notified by Fellsmere Police Department the reckless driver vehicle, later identified as a black 2004 Ford F250 bearing Florida tag Y237KF, was no longer at the above address but had traveled east bound on County Road 512. I patrolled the area and located a vehicle matching the description at the Mobil Gas Station, 9490 90th Avenue, Sebastian.

Upon pulling into the gas station parking lot, Cpl. A. Thomas and I observed a white male, later identified as Mr. Bradley Kettlewell, getting out of the vehicle. Bradley was wearing a red shirt and red shorts. I pulled my marked patrol vehicle behind the black F250 and observed Mr. Kettlewell standing in the open driver's door to the vehicle. I announced myself and confronted Mr. Kettlewell and advised him why Deputies were stopping out with him.

I asked Mr. Kettlewell if he was at the RaceTrac before coming to the Mobil gas station and Mr. Kettlewell expressed, he did drive from the RaceTrac to the Mobil gas station to get something to drink. I inquired if Mr. Kettlewell had his driver's license on him to which he replied he did not. I returned to my vehicle to verify Mr. Kettlewell's driver's license status and issue him a written warning for not being in possession of his driver's license. While filling out the warning, Sebastian Police Department Officer C. Smith arrived on scene. K9 Officer Smith's K9 partner conducted a free air sniff of the vehicle. K9 Officer Smith advised his K9 partner alerted to the black 2004 Ford F250 bearing Florida tag Y237KF.

I proceeded to search the black 2004 Ford F250 bearing Florida tag Y237KF. Upon searching the vehicle, I located a black backpack in the passenger seat. Before opening the bag, K9 Officer Smith asked Mr. Kettlewell if the backpack belonged to him. Mr. Kettlewell advised, "No." During the search of the backpack, I located a three clear baggies with a white and pink powdery substance. The baggies were right next to a bank card with Mr. Kettlewell's name on it. Additionally, I located a black eye glasses case in the center console. Inside the eye glass case was a broken burnt glass pipe and metal rod. During a search of Mr. Kettlewell's person, I located two syringes in his right zipper pocket. One of the syringes looked to be used and the other was clean.

Based on my training and experiences, I know the items found to be the following: 1. White powdery substance suspected Cocaine, 2. Pink powdery substance suspected Fentanyl, 3. Broken burnt glass pipe suspected crack cocaine pipe, 4. Metal rod suspect "pusher rod" for the crack cocaine pipe, 5. Syringes suspected intravenous drug use. I tested all the substances with field test kits. The field test results were as followed: 1. White powdery substance - FTP Cocaine, 2. Pink powdery substance - FTP Fentanyl, 3. Glass pipe - FTP Cocaine, 4. Syringe - FTP Fentanyl. I weighted each baggie with a field scale. The FTP Cocaine weigh approximately 1.44 grams and the FTP Fentanyl weigh approximately .46 grams.

Based on the evidence gathered, I arrested Mr. Kettlewell for possession of a controlled substance and drug paraphernalia. I ensured Mr. Kettlewell's handcuffs were double locked and checked for proper fit. I then read Mr. Kettlewell his Miranda Warning from my agency issued Miranda Rights card. Mr. Kettlewell advised he understood his rights and declined to
