NARRATIVE

On February 12th, 2025, at 1749 hours, I responded to 20th Place and 4th Avenue Southwest in Vero Beach, Florida, in reference to a disturbance.

Upon arrival, I met with [redacted] who were both confirmed to be [redacted]. [redacted] informed me of the following:

[redacted] and [redacted] were driving their dirt bike around 20th Place and 6th Avenue Southwest. As they were passing by a light green house located at 625 20th Street Southwest, they observed a white female, later identified as Victoria Lund, wearing a black short and a light red t-shirt, standing in her front yard, holding a long skinny gun with both hands while pointing it at them. When [redacted] saw Lund pointing the gun, [redacted] yelled at [redacted] "duck!" [redacted] then heard two bangs, which [redacted] described as similar to someone throwing a rock at a garage door. [redacted] stated that [redacted] observed a trace of the "bullet" pass by [redacted] legs. The incident did not result in any injuries, and it remains unclear if the bike sustained any damage. Both [redacted] said they were confused and scared because they didn't understand what was going on, but they felt scared.

[redacted] showed me a video [redacted] took with [redacted] phone during this incident. The video showed a white woman wearing black shorts and a light red t-shirt standing in the front yard of a light green house while holding an object with both of her hands. [redacted] was driving the dirt bike while singing, and as [redacted] passed by Lund, [redacted] called out to [redacted] friend [redacted] as [redacted] slowed down. As soon as [redacted] accelerated the dirt bike again, [redacted] yelled, "Go home, right now."

[redacted] confirmed Lund's address using Google Maps to be 625 20th Street Southwest. I drove to that address, where I made contact with Victoria Lund, who was wearing a black short and a light red t-shirt. I informed Lund of her Miranda rights, which she understood, and she agreed to speak with me. Lund informed me that she was outside with her children when she observed [redacted] and [redacted] driving their dirt bike on the roadway "recklessly" while flipping [redacted] off several times. Lund stated that they both drove back around, at which time, Lund admitted to grabbing a BB gun and "held it at them" to scare them off. I asked Lund to specify if she pointed the BB gun at them and she stated no. Lund also stated that she did not shoot at them.

Lund gave me permission to go inside of the house where I retrieved the BB gun with pellets in it. The BB gun is black and brown in color and long and small, consistent with [redacted] and [redacted] statements.

Based on the totality of the circumstances and the statements provided by all parties. I placed Lund in handcuffs and transported her to the Indian River County Jail without issues for the following charges.

1. Aggravated assault with a deadly weapon without intent, consistent with FSS 784.021.1a.
2. Child abuse, consistent with FSS 827.03.1.
