NARRATIVE

On 05/07/2026, at approximately 1020 hours, I responded to 5240 US Hwy 1, in reference to a theft. Upon arrival on scene, contact was made with the store clerk Andrew Warner. Andrew advised a B/M suspect entered the store and grabbed two bottles of Jose Cuervo Tequila. The suspect approached the front entrance of the store with the two bottles of tequila in his hands. The suspect walked past Andrew and all points of sale without paying for the tequila. The suspect then exited the store and ran towards a gold Toyota van that was waiting in the parking lot. Andrew ran after the suspect but was unsuccessful in making contact with him.

Total loss was \$59.98

A BOLO was issued for the vehicle which was located at 42<sup>nd</sup> Street and 25<sup>th</sup> Ave in Gifford.

Contact was made with the owner of the vehicle identified as Julian Irene Best.

Best advised the suspect we were looking for is Terry and she dropped him off on 27<sup>th</sup> Ave.

I began to canvass the area of 27<sup>th</sup> Ave and observed the suspect at 43<sup>rd</sup> Street and 27<sup>th</sup> Ave. The suspect was wearing khaki shorts and flip flops. Once the suspect saw me, he fled to the rear of a house in the 4300 block of 27<sup>th</sup> Ave. I knocked on the door and made contact with the suspect identified as Terry smith. Terry was detained for further investigation.

I asked terry if he had anything on him I should know about. Terry advised me he had a stem inside his pocket. A stem is street terminology used for a glass pipe used for smoking crack cocaine. I retrieved a cylindrical glass pipe approximately 2 inches in length from his pants pocket. The pipe had burnt residue inside and mesh wire inside which acts as a filter when smoking. I immediately recognized the device as a crack pipe.

Deputy Baumann transported the store clerk Andrew to the 4300 block of 27<sup>th</sup> Ave to conduct a Show-Up. Upon arriving on scene, Andrew positively identified Terry Smith as the suspect who stole the bottles of tequila from the liquor store.

Terry was taken into custody and transported to the county jail for petit theft and possession of drug paraphernalia.

I conducted a field tested the residue inside the crack pipe, which yielded positive results for the presumptive presence of cocaine.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On May 7, 2026, at approximately 1339 hours, I responded to a hit and run which occurred at Cumberland Farms (957 Sebastian Blvd). The witness stated the suspect vehicle was heading north on Barber Street and provided a description of a silver/grey in color KIA Sportage bearing FL tag# LA067D.

While on BOLO for the suspect vehicle, I observed the suspect vehicle traveling east on Roseland Road and turn left onto US Highway 1 northbound. The vehicle had the front bumper hanging from the vehicle as described by Sebastian Dispatch. I activated my emergency lights on my marked Sebastian Police patrol vehicle and attempted to initiate a traffic stop at Roseland and US1. The vehicle was accelerating and I caught up to the vehicle utilizing my emergency sirens and attempting to gain attention of the driver and stop the vehicle. The vehicle continued north on US1 until after the bridge by Palm Ave and US Highway 1.

While making contact with the driver, I could smell the strong odor of an alcohol beverage emitting from her breath. The driver was identified as Constance Dusek. Constance provided her registration and current proof of insurance, but stated she did not have her license due to misplacing it or losing it. At first, Constance handed me her handicap placard registration instead of her vehicle registration I asked for. Constance was slurring her speech and stated this may be due to her recently having \_\_\_\_\_ Constance kept stating that she only lives just up the street and asking to let her go. Constance was ordered from the vehicle and advised to walk to the front of my patrol vehicle. Constance stated if she walks unusual, it is due to her having hip complications and that she is not under the influence. It should be noted I did not even mention impairment or suspicion up to this point. During this walk, Constance did not walk a straight line and did appear to stumble while walking. Constance stated she did hit something at the store due to her not being able to turn her body to see while backing up and her not seeing it on her back-up camera. While Constance was walking to the front of my patrol vehicle, she took a hit of her vape pen and was not listening to orders. The vape pen was removed from her hand and had to be placed on the hood of the patrol vehicle. Constance was not making sense while speaking to her and difficult to understand while speaking to her.

While speaking to Sgt. Richard and I, Constance was ordered to the right side of my patrol vehicle to be out of the roadway in a safer location. Constance was told by Sgt. Richard to stay put and stop moving. While speaking to Constance, she walked away toward the roadway/traffic and attempted to retrieve her vape from the hood of the patrol vehicle. While attempting to grab Constance, she pulled away from Sgt. Richard and I. At this time, Constance was going to be placed into handcuffs. Constance tensed her body, pulled away both arms from Sgt. Richard and I, and stated she was not going to be put into handcuffs. Constance was ultimately put into handcuffs which were double locked and checked for fit.

While on scene, Constance refused to perform standardized field sobriety exercises (SFSE) and stated she was not going to be charged with DUI. Constance was searched and placed into the back of my patrol car. In Constance vehicle was (2) White Claw alcoholic beverage cans, an open container of Svedka Vodka, and several vape pens. This interaction was captured on my body-worn camera (BWC).

The victim, Cumberland Farms, declined prosecution for the damage of the struck object on their property and filled out a lack of prosecution department form on scene. See Ofc. Wilkinson #419 supplement report regarding this interaction.

This incident is cleared by arrest.

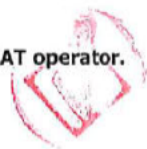

NARRATIVE

On May 7<sup>th</sup>, 2026, at 1913 hours, I was patrolling the 7400 block of 20<sup>th</sup> Street westbound when I observed a white Nissan Rogue bearing Florida tag 92CGYN traveling at what appeared to be a speed in excess of the posted speed limit. I then began to pace the vehicle between 60 and 65 miles per hour. I activated my Stalker DSR 2X-mounted radar and visually confirmed the vehicle's speed to be 62 miles per hour. When I attempted to clock the vehicle at the measured speed, the vehicle turned north onto 79th Avenue, where I initiated a traffic stop by activating my emergency lights and sirens.

I then made contact with the driver, later identified as Secundino Pastor Hernandez, and informed him of the reason for the stop. While interacting with Hernandez, I observed him to be extremely nervous, as his tone of voice was soft and he was physically shaking. I asked him to provide his driver's license, registration, and proof of insurance. Hernandez informed me that he did not have a driver's license. To clarify his statement, I asked him whether he did not have one in his possession or had never been issued one. Hernandez stated that he did not have one and proceeded to provide me with a Florida identification card.

A query through D.A.V.I.D. revealed that Hernandez had a revocation status dating back to February 28th, 2022. A further query of the driver transaction history through D.A.V.I.D. revealed that on December 8<sup>th</sup>, 2023, Hernandez completed a transaction for a Florida identification card only. On December 8<sup>th</sup>, 2023, a sanction record was located on D.A.V.I.D. indicating a DL Cancellation in accordance with F.S.S. 322.08(7), reference suspension case # 437192531. No further driver license history was located. Indicating that Hernandez did not possess a valid driver's license in the State of Florida.





NARRATIVE

On May 7<sup>th</sup>, 2026, 2219 hours, while on routine patrol, I located a black in color Nissan Rouge, bearing TX/ VKC7908, traveling eastbound on 45<sup>th</sup> Street and positively identified the driver as 20-year-old, Curtavion Lanier Naphier. Based on prior law enforcement intelligence and social media information, it should be noted that this subject has been identified through open-source social media intelligence as being in unlawful, open carried, possession of a firearm (specifically a black handgun with a tan colored extended magazine and a blue laser) and large amounts of U.S. currency believed to be proceeds from credit card fraud schemes. These observations on social media were recent and included images and/or videos showing the subject with the firearm and currency, sitting inside the back seat of the aforementioned suspect vehicle.

It should be noted that I conducted a query for this vehicle by utilizing the FLOCK Safety camera system, which revealed the same aforementioned rental vehicle had just exited the county and reentered shortly after before traveling up to the Gifford area, indicating that the suspect vehicle was not engaged in normal local travel. Additionally, the suspect, Naphier, does not reside in or near the Gifford area. It should be note that rental vehicle's bearing out of state license plates, are frequently utilized by criminals engaged in fraud, firearm offenses, and narcotic related activities because they are difficult to trace back to the operator and allow for quick disposal or return if compromised.

Prior to the stop, the vehicle was observed operating in an overly cautious and unusually law-abiding manner. The driver traveled 2-3 mph below the posted speed limit whenever there was little to no traffic on the roadway, came to a complete stop well before the painted stop bar at intersections, and even activated his directional turn signal on every turn even when there was no oncoming traffic or other vehicles present absent of my marked patrol unit. This pattern of driving commonly referred to as "police driving" and is consistent with individuals attempting to avoid drawing attention to themselves while engaged in criminal activity.

As I approached the suspect vehicle with my marked patrol vehicle from behind, it should be noted that I was met with an overwhelming odor of burnt marijuana emitting from the vehicle, and without activating emergency equipment or initiating a traffic stop, the suspect vehicle immediately turned into a nearby residential driveway. As I continued past the suspect vehicle, I positioned my marked patrol vehicle in a manner where it was out of sight under the concealment of darkness, but allowed me to maintain a clear, unobstructed, line of sight of the vehicle. I observed the driver, Naphier, to remain seated inside the vehicle and never observed him exiting. After an approximate 3 minutes where Naphier remained seated, and was never seen making contact with any subjects inside the residence, I observed

the suspect vehicle to depart from the residence, back tracking the original path of arrival; highlighting the likelihood that Naphier pulled into the residence in attempt to evade law enforcement. It should be noted that this behavior supports reasonable suspicious of nervous, unprovoked flight/evasion, in the high-crime area known as Gifford, where the suspect, Naphier, does not reside.

These actions, combined with the subject's known recent involvement in violent firearm related crimes (the observed social media post and IRCSO Case #2025-70341) and property crimes (IRCSO Case #2025-83983 and #2026-36177), created reasonable suspicion that the subject was actively attempting to evade law enforcement detection and was engaged in, or about to engage in, criminal activity. The evasive driving maneuver, pulling into a driveway immediately upon the presence of a marked patrol car, is consistent with consciousness of guilt and an attempt to avoid law enforcement contact while in possession of contraband.

Pursuant to FSS 901.151, stop and frisk law, and consistent with case law Terry v. Ohio, United States v. Arvizu, State v. Fortin, and Illinois v. Wardlow; I initiated a traffic stop based upon reasonable suspicion that criminal activity was underway. The stop was not based on any observed traffic infraction, but rather on the totality of the circumstances;

- the subject's documented recent illegal possession of a firearm
- the suspicion of ongoing credit card fraud activity
- the suspect vehicle emitting an overwhelming odor of burnt marijuana
- the subject's immediate evasive reaction to the marked patrol vehicle
- the subject remaining inside the vehicle and departing shortly after my presence was no longer visible

Upon approaching the vehicle and making contact with the driver, Naphier, I immediately observed multiple pieces of a green leafy substance I suspected to be loose marijuana, commonly referred to as shake, scattered across the vehicle. In addition to the "shake" I observed two ashtrays containing multiple "roaches" (the butt of a marijuana joint after the majority has been smoked). I request Naphier to provide me with his driver's license and then to exit the vehicle, too which he agreed. After exiting the vehicle, Naphier was detained without incident and searched. I located 3 clear plastic baggies containing more of

the same green leafy substance (suspected loose marijuana) scattered across the interior of the vehicle. An agency issued field drug test kit was utilized to test the substance, resulting in a positive test result, indicating the presence of THC. I then placed Naphier in the rear passenger compartment of my agency issued marked patrol vehicle. After securing Naphier, I searched the interior of the vehicle and located 4 bank cards inside the vehicle that did not belong to Naphier; as well as opened bottle of Don Julio tequila.

Through my investigation, I found Curtavion Lanier Naphier, to be in violation of;

- FSS 893.13(6)(B), possession of marijuana not more than 20g (citation #ANHAW7E)
- IRC Ordinance 300.07(2), possession of an open container in a motor vehicle (citation #ANHAW8E)

On 5/7/26 at approximately 2238 hours, I Ofc. Kriegner observed a suspicious vehicle (silver Honda FL tag#NSTH96) idling in the parking lot of TD Bank (4100 20th Street), which was closed at the time. The vehicle was idling in the middle of the parking lot, facing west, not pulled into a parking space.

Upon approaching the driver's side of the vehicle, I observed the driver (identified as Jennifer Slakis) of the vehicle appearing to be asleep. I knocked on the window loudly, several times before the driver responded (the driver opened her eyes and looked as if she had just woken up). I asked Jennifer what her business was in the parking lot of a closed establishment and where she was coming from. She initially responded, saying she was traveling home from work at TJ Maxx but could not provide an address for the business. As she spoke, her words were slurred and I could smell an odor of an alcoholic beverage emanating from her breath. I asked her if she had been drinking to which she responded yes and said she was actually coming from the Rowdy Rooster (1103 21st Street). She stated she had pulled into the parking lot of the bank attempting to "sober up" before traveling home. I requested she conduct Standard Field Sobriety Exercises, she stated she would and stated she had done them before in Brevard County.

During the Horizontal Gaze Nystagmus exercise:  
 unable to maintain balance  
 swayed while standing  
 unable to follow instructions, turned head while following stimulus.

While explaining the instructions for the Walk and Turn Exercise, Jennifer was unable to maintain balance or follow instructions and stated she "knew" she was going to jail and stated she did not wish to proceed with the exercises. Based on my observations, Jennifer was placed under arrest for FSS 316.193 DUI and transported to the Indian River County Jail. I confirmed with Vero Beach Communications that Jennifer has a prior conviction for DUI out of Brevard County.



Her vehicle was towed by Jerry's Towing. While conducting an inventory search of the vehicle, I located an opened, half emptied can of "White Claw Hard Seltzer" in the center cupholder of the vehicle.

At the jail, Ofc. Hernandez conducted two Breath Alcohol Tests on Jennifer. The first test showed a reading of 0.161, the second showed a reading of 0.153.
