NARRATIVE

On Monday March 23, 2026 at approximately 1254 hours Cpl. Rollando and I responded to 1295 US Highway 1 (5 Below) in reference to shoplifting. While enroute Indian River Public Safety Dispatch notified me the suspect was walking southbound on US Highway 1 from the above address wearing a teal dress. While canvassing the area I observed the suspect matching the description and destination of travel. I then detained the suspect at 1180 US Highway 1 (WAWA) where she stated the following:

Lena Ann Boothe (Defendant) stated she was just going to talk to one of her friends who was sitting inside a vehicle at the WAWA. When I asked her if she went inside 5 Below, she stuttered then said "yes, all the items are inside this bag". Upon searching the bag she was in possession of, I observed multiple finger nail products, fragrances, make up items, and an additional bag, most of which was still in the original wrapping and boxes without a receipt. I then detained Boothe and transported her to 5 Below for further investigation.

I then met with Candice Rampulla (manager) of 5 Below who stated the following:

Rampulla stated she was sitting inside her office when she looked at the camera monitor screen and noticed Boothe, who she recognized from a previous theft which wasn't reported, grabbing multiple items off the shelves and placing them inside a bag. Rampulla said she watched Boothe look around then proceed to walk past the points of sell without attempting the purchase the items inside the bag. Rampulla also wished for Boothe to be trespassed from the store.

I then brought all the items Boothe was in possession of back into 5 Below which revealed all were stolen including the bag they were placed into accumulating the total of \$176.55.

While searching the other bag Boothe was in possession of, I observed a burnt pipe with a lighter in the same compartment. When I asked Boothe if she had anything on her person which I could've missed while searching her, she stated she had a pipe which she used to smoke in her bag.

Boothe was placed under arrest then transported to Indian River County Jail where she was transferred over to the care and custody of the IRC Corrections Deputies.

Upon a query via the clerk of courts website it was revealed Boothe was previously convicted Felony Petit Theft on 08/29/2025 (2025 CF 000996 A). Petit Theft on 12/16/2024 (2024 MM 001975 A), Petit Theft on 5/5/2026 (2025 MM 000538 A).

I charged Boothe with felony petit theft along with possession of drug paraphernalia.

This interaction was captured with agency issued BWC.

NARRATIVE

On March 23, 2026, at approximately 1843 hours, I responded to the intersection of 49<sup>th</sup> street and 29<sup>th</sup> Avenue, Vero Beach, Florida, in reference to an auto accident.

Upon my arrival, I made contact with, Brandon Taft, who was the driver of a black Mitsubishi Elantra bearing Florida tag 11BHJJ. I asked Taft for his driver license registration and insurance. Taft Immediately lowered his head in disappointment and stated "I don't have a valid driver's license; I think it's from not paying child support". I asked Taft if he had any type of identification, he handed me a Florida drivers license. After running a query, Indian River County Public Safety Dispatch informed me that, Taft does not have a valid license, it has been suspended as of August 2<sup>nd</sup> 2024 for failure to pay child support. This suspension is consistent with his non extraditable warrant out of Ohio for failure to pay child support.

It should be noted that, D.A.V.I.D. record system, shows five prior driving while license suspended or revoked convictions.

Based on my investigation, Taft knowingly operated a motor vehicle with knowledge that his license was suspended.

Because on the facts listed above, find probable cause to charge Taft with:

**NARRATIVE**

On Monday, March 23, 2026 at approximately 1920 hours, I responded to the residence located at 4430 10<sup>th</sup> Street, Vero Beach, Florida 32968 in reference to a disturbance.

Prior to my arrival, Indian River County Communications Center received a call from a neighbor to the above-mentioned address. The neighbor advised he believed a disturbance was occurring due to him hearing a female's voice yelling for help and loud banging coming from the neighboring residence.

Upon my arrival, I made contact with Ms. Melinda Watts who was visibly distraught and crying in the front yard. Ms. Watts had her phone up to her ear and stated "oh good they are here" and put the phone down. Ms. Watts proceeded to advise the following: Her and her fiancé, Mr. Michael Fry, were in a physical altercation that stemmed from them talking about breaking up from their seven plus year relationship.

Ms. Watts advised she was pushed out of the front door by Mr. Fry and attempted to get back inside but Mr. Fry had locked the front door. Ms. Watts then walked around to the back of the residence and was attempting to get in through the back door when Mr. Fry came out, grabbed her by the neck, picked her up and threw her down.

Ms. Watts expressed she was unable to breathe when Mr. Fry grabbed her by the neck. Ms. Watts had visible redness on her neck and chest area. Ms. Watts declined medical attention.

Deputies then made contact with Mr. Fry who advised the following: He and Ms. Watts were in a verbal argument after he came home from work and he just wanted her out of the residence. Mr. Fry expressed how Ms. Watts damaged the bedroom door and threw planting pots on the patio and because of this he just wanted her to leave. Mr. Fry did not advise if the altercation became physical. [REDACTED] (one night).

I observed a small laceration on Mr. Fry's forehead and when asked about it, Mr. Fry expressed he didn't know exactly what it was from but thought maybe it could have been from Ms. Watts throwing a planter's pot. Mr. Fry declined medical attention.

Deputies noticed ring cameras on the front door and covering portions of the back patio. Mr. Fry was able to access the cameras which captured portions of the disturbance. I proceeded to observe the following from the front door camera: The front door opens and Mr. Fry can be seen actively pushing Ms. Watts out of the front door. Ms. Watts is facing the front door and "walks" out of the front door face first while appearing to attempt to stop Mr. Fry pushing her. Ms. Watts then checks for her phone in her back pocket but notices it is not there. Ms. Watts knocks on the door then bangs on the door with no answer from within.

From the back patio camera, Ms. Watts can then be seen in the back patio area throwing a planter pot against the back door. Mr. Fry comes out from the same back door, grabs Ms. Watts by the neck and chest area, appears to attempt to pick Ms. Watts up and move her towards the screen door. Mr. Fry pushes Ms. Watts against the screen enclosure and then

Mr. Fry can then be seen from the front door camera footage throwing Ms. Watt's cell phone onto the front patio/walkway and closing the door once again.

Due to the statements made by Mr. Fry and Ms. Watts, evidence presented by the camera footage and Ms. Watts person, I have probable cause to believe Mr. Fry did commit battery by strangulation (F.S.S. 784.031). Mr. Fry was subsequently placed under arrest utilizing my department issued handcuffs. I ensured proper fit and tightness as well as double lock before placing Mr. Fry into the back seat of my patrol vehicle. Mr. Fry was transported to the Indian River County Jail Complex without issue.

NARRATIVE

On March 23, 2026, at approximately 1934 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I met with Mr. Lawrence Ignazio who stated he was locked inside a separate room at the aforementioned address. He heard what sounded like a physical fight between two males in the residence. He could hear items breaking and came out of his room to see Joan Ramirez leaving the apartment, and an unknown black male in the apartment [REDACTED]. He did not observe any of the fight.

I met with Ms. Shannon Sweeney who stated the following: She is afraid of Joan and is working to get an injunction against him. After Deputies left the apartment due to a prior disturbance, Shannon texted Nathan Walker to come over as she was still scared. Nathan went [REDACTED] to talk to Joan. Joan became irate with Nathan, and started punching him. Joan pulled Shannon into the fight, and bit the fingers on her left hand. Joan also punched Shannon in the head.

I observed a linear cut consistent with a bite on several of Shannon's fingers. She also had some redness and swelling on her brow line between her eyes. Shannon stated she has been in a romantic relationship with Joan for approximately five months [REDACTED].

I met with Mr. Nathan Walker who stated the following: He came over to the residence after Shannon texted him about the situation with Joan. He talked to Shannon, then decided to speak with Joan. He told Joan how he was abusing Shannon and this enraged Joan. Joan began punching him in the head and eventually they began wrestling on the floor. Nathan pinned Joan to the floor between his legs and tried to hold him there while he yelled for someone [REDACTED]. Shannon became involved in the struggle and Joan bit her on the hand. Eventually, Joan got free and walked out of the apartment.

Nathan had fresh, bleeding scratches on his left forearm. He also had a contusion on top of his head. Nathan wished to press charges.

In a post-Miranda interview, Joan stated the following: Nathan showed up to the apartment and began yelling at him about how he was abusing Shannon. Joan and Nathan began yelling at each other and Nathan got in Joan's face. Joan pushed Nathan away, then he began punching Joan. The two continued punching each other and wrestling on the floor, until Nathan pinned Joan to the floor. Shannon came over and Joan thought she was trying to break up the fight. Instead, Shannon started scratching Joans face and pulling at his lip. Joan bit Shannon's hand while she was pulling at his lip. Eventually, Joan broke free from them and walked out of the apartment.

Joan had fresh, bloody scratches to his right arm and to his face. He also showed me bruising to his abdomen. I also observed Joan and Shannon's bedroom to be in disarray with broken items strewn all over. Joan confirmed he is in

NARRATIVE

On Monday, March 23, 2026, at approximately 2141 hours, I responded to 690 4<sup>th</sup> Place, in reference to a suspicious person. The complainant, Milton Johnson, stated an unknown male wearing dark clothing with a hood over his head was seen walking around his shops.

Milton stated as he got near the subject the male was observed running away from him and concealed himself in a port-a-potty. Milton also stated he has seen the male on the property before; however, stated the male usually "disappears" before Law Enforcement is contacted.

I arrived at the aforementioned location, at which point I observed a white male matching the provided description walk around the corner of the building at 640 4<sup>th</sup> Place. The male upon seeing my patrol vehicle, immediately turned around, and began walking away with haste.

I exited my patrol vehicle, and began giving the male commands at which point he was compliant. The male was later identified by his New Hampshire identification card as, Chase Phillip. Chase was advised of his Miranda Rights, and was given the opportunity to dispel my concerns. Chase initially stated he had nowhere to go, and was just hanging out. Chase stated he did not wish to speak with me regarding the incident.

It should be noted that Chase was in a posted active construction zone with a no trespassing sign. The sign was listed as Bill Bryant & Associates LLC, General Contractors No Trespassing. Chase was also observed walking around closed businesses in dark clothing with his hood covering his head. Chase was also observed by Milton attempting to conceal himself from sight inside of the Port-a-Potty upon his arrival at the location. This behavior combined with Chase's attire covering his face with dark clothing is not common for normal law-abiding citizens. It is also not common for the area to be traveled as the businesses were closed with no employees present.

Due to Chase's inability to dispel my concerns that he was unlawfully in the area without malicious intent, I placed Chase into custody. A search of Chase's backpack incident to arrest revealed approximately (20) green and white pills marked with "E 615" inside of a small clear Ziploc bag.

I utilized the Drug.com drug identifier application, which revealed the pills were, Hydroxyzine Pamoate 50mg capsules. This pill is a sedative and hypnotic commonly used before and after anesthesia requiring a prescription for possession and usage.

I asked Chase if he is prescribed any medications, at which point he stated, "I found those on the side of the road."

Due to the aforementioned facts and circumstances, I find probable cause to charge Chase Phillip with
