On August 26, 2025 at approximately 1450 hours, I responded to a disturbance in progress along with Deputy Portocarrero located at 1455 90th Avenue Lot 257.

Prior to arrival, the complainant Karen Sapp, called into public safety dispatch that her husband, Alfred Sapp was breaking items in their home. During the investigation, it was determined by Deputy Portocarrero that Alfred Sapp needed to be Baker Acted by Law Enforcement. Alfred was not cooperative and became actively combative during detainment. While engaged in a physical confrontation with Alfred Sapp, Karen Sapp began to plea that we let her husband go, even though she was the primary caller on the disturbance.

Karen then became physical and attempted to intervene and get in between Deputy Portocarrero while on the ground fighting with Alfred. Karen Sapp then jumped on my back trying to pull me off of her husband. I straightened my torso and she let go of me. It should be noted that both me and Deputy Portocarrero were wearing Indian River County Sheriff's Office "Class C" uniforms. Karen Sapp had to be pushed away from us so that Alfred could be detained. Karen Sapp was placed into custody after multiple deputies arrived on scene. I do not believe that Sapp tried to cause me harm however, she did interfere with our lawful ability to detain her husband following an official investigation.

Karen Sapp is in violation of F.S.S. 843.02 Resist Officer without violence.



NARRATIVE

On August 26, 2025 at approximately 1450 hours, I responded to a disturbance in progress along with Deputy Portocarrero located at 1455 90th Avenue Lot 257.

Prior to arrival, the complainant Karen Sapp, called into public safety dispatch that her husband, Alfred Sapp was breaking items in their home. Upon arrival, I noticed Deputy Portocarrero speaking with Alfred Sapp in the backyard of the residence. Sapp was extremely agitated by the presence of law enforcement. Deputy Portocarrero then advised me that Alfred needed to be [REDACTED] by law enforcement. Every time we attempted to get close to Alfred to detain him, he would back up frantically and believed that we were there to kill him. Deputy Portocarrero attempted to deescalate and assure him that he was not going to jail and that we were not going to harm him. Alfred still would not let us near him and eventually we were positioned approximately 100 yards south of his residence, following him in the residential community. It should be noted that both me and Deputy Portocarrero were dressed in a Sheriff's Office "Class C" Uniform and identified ourselves as law enforcement.

I made the decision to loop around one the modular homes and cut his movement off so that he could be detained for a [REDACTED]. Alfred still would not allow us to take him into custody. It appeared that Alfred was under the influence of unknown substances. As a result, I issued my agency issued taser and deployed six projectiles which were not effective. Every time Alfred was struck by a taser projectile, he would quickly pull them out making the use of force ineffective. Deputy Portocarrero and me then engaged into physical force to detain him however, while on the ground, Alfred became actively combative, kicking Deputy Portocarrero in the leg and scratching him on both hands causing minor injuries. Alfred then spit in the open wounds on Deputy Portocarrero hands. Alfred Sapp kicked me in the groin and spit on my uniform. I did not suffer any injuries during the physical confrontation. More patrol units were required to successfully detain Alfred. As a result of the incident, Deputy Portocarrero had to be seen at the Cleveland clinic emergency room as a result of the injuries he sustained during the physical confrontation.

Based on the above facts, Alfred Sapp did not comply with lawful commands to be placed into custody. Alfred Sapp actively resisted law enforcement and struck Deputy Portocarrero physically by kicking and spitting on him multiple times. Deputy Portocarrero is a law enforcement officer employed by the Indian River County Sheriff's Office. Alfred Sapp is in violation of F.S.S 784.(2)(b) Battery on a Law Enforcement Officer.

Additionally, Alfred Sapp knowingly and willfully resisted Deputy Portocarrero and me by offering physical violence striking us multiple times along with weaponizing his bodily fluids, spitting on Deputy Portocarrero. Deputy Portocarrero and me were at the scene for a lawful purpose and legally authorized
