



NARRATIVE

On Thursday, September 25, 2025, at approximately 0723 hours, while conducting traffic enforcement in the area of 4th Street and US Highway 1, I observed a white Dodge SUV make an improper right turn on red, where posted "No Right Turn On Red".

I conducted a traffic stop on the vehicle (FL / PEQC05) at the 100 block of US Highway 1. Upon making contact with the driver, later identified as, Samuel Mendez-Perez, I asked him for his license, registration, and insurance.

Mendez-Perez stated, he does not have a driver's license, and instead produced a Mexico Passport.

Mendez-Perez stated he has lived in the states 27 years, and never had a license.

Upon running Mendez-Perez, I learned he does not hold a valid driver's license. Mendez-Perez stated his ride never picked him up for work, so he decided to take himself.

Mendez-Perez was placed in hand restraints, and transported to the Indian River County Jail without incident.

Mendez-Perez was issued a Uniform Traffic Citation for No DL (Citation # AM2NM4E).

I, Ofc. Z. Dominguez, was dispatched to 1865 18th Avenue in reference to a potential stolen vehicle.




Upon arrival, I made contact with the complainant, Kassandra Whitworth. She advised that her vehicle 2007 Ford SUV with FI tag# BF64HJ was borrowed around 9:00pm on 09/24/25 by Jessica Stewart and Cyteria Davis last night to run to a nearby store. However, they had not returned the vehicle as of this time. Kassandra also advised that they were only invited to her house to stay overnight, and they did not live there. After not hearing from Stewart and Davis for hours, she wanted us to attempt to locate the vehicle but declined to report it stolen.



After putting out a BOLO for the Kassandra's vehicle at 1122hrs., Cpl. Lachowicz located the vehicle in the area of US1 Hwy/17th Street and conducted a traffic stop on it in the 900 block of 18th Street. Myself and the complainant Kassandra went to the location to retrieve her vehicle. Cpl. Lachowicz informed me that Davis was the driver of the vehicle and she had a suspended Florida drivers license. Through a records search, her license had been canceled indefinitely due to habitual traffic offender since 02/22/2022.

On scene, I spoke to the driver Davis and she acknowledged that she did not have a driver's license and had to pay fines. At this time, Davis was detained for not having a valid license. The vehicle was then searched by Cpl. Lachowicz and he located a cigarette pack (Brand 305, green in color, non menthol) in the center console cup holder. Cpl. Lachowicz looked inside the cigarette pack and observed a rock-like substance and a powder white substance wrapped in a clear / paper holder. Cpl. Lachowicz field tested the substances and they tested positive for Methamphetamine and Fentanyl. The substances were later weighed totaling 1.9 grams of Methamphetamine (w/packaging) and 1.6 grams of Fentanyl (w/packaging).

I read Davis his Miranda rights which he acknowledge and waived. Davis was willing to talk to me about the substances that were found. I asked Davis about the items and he denied that they belonged to him. NOTE: Cpl. Lachowicz advised me that Davis was smoking a 305 cigarette upon making the traffic stop. Davis's passenger, Jessica Stewart advised she did not smoke cigarettes and did not know anything illegal was in the vehicle. Davis was then transported to the Indian River County Jail for holding with no bond.

On 9/25/2025, at approximately 0932 hours, I, Deputy A. Brady, responded to [REDACTED] in reference to a CFSFAX. The statements in this report are paraphrased.

After reading the intake report, Frabotta and I made contact with [REDACTED] Colleen Bethel. Frabotta explained the allegation of the intake report to Colleen and Colleen gave us permission to do a walk through of her home. During the walk through of the home I was immediately met at the front door by an incredible smell of ammonia. So much so that my nostrils began to burn. A short time after being in the residence I was starting to feel unwell and dizzy. As Frabotta and I walked through the home we could see cat feces everywhere throughout the residence. There was cat urine and feces in every room of the residence. Colleen stated [REDACTED] sleeps in the living room on the futon couch she had just purchased for [REDACTED] to use as a bed. Colleen stated she purchased the couch for [REDACTED] because [REDACTED] bedroom is too dirty for [REDACTED] to sleep in. On the couch where Colleen said [REDACTED] sleeps, there was cat feces in all the crevasses. I observed household garbage all over the house making it difficult to walk through. There was also old food left everywhere in the house and many flying insects. As I made my way to the kitchen and hallway there was even more cat feces on the floors. In the kitchen was more garbage, old food, cat urine, and feces. I made my way to the first bathroom, which was [REDACTED] bathroom. I observed [REDACTED] on the sink in her bathroom. In the bathtub was even more cat feces and urine. Colleen stated [REDACTED] now uses her bathroom in Colleen's bedroom because the cats have used [REDACTED] bathroom primarily as their restroom. I then made my way to [REDACTED] bedroom. In order to get into [REDACTED] room, I had to climb over piles of garbage. On top of several piles of garbage was a small children's mattress, with no sheets, blankets, or pillows. At the foot of the bed with garbage, was an over full kitty litter box with cat feces. On the wall above the bed were lists of chores for [REDACTED] to include; cleaning the house and taking care of the cats. I then made my way to Colleen's bedroom. Again, I had to climb over piles of garbage to enter her room, where there was

more garbage on the floor. In the hallway between [REDACTED] and Colleen's room was more cat feces smeared all over the floor. I then went to check the garage, which was piled to the ceiling with boxes and more garbage. I was unable to walk into or through the garage. In the pantry where Colleen keeps some of their packaged food, there was more cat urine and feces on the packages of food.

Frabotta and I then made our way to [REDACTED] to interview [REDACTED]. [REDACTED] was well spoken, had a good understanding of the situation, and was able to give Frabotta clear answers to her questions. During Frabotta's interview [REDACTED] immediately began crying. Frabotta asked [REDACTED] to tell her about [REDACTED] issues at school. [REDACTED] explained how the kids at school bully [REDACTED] because [REDACTED] smells like cat urine. [REDACTED] stated [REDACTED] tells [REDACTED] to clean the house and take care of the cats but knows [REDACTED] can't do all of it. [REDACTED] Although Colleen stated [REDACTED] sleeps in the living room on a couch [REDACTED] told Frabotta that [REDACTED] sleeps in [REDACTED] bedroom even though its full of garbage. [REDACTED] stated when [REDACTED] does try to sleep, [REDACTED] has to cover [REDACTED] face with a blanket to try and limit the smell of the cat urine, which makes it hard for [REDACTED] to sleep most nights. [REDACTED] stated living in [REDACTED] home makes it hard for [REDACTED] to breathe. [REDACTED] said they have twelve cats in [REDACTED] and that [REDACTED] didn't believe the cats should have to live in such a dirty house. Frabotta asked [REDACTED] if [REDACTED] thought [REDACTED] should have to live in a dirty house. [REDACTED] stated [REDACTED] didn't want to live in the house with as dirty as it is. [REDACTED] stated [REDACTED] keeps [REDACTED] clothes in [REDACTED] bathroom in the sink to try and keep the cats from lying on them. This is the same bathroom the cats use as their restroom, along with the rest of the house. [REDACTED] then went on to explain how [REDACTED] has asked Colleen to allow [REDACTED] to [REDACTED] but Colleen said no. [REDACTED] told Frabotta [REDACTED] leaves the home often without Colleen's permission and just walks the neighborhood, to get away from the poor living conditions. [REDACTED] stated Colleen treats [REDACTED] like the kids at school do. When Frabotta asked [REDACTED] to explain what [REDACTED] meant by that, [REDACTED] said Colleen makes fun of [REDACTED] for smelling like cat urine just like the kids at school. [REDACTED] stated [REDACTED]

Animal control was notified and they responded to the above-mentioned address. Animal control stated there were multiple animal neglect/abuse violations and decided to take possession of all the cats. Animal control was able to locate eleven out of the twelve cats. Reference animal control case number 2025-077390. Animal control officers stated they would look into criminal charges against Colleen at the conclusion of their investigation.

I then returned to Colleen's residence and placed her under arrest for F.S.S. 827.03 Neglect child without great bodily harm. I then transported Colleen to the Indian River County Jail, where she was turned over to corrections Deputies without incident.

Once at the jail I read Colleen her Miranda warnings to which she stated she understood. I asked Colleen how long she has lived at [REDACTED]. Colleen stated she has lived there for five years and [REDACTED]. Colleen stated she works from home as a call center supervisor. I asked Colleen why she hasn't cleaned her home. Colleen stated she would clean and then [REDACTED] would mess up the house again so she felt like, "What's the point?"

My involvement with this case was recorded on my body-worn camera.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On **09/25/2025**, at **12:45** (Specifically include facts constituting cause for arrest.)

On 9/25/25 at approximately 1245 hours, VBPD SIO, with the assistance of VBPD CRT and Sebastian Police Department CRT, executed a narcotics search warrant on the residence located at 466 19th Pl. Vero Beach, FL 32960.

While securing the residence, CRT members located and secured defendant Gregory Chaney, W/M DOB 3/11/75, who was found sitting on the bed inside the guest bedroom of the residence. No other occupants were inside the residence.

While conducting the search of the residence, VBPD Detective J. Maslan #40 located numerous items of paraphernalia commonly associated with the use of illicit narcotics inside a white hutch and with bedside table, in the guest bedroom where Chaney was found. Those items included multiple scales with residue, a large amount of small plastic baggies, and a small plastic baggie with an orange color capsule with the markings "Adderall XR". The capsule was confirmed by Drugs.com pill identifier as Amphetamine/Dextroamphetamine (Adderall), a Schedule II controlled substance in the State of Florida. There was a piece of notebook paper inside the guest bedroom closet where Chaney was located that had his name on it, showing Chaney as the person in custody of that bedroom. There were no other names or other items with other subjects names found inside the guest bedroom.

While conducting a search of the guest bathroom, four small Ziploc style baggies were found in the bathroom trash can, immediately next to the toilet. Those baggies contained green plant material and were wet, consistent with those that contained illicit narcotics that were flushed in the toilet, but then removed and placed in the trash can due to the baggies not making down the toilet. There also appeared to be a small amount of dark plant material on the rim of the toilet similar to the plant material found in some of the wet baggies.

Gregory Chaney was the only occupant of the residence at the time of the search and there was a significant lapse of time, approximately 2 and a half to three hours, between defendant Cassie Murillo, W/F DOB 7/19/79, being picked up in a vehicle from the residence and the search of the residence. After being picked up, Cassie Murillo was located at a separate location in the City of Vero Beach and never returned into the residence until the search was completed.

Due to Gregory Chaney suspected to have disposed of controlled substances prior to be taken into custody, he was charged with Tampering with Physical Evidence (FS 918.13(1a)), a third degree felony.




Due to Gregory Chaney possessing the suspected Amphetamine/Dextroamphetamine (Adderall) capsule, he was charged with Possession of a Controlled Substance without a Prescription (893.13(6a)), a third degree felony. He was issued Florida UTC ALZPACE for this offense.

Due to Gregory Chaney possessing numerous items of drug paraphernalia, he was charged with Possession of Drug Paraphernalia (893.147(1)), a first degree misdemeanor.

Chaney was transported to the Indian River County Jail without incident.




